Reports and Images that testify to the existence of a 1930s World UFO Phenomenon.

Among the many popular preconceptions that have attached themselves to the history of our subject is a need to stage a formal starting point for the UFO age. Many commentators look at Kenneth Arnold's 1947 sighting as a convenient

location for this crucial point of origin, for it was this moment that the modern concept of flying alien objects swept across the World and

through a generation. Perhaps some look at the 1947 Roswell incident as a possible beginning. There is also the Second World War 'Foo Fighters' to consider as the birth place of the modern day UFO encounter. An even more tenuous connection that has

been surmised is the first atomic weapons tests or alternately the alleged radar invisibility tests known as the Philadelphia experiment in 1942. Perhaps we have been too altogether quick to set this date in the 1940s.

Contact with entities and unidentified objects now made familiar by modern contemporary reports were already apparent by the 1930s. Although these events did not match the scale of the worldwide UFO waves of the 1950s; we must remember there was no means to recognise and categorise these objects as UFOs which were wholly absent to public knowledge at the time. This widespread failure of recognition plus the maelstrom of the Second World War may well have depleted the surviving total number of reports we have to assess this era. A number of recent photos and articles collected by FSR re-enforce a modern recognisable form of UFO encounter existing by the 1930s. We will take a whistlestop tour of 1930s world signing reports.

Humanoids in Andhra Pradesh, India March 1931 Time: morning

A 14-year old boy looking after his cattle which was near a mountain noticed a "sage" (humanoid?) doing meditation under a tree...the young witness gave respects to him and asked nim from which place did he come from, the sage then pointed at the sky and said from the distant stars...the sage asked to follow him so the boy followed him to the top of the mountain and there he saw a large "Vimanas" (disc-shaped craft). The sage then asked him to come inside, the young witness went inside and was astonished to see many other sages" inside all in deep meditation. He was asked to sit on a golden chair, and he was offered some fruits to eat...the sage later asked the witness if he knew where he was, the boy replied "inside your Vimanas" he then asked the sage to allow him to look around and he went inside several rooms inside made out of what appeared to be pure gold but they looked different...he could not understand anything inside and could only analyze its beauty. The sage then asked the young boy to look at a "strange mirror" like thing hanging over the wall. The mirror began showing different images, including the Hindu Gods, later he saw an image of his own village and his house and all the people in his village and was really amazed to see an image of himself and his family on the "mirror". The sage then told the young boy that on the "mirror" he could also see images of the past and present, excited he asked to see his future which he did but never talked about it. He was then told

Comments: Unfortunately there is no description given of the so-called "sages" but I imagined these were similar to human looking Hindus.





Wilfred. The two were suddenly astounded to see a "bright blue light" drop straight down from the sky. It became larger as it did so and they were able to observe the source of the light as an object that Leonard described as "two saucers" open ends facing each other, glowing bright blue. The object then moved "dead straight" horizontally across the sky. When it just appeared to clear the flagpole on the roof of the City Hall it came to an almost dead stop and Leonard clicked the shutter on the camera. The object then shot straight back up into the sky. "They had never seen anything fly so fast!" This scared them to death and they ran from the scene. The object made no sound. Leonard's daughter. Debra DeCamillis who still lives in the Vancouver Lower Mainland area related this account to us. She remarked how vivid and excited her father sounded each time he described the sighting. Leonard Lamoureux passed away in 1992 and his brother Wilfred in 1955. Misfortune has it that the negative is no longer around as some UFO researchers have suggested that this image is nothing but a watermark defect that appeared during the development of the print. Debra has this to add regarding this assertion: "I know for fact there was no bubbles on the film, or watermarks because I was fascinated by negatives as a child and saw that negative many times. On the rest of the pictures there was nothing but pictures of lights, so I know it had no bubbles or watermarks on it." Deborah provided the following additional details: "The camera was on a tri-pod of sorts because Dad was trying to take sequential shots of the courthouse to capture all the lights. But he was not using a timed exposure; his camera was not sophisticated enough. He did say that he could actually see the bubble or tail as he called it that the object was encapsulated in."

A Small Humanoid in Avignon 1930.

Frank Teyssier. Lumieres dans la Nuit. Nov 2004. FSR Translations.

I am going to tell you a story that my dad has only just told me. He has never said anything before as he thought my main hobby was astronomy. In 1930, when he was ten years old, he lived in a house with quite a big garden with two big sheds at the end. My grandfather used to work as a railwayman in Avignon, he was part of a special team to deal derailment. My grandmother used to be very concerned with regard to what was going on in our hen house between 23.00 and

midnight, but that never disturbed my grandfather's sleep! "You've miscounted your hens," he would say and smiled every time one used to disappear. A strange thing coming into the farmyard could only be considered a hallucination. She did not dare speak of it to anyone as she thought they would make fun of her. Never the less she saw the thing three times. It walked over the fence coming from the disused seminary which is next to the garden in the East. It went slowly toward the hen house. It's size? The same as a small human. Its clothes? Dark just like it's face and his head. Some characteristics? Too hard to see. That night my Grandfather was again gone to Livron where there was a big train crash. My grandmother asked her brother in law to come and watch over her with his gun. Although very young my dad was also on watch. It was nearly midnight. There it was: a beast, but what beast? A man? He went on all fours, like a monkey, stood up, stopped and lifted his head to look towards the windows. My uncle hit the frame of the window with the butt of his gun. The thing heard the noise. It kneeled down for a long time behind a wheelbarrow, then walked again weirdly. As it reached the henhouse it unbolted the door, moved inside, got a hen (which did not cluck) and closed the door again very gently. My uncle pushed the shutters and fired twice. A dreadful scream! Is it a man? A beast? My uncle thought it was a monkey trained to steal though my father did not believe this. We will never know. Still the thing did not drop the stolen hen. The next day we walked up to the fence. There seemed to be bloodstains. Did they come from the hen? My dad kept his story secret for 74 years. He is amazed that similar stories have been told worldwide. The question remains; the monster did not have the need to go and steal when it could easily find hens, duck, geese and pigs at the seminary next door. Sometime later one of two goats belonging to his neighbours had its throat slit.

The Italian magazine Illustrazione del Popolo reported a flying object in 1935 over Addis Ababa in Ethiopia. (Taken from UFO Notiziarlo April 2005).

Halandri, Athens, Greece Summer 1936 noon

Maria K, 12, was playing with 5-6 other children in an area that was then sparsely populated. As they played the area was suddenly filled with clouds of dust. They stopped playing and looked at the direction from which the clouds had come from. There, they saw a large egg-shaped silvery object, slightly bigger than an airplane. It had landed on the ground on small legs, 100-150 meters away. They did not see any open door on the object, but on the ground under the object, there was a small humanoid wearing a white outfit and a broad belt, with small lights. The creature had long white hair and turned to their direction for a while. After that, it waved its hand like a salute. Suddenly it disappeared. A loud hiss was heard and

the object took off vertically between clouds of dust. It rose into the sky until it was gone. The children were shocked and were not in the mood to continue their game until their parents called them for lunch. The parents did not believe them. Source: Makis Podotas, UFO Greek File

He had a helmet on his head, resembling that of an ancient Russian warrior (?). The helmet had a cone-shaped "bulb" shaped protrusion on top. His face was visible, reddish in color and was wearing something resembling a transparent visor. The entity spent approximately 1 minute with the witness. He opened his visor, produced a protracted smile at the girl, looked around, and touched the grass---he carried an oval device in his hands. After that, he waved his hands, and zoomed soundlessly up into the sky at high speed. After gaining an altitude of about 100 meters, he seemed to compress into a ball and dissolve into thin air. Near Moscow, Russia 1938

A huge unidentified "aircraft" appeared near the Soviet capital causing panic among the military command. Thinking that it was a foreign hostile airplane or a spy balloon or dirigible, the local military authorities became alarmed and scrambled several armed I-16 aircraft with clear orders to force the UFO to land or to shoot it down. After the interception failed, the aircraft opened fire. Immediately after that the UFO approached one of the aircrafts and then both aircraft and UFO suddenly vanished from the clear blue sky in front of astounded witnesses on the ground. The remains of the aircraft and the pilot were never found---they were apparently abducted by the UFO. A similar event reportedly occurred in 1954. Source: Egveniy Valmer, retired officer in "Fourth Dimension and NLO"

Experimental superimental super

Near Chashniki, Belarus 1937 1100 am.

7-year old Ludmila Chepik was shepherding some cows and collecting flowers on a meadow near the River Uloy when suddenly she saw a "man" descending from the sky towards her without a parachute. He descended to about 1 to 2 meters from her. The man was approximately 113cm in height (dwarf like), of athletic built, with broad shoulders and a disproportionately large head. He had a narrow waist, and something like heavy boots starting at the knees, like wide trousers, red in color. The man wore dark tight-fitting clothing.

UFOs of the Spanish Civil War

Although much has been written about pre-1947 UFOs in the United States, our knowledge of "predawn" viology in other parts of the world remains sketchy at best. Long-time INEXPLICATA reporter Javier García Blaicotries sets the record straight with an article concerning JFO activity during this bloody and divisive period in Spair's history. Ten years would have to pass before the so-called modern age" of UFOs would kick off in 1947 with Kenneth Artiold's famous sighting. However, strange flying objects and their crews were already ploughing across our skies, even as Spain was embroiled in a civil war. Nationalist and Republican soldiers at the front must have wondered what those unidentified flying objects might be.

"Kenneth Arnold did not describe the objects he saw as "flying saucers", rather he said that the artifacts he had seen moved like saucers skipping off the water's surface." It was the press that came up with the equivocal designation. Curiously, from that moment onward, witnesses described objects resembling flying saucers." this is one of the arguments wielded by pseudo sceptics to deny the reality of the UFO phenomenon. To them, the UFO "myth" was born from a journalistic error. However, the truth is quite different. The "champions" of rationalism forget (whether intentionally or not) that much before Arnold saw those boomerang-shaped objects (for this was the actual description given of the objects), hundreds, if not thousands, of witnesses around the world had already described disk-shaped unidentified flying objects. Spain was no exception.

Researchers have gleaned a wealth of accounts which make

mention of this type of object, since at the start of the century, when no one spoke of flying saucers and much less of UFOs. In fact, some ten years prior to the start of the modern UFO age and Arnold's sighting, Spain was fighting its Civil War. It need not be said that the generation, which was forced to live through that fratricidal conflict, was not much given to imagining little green Martians. There were other more pressing concerns to worry about, but nevertheless, our files include several cases in which a variety of witnesses had face-to-face encounters with the phenomenon.

Like a Mexican Hat

The sun had already risen and the soldiers whose battalion defended the Peñón de la Mata position (to the north of the Province of Granada) on February 5, 1938 endured the cold as best they could. They guarded their position carefully under perfectly cloudless skies and our witness--a fighter with the 76th Brigade--suddenly became aware of the presence of something abnormal in the skies over Granada.

Located at a considerable distance, and at an altitude of 200 meters, the soldier saw an object resembling "a Mexican hat" the colour of flat aluminium. The sun's rays, reflecting off its surface, enabled him to see that it was a metallic device. It flew slowly as it approached the witness's position. It was then that he was able to observe it with greater detail: "Seen from below, its shape was exactly that of a cartwheel. In its centre, from where the spokes emerged, it had what looked like a photo camera lens and gave a sensation of depth." When the object approached even closer, passing almost directly overhead,

the soldier was even able to make out some curved black windows, which, appeared on the side of the remarkable "Mexican hat". The following is a transcript of an interview with the ABC Andalucía newspaper:

Interviewer. Did the object leave a wake in its path or

anything similar?

Witness. Well, yes. It gave out a sort of vapour from its

sides and gave the overall impression of having a small tail. I can't tell you exactly where it was coming from, but as it came out it formed what I

already said: a little tail.

Interviewer. Was its trajectory always straight or did it make

any kind of turn?

Witness. It made a slight skip as it moved away, similar to

a pulse.

From that moment onward, he stopped looking at it, since the pressing reality was not conducive to distraction. For this reason he was unable to see how the object vanished, perhaps, over the horizon.

Interviewer Could you describe for us, as precisely as possible, what the object looked like?

Witness. Overall it look

Overall it looked like a Mexican hat, as I've told you, but with the detail that its ends formed straight angles. Afterward, as it approached and passed almost directly overhead, I was able to see that it had small windows and was completely round. It gyrated in a counterclockwise motion. At first I thought it was a truck tire that had exploded, but "that thing" seemed to have a life of its own, aside from the fact that had it been a truck tire, we would have seen it fall. Its diameter would have been

approximately three meters.

Interviewer Which way did it go? Witness. From north to south.

Thus ends the soldier's description. The eyewitness, who chose to remain anonymous, wound up losing a leg three days after the sighting. Many years later he became a painter, and would sign a sworn statement attesting that what he had described was completely true. But what exactly was it that those astonished fighters saw, a military prototype in Spain in the 1930's? Let's see what J.J. Benítez has to say about military aviation during the Civil War in his book La Punta del Iceberg:

"In 1936, the Spanish Air Force was small and antiquated. The main fighter aircraft was the Nieuport NID 52 hemi-plane, of which it had 40 left. The aircraft with the largest number of operating units was the Breguet, a twin-engine biplane for reconnaissance and bombing operations (60 units). Germany's earliest aid took the shape of 20 Junkers aircraft. Shortly after, other Italian, German, Russian, French, American, Dutch, British and Czech vehicles would arrive."

However, despite the material aid from other countries and received by the various combatants, neither of these airplanes met the characteristics described by the eyewitness. A circular aircraft in 1938 Spain? While it is true that the Germans did design and build a number of circular wing aircraft, these vehicles did not come about until the Second World War, and could not very well have been flying over Spanish skies. [Anyone interested in man-made UFOs can consult the book Los expedientes secretos del CESID, written by our colleague Manuel Carballal].

Humanoids at the Guadalajara Front

Only five months after the sighting over Granada, other military men would become witnesses this time in the city of Guadalajara, of no less a remarkable event. It was half past eleven o'clock on the evening of July 25, 1938. The witnesses (a lieutenant and his aide) were descending down a gully located in the town of La Alcarria. Suddenly, a powerful white light drew their attention. Shortly after the light was extinguished, a disk-shaped object some 11 meters long and 5 meters high appeared before their eyes.

The disk, which was some 60 meters away from them, appeared to be suspended at some two meters over the ground. The witnesses described it as: "two plates joined on their convex sides, separated by a line or section of a darker color." Furthermore, the object's lower section had a sort of column, which descended very slowly and appeared to contain two humanoid figures. Next, the object began projecting a circle of bluish light on the ground. When the circle of light reached the military men, they felt a sensation of cold. Shortly afterward, the light turned off and the column rose in complete silence, all of this accompanied by colored sparks emanating from the object.

At the time, the onlookers believe they saw "the two halves" of the object begin to rotate, each in an opposite direction from the other. The disk began to project a powerful white glow and rose into the air with great speed, vanishing into the heavens. As with the Granada case, there is no apparent explanation for the sighting. In spite of the fact that both military men believed that they had witnessed a German prototype or something belonging to the "reds", we have already explained that this was materially impossible. The main witnessed (the lieutenant) rejected any publicity regarding the subject and insisted upon remaining anonymous to our colleague Manuel Carballal. Having eliminated the possibility of fraud, what is left? We can only accept that the UFO phenomenon was widespread in Spain in 1938.

UFO Landing in Avila

It was Juanjo Benítez who brought this case to light in his book La Punta del Iceberg. The eyewitness, Mariano Melgar, who was a 7 year-old boy at the time, had been sent by his parents to the town of Muñizo to safeguard him from the horrors and perils of the war. It was the summer of 1938, and one morning, while the boy tended to the cattle, the incredible event occurred.

"I looked after some of my relatives cows at the time, and on that hot summer morning, at around twelve o'clock, I left town toward a rural area located some 2 or 3 kilometres from Muñizo. I reached the little forest and sat down among the trees while the cows ate in a nearby field. It was then that I heard a buzzing sound that almost pierced my eardrums. I looked up to the sky and saw a flash of light amid the blue. Suddenly I became aware that it was a circular device that fired off flashes like silver. It came down not far from the copse's edge and touched ground. I took shelter behind one of the trees and spied its movements."

It was then that Melgar closely observed a circular object measuring some 15 to 20 meters in diameter and which featured a sort of cupe a on its uppet half. Several legs which supported the object could be seen in its under-section and dozens of colored lights went on and off on the "ship's" fuselage. Suddenly, a door opened on the structure and after lowering a ramp, three "men" emerged: "Only a few seconds had gone by when I saw a "man" appear through the door. A second one, and then a third followed him. But while the first two walked along the ramp and moved some five or ten meters away from the craft, the third, which was slightly shorter than the others, remained at the doorway. The first two men almost reached the top of the door, and I figure that the door was some two meters tall and another two wide. The fact is that the

first two began collecting something; I couldn't tell you if it was plants or soil. One of them kneeled, of that I'm sure. They had something in their hands perhaps it was a bag. I tried to approach the strange pilots, but I hadn't walked more than five meters when the one standing at the doorway fired a flash at me that almost landed me on my back. That scared me, so I went back to the trees." After Mariano made a second attempt to approach, and received a similar discouragement, the "men", who seemed to be moving in slow-motion, returned to the vehicle. One of them made the unusual gesture of raising a hand as if waving to the youngster. "From there I was able to see the object taking off. First the ramp went back in and the door closed next. Then, within seconds, the device rose some 50 to 100 meters into the air, spinning on its own axis, and many colored lights could be seen. It then went away toward Barco de Avila." This ends the boy's tale. He had remained in absolute silence about his unusual experience for forty years, until Benítez's fortuitous interview. As with the earlier cases, the child then identified the crewmen and their aircraft as "one of General Franco's aircraft." However, he himself acknowledged years later: "Today I know that "thing" couldn't have been related to our war in any way."

Epilogue for a War

The Spanish Civil War came to an end in March 1939, when Nationalist troops reached Madrid. However, UFO activity continued, apparently oblivious to the conflict's progress. In

May 1939, some residents of the Horcajada farmstead were startled by the unexpected arrival of a humanoid entity with metal legs, who was seen on a number of occasions. One of the witnesses, Adelaida Rubio, claims that the entity, whose appearances were always prefaced by a powerful flash, had the aspect of a "strange soldier", moving clumsily along with large strides. Two months later, on July 1, 1939, several children who looked after cattle in Zahara de los Atunes (Cádiz) witnessed a flying object eighteen meters in diameter. When the UFO flew over their heads at low altitude, they felt a sensation of extreme heat. The object landed with a whistling sound some 30 meters away, kicking up a dust storm. A door emerged on the object's side and two beings emerged from within, one of them tall, and the other short and squat bearing a sort of flashlight which was able to illuminate the surroundings despite the fact that it was noon. After walking some twenty paces away from the UFO, the beings turned around and re-entered the craft. The strange encounter lasted 15 minutes. While Spain tried to rebuild after the horrors of the war, sightings and landings continued to occur all over the country. Cases earlier than 1947 (the start of the UFO "myth" for our illustrious pseudo-skeptics) in Spain number in the dozens. Who knows how many cases may have never been disclosed, remaining locked forever in their protagonist's memories? One way or another, these case which predate Arnold's show that UFOs were already crossing our skies when the words "flying saucer" had not yet been uttered.

Further thoughts on my abduction in Shropshire Peter E.

In issue 50/4 I described the after effects of my abduction in 1984. The appearance on my wrists of red bracelet marks. There was also a similar band mark on my genitals. There were rashes on my face and chest. Some of my body bair fell out including my eyelasms. I became ultra sensitive to noise and vibration, I heard buzzing in my ears I felt requent nausea and sickness and my pupils constricted. (FSR Comment, Peters symptoms now appear similar to someone who has a deficiency of stimulating hormones (gonadotrophins), or damaged receptors for the release of testosterone. He suffered testicular and genital atrophy in the following months; this led a sexual encounter with a mysterious temate rigure that may well be connected with the initial abduction).

Six months after my abduction I encountered a woman who seemed very interested in my experience. This was odd as I had told no-one but my therapist at the time. Zoyra was a stunningly beautiful young woman, often dressed exotically in red or black. She was bark and syelte. She announced over the prione that she had spoken to my ex-partner (who I had left following my abduction injuries) citing that she had put her on to me and she was offering to be helpful. It turned out that my ex-partner had nothing to do with it—this mystery woman had contacted me truly out of the blue and created this false cover story to regisimise her in my

Zoyra wanted to know all about me, she seemed to already know my symptoms and story without my telling her. I met her several times, often not by arrangement but through odd accidents. Each time I found myself being burnoad for information. I did not think at that time that this had so be deep connected significance with my abduction, rather she was being prurient. It azzled me that she could have an inkling; how could she know? I didn't advertise my mistoriume.

Zoyra seemed unusually keen that we embark on a romance, something I had mixed feelings

about. Why such an interest in someone she had only just got to know, was it because of a presume deliberacy in... What astonished me was that she was seemingly knowledgeable about my abduction. Gerience even before I had said anything, she didn't hide the fact that she was almost anticipating my story as I related it; she agreed that my post-abduction impotence did relate to the incident. She told me she could fix it and we would meet again. Despite weeks of her 'therapy' there was no improvement, in fact quite the reverse. Once more she suddenly disappeared from my life.

One final note, while at the original guesthouse in Shropshire another guest, a young man called George seemed to know from the clues of my disorientation and missing time, things that might easily be clues for someone in the know; I had suffered an alien abduction. The hinted that he had a similar experience to mine. When I met him six months later he asked me if I had any long rasting effects? From what? I asked him, unwilling to engage him on this topic further. He was sure I'd had the same experience as him. He hinted that he too had suffered impotence; he told me his life had been ruined. He was clearly annoyed when I made no reciprocal confession.

In conclusion, I feel uneasy about the idea of repeated exposures to this kind of experience as if 'chosen.' I certainly don't feel chosen in any way except at being in a particular place at a particular time. I am convinced that impotence may be a post abduction after effect for those ,males who have undergone similar abductions to myseli.

FSR Comment; this case raises disturbing questions about the true state of alien-human experimentation. The witness has a definite sense that his entire life experience since abduction has been tainted by a deliberate campaign of manipulation by the perpetrators. If the boundaries of secrecy were ever to come down on alien-humanoid, sexual relationships with humans, forbidden liaisons of this kind and other far more alarming protectics would be roruncoming.
