biophysical mechanism is presently known that could be responsible for the observed correlations between EEGs of two separated subjects." Similarly, scientists at the University of Milan conclude that "experimental data seem to strongly suggest that biological systems present non-local properties not explainable by classical modes."

Significantly. Thaheld argues that individuals may be bombarded daily by extraterrestrial communications but filter this out: "most of the non-local communications is probably lost within the normal brain wave or EEG noise, otherwise we would be incapable of functioning normally and would overload when confronted with such an influx of data. He proposes a series of experiments involving human subjects to test for possible extraterrestrial communications occurring in the subjects' brain which occurs without their awareness.

In conclusion, the implications of Thaheld's study are enormous for those advocating empirical methods for the Search for Extraterrestrial Intelligence. His study suggests individuals can receive within their brains, frequencies that are very likely used by extraterrestrials for communication purposes. While most individuals fifter these out in order to function normally, it is very possible to access and interpret these brain frequencies. This makes it feasible for individuals

to be trained to access these frequency bands in ways that makes communication with extraterrestrial intelligences possible. This would enable the development of a scientific protocol for "Controlled Superluminal Communications." There is also the possibility that such ability may develop spontaneously as claimed by a growing number of individuals who claim to be in regular telepathic communication with extraterrestrials. Telepathy is widely disparaged by researchers in the SETI community and ridiculed by scientists and society in general. Thaheld's study suggests the inadvisability of such a dismissive attitude due to the quantum entanglement that exists between biological organisms throughout the universe and the non-local influences that are occurring. The scientific data and theory presented by Thaheld points to one or more forms of telepathy as a feasible form of communication. Most importantly, Thaheld opens the door to a hitherto unrecognized form of communication with advanced extraterrestrial intelligence being tested and developed through appropriate empirical methods and scientific protocols. A review of the ideas of the Late Walter Buhler on alien to human telepathic communication.




Brazilian lawyer Jonil Feydit Vieira

The following thought provoking quote was described by a Brazilian lawyer who encountered a brightly lit object intent on repeatedly signalling to him on the road to Miguel Pereira in the state of Rio de Janeiro on the night of August 3rd 1967:

At one time I had the intuitive feeling that someone was trying to communicate with us, the same thing happened to the driver. I felt an intense headache localised between my eyes, and a thought which was not mine asked "How will this vision before you be received?" I don't quite know how to explain the sensation, but I am certain that I was

not asked the question in words. Perhaps it was a telepathic contact? As if to get away from the thought or perhaps to respond to the question, I said to the driver that I believed in the existence of beings from other planets because, by logic, if there are planets older than ours, then it would be quite probable that other forms of life exist on them. And that if by chance a flying saucer appeared, 1 should. provided that my physical well being was respected, like to get a better look at it, especially from the side view, but that I didn't know whether I would have the courage to meet one face to



face. In fact I said I didn't know what my reactions would be.

Again the driver flicked his headlamps at the UFO and it responded by flashing back yellow and blue lights, at the end of a 40 minute long pursuit by a UFO, what seemed to be a 10 metre wide blue dome touched down, floating one metre above ground. Pereira curled up in his seat and began praying, by his fourth Lord's Prayer the object blinked out.

Commentary by FSR: What is apparent is this case, is the telepathic invitation which led to an open approach by a 'curious' UFO craft was halted by fear. This was not the usual case of alien abduction or kidnap but the curious prospect of a voluntary meeting with another sentient humanoid species. Is the human consent to be open to their invitation all important; a conscious or sub-conscious mental brainwave or observed behaviour, is this kind of person who says mentally 'yes' the kind they choose to telepathically link with?

The most commonly reported experiences of alien communication are the many incidents of telepathy associated with encounters, which seems to have been the chosen medium of contact from the very beginning. Perhaps the flashes of telepathy input the necessary new centres of meaning into our consciousness, upgrading the human hardware needed to bridge the development gap between us and them. Telepathy often seems to leave latent effects that may indicate facilitated growth of new connections in our brains. For example, after an encounter at the North London Suburb of Wood Green on August 15th 1966, a witness: Mr Palmer is described in his case notes by Gordon Creighton in the following way: "Mr Palmer firmly maintains that his experience has had some kind of permanent effect upon him and has changed his personality. He seems to feel that there has been an enlargement of his consciousness."

However one should bear in mind that a number of the stronger telepathic contacts resulted in partial destruction of the core personality of the witness leading to mental aberrations and personality disorders. Here are two cases that give us insight into the lives of people who have been subjected to strong telepathic contact by alien beings.
