

RESEARCHING “NORDIC-TYPE” ALIEN EXPERIENCER CASES. © BY DON WORLEY (Indiana, USA), FSR CONSULTANT. (1051 Beech Street, Connersville, IN 47331, USA.)

What can we learn from these kinds of cases? What do they reveal about the moral orientation of these entities who are such a vital element in the alien presence. Can they be Angels or can they be just cunning deceivers? Members of opposing groups? All one vast centrally directed conglomeration? These questions are of the upmost gravity for our human species.

For the last 35 years I have specialised, for the most part, in alien human abduction and the Nordic-type aliens. My conclusions will be based on 45 of my cases where the Nordics were involved. In my 71 other cases the Nordics may have been involved but the information was not forthcoming. My conclusions are also based on other cases that I have heard about elsewhere. Due to space limitations I can highlight only important features in the nine cases that I have chosen.

At this point I will describe a Nordic, and this description will apply to all the abductees in the cases I will discuss. These beautiful, tall, entities with angular faces, usually have long blond hair, and breath-taking, unfathomable blue eyes. This is not an absolute, for the eyes can change with emotion. Giant-sized and human-sized Nordics also exist. Females and a rare child have been seen. The beings wear skin-tight garments or beautiful white robes. Their telepathic communications are soothing and they project an intense feeling of love for the abductee. Some persons have remained in a euphoric state for weeks afterward. Let's now look at the cases I have chosen.

Case #144, Virginia State, USA.

Roberto, a successful aeronautical parts dealer, once kidded his lifetime Nordic mentor, whom he calls Thor, about why he, a dark-skinned, dark-haired Brazilian, also has such bright blue eyes. The entity has intense blue eyes, a predominant feature of the Nordics. So much of this “blue eyes business” makes me wonder about gene manipulation.

As a baby Roberto* often played with little rust-coloured beings on the farm in Brazil. Once in the USA it became an assortment of the Grey types, whom he disliked. At the age of 17 Thor appeared, and would always be present along with a beautiful red-headed woman for the rest of Roberto's life. For years Roberto never had a clue about what was happening and sought to escape by moving often.

Once he was taken to a subterranean place, along with over 50 other persons, and shown scenes of massive wave destruction. On another occasion I got him to ask Thor just when all this was going to happen. The reply was, “Only the Creator knows the time.” Sometimes in his life when Roberto is fearful Thor will come into his

mind and reassure him that all is well.

Roberto has had so many periods of lost time that he has lost count. His underclothing is often on wrong, and he has three used shirts in which he has come back and which were never his. Recently his penis suffered minor damage, and a black limo began to park on his quiet street. This was all too much for his wife, and she destroyed his answers to my questionnaire.

Case #99. James Gilliland, The Bridgehouse, 356 Little Mountain Road, Trout Lake, WA. 98650, USA.

Jim has established a retreat in the scenic splendor of Washington State near Mount Adams. He remembers two abductions, and is a frequent channelling source for his Nordic mentor named Cazekiel. A week ago a film company in Studio City, California, called me wanting some good abductee prospects for a show they will produce.

Jim is one of the eight persons that I proposed for them. He called me on March 16th of this year and informed me that things have really got busy at his site. The alien craft have become quite bold, performing aerial manoeuvres overhead and hovering close. These events were witnessed by groups of people, and some good photos have been obtained. The Hollywood company wants to get a film crew to the site. Knowing how things have been on other film events, I hope the aeroforms don't now become shy!

Jim says, “I have been working with the Nordic race which in truth comes from Orion and the Pleiades. It comes with the territory when you awaken spiritually. Many people believe themselves to be working with 'Angelic Guides' or 'Ascended Masters', when in truth it is with *these* spiritually and technologically advanced beings. Most of my work is done with the Andromedans as they are known throughout the Universe. They have magnetized bodies of light, are beautiful, and stand eight feet tall. My contacts with these groups have been a blessing. The Greys give me a headache, and I push them out of my consciousness. *There are others who seem Nordic but do not have Earth's highest and best good in mind. They are remnants of the Jehovah energy, but they are being turned around or removed by higher forces.*”

Case #110. Rural State of Missouri, USA.

Diane* has had a lifetime of alien activity. Here is her description of one meeting with a Nordic. “As I lay listening to grandma's TV in the front room, a very tall being appeared at the foot of my elevated bed. He was a male, had long blond hair, and wore a long white gown tied at the waist. I don't remember the features of his face except that I thought he was beautiful. *He also had*

white wings on his back that went from the top of his head to his feet. As he started to fade I asked him his name. He said his name was Michael the Archangel. I didn't know then what an angel was. I ran to grandma and told her but she thought I was dreaming."

"I am very tense as I try to describe a later meeting, in my life, with a Nordic. With the Greys, it's pretty cut-and-dried — routine, I guess. The Nordic experiences seem to be more of a psychological test, and emotions are high. I never know when he is going to enter my life or what the stage setting will be. In every meeting with him I am made to feel emotions of the highest intensity that a human can feel, whether fear, love, hate etc. This time it was love for him, and a sexual desire that went beyond anything on earth. I am purposefully blocking out a lot of it, for I now feel sadness and much guilt. I cheated on my husband. It is difficult to explain the sex that I had with the Nordic, for it seemed to be "other-dimensional". I was at his place, and I remember the outside walls were glass. The sex far far beyond anything we can do on this earth plane. The orgasms were constant, fast, furious, and savage. I remember looking up once at his beautiful face. God! I could have consumed him!"

One time, at a family picnic, Diane was sent to get the salt they had left in the house. *When she returned, the feast was long since over; no one noticed their saltless meal or the over two hours of missing time.*

On another occasion a fairy circle remained in the yard after Diane had been taken. She and the other kids walked in the circle and thought the "tingly" feeling in their legs was great fun. This reminds me of case No. #116, just next door in Rush County, last week. The abductee walked in the 18ft. circle and then entered the house. The ceiling-light immediately blew to smithereens.

Case #53. Ontario, Canada.

Penny has a degree in Philosophy. For years she wondered about her strange life, and then things began to fall into place. Her interactions with both the serene Nordics and several types of Greys are very extensive. The Greys were fast-moving workers. The blond Nordics seem to be aloof supervisors, who could speak English, but chose not to. Penny's son and daughter were also involved in some of this with the two types, and closer bonding came about. One little Grey sat on Penny's lap, for it wanted to learn about human affection and cuddling. On one occasion, in an altered state, Penny found herself in a sexual union with one special Nordic. *Penny was also shown scenes of coming destruction that had vivid geographic details. Having no knowledge of such things, she was unnerved by it all. She was also told that the Nordics and others like her would be present at the dimensional place to help the millions of souls displaced by these coming Earth changes.*

Case #89. Western Canada.

The most high Reverend** occupies a position near the top of a large religious group that extends over parts of Canada and the northern European countries. (Their sacred tenets are similar to those of the Amish.) His lifetime of interaction with those who he calls the "non-

terraneans" is mind-boggling. Many of his brethren know of the Nordics too. As a child he sat in the lap of his mentor whom he calls "Gold". Gold's eyes have a golden sheen. The Reverend has been naked alongside one who was also *naked and he was — um, coupled to this one.*

On one momentous daylight occasion at one of their religious ceremonies in a remote fastness "Gold" and some of his buddies materialized, partook of the bread and wine, and then vanished in "wavy air" just as they had arrived. This was seen by several hundred people and by a pack of animals. Throughout his life the "Reverend" has suffered damage in his groin region from abduction, but, all in all, his Nordic friends (who chose him when a baby in Europe) have kept a protective watch over him. He has a number of university degrees and is a brilliant man.

I spent most of three summer months several years ago documenting his case. The "Reverend" insists that the Nordics do breathe, and do have a bathroom. When they were not sucking fluids out of him with tubes he says he has been to their bathroom. He describes it as "like an Asian toilet with suction to it."

Case #91. New Hampshire State, USA.

Cheryl's* nocturnal life with the blonds started when she was very young. She thought they were her "other-time family". *Both the Nordics and the Greys have told her that she is really "them in human form".* She is also acquainted with slightly shorter beings who look like Nordics, with the same aura and strange eye colours, but dark-headed. There is nothing like so much closeness with them, and they work more with the Greys. Two names come up often when she is talking to other abductees about the Nordics. These are the names "Malanie and Christance", and she wonders why. Like the "Reverend" she has been in a toilet during abduction. Without knowing what the "Reverend" has said, she also describes it as "like an Asian toilet,"

She has also been shown scenes of coming destruction. The upper East Coast of the USA will almost be beach front right up to the White Mountains, in Maine (44 degrees 15N, 71 15W, GC.)

But this does not mean that it will be trashed forever like the western USA coast. The farther down the east coast you go the worse the changes will be. Across the Atlantic, a large part of Europe will be changed. The UK will become much larger, and the Mediterranean will be only a puddle.

Case #31. Kansas State, USA.

For Donna Butts it all began on her parents' farm in Kansas. On a hot evening in July 1950, at 2.10 a.m., brilliant light bathed the farm in a fluorescent glow. UFOs were present. Soon a glowing human-like figure appeared from behind the barn, and told Donna's mother that in one year she would have a child that would be what he called a "prepared child". In November of 1980 a gigantic glowing UFO abducted Donna off route 170 in Kansas.

It was in 1984 that Donna began to see "the walking

wonder” near the laundromat she visited. He was gorgeous, with aquiline features, sky-blue eyes, silver-blond hair and a body any man would envy. He looked about 50 or 60 years old and drove a beautiful Rolls-Royce. He began to call Donna, and finally she got the name “Peter Lee Koney” from him. Filming and recording attempts failed. The mysterious stranger was right about that. When he was up to a block away from her Donna would get cold chills. Then came the day when he appeared as a sparkling white figure in a uniform, right in her front room. He looked solid enough, but she and others present could see through him before he faded away. Donna had suspected him of being some kind of a “nut”. but now she knew that he had to be from some place other than Earth. Thoroughly dismayed, she spent the afternoon shaking and smoking cigarettes.

“Peter” had urged her to receive his teachings and now she was ready to listen. In the next abduction she was taken to a huge awesome “throne-room” in a huge craft. With “Peter” in the lead, a number of things happened to her, including being given a light treatment, drinking a hauntingly beautiful blue liquid and getting an implant through the ear. Later Donna was privileged to see many things and learn much. *Her predictions as told to her by her benefactors are many. She says, “We can look at the Bible with the understanding of advanced intelligence. It has been termed a coded message unable to be understood until the last days. These are most assuredly THE last days.”*

Case #40. Colorado State, USA.

I want to mention this case that I carry in my records under the name of “Horse”* because of a remarkable thing that happened to this abductee. It is clear that this woman, who has a Law degree, is being looked after by the Nordics whom she experienced and of whom she can make such beautiful drawings. This happened when, on her horse, she was on a dangerous mountain trail. The horse failed to make a crucial turn, and stepped off the cliff-edge into space. The next thing she remembered was being back on the trail. When finally at the bottom she said, “Wow! I could have sworn that she stepped off the cliff!” The other two riders sat there staring open-mouthed at her. *All three had positively seen the horse step off the cliff.*

Before I finish my assessment of all this I want to add mention of a case*** that beloved researcher Karla Turner, now deceased, exchanged with me. This happened in my own home State of Indiana on a farm near Floyd’s Knob in the summer of 1954. A brilliant light-beam came through the ceiling of Nell’s bedroom and in it stood a blond-headed, blue-eyed figure in a resplendent robe. Taking Nell by the hand he said, “Do not be afraid my child. These are mine.” He indicated the little Greys standing around the room. He then said, “I am the light of the world.” The shaft of light returned and he rose through the ceiling with it. Nell and her sister went up next. During the time that the child was in the UFO she managed to ask the glorious figure an important question. She asked, “*Are you an angel?*” The entity replied, “*Yes, but not like you have been taught.*”

The next day a staff car, a jeep, an instrument van, and a loaded troop-carrier descended on the farm. The house, land, and inhabitants were thoroughly scrutinised. White-coated doctors gave Nell a shot that brought forth the secrets of her mind.

Are the Nordics “angels”? Let’s hope we don’t become lost in a maze of conflicting implications on this question.

1. *In cases 114,99,110,53, 89,91, 31, and 40 we have the Nordics in their mentor-protector role. All these people in these cases enjoy good lives, except for Penny, who has a liver disease that may take her out in less than 10 years. Of course all have had to endure the trials of criminal abduction. Even so I’ll count this sort of protective benevolence as a point in their favour as “angels”*

And, on second thoughts, since the Nordics could be engaged in some kind of human-species DNA saving action due to their frequent predictions of monstrous comings, maybe the term “criminal” ought not to be used to describe their abduction activities.

2. *The association of the Nordics with all the unsavoury alien crowd does not help their image as “angels.” I won’t list all the cases.*

3. *In cases 110,53, and 89 we have the human/Nordic sex-act in the out-of-the-body state. This, shall I say, is very “un-angel-like”! In cases 114 and 89 we have a male suffering sperm loss and temporary damage. Not exactly “angel-like”.*

4. *In cases 89, 96, and 50 we have the entity existing and performing tasks in our three dimensions. This makes you wonder how much of this could be going on. These ones clearly identified themselves, but what about all those others who seem just like us, and in what positions of power are they?*

5. *Their image is definitely helped in the cases where the entity had “wings” and claimed to be an angel, “but not like we have been taught.”*

6. *The great skill of the Nordics in deceiving humans, with “screen-memories”, “shape-shifting”, and what have you, is no help to their “angel” image.*

7. *In cases 99 and 54 we have specific claims that there are both benevolent and evil groups. Whatever they are, all this is the secret Government’s deepest secret. They certainly know immensely more about all this than I, and due to their fear of social chaos they never want you to know the truth.*

My abductee #108 Marie, an Afroamerican of partly Choctaw Indian ancestry, living in Louisiana, USA, is probably the most abducted, most “other dimensionally aware” person I have ever met. She says, “*because I can see and hear in spirit I am able to contact other worlds 24 hours a day. There are negative beings as well as positive ones that are very busy on Earth. People would be shocked if they knew how they are being influenced by forces they cannot see but that are around them.*” Recently Marie told me that three Elders (beings of light, white-robed in a magenta-coloured ray) and my own mentor, an Aztec/Nordic named X’t’lan, want me to meditate more so that they can give me more information and guidance. I am listening, but knowing the hazards

of twisted reality and illusion, I take a "wait-and-see" attitude. *I wish the Nordics were really angels but they are NOT.*

Sr. Miguel Calderón is the owner of an estate near Caguas in the Municipal area of Utuado (west-central part of the Island of Puerto Rico) - and it is to be noted that *Arecibo*, where the big Radio-Astronomical Observatory is, lies not far to the north of Utuado.

Sr. Calderón states that, one night in May or June of 1997, at about 8.30 - 9.00 p.m. he was driving his 1990 *Suzuki* jeep along the road from Mameyes in Utuado Municipal Area towards Caonillas when suddenly, at a distance of about 100

or 150 ft. ahead of him, he saw "two little boys" dressed in silver-coloured overalls, tight-fitting one-piece suits with turtle necks. They wore no helmets, and had very pale greyish-yellow skin and big black "Chinesey" eyes showing no pupils. The entities halted, and one of them raised an arm towards him. Instantly his engine cut out and his lights dimmed. His starter would not operate, his battery seemed dead. His radio had been playing, and that too was dead. His lights remained on, very faint.

Then the entity suddenly lowered its arm and both of



them totally silently shot straight up into the air and vanished into the night. His engine sprang into life again and, scared to death, he drove off at top speed.

And then came the reaction. First he began to weep violently, and then to vomit, and he was obliged to pull up for a while. He said that at no time had he glimpsed any craft or heard one.

As is reported in so many cases, Sr. Calderón said that throughout the experience he felt it totally impossible to take his eyes off the two beings, and something seemed
