Cur dear friend Ignatio:

Our <u>many</u> thanks for the recent series of clippings and articles from your files and colleagues; though apparently sent over a long period, they have all recently arrived within a few weeks of one another. For example, the letter dated 24 Nov 1978 arrived only last week -- so we're not as far behind in responding to you as you might have thought, Hope postal service gets better... 2-3 months is a long time to await exciting developments from the Spanish world.

Appreciate the letter from Fernand Lagarde about the Nancy SHC case; we had written to French authorities right after receiving word about the case from you, but to date no response has been received. Do you think it advisable to contact Lagarde or Dr. Krantz (whom he mentions in his Sept. 11 letter)? If so, a mailing address would be most helpful.

The "Pennsylvania Triangle" concept was a mention to our article on very strange series of UFOs in northcentral Pennsylvania — where huge ice deposits form only during the summer (Unbelievable Frigid Orifices) in shallow holes, which when located accurately on a map define a 24-square-mile triangle! Inside this Triangle (far better documented than the so-called Bermuda Triangle) occur more UFOs: the OVNI type, Unfathomable Flaming Objects (that is, case of SHO), Unidentified Flying Ornithoids (that is, thunderbirds of the type reported over Miami in the clip you sent us), etc. We thought we had sent you a copy of the article, but apparently didn't; therefore, you'll find that copy enclosed now.

Any comments/criticisms/speculation is welcomed! We think it a materialization/bleed-through

How to the transcribed interview."25 QUESTIONS ON VANGUARD UFOLOGY": We read it with great interest, agreeing with most points, disagreeing but not discounting a few others, and learning throughout.

However, at this moment the better UFO mags here with which we are familian and not printing much in the way of "interviews". The emphasis now -- especially with UFC REFORM, which we believe is the best (and best-paying) popular UFO mag in America -- is on case histories, with growing interest and consideration of paranormal events (whether or not they relate directly to ufology). One suggestion is to give them a story on Spanish or South American UFO incidents, an area little covered by U.S. press. (See enclosed article from the current issue as a typical example of what they'd like to purchase.) If you want to stick with points raised in the "Vanguard Ufology" transcript, we recommend elaboration upon these points: 1) why Aliens generally contact children (p 3), and give cases; 2) the "lot of different ways" in which Aliens are aiding us (p 4); 3) strategies and techniques Aliens use for contact (p 4), especially developing the intriguing 'anti-blanketing' concept; 4) impact of UFOs on technology, society and perhaps especially the economy (p 5, on arming against Aliens, is a novel approach); 5) expound on the "well-planned operations designed to set up waves of popular religiosity" [do you really believe the Marian Puppeteers were pro-

jected by Aliens, or might this aerial apparition have been a time-warp bleedthrough of an event magnified from another era? ; 6) concept of Aliens changing their "psychical variables" to fit "social and mental co-ordinates of different peoples at distinct stages of human evolution" is an important observation (p 7), one which could be developed into an important essay if a review were extended back to the Egyptians and MesoAmerindians; 7) consideration (p 8) that Aliens are "playacting" because they allow the selves to be observed in mundane activities is worthy of further development and philosophical speculation.

In addition to item # 6 above, we would encourage you to consider developing in detail these subjects touched briefly in the transcript: 1) an article on the "more than 21,000 apparitions on record in Spain alone" ala Fatima (for example, we are unfamiliar with the Marian Puppeteers) -- viewed either as Fortean phenomena, orras UFO-induced projections/hallucinations; 2) parallels of experience in the "Contact Syndrome" -- are there personality types, physical experiences/traits before or after contact that are common to contactees, etc., and how well do the contactees (especially Spanish-speaking ones, for example) perform as "the instruments of a complicated operation on an interplanetary scale"; 3) the messages and literature of the contactees -- on p 12 you list many individuals we don't know (so the same can be said for most Americans), and what they say/do on a case-bycase basis would be a valuable addition to English-language Ufology; 4) and focusing on item 3. the parallels and prophecies in the messages of the "Prophets of Doom" contactees, particularly relative to geodynamic cataclysms and the following New Age of harmony and enlightenment. Item 4 is of great interest to us, and your familiarity with many Spanish contactees is fertile territory for information new to us folks in North America! Also, UFO REPORT has been running several pieces on cataclysms. so a story that ties geologic catastrophe into UFOs/contactees would likely be given quick and positive consideration.

If the above comments interest you. you could send the manuscript(s) to us for review and forwarding or mail them directly to the editor who has been dealing with us recently: Thomas Steers, Associate Editor, UFO REPORT, Gambi Publication. 333 Johnson Avenue, Brooklyn. New York, USA 11206. A good manuscript length is 3000 words, for which payment is about \$325-350. They accepted a monster 6000-word article from us, but you stand a better chance with a story in the 2500-300 range. BE SURE TO KEEP A DUPLICATE OF WHATEVER YOU SENDII!

Running out of paper, and the postman comes soon. Hope the above suggestions stimulate your pen (and eventually your bankaccount). Always delighted to hear from you and your European/South American colleagues-in-the-Unknown. Remaining as always

ZetaTalk: Spontaneous Human Combustion



Humans tend to think of fire as occurring at a high temperature, as when the process is going full bore this is indeed the case. But what of the moment when combustion is first starting, when sunlight is warming chemicals or a match is being dragged across a surface? High temperatures are *not* required to start the combustion process, which is but a chemical process, though high temperatures most often result. Many chemical reactions give out heat, a byproduct in excess during the molecular rearrangement. Many combustion processes also occur in a finite or limited manner, and may go unnoticed. A limited combustion process is what keeps the human body at 98.6 degrees, for instance - a slow burn.

Oxygen is present in the blood due to the bellowing action of the lungs, and fats or sugars present from stores in the liver or as a result of digestion. The components for a fire hotter than 98.6 are therefore present, but are held in check only by the limited supply of oxygen. Damp a fire and its pace becomes controlled. Blow on a fire and it flares. The pace of a fire is determined by the availability of its ingredients, and for the slow burn that takes place in the human body, oxygen is one of those ingredients. What would occur, then, if a substitute for oxygen were to become available, along with a catalyst to start the process. Matches start a fire because the heat produced by friction acts as a catalyst for the chemical mix on the head of the match. Where heat is not required to start the chemical process known as combustion, oxygen or a similar ingredient is required to keep it going.

That said, what causes spontaneous human combustion, a rare but frightening occurrence.

Beyond what is normally present in the human body - oxygen in limited amounts and fuels - those who spontaneously ignite have inadvertently created their own cremation by fretting and eating, a combination that often occurs. If life feels out of control, then eat. Fat laden foods comfort the most, as comfort from banking against the cold of a long winter or lean times is built into the human animal. The more worry, the more chomping occurs, and under normal circumstances this simply results in obesity. However, worry causes the liver to flood the blood stream with a fine oil, readily lit, in case the body may need to take flight or fight. In some humans a rare genetic condition exists that allows the combustion of this fine oil to continue, unabated, when in combination with a type of adrenaline, the catalyst. The need for oxygen is *bypassed*, as a self-feeding chemical reaction starts where a byproduct of the catalyst- induced combustion incites combustion in neighboring areas, and the matter goes out of control.

These humans, ostensibly fat and even jolly, are invariably found alone in their cremated state. This was a source of their self induced anxiety, as they *chose* to live alone, yet feared being alone, being their own worst enemy on all fronts. Does the human suffer? They feel no pain, as they become unconscious early in the process. A warm feeling, and then all goes black, as the brain is the *first* to receive blood from the pumping heart and brain cells are delicate. The unconscious and rapidly dying body, heart and breathing stopped, progresses to an intense chemical reaction, without oxygen, that is fast, hot, and very limited. The surroundings rarely burn unless highly flammable, as it is over too quickly to heat the air or raise the temperature of flame resistant furniture to the level where combustion runs unabated. Before the advent of flame resistant furnishings, spontaneous human combustion was not recognized for what it is. A spark from the fireplace or perhaps murder were suspected, but all clues were destroyed in the fire.
