EDITORIAL: FÁTIMA -THE THIRD SECRET.

As FSR readers will have noticed, the Vatican has recently released what was described as the last part of the "Third Secret of Fátima", and consequently *all* of the message that remained to be given.

A NEW, UNIQUE SCIENTIFIC CONCEPT.

ORIGIN AND NATURE OF HIV/AIDS.

Infection with Human Immunodeficiency Virus (HIV) eventually results in the disease Acquired Immune Deficiency Syndrome (AIDS). AIDS is a brand new, entirely different, lethal human disease; nothing even remotely like it was known before 1979.

HIV replicates in and attacks cells of the human immune system, eventually allowing opportunistic infections which terminate in death (1 - 5). AIDS patients presenting with multiple opportunistic infections are considerably more difficult to treat than situations of disease due to infection by a single organism (3, 4).

For a previously unknown (because previously non-existent or harmless) virus to suddenly arise and cause major lethal pandemics, is contrary to all medical and natural experience (1).

There is excellent evidence that HIV infection was initiated on two different, widely separated continents, Africa and North America, at very close to the same time, in two different strains (1,2). The time frame of origination is reliably believed to be between 1910 and 1950 (see references 8 and 9).

The African strain is infective heterosexually, the American strain is infective homosexually (1- 3). Both strains are readily infective by blood transfer.

The origination of these two different viral strains, in two distant locations, at the same time, in two differently susceptible human populations, is entirely contrary to how natural infectious disease works (1,2).

HIV is a retrovirus, necessarily employing the enzyme RNA transcriptase in its replication. RNA transcriptase is notoriously prone to transcription errors, resulting in numerous viral mutations (sudden marked genetic changes) (4). Viral mutations can be expected to select for properties favouring viral survival, such as drug resistance and increased infectivity (4,5).

HIV replicates in and destroys primarily certain cells of the immune system, thereby weakening it over time. Eventually the weakened immune system allows multiple opportunistic infections (1,4).

Until opportunistic infections appear, *only* laboratory tests reveal infection with HIV during this asymptomatic period. Again, HIV infection can be determined *only* by laboratory testing, which commonly detects antibodies to the virus (5,6).

HIV's unusually long asymptomatic period averages roughly about 10 years; during this time the infected person may be quite unaware of the fact he/she is infected, and possibly spreading the infection.

When a pregnant woman is HIV infected, her infant is commonly infected during pregnancy and/or during passage through the birth canal, or by breast feeding. Effective treatment before and after birth can be helpful. An HIV infected untreated infant's death by AIDS usually occurs within a few years of birth. (1,2,3)

HIV's sexual spread promotes infection and death among people of the most active age range - in America AIDS is now the most common cause of death for males aged 25 to 44 (5).

It has been said that HIV is the ideal agent of mass human destruction; it is an ideal Biological Warfare (BW)

agent, in that it cannot be improved upon (6). If it were more infectious and rapidly lethal, like Ebola, infected persons would be readily identified and quarantined. Then its spread would be effectively halted (2).

With HIV however the spread continues unabated, simply because people don't know (and may not want to know) they have it, and are spreading it to people who don't know they are being infected. Some people may know they are spreading it but don't care (3).

In nature there is always some type of balance between parasitic organism and host. A parasite that kills all its hosts also perishes. No such balance exists between HIV and humans.

The body's major defence against viral infection is the immune system. HIV specifically attacks the immune system, the body's only defence against it.

Then, since HIV attacks the only defence against it, there is no natural defence against HIV (1 - 4), as there is with *every other* organism. **HIV acts contrary to nature. I suggest this is because it originated outside nature.**

The official view of HIV origination is that it came from non-human primates, infected with Simian Immunodeficiency Viruses (SIVs), which somehow became HIV and infected humans (2).

The evidence all contradicts this. SIVs are genetically *very* different from HIV. They do not cause Simian AIDS - if they did, there would be few if any Simians left. Attempts to infect Simians with HIV and produce AIDS have all failed.

HIV is a new, unique virus, causing a new, unique lethal human disease, AIDS. There is no logical connection in any way between HIV and SIV (6). The idea that HIV originated from SIV is quite scientifically incorrect; it is maintained only due to its political correctness.

Consider these facts. This concept requires that Simians in Africa *and* North America transmitted two different viral strains, to two differently susceptible human populations, at the same time.

The two different viral strains would have had to originate in the Simians, be promptly transferred to humans (because the virus does not last long outside host cells) and then vanish, because HIV has never been found in Simians.

In addition, numerous attempts to substantiate this concept by infecting Simians including chimpanzees with HIV had all failed. When introduced into Simians HIV always dies; it cannot replicate in this (foreign) host. There is no way HIV could have originated from SIV. Nature simply does not work this way. It never has and it never will.

FALSE CONCEPT THAT HUMANS CREATED AND SPREAD HIV.

The foregoing facts have resulted in concepts whereby HIV was created and spread by humans. Then HIV was supposedly created by human Biological Warfare research science, and spread either accidentally or purposefully by medical procedures such as inoculation and vaccination (1,7).

All such concepts fail due to the fact that HIV originated at a date when human science was quite incapable of creating it.

According to the work of Wolinsky et al (8), HIV originated around 1950. According to the very recent and supposedly even more exacting work of geneticist Dr. B. Korber (9), the date is more likely around 1930. Human science was quite incapable of creating HIV anywhere around these early dates.

For example: The key enzyme Reverse Transcriptase, detection of which made possible the discovery that HIV was a retrovirus, was discovered in 1970; retroviruses were first discovered in humans in 1978; and the Polymerase chain reaction, central to retroviral research, was discovered in 1983 (10).

It was quite impossible for human science to create HIV around 1950 or earlier, because *the essential research and development tools were quite unknown then. The concept that HIV was originated initially by human activity, is contradicted by the scientifically established time frame of HIV's origin.*

In addition, even if it were possible, what human being or human organisation would purposefully develop and unleash the infectious lethal virus HIV, which threatens to destroy human civilization and possibly even our species? **The concepts of HIV's origination in simians, or by human science, are invalidated and must therefore be discarded.**

CATTLE MUTILATIONS, HUMAN ABDUCTIONS AND HIV.

Information supporting HIV's purposeful ET origination comes from reports of cattle mutilations and human abductions. Authentic cattle mutilations occur without any nearby animal tracks or evidence of human activity.

There is very little bleeding because all the blood has been removed prior to mutilation. Laser-like extremely even cuts are found to have removed certain body parts (11,12,). Parts removed are those which in humans are possible sites of HIV transmission (13). I suggest these are taken for study; the left ear is probably taken to retrieve a locator implant.

Cattle blood is genetically relatively similar to human blood (14), and in theory might be a medium for HIV replication.

The concept that cattle mutilations are related to HIV logically and simply explains everything concerning these otherwise incomprehensible phenomena. There is *no other* logical explanation.

The politically correct idea that animal predators are involved, is readily excluded by the laser-like cuts, absence of blood, absence of tracks, predator avoidance of the carcass, the fact that mutilated parts taken are not good to eat, etc.

And also by the unusual circumstances of death, which in one well documented case was probably due to the homogenized heart inside an intact pericardial membrane (15).

A biocidal light blue gel containing formaldehyde was found on the body cuts and at the formerly pregnant dead

cow's rear end. I suggested the biocidal blue gel's main function was to protect the new born calf during its passage through the birth canal (the calf could not be found and is presumed abducted).

A similar light blue gel has been reported in connection with preservation of a dead ET alien body, and treatment of abductee vaginal infections (Reference 6 p. 28). The scientific explanation for cattle mutilations involves UFOs and HIV (16). There is *no other* logical, simple explanation.

Authentic human abductions by the extra-terrestrial aliens termed "Greys" involve transports to secure locations, followed by medical-type physical examinations which are centred around AIDS.

The major organ systems examined for disease in a routine human physical, such as the heart, digestive tract, liver, lungs, kidneys, nervous system, etc. are given little attention. Instead, there is examination for lymphadenopathy (swollen lymph nodes characteristic of AIDS) in the neck, armpits and groin.

The mouth and eyes are examined (possible opportunistic infections and sites of infection) as is the rectum (possible site of infection). Samples are taken of blood and reproductive materials (but not of urine) (16,17).

I suggest the evidence shows clearly that people are abducted by ET alien Greys to harvest reproductive materials (17), monitor for HIV/AIDs status (18), apply and service implants (19), and obtain information (20).

There is a case documented in writing where an abductee tested HIV positive until his implant was surgically removed, after which he tested and continues to test HIV negative. The implant was hollow and secreted something... (21).

Reasonably assuming the implant was of ET origin (19), this shows a clear connection between ETs and HIV. I emphasise- the concept that cattle mutilation and human abduction phenomena are related to HIV readily, simply and logically explains the known facts concerning both, including facts that are otherwise incomprehensible.

For example, the ubiquitous anal corings of cattle mutilations, and the common mechanical anal probings of male abductees, are readily explained by the fact that this body region is an important site of HIV transmission.

ET ALIEN GREYS AND HIV.

When all the foregoing is put together, one arrives at the logical conclusion that the ET alien Greys very probably created and initially spread HIV.

The history of humanity shows that when two human societies met, the more technologically advanced societies destroyed the others. How many American Indians are left in America? How many aborigines in Australia? Hawaiians in Hawaii?

I suggest there is only one real form of cosmic wealth, and that is cosmic real estate in the form of a world rich in life — like ours.

When enough people are sick, dying and dead from AIDS, human civilization will collapse, eliminating any opportunity of organized, meaningful resistance, including the possibility of atomic retaliation, which

would make the planet uninhabitable.

Then, assuming the AIDS-ET Connection Hypothesis is correct, alien colonization will begin. Meanwhile, the authorities maintain that UFOs and ET aliens do not exist. And HIV continues to spread rapidly.

The present situation is not stable. About 300,000 new cases of HIV infection occur daily. About 110,000,000 people are presently infected worldwide (22). The spread of HIV infection is believed exponential (1).

No one knows just how many people are HIV infected, because there is no central reporting agency, and *everything works to diminish the reported number*.

If one makes the reasonable assumption that every person with HIV infects just one additional person a year, then within 10 years the calculated number infected exceeds the world's population (23).

Even if a generally effective preventive vaccine is developed then, it will be too late. The answer is prevention *now*.

WHAT NEEDS TO BE DONE?

I recommend mandatory testing for HIV with central reporting, increased education, and identification *without prejudice* of all HIV positive persons.

In addition I suggest the use of protective measures, such as condoms, during all non-procreative sexual relations. These measures will save many millions of human lives. They should be employed.

The public needs and is entitled to know the truth about UFOs and ET aliens. There is no longer any reason to suppress the facts. There is good reason to reveal the truth. UFOs are alien spacecraft, and they and their occupants are here among us. Let the truth about their existence and activities be known.

If you desire medical assistance consult a physician without delay. May God Almighty see fit to spare us from the dreadful plague of HIV/AIDS. Good luck!



II. NOTE BY THE EDITOR OF FSR.

What I am completely sure nobody anywhere in the world now knows or remembers -or cares about- is that, many years ago, I had already arrived at the same conclusions as Dr Phillip Duke, and that, in support of my stance, I had "gone out on a limb" and published a similar warning article on the subject of AIDS -and in fact that was so long as *eleven years ago*- in FSR Volume 14/1 (March 1989).

Not a soul, not a reader, nor a single UFO researcher or doctor or scientist, or any journal or publication anywhere in the world, paid the slightest attention to the article or has ever communicated with me or spoken to me about or commented on it in any fashion or form. (Did not old *Gurdjieff*, in all his teachings, constantly tell us that 95% of the humans are in a permanent state of "sleep"!)

All that did happen was that in due course *Britain's leading expert on UFOs*, or supporters thereof, let it be

known that, in his or her opinion, the author of the piece, Mr B. W. L., did not exist anyway, and that the article was a mischief-making concoction by me.

I wrote and informed Mr B. W. L. that he did not exist. However, I am happy to be able to add that he is

still alive, and that I have now been able to put him and Dr Duke in touch with each other. I now reproduce his article below, along with my own introductory remarks of 1989:-

AIDS. -Reprinted from FSR Volume 34, No. 1 (March 1989).

Long ago I came to a whole lot of conclusions about the true significance of the "UFO Phenomenon" which it might not be prudent to voice. Subsequent events and revelations have only reinforced this feeling, and in a recent letter from a British reader who works in the Defence field (see pages 17/18 of FSR 31/4, *Food For Thought*) certain important possibilities were hinted at.

The contribution from our Californian subscriber, the artist B. W. L., which I reproduce below, will be found to be in line with that same trend of thought, and I suggest that it deserves careful study, although I must add that since I received it I have begun to see an entirely different possible explanation than the one adopted by the writer, and one that is maybe slightly less ominous for mankind as a whole. I must also add that I would never have considered publishing this article had it not come to me with a personal reference from one of FSR's most respected U.S. Consultants.

So far as one can learn, it seems that the "official" view about the origin of AIDS is that the disease has suddenly emerged from Central Africa, after lying unknown there for who knows how long, and has then passed into the U.S.A. and Western Europe on a large scale probably via Haiti -at least as some have suggested.

Well, it is of course true that, after a century of exploration and research, there still remains much to be discovered in the heart of the Dark Continent in all spheres, including the medical. Nevertheless, I find it

incomprehensible that so many Western doctors and nurses who have worked in Africa so extensively would not have come upon any trace of it earlier, and, frankly, I rather doubt the "African Explanation", though I admit that it is a very 'handy' one. And I am not entirely convinced that our own Governments believe in it.

Alternatively, might it not in fact have been a particularly clever ruse on somebody's part to elaborate the disease elsewhere, and then to implant it in the highly suitable field of Central Africa and let it burst upon the world as a new "African" disease?

As regards the theory that it was launched in order to wipe us out, I don't quite "buy" it at present, because, surely, so many far, far easier methods could have been found by anybody desirous of eliminating us.

Far more probable, in my view, would be the explanation that, since there are Alien Powers of an intermediate level -who are probably our Owners and would clearly regard us as herds to be exploited, or as biological-banks or gene-pools, then they would of course (like any sensible farmer or herdsman) be concerned to keep their cattle normal and healthy and disease-free, and would therefore take effective steps to eliminate any undesirable taints likely to impair the quality or quantity of the genetic material available, and particularly so should they themselves depend in some way on the latter for some part of their own well-being! - EDITOR.


AIDS . . . AND THE UFO CONNECTION: A POSSIBLE PLAN FOR GENOCIDE? BY B.- W.- L.- (California)

By way of introduction, may I state that I am a concerned citizen who happens to be an artist and a printer. Over the years I have built up an extensive knowledge on the subject of UFOs, reading books and articles by such authors as Frank Edwards, Gordon Creighton, John G. Fuller, Jim and Coral Lorenzen, Ralph and Judy Blum, and many other private investigators.

The gravity of the AIDS crisis makes it imperative that we consider all possibilities as to its origin .. even if the evidence is vaguely circumstantial. If we are to find a

cure for this "ANDROMEDA STRAIN" -then finding its origin could give our scientists the edge they need.

What I may have discovered is a "connection" between AIDS and the animal mutilations of the 1970s. For it strikes me as a little more than coincidental that the nature of the mutilations has a parallel with the way in which AIDS is transmitted.

We humans have short attention-spans. Thus, when events are separated by large gaps in time, we have difficulty in visualizing what in this case could be a deadly scenario.

Are we being victimized by hostile alien forces? Before you answer 'No!', consider these facts:-

THE FACTS.

During the 1970s the world experienced a bizarre and gruesome phenomenon commonly known as "animal mutilations". In the United States alone, some 10,000 cattle were butchered with such surgical precision that our veterinarians were stunned and baffled by the method used. The mutilations stretched from Oregon to Tennessee ... one-third of the extent of the Continental United States.

1. All slaughtered cattle were drained of blood.
 - a. AIDS is a blood disease.
2. Many cows had their reproductive organs removed.
 - a. AIDS is transmitted by sexual contact.
3. In many cases the entire anal canal was removed.
 - a. AIDS first began to manifest in the "gay" community, and involved the peculiarly absorptive properties of the anal canal with which so many of the "gays" are so preoccupied. (5) Other organs taken were eyeballs, tongues, heads, and large patches of epidermis.
4. The animal mutilations started in 1972 -and diminished in 1978.
 - a. The AIDS syndrome began in 1977. . . amounting to the five year incubation-period! (1972-1977.)

All of these surface details were widely published and are easily verifiable. The mutilations were investigated at the highest levels. At one point the F.B.I. became involved, but nothing was reported to be resolved, the problem becoming a colossal embarrassment to the authorities. They simply hoped that it would go away.

The ranchers, for their part, knew that something alien was descending on their cattle. They watched large glowing lights in the night sky . . . then smaller lights descending to do their dirty work, as the coming of day would reveal.

Looking at the nature of the mutilations, one could surmise that aliens were engaged in massive research into various ways of spreading the virus through human contact.

Mark Feinberg of Stanford University says: "AIDS is unlike any disease that is prevented by vaccination. It attacks the very antibody-producing machinery that a vaccine is supposed to stimulate." And he says further: "AIDS has mutant strains, an ever-changing genetic structure. It's like trying to hit a moving target" (NEWSWEEK, November 24, 1986.)

LOGISTICS.

If an invading armada wanted to decimate the human population, there would be no need to transport massive war equipment across the depths of Space. There would be no need for blazing ray-guns or neutron bombs. A deadly genetic virus would do the job rather well, and leave the environment intact.

The mutilations did happen, and the reasons for them were never given or explained by anyone. I submit that, if we continue on our present course of blind complacency and indifference in regard to UFO activity, there may be little salvation for the human population.

It is my hope that those who are in authority will reopen the mutilation investigation and, in this new light, look for other clues that might put our scientists on the path to a solution.

In my firm opinion, AIDS was designed and calculated to invade the blood, lie dormant for a long period, so as to be passed on to others, and finally kill the host. While we are preoccupied with fighting one another over issues of territory, race, and religion, we may ALL be victimized, AND POSSIBLY FOR JUST THOSE REASONS.

Are we to learn nothing from the ranks of those with vision?

III. U.S. GOVERNMENT'S RECENT WARNING ON AIDS.

On April 30, 2000, U.S. newspapers carried the following statement from the Washington Post about the current world situation concerning AIDS, and warning of serious future developments:-

National Security Threat Seen In HIV/AIDS Spread Overseas.

Washington - Convinced that the global spread of AIDS is reaching catastrophic dimensions, the Clinton Administration has formally designated it a threat to U.S. national security...national Security Advisor Leon Fuerth acknowledged that the (doubled) budget request of \$254

million provides "resources inadequate for the task."

Fuerth also stated that "The number of persons who are dying, the impact on elites- like the army, the educated people, the teachers- is quite severe. In the end it's a kind of slow motion destruction of everything..."(in Africa).

A new White House interagency task force has been created to drive international efforts. Task force co-chairman Sandra Thurman stated, "the thing that's most staggering, that people are just beginning to grasp, is that

Africa is the tip of the iceberg," And, "we are just at the *beginning of a pandemic the likes of which we have not seen in this century, and in the end will probably never have seen in history."*

FURTHER COMMENT FROM DR PHILLIP DUKE.

For years I have been trying to alert people concerning the coming world-wide AIDS cataclysms. But I have been only a voice in the wilderness, unheard, unheeded and much criticized. I have no funding, and except for *FSR* and *Paranoia* magazine, no publication except for my self-published book *The AIDS-ET Connection*.

My book predicts the coming cataclysms, and presents scientific evidence concerning their true origin and nature. Both the scientific and UFO communities have refused to review my book, with the result that it is little known.

Based on reasonable assumptions published in my book, when probable present rates of HIV infection are conservatively projected forward, by about 2010 A.D. the majority of the world population will be infected with lethal HIVs.

Then by roughly 2020 A.D. so many people will be ill with AIDS, that by about roughly 2025 it will be all over. Human civilization will collapse country by country due to lack of manpower, and as intended all chance of organized, meaningful (atomic) retaliation will be lost.

These figures may err, but then, if it takes a few years longer, what difference does that make in the long run? None, because what really matters to the originators of HIV is the final end result.

My research indicates purposeful origin of HIVs and their pandemics. HIV is the ideal Biological Warfare agent of mass human destruction, and it is in process of doing the job it was made for, which is to kill enough people so that eventually human civilization will collapse.

Meanwhile the authorities have continued to maintain HIV/AIDS is just another pandemic of natural origin, and the (overseas and domestic) situations are both no

threat.

The above article in the *Washington Post* emphasizes HIV/AIDS created problems in Africa, and also mentions that the "(African) disastrous course could be repeated, perhaps exceeded, in south Asia and the former Soviet Union."

Nothing is said about China and India, our two most populous nations, where HIV is spreading like wildfire. Nothing about any other countries. And absolutely nothing about HIV/AIDS in North, Central and South America. It's as if the problem does not exist here in the Americas, including North America. But only "overseas."

IV. -THE STATISTICS OF AIDS INFECTION.

[I have been doing my own researches. The following information comes from the very informative and sobering website at <http://www.amnh.org> -Philip Creighton.]

More than **14 million** people have died of AIDS.

35 million are now living with AIDS, and this figure is increasing at a staggering rate. That is **one in every 100 adults** around the world, ages 15 to 49, is infected with this disease.

Worldwide, **five people** between the ages of 10 and 24 **are infected with HIV every minute**. Well, there are $60 \times 24 = 1440$, minutes in a day, so that makes 7,200 new infections per day -and **2.63 million per year...**

The **greatest growth in AIDS cases** is expected in densely populated countries of **South Asia, Africa and India**.

Women, children and adolescents are the most rapidly growing segments of the population becoming infected with HIV.

Combination drug therapy costs an average of **\$10,000 to \$15,000** per patient per year, **-quite unaffordable in the developing world.**

On page 4 of FSR Vol. 8, No. 5 (1962), we mentioned a report (*SCHOOLBOY SNAPS SAUCERS*) describing how a fourteen-year-old-lad, Alec Birch, had, on March 4, 1962, been sitting with two young friends in the back-garden of his home at 12, Moor Crescent, Mosborough, Sheffield, in southern Yorkshire, playing with his old *Brownie 127* box camera and taking snapshots of his dog, when he suddenly noticed dark silent objects hovering in the sky near by and promptly aimed his *Brownie* and photographed them.

The pictures, one of which was to become famous, known and reproduced all around the world, were not developed for some weeks. But when they were developed one of them showed a total of five dark craft, two of them complete with the familiar “domed saucer” shape, while the other three appeared to be in what seemed to be various stages of “incompleteness”. (It is well known that many UFO photos have shown curious distortion, and a popular theory has been that this effect might be due to the hazy magnetic field around the UFO itself. **But there is of**

course another possible cause, of a most surprising nature, about which many folk are starting to speculate today - but would never have done so back in 1962!)

Of the two other boys who were in the garden with Alec, at least one, David Brownlow, is known to have given precisely the same account of the five flying objects seen by him as Alec has done.

The photograph was inspected by the Science teaching staff of Alec’s school, Westfield Comprehensive, and Alec and David Brownlow were called in to explain their story to Mr. Colin Brook, the head of the English Department.

Both boys gave him precisely the same detailed account of the five mysterious dark silent objects seen briefly hovering in the sky *and then vanishing suddenly*.

The photograph was next taken to Kodak, whose experts pronounced it to be genuine in their opinion. It is known that the British Air Ministry and the Pentagon received copies of it and conducted enquiries into the affair.

The photograph appeared in newspapers and magazines and television programmes around the world
