## EDITORIAL

### THE END OF AN AGE.

**D**uring the half-century since the massive appearance of mysterious craft in our skies, a number of distinct phases seem to have been observable, the latest of which, beginning a few years ago, we might term the phase of the Giant Triangles and "Boomerangs".

The accounts now coming in, from all over the world, about sightings of these types of craft, are so numerous that it would seem foolish to waste time and valuable journal space on attempting to log or record them.

Clearly a new stage appears to have been reached. (Some folk might possibly have been optimistic enough to hope or imagine that these huge devices might herald the arrival on the scene of a new and possibly more "benevolent" type of "alien", but all the evidence that I have seen so far seems to suggest, alas, that the occupants of the great triangles and great "boomerangs" are still the "little Greys".) My guess is that we have very little time left before the much-predicted "Extraordinary Event" happens here. Our readers will no doubt be well acquainted with some or all of the various theories as to what precisely that "Event" will be, and it is interesting to learn that in a TV appearance early on Sunday, October 14th 1998, Uri Geller voiced the conviction that something enormous is impending. Unfortunately I missed seeing the programme myself.

My guess is also that these enormous devices -and possibly most of the entire "UFO Phenomenon"- do not come out of *our* three-dimensional Universe at all, but from somewhere else -maybe a "Parallel Universe", as suggested by the great Soviet scientist Andrei Sakharov and by Dr Jean-Pierre Petit in France- or, as sometimes suggested, a "Mirror Universe", not at all distant from us. Possibly what Dr Meade Layne in the USA, as long ago as the late 40s and early 50s, was describing as the "Dense Etheric". According to Meade Layne's sources, such craft and their occupants (of various species) make their appearance when the end of a civilisation is at hand.

For clear proof that this Age is indeed going down to its end, seek your evidence in every newspaper and radio and TV programme, and in the behaviour of people all around you. In a subsequent issue it will be possible to write more precisely about these matters.

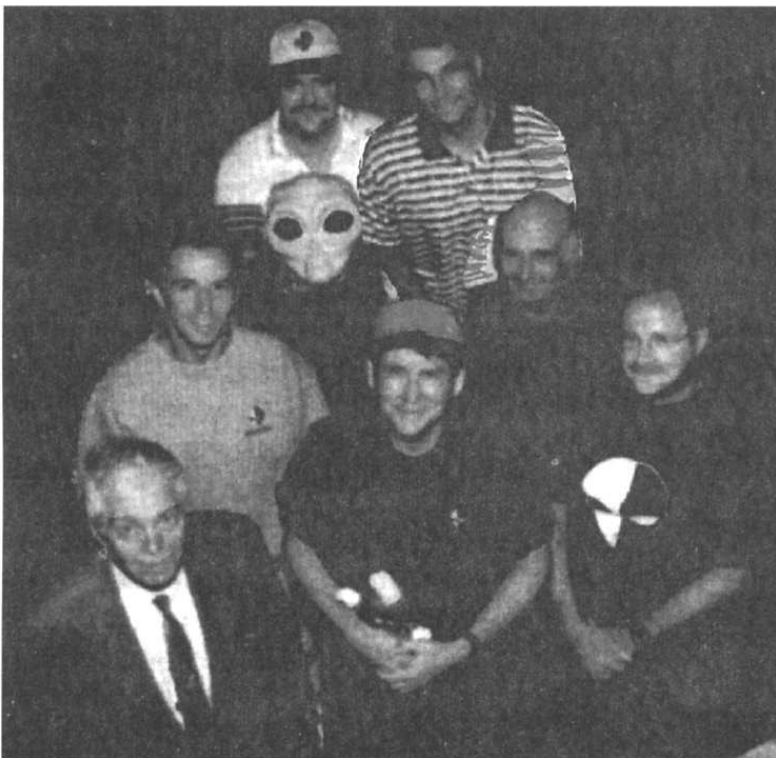

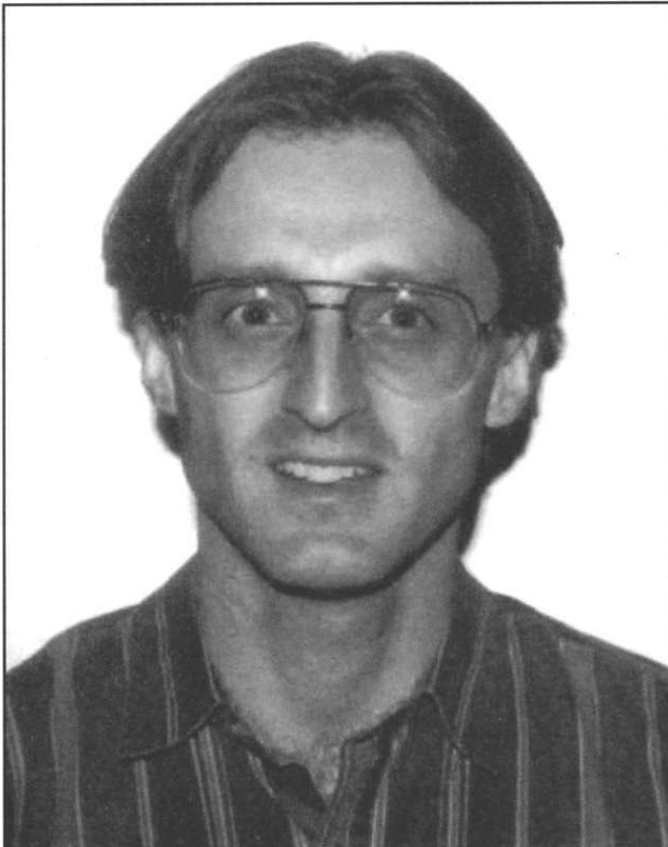

# SEVEN UFOs PHOTOGRAPHED OVER TAGISH LAKE, YUKON TERRITORY, CANADA.

## THE LOCATION.

Tagish Lake is a large glacial-fed Lake in Northwestern Canada. The lake straddles the border of the Yukon Territory and the Province of British Columbia and is about 100 km (60 miles) south of Whitehorse, the territory's Capital. The western boundary of the Yukon Territory borders the State of Alaska.

## INTRODUCTION.

As a result of some local publicity in May and June of 1998, we were informed that a photograph of several UFOs near Tagish Lake was taken some years back.

In July of 1998 an investigation led to the identification of the secondhand witness who was in possession of a slide duplicate of the image which was taken around 1970. A copy of the slide was made, the witness was interviewed and a preliminary analysis performed.

A cropped portion of the image is shown on the cover of this issue of Flying Saucer Review, and the entire image in Figure 2 (inside front cover). There are seven UFOs in the image.

We know that there was a total of seven objects from witness testimony. This is important since UFO#7 (the smallest object) is almost indistinguishable from bright reflections off the mountain bedrock. The UFOs in Figure

2 are numbered 1 through 7.

A closer look at UFOs #2, 3, and 4 is shown in Figure 5, and all seven objects are enlarged in Figure 4. (See inside back cover.)

## SIGHTING DESCRIPTION AND STORY BACKGROUND.

Two couples were doing some recreational boating on Tagish Lake in 1970 (approx.) and were travelling in two separate boats. We now have permission to reveal the names of the two men involved as Jim and George. George was in his early 50s and Jim was in his mid 60s around that time.

It was about 10 am when they were travelling southbound on the lake. It was windy and the water was a bit on the rough side. Jim's boat was smaller than George's and also had an open top. George and his wife were driving in a closed and larger boat.

Because Jim had a smaller boat and wanted to stay out of the roughest water, he was travelling close to the shoreline, while George and his wife could afford to travel out in the middle of the lake and were about 5 to 8 kilometres (3 to 5 miles) back.

While travelling along the edge of the lake, Jim and his wife saw the seven strange glowing orbs as shown in the photograph. There are four closer objects and three more further up the mountainside.

Jim estimated that they were 3 to 4 feet in diameter. The UFOs moved about slowly for the estimated 15 minutes that they watched them as he and his wife travelled down the lake. The four closer objects eventually made their way up the mountain to join the other objects.

George was too far back to notice the objects and didn't even have sight of Jim's boat. His concentration was devoted to the rough water. Jim or his wife never mentioned anything to George until the film was developed, about a week later. We can speculate that this may have been because of the fear of ridicule or disbelief. That is until Jim had the slide in hand.

As far as George knows this was the only photo of the objects that Jim took.

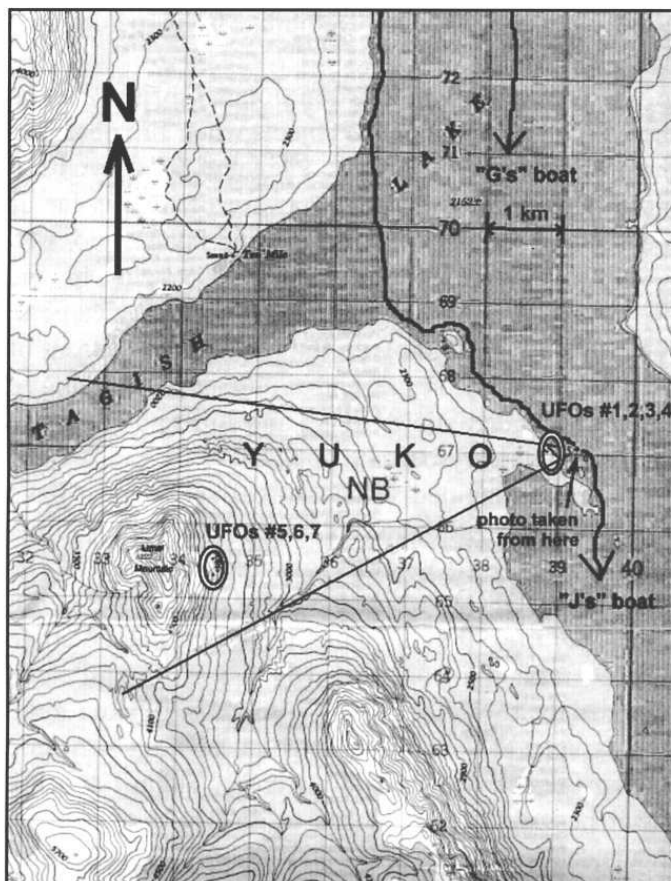
Jim used slide film and made a couple of slide duplicates for George. George submitted one to the Weather Office who submitted it to the Department of National Defence in Ottawa.

About a year later George was curious to find out what the department found from their analysis so he asked the person at the Weather Office to look into it. The answer he got back was that that information was classified.

## PRELIMINARY INVESTIGATION AND ANALYSIS.

The analysis performed here does not come from

experience in analyzing UFO photographs but rather from the viewpoint of experience with photography. Further analysis is warranted by experts in the UFO field.

On Sept 5, 1998 a field trip was undertaken to establish a more precise location of the sighting and the location of Jim when he took the photo. After some effort the location was found and a 1998 photograph (Figure 3, on inside front cover) was taken from the same spot using a camera with the same focal length lens as Jim used.

The UFO locations were drawn as red circles in this figure to facilitate analysis. The island in the forefront enabled us to pinpoint the witness location on a map of the area (Figure 1). It is estimated that the 1998 photo was taken within about 10 metres (30 ft) of the 1970 photo.

Unlike the 1970 photo which was taken under cloudy conditions, the 1998 photograph was taken in good lighting and therefore shows a lot more detail in the terrain. The photograph was taken at about 9:45am, about the same time of day as the 1970 photo.

Because of the higher detail some further analysis could be performed. By measuring rock formations on the island and scaling them on the photograph it was established that Jim was approximately 50 metres (164 ft) from the island.

The distance of 250 metres (820 ft) from the island to the shore behind it was scaled off a map. Therefore, the total distance from Jim to the shoreline was approximately 300 metres (984 ft).

The 1998 photograph clearly shows that UFO#1 was in front of the tall spruce trees at the shore line. If we assume that UFO#1 is just in front of the trees and therefore 300 metres from Jim, we can calculate its size. After doing the math we get a maximum object diameter of 1.4 metres (4.5 ft). This agrees well with Jim's estimate that the objects were about 3 to 4 ft in diameter.

Although the objects look like dots in Figure 2, calculations show that UFO#1 would have appeared to be about half the diameter of a full moon to the witnesses.

The magnified images in Figures 4 and 5 (inside back cover) are magnified to the point where the grain structure of the film can be seen. This should be taken into account when looking for details in these images.

Nevertheless, useful data can be obtained from these magnified photos. The objects appear slightly hazy or diffused. However, note that there is no sharp detail in the entire photo so it is therefore not possible to tell if the actual objects were well defined spheres or diffused lights.

Figure 5 (inside back cover) shows that the edge of the mountainside in the upper right-hand corner is not any less diffused than the UFOs. Of notable interest is UFO #4. It is surrounded by 3 anomalous bluish objects or lights.

The magnified images can give us a relative diameter and color of the UFOs. The diameter was used to assess object size and distance. The color of the objects also gives us some important information.

This color difference is dramatically shown in Figure 4 (inside back cover). Note that UFOs 1 through 4 (the closest ones to the camera) are not in direct sunlight as the surrounding trees are not illuminated (see front cover). Therefore, these objects may be glowing by their own source. The glow is of yellow and perhaps of a slightly green color.

In contrast, the area around UFOs 5, 6, and 7 up on the mountainside is bathed in morning amber light from the sunrise. The three UFOs also seem to be of a similar amber color, suggesting that they may be reflecting sunlight as well. If this is true, it indicates that they are of a solid nature rather than some form of plasma.

The questions remain; if the 4 closer objects were exposed to the sunlight, would they also reflect it over and above their glowing yellow color? Did they appear to be of the same amber color to Jim once he observed the 4 closer objects join the other objects further up on the mountainside?

Because there were nearby trees behind UFO#1 it was possible to estimate the maximum distance and size of this UFO. This was not so easy for the other six. However, if we make some assumptions, we can perform some further calculations. If we assume that the other UFOs are of the same diameter, we can calculate their distance from the camera. When we do this we obtain:

UFO#2 distance = 313 metres (1027 ft)

UFO#3 distance = 378 metres (1240 ft)

UFO#4 distance = 406 metres (1332 ft)

If we do this for UFO#5 which appears to be further up the mountainside where the sun appears to be shining, we obtain a distance of 1.15 kilometres. However, this is inconsistent with the actual distance of about 5 kilometres to this location. See map in Figure 1.

One way this can be explained is if the objects on the mountainside are larger than UFO#1. If we do the calculation, UFOs #5 and 6 would have to be at least 6 metres (20 ft) in diameter. UFO# 7 appears to be much smaller in the photo and may be partially obscured by trees and a size calculation was not performed.

The possible locations of the seven objects are shown within the two ellipses in Figure 1.

Figure 2 (inside front cover) shows useful information which will aid in further analysis. Several dust particles and the frayed edge of the slide can be used to assess the quality of the copy negative and print. Ideally we want the grain structure of the copy film finer than the structure of the slide to capture the most detail. This is likely the case as films today have a much finer grain structure than in 1970.

Nevertheless, this can be independently assessed by looking at the film grain size representing the dust particles. The print will have to be enlarged further and rescanned for this analysis to be performed. Figure 2 is not scanned at a fine enough resolution for analyzing the film grain structure.

#### **FURTHER INVESTIGATIONS.**

It would be ideal to work with the original slide to perform further analysis. It would also be of great value if other photographs of the objects were taken. Perhaps one of the four UFOs in the forefront moved further up the mountain.

Unfortunately, Jim has moved down south and has since passed away. His wife is also deceased. Attempts will be made to recover the original slide by contacting surviving relatives. George still resides in Whitehorse.

A careful look at the film grain structure representing the dust particles on the slide will be compared to the grain size representing the UFOs to assess if the copy negative was of a fine enough grain size to record as much detail as possible from the slide.

#### **WITNESS RELIABILITY.**

The testimony of the secondhand witness George sounded very sincere. George was curious about what Jim saw and photographed, and added that neither he nor Jim have or have had a big interest in the UFO phenomenon.

There was no apparent reason for Jim to make up the story or to fake the photograph. Jim's story which was related by George sounded sincere and the two were close friends. Jim was the Chief Grain Inspector of Canada around that time and therefore it is unlikely

he would have risked his credibility by perpetuating a hoax.

One question which often comes up is "Why is there only one photo of the objects when Jim observed them for 15 minutes?" Of course there may have been more photos that we are not aware of, but as far as George knows, Jim only had the one image.

However, during the September 1998 field trip, one possible explanation for the one photo theory came to mind. As I was holding up the UFO photo in front of me, looking at the scene, and simultaneously trying to steer the outboard motor to get into Jim's position, one thing very quickly became apparent.

When I imagined what the real scene must have looked like, it almost sent chills down my spine. Although, UFO#1 looks only like a dot in the photograph, UFO#1 would have looked "DAM CLOSE ! " in real life. If Jim wanted to at the time, he could have driven the boat towards the UFO and been underneath it in less than 30 seconds and taken more photographs at very close range.

Surrounded by ice-cold water it wouldn't surprise me if he would have chosen to do just the opposite; that is, take one quick photo and continue to drive down the lake while keeping a somewhat fearful and very watchful eye on the objects!

#### **TECHNICAL INFORMATION.**

It is unknown what brand and model of camera was used to take the original image. However, George thinks it was a good quality camera, perhaps a Leica. The film format was 35mm. George surmises that Jim may have been using 25 ASA slide film at the time. The September 5th, 1998 field trip established that the lens focal length was a standard 50mm.

The images attached here were obtained from the one slide duplicate in the following manner:

Fuji 100ASA print film was used to make a copy of the slide. A copy stand and a 35 mm Cannon SLR Camera (EOS 630) was used to take negative copies. A 100 mm (true Macro Lens) was used, magnification was 1:1. The slide was backlit using Tungsten photo lamps with a blue corrective filter over the lens to compensate for use with daylight film. Aperture was set at f9.5. Shutter speeds were bracketed and ranged from 1/4 to 3 seconds. A timer was used to reduce camera shake.

Glossy prints measuring 4x6 inches were made of the entire image (these would be approximately 4 times magnification of the slide). Twenty times magnified 5x8 inch prints of the UFOs were also made. The prints were scanned using a UMAX 1220S Scanner ranging from 300 to 1200 dpi.

#### **REMARK.**

UFO\*BC welcomes assistance in performing analysis of this image, and will provide a copy negative to serious researchers.■

### CONFIDENTIAL REVELATIONS FROM A FORMER MEMBER OF A TOP-SECRET U.S. ARMY UNIT SPECIALISING IN RECOVERY OF UFOs AND CAPTURE OF ALIEN ENTITIES.

[ In a recent issue, FSR 43/1, I gave an article by Jorge Martín relating the top-secret revelations of an American Army Officer. (*Operation Curtain: Joint Military Exercises with Aliens?*) It is evident that Señor Martín has very good contacts in these important military quarters, and here is another report, from a different U.S. Army Officer, that will also give you plenty to think about! - Editor of FSR. ]

We were recently contacted confidentially by a source who at present still prefers to remain "anonymous" for reasons relating to his own security, and who gave us certain information apparently linking the mysterious "chupacabras", now plaguing Puerto Rico, with....Roswell!

This person approached us after hearing one of our radio programmes on the *Notiuno* Channel at 10.30 pm on Thursdays.

Employing the pseudonym of "Don Ernesto", this U.S. Officer, now aged 70, offered to tell us what he knew about the "chupacabras", which he says are linked with the UFO Phenomenon, but -so he claims- **are not offensive towards humans!**

Initially he was extremely cautious in his approach, emphasising that he had worked for U.S. Intelligence in very delicate and classified matters, and that, were his contact with us discovered, he would be "likely to face very difficult and dangerous moments."

Finally, however, after considerable indirect contact, we were able to meet with him in a public place in our capital, San Juan, where our respective credentials might be exchanged, and his revelations to us might begin.

Speaking with very great care, and carefully choosing his words, he was able to satisfy us as to his identity, and also as the nature of his past services.

He began as follows: "I've been listening to your programmes for quite some time, and I can see that you are a brave man, for there is a lot of danger in all this UFO business, and I see that you are the only one who dares to discuss things. But you have got to be very, very careful.

"There are certain areas of the Government that don't

want these matters known. *I know* because I've worked in Military Intelligence myself, with a very high security grading, and I've been involved with some things that I now rather wish I hadn't, and that I can't discuss with you."

His features as he spoke were grave and pensive, and I can only say that if what he was telling me was faked, then he was a very good actor. He went on to say that the whole UFO business was now badly out-of-control and was creating a climate of hysteria; and that some sort of statement from the U.S. Government was long overdue in his opinion, and in the opinions of some of his colleagues.

And, in particular, he was worried about the general panic in Puerto Rico about the "chupacabras", which he said **are of no danger to humans, whether adults or children.**

We asked how he knew this, and he said he **knew because he had seen them, that the creatures are extraterrestrials, and that the U.S. Government is fully aware of it.**

He said his first knowledge of these matters went back to 1960, and his words were as follows:-

"I was stationed at Fort Sill in Oklahoma, and I and other personnel boarded an aircraft there, and were taken to Roswell Base in New Mexico, touching down en route at Wichita Falls. And at Roswell we saw the creatures in sort of cages. I don't know exactly whether we were on the main Roswell Base or not, but anyway, it was close near there. ( About the alleged Roswell Crash in 1947 I know nothing -that was 13 years earlier. )

"One of the entities that I saw there was similar to what was later shown in the TV film about the Roswell Crash, though certain of its features were different."

When we asked him *how* the features differed, he replied that what he had seen in the cage at Roswell "was taller - about 6 ft. high, with very tiny ears. Like humans; it had a very fine, thin, velvety sort of down as hair. And it had a friendly, benevolent gaze, with sad-looking, dispirited eyes, as though lost, a stranger, and asking for something, or wanting to talk, but as though nobody could understand it."

"There were lots of other people there, examining the creatures. My own work in the group had to do with the compilation of information of a certain specific nature. *We* were military, -the rest of the people there were doctors and scientists, and specialists in other fields. Some of the people there appeared to be civilians, while others appeared to be military, but in fact all of them were in civilian clothes. So far as I recall, they had come from all over the USA - Indiana, Delaware, Colorado, California, Texas, and so on.

"Three very strange things that I saw there struck me. One of the beings that I saw there was a queer one. It was in a great big white building constructed of white tiles. The being was in there, in a sort of cage, and although it wasn't a human being, it was very, very much like one. It had "Chinesey" type eyes ( i.e. oriental ), brightly shining eyes, but they were *red*, and covered with a sort of skin or membrane. It had no eyelids.

"They were taking photographs of it, and each time they used a flash, the eyes closed and then opened again. But the eyes themselves were red. The mouth was extremely small and fine, and it had no teeth. And tiny, tiny little ears, and a tiny little nose that you could hardly see. And the face was really pale, very pale.

"And it looked so fragile. Its skin looked so transparent that you could see right down into the veins. A very, very smooth, pale, slightly rosy-coloured skin. I would reckon that, with a skin like that, 3 minutes or so of direct sunlight would burn it. You could see that it was very, very sensitive skin.

"The shape of the head was *round*. It had a sort of - not hair- but, as folks call it, a sort of *velvet*, and only on the head. There was no other sort of hair on the body, and, apart from the upper part of the head, the rest of the entire body was almost completely human-looking.

"In other words, the only part that was different from a human being was from the neck upwards. The head was round and very big in proportion to the face. I would describe the head as looking very swollen or inflated. But there was no sign of any wounds or anything like that. So that's just how it was!

"He was a male, and he was naked. They were keeping him in a sort of cell, like a small room, with a grating, inside the bigger room -just like a sort of cell. In the cell they had a bed for him, a toilet, and a washbasin -that's how the cell was fitted out."

We asked him whether the little room was insulated or sealed, or equipped with a special atmosphere. He said "No, -the cell was just fitted out as described, and the entity was enclosed in it, with a padlock or special clasp on it."

He went on: "There were about 15 to 20 of the technicians and scientists there, and it was quite clear that they hadn't the faintest idea what this was they were having to deal with. This has given rise to a whole lot of problems for me, in my own life, for I had problems with my own family. *I had a family -and yet I couldn't tell them what sort of work I did. Everything was classified at the very highest level of security.*

"It is all so many years ago now, and I have never wanted to talk to anybody about it -nor could I do so. And

I still worry about it, for I find myself thinking about that being who seemed so lost... trying to say something to us, but unable to..., and gazing at us with eyes that looked so sad and so kindly. It just looked amiable. There was no hostility in the gaze. And it was trying to talk, and nobody understood what it was saying. Its voice was like a monotonous modulation, neither rising nor falling. Just very soft -*as though praying.*"

We asked "Don Ernesto" to try to imitate as well as he could for us the sounds that the being was uttering, and what he gave us was a sort of "*Huuuum siuum siuu biuu.* "It was almost like singing", he said -"*something sublime.*"

"Don Ernesto" reproduced this in a soft, very faint, musical tone, and he continued, "But it also seemed as though the entity was somehow *whistling*, and when he whistled and made a hissing sound too with it, the doctors and all the others who were there laughed at it. At one moment the entity managed to laugh too, apparently in imitation. Then, when everybody began to laugh, he uttered a sound and produced something like a sort of smile. When he talked it was almost like a kind of singing. Almost like praying. It was -as I have said -something sublime.

"I would say that the language it was speaking was from the Middle East. Its arms and hands were very fine and slender. I don't know whether the hands had five fingers or six. The fingers were long. I don't recall whether or not they had nails. The feet were just like those of a human, but long and lean.

"He had a male sex organ, but it was a sort of pinkish appendage resembling what we see on a small pig -pinkish, delicate, a bit like that! It was a *small* type of penis, of a maximum size of about 3 inches. And it wasn't like the penis of a human, but had a tip that looked as though it had been cut off with a knife. Like a little tube. It had no foreskin as we humans have.

"I didn't notice whether he had testicles. If he had, I don't recall having seen them. Maybe they were *inside* -I just don't know.

"Along with that being, they also had, in a cell inside another room, some other creatures that were very strange -different- very different. They had more-or-less the same features as the first one just described by me. The head large and pear-shaped, two little holes for a very tiny nose, and practically no ears visible at the external level. They all looked quite alike, but these ones had the whole body covered in hair, like a sort of fluffy down.

"And on their backs they had, as it were, flexible spines -not little wings- but, as I say, like *flexible spines*. They had tiny arms with little hands on them, with fingers and claws, just like one great big nail. And these ones did have teeth, though not very visible.

"On their backs, from the necks downwards, they had, as I say, those things like spines, just like the spinal crest of an iguana, extending right down as far as the lower part of the back, and they were moving these about slowly.

"They were about 5 ft. high, with "Chinesey" (slanted) eyes, also reddish, just as on the other creature -the more "human" one. Their knees were as if doubled back, like the knees of fowls, and went up and down as they



stretched their legs.

"The upper parts of the feet looked muscular and strong. Obviously they were powerful, and designed for running and jumping. They looked somewhat like the feet of kangaroos -but not exactly. I wasn't able to note at the time whether they had claws on their feet. The fine down on their skin was of a brown shade -almost red.

"They were clearly some sort of animal or creature or whatever you might call it, because whereas the first one -the tall one- had a more human-like aspect, these certainly had *not*. *They had a sort of long tongue darting in and out of the mouth like a snake's tongue*, except that, instead of being *forked*, as the tongues of snakes are, this was long and pointed, and you could see that at its tip it had a sort of little orifice, and through this little hole they seemed to be taking in air, or blowing out something.

"There were two of these particular sort of creatures - both alive. And they were being held separately from the other one -the humanoid one. One of them, as you could plainly see at a distance, was a female. It had what looked like breasts, with several small, fleshy little tubes. The other of these two was obviously a male because, you see, it had a penis. On the female nothing genital was visible. The female was the fatter of the two, and apparently pregnant. We all assumed that they were a pair.

"At that point the specialists who were there were remarking that they were going to carry out an examination of them both, and see why one was fatter than the other. *First of all they took away the one that seemed to be female (-I wasn't there to see it-) -but they later explained to me that they had killed it and examined its inside in detail, and had found a baby in it. THEY HAD KILLED IT. They didn't let me into the laboratory where they did that.*"

At this point in his story I noticed that his face was now grave and sad, and his eyes tearful, so I asked him why this was so, and this is what he replied:-

*"It upset me quite a bit, for what they did was an unjust and barbarous thing. They ought not to have done that! They should have tried to find some way of communicating. But -why KILL her! That upset me when I found out that they had killed her. And later I learned that they also killed the male in order to study him.*

*"Both these species of creatures that I saw there seemed to me, from what I could see of them, to be intelligent beings. Obviously the bigger one -the humanoid one- looked more intelligent than the other two, but that might well have possibly been because, in our view, he looked more similar to ourselves. What they later did with the more human-looking one I never heard. They were thinking of taking it to some other place. But I don't think they will have killed it.*

"Well, of course, from what we saw of them it looked as if those two that they killed were apparently totally inoffensive towards us humans. They were just a couple of little animals, like teddy bears. Admittedly ugly, yes, but inoffensive, and from what we were able to hear, they seemed to be some sort of *pets* owned by the tall humanoids.

"Apparently the Government had captured an

extraterrestrial craft with that tall being aboard it, and those two other beings were also in that same craft, but were a sort of mascot or animal of a certain degree of intelligence that they had with them aboard the craft. But personally I never got much information about the matter.

"I was never told where the craft had come down, nor where the craft was being kept, nor did I learn what they subsequently did with him, nor whether they had any more like him. Bear in mind, Martín, that in the Forces and the Intelligence Services you only have access to information up to the level of what it is that is necessary for you to know in order to do your job."

I asked him: "Did any of the similar creatures to these - which, as you say, are being seen in Puerto Rico at present -*did any of them ever try to attack your people?*"

He replied: "No. The critters just gazed at you with sad, imploring eyes. They inspired pity. They were lost, in a world unknown to them. So far as we who were there saw them, those creatures *are harmless. The problem is that they LOOK UGLY AND DIFFERENT FROM US, and so people are scared at the sight of them.*"

#### HE SAW BOTH TYPES OF CREATURES AGAIN.

"In 1970 I again saw both types of the creatures. At that time I was still a member of a Special Unit, and stationed at an Army Base in the USA, and we received orders to go to Florida. They took us to a Facility at Cape Kennedy - but not one in any way connected with NASA or with rockets, etc. (They also told us to bring along civilian clothing too so that, if we had time, we might be able to get a chance to see Disneyworld. But we had other priorities, so we didn't consider it.)

"I can't go into certain details with you, but I will tell you this: In those buildings at Cape Kennedy they had *another entity*, also alive, like the tall one that I had seen in 1960 at Roswell. It was completely similar, and they also had it there naked.

"Now, that place at Cape Kennedy was *different* from the place at Roswell. There was a large room, and in it the cell in which the being was kept. The place looked like the inside of a hospital -it was a big, extensive room. The entity was loose in the room, along with the people who were examining him, i.e. the Cape Kennedy place staff and the Military.

"He was able to move around freely there. I even managed to touch him, but doing it scared me a bit, for, as I've told you, those beings had such extremely delicate skin, and I was afraid of doing him damage. I managed to just touch him with a finger, but I drew it away again quickly. He felt cold to my touch. If you touch them they at once shrink away from you.

"So, the place was a sort of hospital, and they had a bed for him there -a bed of the type just like you see in hospitals, and there was lots of medical equipment. *But the entity wasn't caged as the one at Roswell had been.* Several specialists were engaged in examining him, with stethoscopes and other instruments, and after them others were coming and repeating the same experiments in order to verify the findings."

In answer to further questions, our retired Military

Officer went on to explain: "Those folk who were there with the creature *were* attempting to communicate with it. They were trying out all manner of sign-language and sign-systems. There are some 167 (\*See footnote 1) languages in the whole world, and I would say that there were representatives there from many, many countries, using many of the languages, and, as it seems, nobody had managed to communicate effectively with him.

"They were making all manner of attempts, using facial features, and eyes, and grimaces, and so on. I noticed at one point that the entity made a face -some sort of gesture- and one of the doctors who was there said: "It looks like he's thirsty." And they brought him a glass of water, and very humbly the creature took it and swallowed it at one go, just like any human would have done. I was able to see that in this case, just as in the previous case at Roswell, the entity had no teeth.

"Subsequently the creature was moved to Dover Base in Delaware, in the north-eastern part of the USA, though I don't know for what reason.

"But, to my great surprise, later in that same year, I was ordered to go to Panama, and when I arrived there, at Fort Sherman, I was directed to go with some junior officers on a survival course in the jungle. I protested, and asked why I, who was already 38 years old, and not physically in the best of shape for that sort of exercise?

"But the officer who was my immediate superior told me that, while the *official* reason for the operation in question was the alleged "survival exercise", the real reason for the trip was to visit that entire jungle area, and conduct confidential interviews with the native Indians and with the settlers in the villages there, and to collect all possible information about some mysterious creature that was allegedly killing domestic animals in the area. *The mission was to be very secret.*

*"Later, when talking to the Indians, I was greatly surprised as I realised that the creatures they were describing to me were similar to those I had seen at Roswell in 1960. According to the statements of all of them, those creatures were killing their domestic animals BUT THEY DID NOT EAT THEM. They merely seemed to be piercing holes in them and sucking out their blood. And they assured me that the creatures WERE NOT ATTACKING HUMANS -ONLY ANIMALS!"*

### WHY THE NAME "CHUPACABRAS"?

Then "Don Ernesto" put to us the following question:- "Martín, hasn't it occurred to you why it is that these creatures like the blood of our animals, and why especially they like the blood of sheep and goats? The first creatures of their type were, apparently, captured in the American Mid-West *after* UFOs had crashed.

"So it seems that the ones I had seen at Roswell weren't the only ones that the US Government had."

He went on: "You know, Martín, that in the American Mid-West there exist certain places where the Government is testing new types of aircraft, along with "*other things*" -places like Area 51 in Nevada, and in Utah, and New Mexico, where there are enormous level tracts. And in Arizona too, where there are mountains up to 9,000 ft. high,

some of them "inaccessible".

"Well now, among some of those mountains there are closed-off valleys, and other things...some of those areas -some of the biggest ones- are in other States too, but of course, in the least inhabited ones. In those areas you will find Indian Reservations, and, *inside* those Reservations, you will find certain "*other types of reservations*" -i.e. other areas which are reserved, NOT NECESSARILY AS ZONES FOR NATIVE INDIANS, BUT ALSO FOR "OTHER THINGS". These places are very difficult to find. There are no paved roads leading to them. And the mere attempt to reach such places can endanger the lives of those who try it!"

We next asked him: "What would be the importance of those valleys and those zones?" He replied: "Well, their importance lies in the fact that those valleys and those mountains harbour certain facilities, certain buildings, which of course officially don't exist, and where various types of experimentation are going on, on various... let us call them "creatures" -or whatever you like to call them! Bear in mind too that, except for a few months in the year, the climate and temperature in those places tend to be somewhat similar -although less *tropical* -to, for example, those of Puerto Rico.

"So, let us suppose that some branch of the Government was intent -for reasons unknown- on seeing whether creatures like those I saw at Roswell could adapt themselves to living on Earth. (\* See footnote 2) Quite obviously the first thing would be that they would have to be kept in a climate and temperature to their liking, as as to facilitate their adaptation, and apparently what they like is a warm and tropical climate. Very probably, of course, their place of origin would have had such an environment.

"And -another detail that needs to be considered. Have you realised that it was during the 1960s that allegedly the mutilations and mysterious killings of thousands of heads of cattle and farm animals in the USA commenced -AND PRECISELY IN THOSE STATES OF THE MID-WEST! And also, did you know that the Indians who live on the Reservations in these States are engaged principally in the breeding of *sheep*, and the exploitation of their meat and wool?

"Did you know that, for a long time past, they have been complaining that "something" is killing their sheep? If we add it all up, the picture becomes clear and complete. And don't you think this is how it is? Why is it that these creatures *like* sheep and goats more than other animals? It's simple! It is because the first that they ever got to eat on Earth were the sheep and goats of the Indians on the Reservations near the secret Governmental installations where the US Authorities were holding the creatures, and the latter had picked up a taste for the blood and internal secretions of those particular breeds of animals?"

-INTERESTING, YES. But we still have to ask ourselves: HOW DID THESE CREATURES ARRIVE IN PUERTO RICO? To this question "Don Ernesto's" reply was as follows: "There are only two ways in which they could have come. Either they had arrived in other UFOs, as had occurred in the situation in which I had got involved with them originally. Or "someone" had brought them to the



Island -probably the Federal Government or some military or scientific agency of the USA -in order to see whether they adapted themselves to it.

“Very possibly some of the creatures might then have escaped, and this has been the cause of all that is still going on today involving the “Extraterrestrial Biological Entities, or “chupacabras”, and the animals on the Island.”

### COMMENTARY AND SUMMING UP BY JORGE MARTÍN.

Certainly this account as given to us by “Don Ernesto”, and his analysis of the entire situation, provides much food for thought, because he does include certain logical details that we too had been considering in relation to how the “EBs” could have got here -some of which details we have ourselves already outlined in previous issues.

BUT EVEN SO, WE ALSO HAVE TO TAKE INTO ACCOUNT THE POSSIBILITY THAT THIS INFORMANT IS FEEDING US WITH CONTAMINATED INFORMATION, i.e. DISINFORMATION, IN ORDER TO THROW US OFF IN OUR INVESTIGATIONS.

WE MUST NOT FORGET THAT HE HAS WORKED IN THE MILITARY INTELLIGENCE SERVICES OF THE U.S. ARMY, AT THE HIGHEST LEVEL, AND THAT AS A GENERAL RULE THOSE CONNECTED WITH BRANCHES OF DEFENCE AND GOVERNMENTAL SECURITY DO CONTINUE TO MAINTAIN VERY CLOSE LINKS WITH THOSE SERVICES. EVEN WHEN THEY HAVE RETIRED, THEY TEND TO MAINTAIN VERY POWERFUL LINKS OF LOYALTY TOWARDS THEM. WHICH, OF COURSE, IS LOGICAL, AND IN NO WAY WHATEVER ARE WE CRITICISING THIS.

THAT HAS BEEN THEIR LIFE, AND THEY FEEL THE PATRIOTIC DUTY TO CONTINUE. BUT PRECISELY BECAUSE OF THIS WE MUST TAKE MUCH CARE WHEN WE ARE APPROACHED BY INDIVIDUALS WHO HAVE BEEN CONNECTED WITH THOSE SERVICES - THOSE VERY SAME SERVICES, REMEMBER, THAT FOR OVER FIFTY YEARS PAST HAVE BEEN COVERING UP OVER THE UFOS AND DISINFORMING THE UFO INVESTIGATORS COMMUNITY AND THE PUBLIC IN GENERAL AS TO THE REALITY OF THE MATTER.

All the same, we must also say that, as we have been talking with him, we have had the feeling that “Don Ernesto” was very, very sincere, as displayed both in his feelings and in his words, regarding everything that he claimed to have seen and to have experienced thanks to his alleged membership in the Special Unit of the U.S. Armed Forces involved with the UFO question.

Furthermore, it is important to note that, at the moment when he first contacted us, “Don Ernesto” told us *certain other things* when he was describing the creatures allegedly seen by him in 1960 at that installation at Roswell -things we already *privately* knew from our own investigations of the EBs on Puerto Rico, *but which were not known at all to the general public*. Among these things we can mention the following:-

1) *The semi-humanoid form of the bodies, with oval-shaped heads, almost imperceptible nose, and the skin*

*covered with reddish-brown coloured down.*

2) *The description of the red “Chinesey” ( i.e. oriental ) eyes, and how they turn black or red according to the amount of light.*

3) *His description of the short arms, and the hands ending in claws.*

4) *His description of the creatures’ feet. “ like the feet of a kangaroo, but not quite identical ”, with their knees “bent back” like the legs of a fowl, and how the feet looked longer when stretched out.*

5) *His description of the long pointed “tongues” that shot in and out of their mouths rapidly like tongues of snakes, and his mention of the tiny orifice at the end of the tongue through which they drew air or blew out something. This was something that we had till then known, but kept secret. It had been mentioned to us by various serious and reliable workers in Puerto Rico. This particular feature is especially important, seeing that he had no way whatever of knowing about such a detail unless he had actually seen it himself. This proved to us that he had indeed had some connection to a Federal Government Agency with knowledge of all that is going on.*

AS OF NOW IT IS THEREFORE OUR BELIEF THAT THIS INFORMANT HAD INDEED BEEN, AS HE CLAIMS, A MEMBER OF THAT SPECIAL UNIT, AND THAT WE CAN TRUST HIS STATEMENTS, ESPECIALLY AS WE HAVE SINCE GOT TO KNOW HIM MUCH MORE CLOSELY, AS WELL AS MEMBERS OF HIS FAMILY.

AND BEFORE I TERMINATE THIS ARTICLE I MUST ADD THAT THIS INFORMANT HAS ALSO GIVEN US OTHER REPORTS OF GREAT VALUE THAT CORROBORATE MATERIAL ALREADY RECEIVED BY US VIA OTHER CHANNELS, AND CONCERNING YET OTHER GOVERNMENTAL AGENCIES INVOLVED WITH RECOVERY OF CRASHED UFOS AND CAPTURED ENTITIES.

THESE FURTHER REPORTS WILL BE DISCUSSED IN OUR NEXT ISSUES, TOGETHER WITH STILL MORE REPORTS GIVEN TO US BY YET FURTHER EX-MEMBERS OF THE U.S. ARMED FORCES -DIRECT EYEWITNESSES, WHO HAVE SHOWN CLEARLY THAT THE U.S. GOVERNMENT, AND MORE PARTICULARLY ITS MILITARY AND INTELLIGENCE AGENCIES, ARE INDEED WELL AWARE OF THE REAL EXISTENCE OF THE “ANOMALOUS BIOLOGICAL ENTITIES”, AND OF THEIR PREVIOUS PRESENCE IN SUCH COUNTRIES AS PANAMA. WE URGE YOU NOT TO MISS OUR NEXT ISSUE OF *EVIDENCIA OVNI!* -J.M.

## GROOM LAKE AND ANTI-GRAVITY: AN ANSWER TO DR PIERRE GUÉRIN.

[Dear Gordon: Here is my response to Pierre. I am sending him a copy of this text. With warm regards, Jacques.]

Few subjects have struck the public imagination in recent years with as much power as the possible presence of extraterrestrial craft at the Nevada test sites. The suggestion has been made repeatedly that captured UFOs had been reverse-engineered and were being tested at Groom Lake.

In my book *Revelations* I mentioned my reasons for being skeptical of this idea. In the course of my research I had spoken at length to those who had originated the story, notably John Lear, William Cooper and Robert Lazar, and found their data unconvincing. I also visited the area around the site.

Until Dr. Guérin raised the question again I had no intention of expanding on what I had published, or to respond at length in print to those who questioned my position, which they certainly have every right to do. However I must make an exception for Dr. Guérin, in view of our long friendship and my regards for FSR, which published his article on the subject (*The U.S. Air Force, Antigravitation and UFOs*. Summer 98 Vol, 43/2, pp.2-7)

At the outset it should be clear that Dr. Guérin and I have quite similar views about the current state of physics, and agree on the fact that many laboratories, including military facilities in the U. S., are working on advanced propulsion and antigravity. Some of these laboratories are known to have systematically gathered information from UFO witnesses in support of secret projects to inform such research.

I believe we would also agree that military authorities (not only in the U.S. but also in France, Great Britain and Russia) are abusing the standards of secrecy by refusing to release all the data they have about UFOs, which should be open to science. Every government, it seems, has a high-priority, deeply classified interest in "our subject."

Where I differ from Dr. Guérin is in the interpretation of rumors surrounding Groom Lake, the actual observations of objects flying over the base, and specifically his belief that objects seen at Groom Lake can *only* be powered by antigravity and therefore are of alien origin or inspiration.

I am surprised to read that Dr. Guérin accuses me of being "anxious to ridicule those who believe in the existence of a great subterranean base" underneath Groom Lake, when I ask the question, "who takes out the garbage?" That quote is taken out of context from a section in *Revelations* which relates a long interview I had with William Cooper.

The specific subterranean base we were discussing was not Groom Lake but a different site, allegedly located near Dulce, in New Mexico. It was not even supposed to be guarded because "that would only attract attention", Cooper assured me. As my enquiries about Dulce have confirmed (I went to New Mexico, spoke to people who had flown over the site and I saw many aerial photographs), any sizeable construction project on the Indian reservation there would have been clearly visible.

In contrast, underground facilities are known to exist at the Nevada sites, if only to shelter computers from desert temperatures, and they are very heavily guarded. I never said anything different.

More to the point, Dr. Guérin goes on to ask me, "With what power source and what mode of propulsion can those silent drones that you describe to us be flying?" He has considered in turn -and eliminated- known forms of propulsion, namely (i) rocket engines, (ii) turbines and (iii) MHD. I cannot fault his analysis on this basis.

However I believe there are interpretations for what is seen and filmed in Nevada that do not involve antigravity or alien intervention. One such interpretation would center on a new generation of devices that do not carry their own power source and are therefore capable of high acceleration and extreme maneuverability.

In its issue of 17 February 1996 the British magazine *New Scientist*, hardly a classified publication, carried a cover story entitled "Forget aerodynamics -anything can fly." The article by Mike Ross had as a subtitle: "Hypersonic flying saucers driven by microwaves: not science fantasy but the goal of serious researchers in the U.S."

In a classical application of current physical concepts, scientists Leik Myrabo and Yuri Raizer at Rensselaer Polytechnic Institute in New York State have researched ways of controlling air flow around a craft by directing an energy beam at it, either in the form of microwaves or lasers, creating an "air spike." Their initial work was sponsored by the Space Studies Institute in Princeton, New Jersey.

Since the early days of the "Star Wars" project other groups around the world are known to have experimented with various vehicles powered from the ground, from aircraft or from satellites with directed energy beams. Such devices would meet the



criteria required by Dr. Guérin, yet they would remain within the standards of known physics.

My guess is that observers around Groom Lake have been seeing advanced platforms using such powered beam propulsion rather than any of the three conventional power sources listed by Dr. Guérin. Given the notoriously unreliable nature of the sources for the "Alien presence" stories at Groom Lake, I regard these rumors as a form of disinformation deliberately planted to discredit anyone observing secret tests of the new platforms, and as a distraction from the main problem ufologists should be researching.

To me, that main problem concerns the nature and origin of the objects described to us by reliable witnesses who provide us with verifiable, first-hand data, including actual physical samples in some cases. In his classic field work at

Valensole and other sites, Dr. Guérin has inspired us to pursue this research.

One last comment about Groom Lake: The Nevada base, with its very long runway used by over a dozen different military and intelligence agencies and their contractors, is designed to test platforms that require enormous airspace for telemetry, combat simulation and training. These do not seem to be the conditions under which one would need to experiment with reverse-engineered antigravity systems.

Given the large number of truly secret facilities available around the world, it would seem odd for the U.S. military to test an antigravitation device at such a site, especially if it was derived from alien technology where strict compartmentalisation was required.■

## MY REPLY TO JACQUES VALLÉE.

I am extremely sorry over my confusion of Groom Lake and Dulce in connection with the subject of the "collection of garbage"! I can't understand how it was that I misinterpreted in this fashion the reference given by Dr Vallée in his book *Revelations*, and I ask him to accept my apologies.

But now I come to the root of the argument. Dr Vallée cites state-of-the-art American technical research aimed at reducing air-resistance to hypersonic speeds by means of powerful laser beams discharged in front of a craft so as to create a trough. (See footnote 1) If the craft is very light it then becomes capable not only of great speeds, but also of very powerful accelerations, and it could easily be taken for a "UFO".

First of all I will point out that, in his book *Revelations*, in order to explain what has been observed over Groom Lake, Dr Vallée had suggested the idea of *drones* (tele-controlled observation platforms), which have in fact long been in use by the American Armed Forces. I had opposed that explanation, which did not account for the facts of the situation. Now, however, Dr Vallée seems to have renounced on the theory of *drones*, and is invoking technologies of a more revolutionary nature.

But the *New Scientist* article that he quotes in support of his statements dates from 1996. And at that time -1996- according to the author of the article- the research into the employment of lasers to reduce air-resistance was only at the stage of wind-tunnel tests. Even if in other U.S. laboratories they may at that time already have been further advanced, it is difficult to believe that such advance could have been of more than just a few years at the very most.

*But the "UFOs" seen over Groom Lake had been in the news for much longer than that. In other words, in order to explain those sightings over Groom Lake, Dr Vallée is invoking machines that are only NOW possibly starting to fly.*

But there is more to it than that! The power that is driving such craft is *not laser power*. Laser power is merely aiding them to penetrate into the atmosphere. And at once we find ourselves confronting the question of the very nature of the propulsion system involved, *which has got*

*to be silent, and has got to explain the sightings.*

I recently saw, here in France, a video cassette that is on sale commercially, and that, in particular, contains two film footages taken by amateurs and showing -against a terrestrial background with identifiable landmarks- the movements of two types of craft that have been observed over Groom Lake.

In the first of these two films you see an object with a forward-and-backward motion that is absolutely extraordinary, with no apparent inertia whatsoever. And the object's accelerations, at the moments in its course where it reverses direction, are virtually infinite.

In the second of the two films you see two objects performing circuitous weaving movements at apparently infrasonic speeds. At one moment one of the objects, having passed in front of a hill and then climbed again into the sky, *vanishes on the spot, and then reappears instantaneously at a considerable distance from its previous 'position', seemingly without having followed a trajectory between the two points.*

*These are well-known and frequently described features of the movements of "real UFOs". Classical physics cannot explain them.*

### NOTES BY TRANSLATOR:

1) An "air-spike" is the term used by Dr Vallée, as well as by the aerospace scientist Leik Myrabo of Rensselaer Polytechnic Institute in New York, and by the plasma physicist Yuri Raizer of the Moscow Institute for Problems in Mechanics, who were the two pioneers that, in 1993, with funding from the Space Studies Institute at Princeton University, did the original research into how an "air-spike" could be made to work.

2) I have just located another relevant, recent *New Scientist* article. See "On Wings of Light", *New Scientist*, 10th January 1998, page 34. It describes how tiny, fuel-less spacecraft could be launched, powered by a powerful laser beam which causes "air detonation" in a focussing chamber at the base of the craft. This is also the work of Myrabo et. al. -Philip Creighton.■

# THE FARMER AND THE REVEREND

## -ALIEN ENCOUNTERS FROM MY CASE LIST

I have chosen two cases, each of a different nature, showing the great complexity of the abduction syndrome. I am certain you will encounter some surprises and as a result will be much better informed on such matters.

I cannot give the true names or locations of these persons, for that would be a terrible dis-service to those who trust me. I regret to tell you that it is not socially acceptable to be an abductee or, for that matter, even an investigator-researcher of them! The attitudes of many people, especially in the academic, media, and religious fields of life, are deplorable. Sometimes one's own home-folks can become one's foes.

Born of ignorance, this opposition can be subtle or emotionally hostile. Were it not for the fact that I am often a valuable help to some bewildered souls in the throes of the Aliens, I would phase myself out of this business.

There are two polarities in the experience of abduction. I'll call one the fear/despair pole, and the other the euphoric/trusting pole. Some persons have alternated from infatuation to wanting to wring the Aliens' skinny necks. The outrageous aspects of this immoral, lawless, activity are by nature all-pervading.

It is these frightening acts of temporary kidnapping and child molestation, to name a few, that would, if Government lost control, send humanity into an abyss of terror and near-collapse. A positive experience does exist for some abductees, but it is often tinged with a degree of helpless resignation and apprehension. In cases 4 and 90 you will see each extremes demonstrated.

First, I want to mention briefly a few other cases, 101 to 103, on which I am now working, in order to give you an idea of the great range of experience encountered in this phenomenon.

In Case 102 I am attempting an analysis requested by the subject, of her extensive experiences. I "have my work cut out", for in her case we have; (A) A lifetime "Grey" mentor who has even taken her on underground trips. (B) Tall Caucasian-looking guardians provided for a non-altered state daylight trip. (C) An abductee who is a temporary foetus - incubation source producing some 25 hybrids.

In Case 101 the abductee says, "Life is just terror. I know when they are coming and I fear the night. I don't know how my heart holds up." I have been able to help this lady.

In Case No. 94 there is lifetime contact with the Nordic types. She is also familiar with the Grey types, who she calls the Zetas, and she has been on board their craft, where she viewed ordinary humans and halflings (alien/human) in a park-like atmosphere. My last word from her was not good. She said, "I have been suffering great anxiety as a result of some of my experiences. Not so much from the ETs, but from the other guys who get me to find out what the ETs are doing. I feel very "caught in the middle", and am having a lot of medical anomalies, causing me to be hospitalized."

The last word from Case 97 was not good either. It was a call from his brother telling me that my Anderson (Indiana) abductee was in the hospital for medical observation. It was no surprise, for the adolescent-type Nordics were simply abducting this man too much, disrupting his life and ruining his health. I knew that if he spoke any of the Sanskrit-like languages that his nocturnal companions had been teaching him he would be in trouble. (Sanskrit was the language of ancient Gods of India who flew in wondrous aerial craft.)

### CASE 4: FARMER JOEL PARKER (EXAMPLE OF FEAR/DESPAIR)

Few know about this stark drama which took place on a southern Illinois farm. At 4.30 am one day in June 1974, Alan Parker, enroute to the bathroom, looked out and saw a large fiery craft take off from his soya-bean field. Close by was the bedroom where his son Joel was sleeping. Next day, Joel wondered why his socks (he had slept with them on), were wet and dirty. Soon after that, his mother had to take him to a doctor for a bladder infection, and for examination of a small hard knot on the rear underside of his penis.

A few years later, the Parkers moved to another house, on the same farm. The new tenants in the old house quickly moved out however, saying that they had been visited by some "scary ghosts" who appeared at their bedsides and stared at them. These were diminutive big-headed ghosts with large black eyes.

*On a spring day in 1986, Joel pushed on a festered place near the knot on his penis, and out popped a wafer-thin, round, blue-grey, hard, object. Not realizing its significance, he threw it in a trash can.*

Several months later, as the family were standing in their yard, a silver disc zipped from the old house, hovered overhead, then vanished upwards. The family remained as unsuspecting as ever. Then, one dark September evening, something began to pound on a metal silo behind the house. Joel grabbed his rifle and slowly approached the site. In the dim light he spotted a strange figure crouching on the peak of the roof. It quickly vanished, but he took a wild shot and fled back to the house.

His sighting of this strange being began to trigger latent and forgotten scenes in the mind of Joel. In the following months bits and pieces of what had happened on that eerie night 12 years before began to enter his conscious mind. During that moonlit summer night he had awakened and found himself partially paralyzed, but was able to raise himself up on his elbows and see the entities approaching.

Moonlight and shadows played across their moving figures, and he could see their big heads, grey-white skin, and their blue clothing. After a Grey had arrived at each side of his bed one of them reached out and touched Joel on the shoulder. It was as he says "just like getting a shot of Novacain." The phantom-like creatures communicated with him mentally, and knew what he was thinking. They



took him outside, and in the yard he and his unreal escort passed by the four family dogs, all laid out immobile.

The party entered a white compartment in a grey-coloured craft sitting on legs in the field. Pulsating soft lights, in a rainbow of colours, filled the cold chamber. The facial expressions of the five Greys around him never changed, but the mean tone of their commands were very clear. Joel tried to resist but was quickly laid out naked on a grey metal table.

After they had taken a hair-sample, a tube was inserted up his rectum. One taller being stood, across the room, watching while the others seemed to get excited about the tube business judging from their actions. When speaking to us of his ordeal on the craft Joel shows complete revulsion and hate. Next a shiny metal tube was moved around inside his mouth. Then something was threaded into his penis. Next he heard a mechanical sucking sound.

As Joel recalled further details his recollection of the features of the Greys became clear. They looked "like an eight-month old foetus with a long thin neck." Their eyes were very large, without pupils, and they had tiny pointed ears. The tight-fitting suit had a turtle neck and a white stripe around it. The beings moved around in a jerky faster-than-human fashion.

In the years 1987 and 1988 a bright chrome-coloured elliptical object was often in the area. Joel began to get messages in his head from it. This was not an external voice, but instant telepathic knowledge received by him. These intrusions into his brain would sometimes be threatening, sometimes taunting, and sometimes reasonable.

One time the aliens said, "We have a jewel here, that you would really love to see!" Intimating, of course, that they had a creation there that was part of Joel himself. In one mental exchange Joel learned that he was part of a special project. One night when he was alone, out on the road, the golden-orange object appeared in the sky again. Because of the despicable things that they had done to him sheer hate overrode his fear. He jumped out of the car and shaking his fist at the UFO shouted, "You extraterrestrial bastards!" The family ceased to go to town after dark.

One March evening Joel began to get again the weird feeling that their presence always caused in him. Looking out the window toward the area visible in the fading light, he saw three of the beings moving over the ground in a trooper-like row. By the time he rushed outside they were gone but he fired three shots in their direction anyway.

On another occasion two pulsations of a thin light beam came in through the window, missing him, flashing down the hall, putting out a table lamp, and sending the family's cat off for parts unknown. Darkness brought great apprehension. They lived a nightmare, fear was stalking them. They sealed up every opening in the house. On yet another occasion the face of one of their tormentors appeared in a hall-window which they had forgotten to cover. This face too vanished before Joel could shoot.

During my contact with the family, I found them to be in a state of distress, Joel angry, often despondent. He wanted to "blow the heads off" those who were doing this to him and his loved ones. The near ruination of one's life

in such a fashion is so cruel and unjust.

It was apparent that Joel had been "picked on" by the kind of aliens who were "bad". It was true that they might not be actual devils, and were simply engaged in activities important to them, but their ruthless nature could evoke only one human reaction. Joel hoped that I, because of my experience and knowledge, would be able to help him.

*I tried, without success, to get him to try the cross-and-prayer method against those who so spitefully used him. I urged him to wear a crucifix, and at twilight to read appropriate Bible verses and above all to pray. This effort failed however, possibly because the tormented victim lacked a sufficient depth of Christian commitment to adhere faithfully to this advice.*

#### **CASE 90: REVEREND DAVID ADAMS (EXAMPLE OF EUPHORIC/TRUSTING)**

This brilliant, exceptional, pastor possesses a number of University degrees, including those in Philosophy and Medicine, and has had many years of successful leadership experience. He carries the title "Most High" in his own religious Order.

When I first met the Reverend, I thought he must be a poor bewildered preacher having problems with abduction. After months of time spent on him and a very thick file of data, I knew that such was certainly not the truth. I learned that many in his religious group, which numbers in the hundreds of thousands in Canada and the northern European countries, are entirely familiar with the type of alien whom we call the "Nordic" or "the Blond".

These tall, human-like, usually long blond-haired, attractive, beings often project an aura of serenity and love. The Reverend estimated that over 45 years, he had seen these "non-Terrians" as he called them, or had had extended periods of lost time, on about 300 occasions.

And one special "Nordic" called "*Gold*," because of the golden sheen of its eyes, has been involved with Reverend David Adams since he was a baby in northern Europe! This beautiful male figure, who dresses in scintillating body-suits, and who has striking eyes that change colour with emotion, has been his capable protector and guide in this life. For this fortunate man the arrangement has been wonderful and beneficial on the whole! (However that does not mean that all is well, and that there are not certain trying conditions present).

First I want to acquaint you with the intimate nature of the association, and David's description of his "Nordic" friend. The Reverend said, "You have asked me more than once about whether "*Gold*" respirates. You bet! I have had my head against his chest more times than I can recount. Not only have I heard breathing but also noted the rising of the chest. When "*Gold*" touches me, whether in the clinical treatment or otherwise, it is as though there is a palpable emanation of energy incorporate with his touch. He says: "You get a surge of something that courses through your entire body." "*Gold*" has body-odour. The best description that I can tell you is that it makes me think of citric acid. "*Gold's*" outfit is all in one piece, right down to the shoes. Once he has activated the openings of the front-closure, the suit peels off him, developing 'splits' in the fabric which extend down the front of his legs and finally to the feet. It still makes me think of mylar."

"Gold's" facial structure is clean of line, more fasciated than most of ours. I'm still trying to figure out why they have nipples. Theirs are different from ours only in that the aureoles are not bumpy-rugated like ours. His eyes do indeed blink. And I've not seen any obese *non-Terrians*. Of the few that I have seen totally naked, all have possessed complete genitals. The testicular mass seems to ride up higher than in human males. Most are slender, averaging something like 7 1/2 ft. in height, yet some appear massively muscular. They have hair on the head only, and it appears thick, with hues ranging in the golden, bronze, and sometimes orange."

In the times when David and the others around him have been abducted, he refers to the vague places where they have been taken. When there is a visible floor, it appears to be akin to what we know as ceramics. It's seamless, and ranges in colour from bone-white to cream. It looks hard, but anything dropped on it gives no loud report. "While there have to be walls, they are just hazy to me. I've seen half-walls and been led down corridors, yet the walls are hazy. You asked about ceilings. Here too it's hazy, but they have equipment hanging suspended from them and this is clearly seen. Furniture like that found in human living rooms? Nope! Yet there are benches that apparently are just hanging freely in the air. *I have a journal-entry here that tells me that the hard benches can become conformed to human buttocks shape and somehow softer.*

"You want to know about a toilet aboard those places of indistinction? Yeh! There have been times when I had to go, and wasn't hooked up to some gizmo that'd suck it out of me. Reminds me of an Asian toilet. You squat if you're defaecating, over the hole-like spot, and there is some suction to it, so that our excrement goes whooshing into the hole. And yes, I've seen *non-Terrians* entering and exiting from the self-same cubicles, albeit not in the act of using the toilets."

Yet in spite of being "Gold's" own special one, you can sense that this kindly man David Adams at times would like to be normal and above all be free. Far too often he will awaken, and find that something has been done to his genital parts. There will be a bloody tee-shirt and sheet in the vicinity of his groin. Often he will have to suffer testicular, prostatic or urethral damage. On one occasion he thwarted the alien plans, when he first moved a finger then grabbed the bed railing in flight. One would think the aliens could do a cleaner job at sperm-taking. The Reverend describes a type of steely-eyed, short furry workers, who he calls the "*Teckies*", who do the physical procedures. Ordinary "*Nordics*" will not stoop to that most of the time.

It is interesting to note that in contacts between the groups of "*Nordics*" and his rural colony (deep forest dwellers), no UFOs appear to be present, although we know that "*Nordics*" and UFOs are associated elsewhere. Also for some reason the Grey-type aliens seem to be excluded from these northern "*Nordic*" territories, or in cases where these religious sect members are taken in the United States.

No UFOs were mentioned when a group who were hiking in Glacier National Park in Montana approached a geological feature called "The Garden Wall", and then found themselves five miles beyond this wall with hours of time missing and no memory of having traversed that space.

In 1963, in the Icelandic State Park in North Dakota, a party of seven boys saw no UFO, but only recovered normal consciousness next day.

In 1965, on an island on the Wisconsin River, seven more boys were taken in a similar manner. Then, in 1995, 11 boys on a float trip in northern Maine were hit by a beam of blue light as they slept around the glowing embers of their camp fire. Able only to breathe and move their eyes, they were all drawn up, sleeping bags and all towards the source of the blue light. All of these episodes involved concentrated focus on the male sexual system and on that spark of life, the sperm.

Here, in the Reverend's own accurate words, is his description of the *Nordics*' most astonishing broad daylight appearance among his community.

"If memory serves me right it was in late August 1987. Just about all of our Brethren who would be participating in the most-telling ritual were out on the landscape. That would make about 400 men, women, and children, plus several hundred animals.

"The aliens appeared just as we were commencing our march to our most holy place. One second they were not there, and the next second they were. Of the few Brethren facing in the direction in which they appeared the word was that, just prior to the arrival of the *non-Terrians*, there was to be seen a rippling in the air, not unlike that of heat. A most abrupt silence descended on the Brethren when they realized just who had joined our party.

"It was five *Nordics*, led by my 'buddy' "*Gold*". Only he was observably masculine. The others were of the non-gender variety as far as we could determine. As chief functionary I approached "*Gold*". He said mentally that they wished to witness our ritual. They hung around for the entire procedures, then went back to the spot where they had appeared, before departing in the same manner."

One is constrained to wonder about the nature of these wondrous beings!. Are they truly flesh while here? All indications seem to indicate so. Long-time detailed observation and intimate physical contact attest to that. Yet they are also ethereal and soon vanish back into nothingness. Back to their own eternal state, whatever and wherever that is. Are they glorious spirit beings when there? Surely flesh cannot exist there! Because of the acts that they perform we certainly cannot classify them as Angels! (At least not by our scriptural moral code!) And where is their home? If we go by the testimony of the Reverend, their home is in the sky. They do, however seem quite cognisant of what is going on on Earth, and pop in at any time!

In this article I have given you a look at two totally dis-similar cases. In one we had the heartless "*Greys*" who without compassion accomplished their aims and even taunted and harassed the victim along the way. In the other case we had the smiling beautiful "*Nordics*" who however, in their fashion, did accomplish just the same sperm-removal as the "*Greys*" did. Specifically in the most high Reverend's drama, we see him in close lifetime union with a powerful mentor, "*Gold*", achieving many wonderful things all the while and protected from harm (no injuries in two plane-crashes) and with his religious status and position of great influence quite unimpaired.■



# COL. CORSO SWORE ON OATH THAT HE HAD SEEN ALIENS. By Gordon Creighton.

As our readers will probably know, Col. Philip J. Corso passed on, after a heart attack, at his home in Florida, on July 16th of this year. He was aged 83.

A most highly decorated American Army Officer, recipient of 30 medals and commendations in his long military career, he was particularly proud of the award of *Knight Officer Crown of Italy* for his exceptional service in Italy (the land of his forefathers) during and after World War II. He had played a great role as one of the allied military administrators of Italy, following the fall of Mussolini.

According to MUFON JOURNAL for July 1998, we learn that CAUS (CITIZENS AGAINST UFO SECRECY, INC.) has announced that Colonel Corso had sworn under

oath as to the truthfulness of statements already made by him in his best-selling book, *THE DAY AFTER ROSWELL*. (1997), to the effect that he himself had seen alien bodies in July 1947, and that in 1961 he had had the opportunity to read the autopsy reports on them.

CAUS informs us that they now intend to use Colonel Corso's statements about having seen alien corpses in their own lawsuit against the Department of the Army. In this lawsuit, filed in the U.S. District Court at Phoenix, Arizona, CAUS is asking the Federal Court to direct the U.S. Army to provide to CAUS's attorney Peter A. Gersten "any and all documents relevant to what Colonel Corso said he had seen and read." G.C.■

## MICHAEL LINDEMANN'S INTERVIEW WITH COLONEL PHILIP CORSO. By Gordon Creighton.

We understand that, not long before Colonel Philip Corso departed from this life, he granted an exclusive interview to the highly influential U.S. journalist and researcher Mr. Michael Lindemann, Director of the C.N.I. News.

*As will be seen, Colonel Corso is reported by Lindemann as having definitely asserted that there are alien entities who possess the capacity of controlling and operating their craft purely by mental power.*

(This is something which I first saw mentioned in connection with alien encounters in Mexico so long ago as 1965. See Case No. 54 in my article in *The Humanoids* (1966).

I recently received confirmation of Colonel Corso's assertion from yet another quarter - namely FSR Consultant Desmond Leslie, who (if I recall it correctly) said he had two discussions with Colonel Corso this year and that the Colonel had told him precisely the same thing about *alien "thought-power."*

(Maybe it is therefore not at all surprising if we hear that the heretical engineer Dr. Robert Jahn got "demoted" at Princeton University for having asserted that the human mind can influence machinery! G.C.)

### THE INTERVIEW.

Mr. Michael Lindemann, Director of the C.N.I. News, interviewed Colonel Philip J. Corso and his son, Philip Corso Jr. Mr. William Birnes, co-author with Col. Corso of the book *THE DAY AFTER ROSWELL*, was also present.

Discussing his experiences in World War II the Colonel particularly mentioned his own important role as one of the Allies' military administrators in Italy, during the course of which, inter alia, he oversaw the rescue of 10,000 Jewish refugees from Italy and their transfer to Israel. Likewise mentioned was his important role as an administrator in bringing home the U.S. forces from the Korean War.

On the UFO Problem, the Col. remarked "*Maybe we (i.e. he and his superior officer General Trudeau) altered the course of History. The statements that I am making today will affect the future of all mankind. We are old now, and soon we shall be gone. So it is therefore of great importance that the young shall know what happened, where it all began, and know that the events really did occur. They - the young - have got to know, because they are the only ones who eventually will be affected by it all. Thinking it all over carefully, I reckon it was the best job I ever did.*"

*[This is enigmatic talk. Col. Corso is clearly hinting at the fact that, with the aid of alien technology, the USA was able to defeat the Marxist tyranny of the USSR. G.C.]*

**LINDEMANN:** "And, where is it all leading us to? In your book you hint that hostile forces exist."

**CORSO:** "When you're in the Military you always have to keep the hostility angle in mind. The watchword is 'Be prepared if necessary'. The Pentagon Department in which it all began was the R. and D. - Research and Development - it was the start of a new era in History. It's amazing what mankind has been able to achieve in such a short time thanks to the little chip. I asked General Trudeau once what he thought we were letting loose on the world, and I remember that he said: 'Phil, let us hope people will understand what we are doing. But maybe that won't be in our time. Sadly, he didn't live to see it himself, and he died three years ago'."

**LINDEMANN:** "Does all this mean that we are now all set to build machines like the one found at Roswell?"

**CORSO:** "At present, no. I think we will be, in future. It's mainly because we don't understand much about their

systems of propulsion and steerage. Years ago we already reached a conclusion, and we now are receiving the support of the scientists. *But the reason why we don't understand is due to the fact that the extraterrestrial himself is the drive-system.* One day I was chatting with General Trudeau and I said to him: 'I think my son is half-crazy. He says the flying machines talk to him.' Then the General replied: *"Don't you ever say that again! Certain individuals do have a certain relationship with their craft that we don't understand"*.

**LINDEMANN:** "Were you aware that the U.S. public were anxious to have access to that information?"

**CORSO:** "Clearly. I have a nephew who is the director of investigations at a university, and he was always writing letters to me requesting that the truth be revealed. *'We aren't going to tear our hair out or start panicking. We simply want to know'*, he said. And as I am always saying, this is the young folks' era. They aren't going to be afraid of knowing the truth. That Orson Welles programme of 1938 (*"The War of the Worlds"*) scared a lot of people. *It won't be like that this time*".

**LINDEMANN:** "How did your work develop?"

**CORSO:** "We prepared people for war, so that they would not panic, would not run, and would not be scared, and would be able to struggle against the most powerful forces the world had ever seen, and could beat them".

**LINDEMANN:** "Is mankind near to knowing the truth?"

**CORSO:** "We ought to have known it a long time ago."

**LINDEMANN:** "Did you have to violate any personal promise or oath of the Armed Forces of your country in order to be able to make the statements that you have made?"

**CORSO:** "No. the only promise I had made was to the General. And I kept it till his death, because I considered him an honourable and an honest man. During the 35 years that I was a military officer I violated no order and my conscience is clear. I was the only officer invested with the power to detain persons who violated the law. I have made no revelations that were prejudicial to the nation or that ought to have remained secret."

**LINDEMANN:** "There are speculations and rumours in the world's ufological community that the Roswell material seen by you might not have been undergoing investigation for the first time. Are there in fact indications that the Nazis could have achieved their own technological development in the same fashion? What is your view about **that** ?

**CORSO:** "It may be true. I had German scientists in my team. I discussed this point with them. I discussed with Oberth, and with von Braun - he (von Braun) was in *Project Grampo*, along with General Trudeau. In my book I have

a photo of the expert Sovietologist Edward O'Connor - one of General Trudeau's best friends - and it also shows myself and Victor Fediay. Fediay travelled around in Russia, where he asked a series of questions. Through Fediay I had put several questions about UFOs to a KGB General. And when Fediay returned from Russia, he said to me: *'Phil - I put that question to him. And he replied that, if he gave me the information I wanted, he would be a dead man. So it's the Russians and the Germans who are concerned.'*

**LINDEMANN:** "And those countries possess the technology?"

**CORSO:** "I don't think so. The Canadians and the English (sic) also have it, and so do some Italians. They don't know how the propulsion system works. They did lots of experiments with flying saucers, and one of the machines reached an altitude of 4,000 metres, but they don't know the system of steering. *In R & D we made a start by understanding that the aliens themselves are part of the steering system [by means of telepathic linkage.]*"

**LINDEMANN:** "Do you think, then, that in order to perfect our capacity for interstellar travel we will have to develop a similar means for our own space-craft?"

**CORSO:** "Man cannot at present travel in Space. And those clones [Corso considers that the alien bodies recovered from the debris of the craft at Roswell were genetically produced clones] were created specifically for that purpose. Our own muscles, bones, and brain, would never be able to withstand such a journey."

**LINDEMANN:** "But will we be able to do it soon?"

**CORSO:** "When the astronauts go up to the *Mir* space-station they remain there about three months, and when they return they need medical attention. Their bones cannot support the weight of their bodies. If they went beyond that time, they would be unable to walk. But the most important feature of all is that their brains are also affected as a result."

**LINDEMANN:** "What was it that happened over the foreword to your book - the foreword written by Senator Strom Thurmond? Finally he said that he had not known the real contents of the book when he wrote his introduction. The publishers, Simon & Schuster, have already published a formal apology saying that the foreword would be withdrawn from future editions. What sort of deal did your lawyers make with the Senator?"

**CORSO:** "I have known Senator Strom Thurmond for a long time. He is a very honest, sincere man, and a courageous one. I recently discovered that it was his staff who took that attitude. I had talked with the Senator about the presence of extraterrestrial beings and their craft on this Planet. He gave me a copy of *Project Horizon*. A week later I received two handwritten pages from the Senator but also an authorization from him for the



publishers to publish it.”

**LINDEMANN:** “Bill Birnes told me that he had the impression that Thurmond and his team were being ‘pressured’ by someone ‘up above’ to keep out of all of this. Can you say anything about that?”

**BIRNES:** “That is what I heard. The team were not entirely

*au courant* with the agreement between the Colonel and the Senator, inasmuch as it was an arrangement between friends and not between businessmen. No step could be taken without the team being consulted. And, given the circumstances, it was clear that they would not interfere. And so it came about that when it got known that the foreword had been written by the Senator, *the team put a stop to it, claiming that the book could not appear with a statement in it to the effect that the Government of the United States had used alien technology to win the Cold War.*

**LINDEMANN:** “According to your book, you spent most of the time working with the remains of the Roswell incident. But what happened to the aliens who were recovered? What is the situation of the extraterrestrials today? What is your viewpoint regarding the motive for their presence here, should there in fact already be any alien being on the Earth?”

**CORSO:** “I have no knowledge of the existence of any extraterrestrial on our Planet. There are, clearly, reports of flying saucers, but I don’t know of anyone who has seen any alien being’s body - and particularly not recently”. ■

### MISS MF's STORY.

The incident took place on the 3rd of July 1996 in a village called Bilton near Harrogate, North Yorkshire. Miss MF (32) had finished an early shift at her place of work and

as it was a nice sunny day, she decided to take a walk and into the nearby countryside. As she walked along she came across a pleasant looking field and, finding a comfortable spot, sat down to read a book, the time was 9.45am.

It was sunny and warm as Miss MF sat quietly reading, then quite suddenly she was aware of a large shadow moving over her. She looked up and was astonished to see a large black triangular craft overhead. It was twice the size of an aircraft and had a white light at each corner, and hovered over her.

“I was amazed at the size of it, and also the fact that there was no noise. In the quiet of the countryside, there should have been a noise from it, but there was nothing, and that unnerved me. There were three lights on the triangle, but there were also other lights near it, which kept on flashing away”, commented Miss MF.

Then suddenly a beam of blue light shot down from the FT and covered her. “The next thing, I felt that I was going upwards, very, very fast and I felt really sick. My nose was hurting and I’m scared of heights, I couldn’t see anything, I was going up so fast and just seemed to black out.”

“The next moment, I was in a strange building, everything was very bright white, so bright I couldn’t see anything, and there was a funny smell to it. I couldn’t see much, because it was so white. I felt that I was laid on something, but I don’t know what it was.”

Miss MF then went on reluctantly to describe what happened next, there were strange small ‘beings’ around her and they were doing something down near her legs,

but she couldn't see or feel anything. She went on to say: "I know that people see these drawings of Aliens on T-shirts and things, but these weren't like that. They had black eyes, there was no whites to their eyes, they had no eyebrows, no eyelashes, no cheekbones, no ears, no mouth or any facial hair or anything similar to our skin. It was just one skin tone, a translucent white, I couldn't see any pores, any hair or any bone or anything."

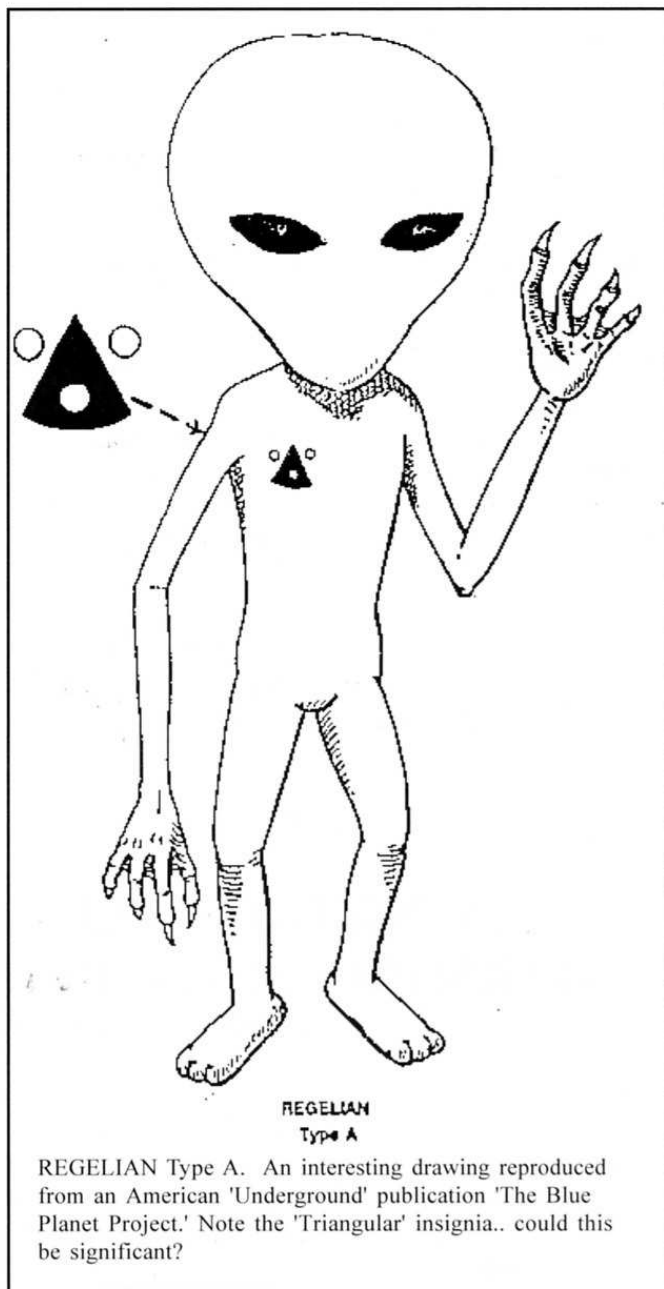
"There was a taller Alien, he seemed to be in charge of the others and looked the same as the others, but he was about 6ft. I say 'he', 'it', I don't know what it was. He stood over me and then stared into my eyes and then I got this feeling of euphoria and happiness, which is odd. I thought that we could communicate because I'm sure that he could see what I was seeing and I had a feeling that I should be at peace, which is not a normal reaction, I should have been terrified."

"That was the last thing that I remember, the next thing was that I woke up in the field (from where she had been abducted), but I was in a different spot from where I had been originally, and I found my book in the hedge. My watch had stopped, although I didn't notice this at the time, and I had a rash on my arm."

"When I got home 5 1/2 hours had elapsed. When I went in -I've got five dogs- the dogs reacted strangely to me, instead of coming up and jumping all over me, like they normally did, they were like whimpering and cowering away and sniffing all the way around me. I had an awful headache, nosebleeds, I thought it was like some kind of dream, but I've kept having really bad flashbacks, and I just felt really ill." Miss MF stated that she has since suffered from a form of epileptic fit and she also believes that she is now suffering from M.E.

While discussing her abduction event recently Miss MF revealed that she had been aware of strange visitations since the age of 6, and had seen UFO craft at various times, when they appeared more as a cigar shape. She recollected that she had been shown scenes of devastation on the Earth and had mental flashbacks of seeing cities destroyed. Miss MF also stated that since the onset of her abduction experiences she had become more artistic and had developed an interest in powers of healing and environmental issues.

She also mentioned that the names Lowestoft and Cromer keep coming into her head. She had to refer to an



atlas of England to see where these two coastal towns were situated. (She was quite unaware that Lowestoft has now been linked as an area where 'FlyingTriangles' have been seen to enter and leave the sea, and that moving underwater lights have been observed by fishermen in this area.)

N.B. To date we have no information on UFO activity around Cromer on the East Coast. ■

## **BOOK REVIEW By Omar Fowler, FSR Director and Consultant (P.R.A. Derby)**

**THE THREAT. THE SECRET AGENDA: WHAT THE ALIENS WANT...  
AND HOW THEY PLAN TO GET IT. By Dr David M. Jacobs, Ph.D.  
1998, Hardback. U.S.\$ 23, U.K. £16.99. Published by Simon and Schuster,  
ISBN 0-684-81484-6.**

I had the pleasure of meeting with Dr David M. Jacobs in 1992 when he addressed a conference held at Manchester University. The revelations that he made then have been superseded by the sensational claims made in this, his latest book, *The Threat*.

The pattern of Alien intervention with our human species as described by him seems utterly fantastic, and more suited to the world of Science Fiction. We are asked to accept the stories of our participation in the Alien breeding program, which is intended to produce a hybrid species that may ultimately take over control of our world.

Dr. Jacobs leaves nothing out; the stealing of eggs from our females, the wholesale theft of sperm from our males (by whatever means), and then the later introduction of the Alien/human hybrid to the human mother.

It appears that most of these procedures are carried out by small 'Greys', working under the supervision of a taller Alien controller.

The human victims are often subjected to the Aliens peering closely into their faces, with the huge black Alien eyes performing some kind of 'mindscan' operation on the helpless human. A common feature being the inability of the victim to move, other than to follow the movement of the Aliens with their eyes.

It seems that a 'downloading' of information is then made, either to steal the memories of the human, in order to pass them on to the 'hybrid' or, in turn, to infiltrate the mind of the human victim with some kind of Alien control procedure. At times a glowing multifaceted orb may be cupped in the hands, which apparently facilitates the 'mindscan' operation.

**It seems highly probable that the Alien hybrid program has been going on for years, and that in many cases they may have achieved their goal. We are told that the Aliens have produced the ultimate hybrid and that many of them**

**are now on Earth and may be working alongside their unsuspecting human colleagues.**

At this juncture, we could well ask, what is the basic human species? A very young child has no blueprint for living and, like a very young animal, it is dependent upon its parents for survival. From an early age we are subjected to a period of learning to conform and behave to a pattern as decreed by the society and culture that we are born into. Our human brain could be likened to a new computer, with only a small percentage of its capability being used. **But could we be in the throes of having a new computer programmer?**

**It might well be the case that "The Earth is in danger and humans are the problem." At times Dr Jacobs might well be thought to be making claims in his book that border on near-hysteria. There is, however, only one minor problem....his deductions are made on well researched material! What he has related in his book are conclusions reached as the result of his extensive investigation into numerous 'contactee' incidents. A world-wide pattern of identical abductions has been established. Should we not share his concern as to what is our ultimate destiny?**

I recently investigated a local UFO sighting\*, and was amazed to discover that the witnesses were part of a family unit that had been subjected to Alien visitations....Many of the incidents conforming to the pattern referred to in Dr. David M. Jacobs book 'The Threat'!

## **U.S. AIR FORCE PLANES AND SAUCERS DURING KOREAN WAR IN 1952.**

[This account comes from the book *ADVANCED AERIAL DEVICES REPORTED DURING THE KOREAN WAR*, by FSR Consultant Dr. Richard F. Haines, Ph.D, published by LDA Press, Los Altos, California, 1990, pages 39 and 40. Quoted from *UFO Round-up*, Vol.2, No.20. EDITOR FSR]

Forty-six years ago, on May 15, 1952, U.S. Air Force

planes chased UFOs over North Korea. The incidents appear to have taken place in the lakes district south of Changsong-ni and north of the Nangnim Mountains. Here are the actual combat reports for both UFO encounters:

"Air Intelligence Information Report 52-79 dated 28 May 1952 describes a brief but interesting encounter with a UFO by two 'very reliable' pilots of the 51st Fighter-

Interceptor Wing, 25th Fighter-Interceptor Squadron. The two planes were on Mission C/51-02 flying wing positions in Maple flight. Lt. McCarthy was the first pilot to see the strange object. He had completed 27 combat missions. The other unnamed pilot was the Interceptor Group Operations Officer with 56 combat missions completed. Following is a summary of key events:"

"A silvery oval-shaped object larger than a MiG jet airplane was seen at the nine o'clock position below the two F-86E (*Sabre*) jet airplanes at an estimated altitude of from 8,000 to 10,000 feet and about twenty miles (32 kilometres) away. The single-seat airplanes were on a heading of 280 degrees; the object continued on in a straight flight path and disappeared at about the three o'clock position.

While flying at an altitude of 30,000 feet and an airspeed of 500 knots, both eye-witnesses saw the object for only 3 to 5 seconds and noted that the object travelled at an estimated 1,300 to 1,500 mph in a 'rolling manoeuvre.' The reported weather (at 8 pm on May 15, 1952) was a medium haze with visibility of 10 - 12 miles."

**Note by Editor of UFO Round-Up**

The MiG-15 had a wingspan of 10 metres or 33 feet. McCarthy's UFO was probably 12 metres or 40 feet in

diameter.)

The second report was at 6.35pm on May 15, 1952. "Air Intelligence Information Report No. 52-81 describes an encounter between the pilot of an F-51 (*Mustang* — same model as Tommy Mantell's) propellor-driven fighter bomber and a silver object estimated to be about 50 feet in diameter. The aircraft was assigned to the 18th Fighter Bomber Group. The pilot had flown 76 combat missions in WW2 (World War II).

He was... flying on a heading of 180 degrees at an altitude of 9,000 feet; he first noticed the object at the one o'clock position. 'By the time I called the object in as a bogey, it had moved to the 3 o'clock position and started a steep climb, which I assumed was the beginning of a loop, but at the vertical position in the loop, the object moved forward in its original course of travel (360 degrees) and wavered momentarily and then descended and disappeared into the haze which reached an altitude of approximately 7,000 to 8,000 feet.'

While the (F-51) airplane was travelling at only 240 mph, the UFO was estimated to be moving at 1,000 mph, first to the east and then changing to the north. It was at approximately the same altitude as the airplane during the 15-to-25 second-long sighting."■

## THE "COLORADO CONNECTION".

On September 2nd, 1995, Mrs. Nancy Teargarden and her husband spotted a pear-shaped object very high in the sky. It was travelling northwest to southeast very slowly, and remained in view from 10.10. am to 10.22 am. The vehicle emitted neither vapour trail nor noise. A cloud-free atmosphere provided the couple an unobstructed viewing of the object through their binoculars.

Residents of Parksville on Vancouver Island, these witnesses are all too familiar with constant military aircraft that fly in and out of Comox Air Base. As this craft appeared to eject flame from its rear section it consequently raised the problem of rational identification.

After some lengthy analysis and no reasonable conclusions, Mrs. Teargarden decided to inform the authorities, therefore she called the Comox Air Base.

Not only were they interested in her sighting but asked her a number of questions. Then they asked her to hold on a minute. Whilst she waited she thought she heard a voice in the background say "Quebec". Shortly after, a woman came on the line and announced that Mrs. Teargarden was in contact with North American Air Defence (NORAD) in Colorado.

Once again she related her sighting details, more questions were asked and the NORAD woman seemed to be excited. Again Mrs. Teargarden was asked to wait and once more transferred, this time to a male officer (?) who listened to her story.

Although Mrs. Teargarden was very much prepared to send her excellent sketch and detailed account to NORAD, the officer (?) would neither provide her with his name or location, only stating that he was not permitted to reveal

that information and that should they decide they wanted the material she offered, then they would make arrangements to collect it.

In January, 1996, a young man in Delta (a suburb 30 kilometres southeast of Vancouver) also had a sighting that he reported. His call was "patched" through to Colorado. (*As we lost the return number for this person, no other information is available*).

On the 15th January, 1997, around 6.10 am, Natalie Preston, who lives in an apartment on East 6th Avenue in Vancouver, watched a light rapidly approach her bedroom window. Coming to a halt, it hovered outside her second storey window and rapidly flashing coloured lights were all she could see.

Grabbing her baby, she panicked, dashed down stairs and phoned 911. The police operator was more than a little curious and as, at that time, emergencies were at the bottom end of the scale, proceeded to ask Natalie a number of questions. After several minutes of exchange the police operator suggested she should call a number she had at hand. Ms. Preston dialled the number provided and was surprised when the Canadian Forces Base Chilliwack (1) answered. The operator asked her questions and soon afterwards requested she stay on the line.

Next stop Colorado. A chat with the operator, who then announced that an officer would call her back that afternoon. Sure enough the phone rang. He said they had not been able to find anything in her area (*what* were they looking for and *how* were they trying to locate it)... he added that they didn't believe in UFOs,... and what she had witnessed was no doubt a meteor!!



On February 9th, 1997, Natalie once again had a close encounter and this time took the previous phone route, minus the 911 operator. On this occasion the NORAD officer(2) suggested that she call a public relations number he offered should a repeat event occur.

On January 13th, 1997 at 8.01 am, Ursula Lomax was driving from her home in Abbotsford to where she was employed in Chilliwack. As she headed east she saw a white cloud "burst" downwards three times, emitting white light. The "extra" clouds dissipated leaving the original (?) cloud in the sky with what appeared to be a black bar(3) below.

After a few minutes, a solid stream of white light came downwards from the black bar, and then there were two! The second bar was slightly smaller and about 45 degrees below the first one. To her amazement both black bars started moving across the sky in unison, with a wave-like motion.

Ursula noted that the total viewing time was 31 minutes. Later that morning two male delivery people arrived at her workplace and described seeing a black bar-shaped object in the sky, at 11.00 am.

On January 14th at 8.06 am, again on her way to work, Ursula noticed a pink glowing "coffee bean" in the sky. This sighting lasted seven minutes. Once more her two delivery people excitedly arrived ready to describe what they had witnessed. It sounded identical.

The very same day on her way home driving the freeway she noticed a very bright light envelope the car. Looking out she saw a large pewter-coloured disc emitting light. It appeared to be over and slightly left of her vehicle. Not daring to take her eyes off the road, she only watched it for a few seconds.

Arriving home she decided to call C.F.B. Chilliwack, and they patched her through to National Defense in Quebec!(4) She proceeded to describe the past two days' events in careful detail. At one point she was transferred to a gentleman (5) with an American accent (probably Colorado again). They asked many questions. On three separate occasions Ursula was asked how she "felt" when watching the object.

On January 15th, again travelling to work in Chilliwack, at 8.05 am., Ursula noted two wispy clouds at a 45 degree angle with a "black bar" protruding. Suddenly a vapour trail dropped vertically, then before hitting the mountains the trail moved horizontally 90 degrees! Whatever was creating this spectacular sky writing could not be distinguished from her location. Once again she completed the reporting procedure, arriving at the same destination.

On the 18th January, Ursula's 23-year-old daughter

came rushing into the house excitedly claiming to have seen the "black bars" that her mother had described. Ursula suggested she call and report her sighting. She called C.F.B. Chilliwack and asked to speak to the same officer, by name, that her mother had described. At first there was some confusion as the base did not seem to recognize the name, but after several minutes she was transferred to that officer. One of the questions he asked her was, "Are you related to Ursula Lomax?" Clearly he either recalled mother phoning three days previously or had checked the computer records for sighting locations.

Far more extra detail could be provided regarding some of these events and the witnesses themselves. However, the principal purpose of this accounting is to confirm and underscore that, contrary to endless official announcements, someone, somewhere, IS VERY INTERESTED in what we are seeing, at a local, national, and international level.

Interestingly enough, I first heard about C.F.B. Chilliwack's connection with the UFO investigation aspect 23 years ago! I can only surmise that a great many reports have travelled through their switchboard in the intervening years. Yet another prime example of tax-payers' money being spent and no dividend offered on the investment. No doubt on the orders of the "mendacious brigade", once again.

#### ADDENDUM.

The investigators involved here are Graham Conway, Gavin McLeod, and David Pengilly, all of UFO BC. All witnesses' names are pseudonyms.

1. CFB Chilliwack telephone number on file.
2. NORAD officer's name on file
3. TV's "Inside Edition" interviewed Jeff Ferris on 16th February, 1996 about a video of "black bars" seen over Tempe, Arizona. Jim Peters of MUFON, also interviewed, said he had studied "volumes" of rod videos, pointing out that the Indiana Crawfordville's *Daily Journal* in 1891 (yes, you read it right) reported an object like a "rod" saying, "it swam through the air in a writhing twisting manner, similar to the glide of some serpents".
4. This could be Saint Hubert's Air Force Base in Montreal. They were accepting UFO reports from Canada's Dew Line, in 1962, then forwarded to NORAD. (NOTE: The DEW line, or Distant Early Warning system, was established in the Arctic Circle during the "cold war" era to detect the potential arrival of Russian aircraft.)

## EXTRATERRESTRIAL GIANTS IN ISRAEL.

For a long time we did not dare publish this material, for it treats of unbelievable events. But is it *really* so unbelievable? The well know Russian ufologist Dr. Felix J. Sigel once wrote: "If we accept UFOs as real objects that do exist, then consequently we must also be prepared to accept that there is

somebody sitting inside and driving them."

The archives of ufology do indeed contain immense numbers of contact claims, but encounters such as we give below are rare, and of course also not trustworthy. However, the genuineness of these particular cases that we report now has been confirmed by

many respected persons, and is also backed by a number of supporting pieces of information.

The facts are that, in two separate regions of Israel, eyewitnesses have seen what amounts to well-nigh a veritable "invasion" by Extraterrestrials, one of the regions being a zone around the town of Kadim (some 60 miles to the north of Tel Aviv), and the other being an area some 10 miles or so around Rishon Leziyon (which lies some 20 miles to the south of Tel Aviv.)

1) The first sighting of a tall humanoid figure was at about 6.30 am on March 20, 1993, at Kadim, in a field owned by a lady named Karmela Tziporet. She recalls how, on that morning, a Saturday, she was awakened by a blinding yellow light that flooded the entire room. Rushing out of the house, she beheld a glittery silver cylinder hanging vertically above the ground. From its upper part five beams of light were shooting down like a shower of sparks.

As she described it: "Then I saw a tall figure, in a likewise silvery, gleaming one-piece garment, standing about 4 m from the cylinder. On his head he had a broad-brimmed hat, resembling a sombrero, and he had a veil covering his face. I asked him why he did not remove his hat so that I could see his face. He answered me: "It has to be so." This was *without words* -but nevertheless I understood him. Then suddenly I had a weird feeling that I must return indoors. And when, shortly afterwards, I cautiously stepped outside again, neither the visitor nor the cylinder were to be seen".

The mysterious space craft left behind in the field a circular mark 4 m wide, inside which the vegetation had been totally destroyed. And in the following 10 days two similar marks appeared. Some UFO investigators who arrived soon afterwards found a light-grey coloured substance in the circles.

2) At 2.30 hours on March 31 1993, Karmela Tziporet's neighbour, a lady named Schosch Jachud, heard an explosion that shook her entire house. She said: "Suddenly there appeared, right there in the room, a bald-headed figure, 2 m or so high. His garb was tight-fitting, and of a metallic sort of hue. He told me - *without words* - not to be alarmed, as he had no intention of doing anything to me. Then he floated around my bed, and suddenly vanished".

Next morning Mrs Jachud found a circular mark behind her house. This occurrence became well known and was even mentioned by the media. Ufologists came and took from the circle samples of the grass, which bore a strange red oily liquid.

3) The next happening of this sort was at the village of Burgata, 2 miles from Kadima, in June 1993. At around 23 hours Hanna Somech was in her kitchen, when her dog started barking wildly. Then, before the very eyes of the astonished woman, the dog suddenly flew through the air, and was knocked against the wall by some unknown force! Hanna opened the house door, to step outside and see what was going on, but ran up against an invisible barrier!

Then, unable to believe her eyes, she beheld a bald-headed giant looking at her small car. She yelled at him: "What did you do to my darling little dog?" And the being answered: "He was in my way. Leave me alone. I'm busy!" \*See footnote.

She rushed back into the house calling for help. At once her husband arrived, as well as a neighbour. The two men searched the yard, but found nobody. But on the ground they found a circle.

4) In July 1993 the beings switched to other places for their visits. They turned up in the house of a woman named Batija Schimon, in the town of Rishon Leziyon, and in the house of another woman, Klara Kachenova, near Cholon. But Klara Kachenova refuses to talk about the occurrence.

However, Batija Schimon stated that, at about 3 a.m. one night in July 1993, she was awakened by a blinding light. And

two uninvited guests, of identical appearance, just like the entities described in the other cases, appeared in the room. She says, however, that they had very "*friendly faces*".

As in the other cases, they told her to "*remain calm*". One of them moved -as though gliding- through her children's bedroom, and stared in evident astonishment at the aquarium there! Then, a few minutes later, these guests had vanished.

In the meantime the substance found in the circles by the ufologists had been examined at the Geological Institute of Israel. And it was established that it consisted of *pure silicon*, (99.9%!).

The director of the laboratory, Dr Henry Fochnet, stated that such a kind of silicon does not exist under natural conditions on this planet.

As for the red oily fluid, it was examined at the Israeli Institute of Biology. And there it was discovered that the principle component of the remarkable fluid is *cadmium*.

5) A fresh wave of sightings of the unknown entities began in January 1995. On the second Thursday of that month, a man named Gerzi Kasatini, head security officer in the village of Jatzitz (about 10 miles from Rishon Leziyon) stepped out of his house to investigate a sudden loud noise and, right outside his door, almost collided with a 3-metre tall giant in a shining grey one-piece garment.

The face of the being was concealed by a sort of veil of glowing vapour. Terrified, he yelled for help, and a friend of his came running up and also saw the figure. Then both of them ran to call the Police, who came and at first assumed it was a terrorist attack, and consequently they in turn alerted the Israeli Army! And shortly the Army's sharpshooters were on the scene too. However, all that the Army found were the strange footprints of the huge being. *Later, the Police stated that these huge beings moved around "as it were on-tiptoe", and must have weighed almost a ton.* This last mentioned case became widely known to the public, and large numbers of people came to see the footprints.

6) A few days later the Giants turned up in a farming settlement owned by Moschaw Potat, near Kadim. One man, named Amos Gueta, and his wife Memunech Gueta, were badly shaken by the events. The wife had awakened early in the morning, and was astonished by what seemed an *unwonted silence* -"as though somehow all the livestock had agreed to keep quiet that morning". But the reality of the situation was very different!

For she found her dog, whimpering quietly, with its eyelids closed, and when she raised them she found to her horror that *there were no longer any eyes there! They had been removed, and quite bloodlessly.* The dog died shortly afterwards. She rushed to see her other animals, and found *three sheep and 35 chickens dead.*

At present there are about 15 people in Israel, all told, who have encountered these gigantic humanoids. The eyewitnesses' statements agree completely, and they are all individuals who do not know any of the others.

#### NOTE BY THE EDITOR.

\*According to a more detailed account by the Israeli political journalist, Barry Chamish, which appeared in MUFON UFO Journal for July 1998, (and for which we are asking permission to reprint from the MUFON editor and from the author), the entities words were considerably more sinister than that, for he allegedly said:

*"Go away. I'm busy. I could crush you like an ant if I wanted to. Go back to your husband."*

I would, moreover, like to draw attention to a very queer point which seemingly has not been remarked on by anyone - namely the fact that, of the six witnesses mentioned in this article (out of a total of 15 in the whole of Israel), no less than six are women! In due course we may be able to ascertain how many of the rest of the 25 (i.e. 7) were also women. G.C.■

## OMAR FOWLER REPORTS FROM DERBYSHIRE.

Dear Gordon, August 7th 1998

Just a few quick lines to let you know that we have been having a bit of a UFO 'Flap' around this area of Derbyshire. Particularly over Ilkeston during the week of 20th July. On Monday (23rd) a huge boomerang craft was seen moving slowly over the town. Observed by a witness who stated that it was something like 9" at arm's length and about 35,000 ft up (some size). An aircraft flew underneath it, en route to East Midlands airport, and the aircraft looked minute.

As the result of local newspaper publicity, I received several calls concerning activity during the following week and this included a multi-coloured 'Jellyfish' and various lights, also a report confirming Monday's report of the boomerang.

I then received a call from an East London man who had found my number in a UFO magazine....He said that early that morning (Thursday 23rd July), he had woken up about 3am and there was a dark anorexic figure, with a large head, peering at him. He felt that there were other figures around the bed, but he couldn't move. He thought "I mustn't panic" and tried through gritted teeth to say "Hello"..With this the figure moved away and disappeared through the wall! "What's going on?" he asked. I discussed the incident with him and then referred him to the London Investigation Group run by Roy Lake.

A member of our Group has just returned from a holiday in France, (1 Hour West of Nice) and said that on Sunday night (2nd August) a flight of six or seven glowing discs flew rapidly through a nearby valley. He was startled and his friends (skeptics) were astounded! More on that later.

## RICHARD HAINES ON PHOTO ANALYSIS.

My Dear Gordon,

Hello from this side of the pond on a hot, dry summer afternoon. The infamous El Niño has taken its toll over here, what with very record-breaking rain last winter and unseasonably hot summer now. The record keepers tell us that 250-year records are falling in our weather effects, as well as all-time records in earthquake magnitudes. ... grist for the self-appointed prophets of the end times, indeed. But this isn't my reason for writing.

On the cover of the recent issue of FSR (43/2, Summer 1998) is a wonderful segmented oval image allegedly taken by Dr. Percy Wilkins. My interest in this 35mm slide image stems from some current research into the application of fractal geometry and UFO energy dynamics. I have prepared a paper on the subject (presented last year in Porto, Portugal) and soon to be on the www for all to see and criticize.

Since beginning this work I have been seeking photos of UFOs in which there are regularly repeating geometric patterns within and near the edge(s) of the object. Your photo qualifies very definitely. Considering the "main (largest image) object" found on page 8 of the journal, I found the following general features:

1) Smooth edges on 2/3rds of its circumference and irregular edges on the other third. This feature closely mimics another B&W photo I analyzed from Costa Rica (dtd. Sept. 4, 1971 at 0825 local time) and published in the *Journal of Scientific Exploration* with Jacques Vallée. There are several other very similar features found within these two independent images.

2) An 8 x 9 matrix of rectangles suggesting either that the object was not circular when viewed in plan view.

3) evidence that the object is basically flat (plane object) but has rolled about a linear axis within the plane by perhaps 10 -15 degrees arc during the exposure.

4) The irregular processes found in the lower right edge are highly correlated with the bright white contour, suggesting a definite image motion blur across the film plane.

Other findings must await more study. This brings me to my reason for writing to you. I would very much like to pursue a more careful, scientific study of this particular image and am requesting to borrow it. I promise to keep this slide safe and to return it to you in its original condition just as soon as I am finished with it.

This 35mm slide certainly must contain a great deal of other latent information that the computer can pull out, well below the visual resolution level and likely buried in the color dye layers which I can separate with relative ease. So, I do hope you will be willing to share this photo with me. If I should write a summary of my findings I will give FSR first right of refusal on an article. Of course it would be most helpful to also receive any and all other available technical information about this shot (camera type, film, lens, etc., date, place..).

On a different subject, if you have been receiving any recent news from Chile and all of the aerial encounters there I, for one would appreciate reading about them. Their air force is now using my pilot reporting form in their research, and I have been in touch with some knowledgeable journalists from Chile recently who are producing a TV special on these activities.

Well that's about all I have for now. But I will not close without sending you my personal greetings and best wishes for the months ahead... particularly as we all head into the Y2K era. Here in Silicon Valley there is growing media attention to some of the very practical problems of Y2K that are anticipated. A sort-of survivalist mentality is beginning to be displayed in some people as they read about power grid shut downs, food and water shortages, civil unrest, etc. It reminds one of the social reactions that took place around the year 998 AD in western Europe. The word "millenium" is powerful, indeed.

Finally, I am enclosing a check for \$ 35.00 US to help FSR defray a bit of its production costs. I very much appreciate FSR for numerous reasons and don't believe anyone should get a free handout of such high quality. Keep up the excellent work, however painstaking it seems to be.

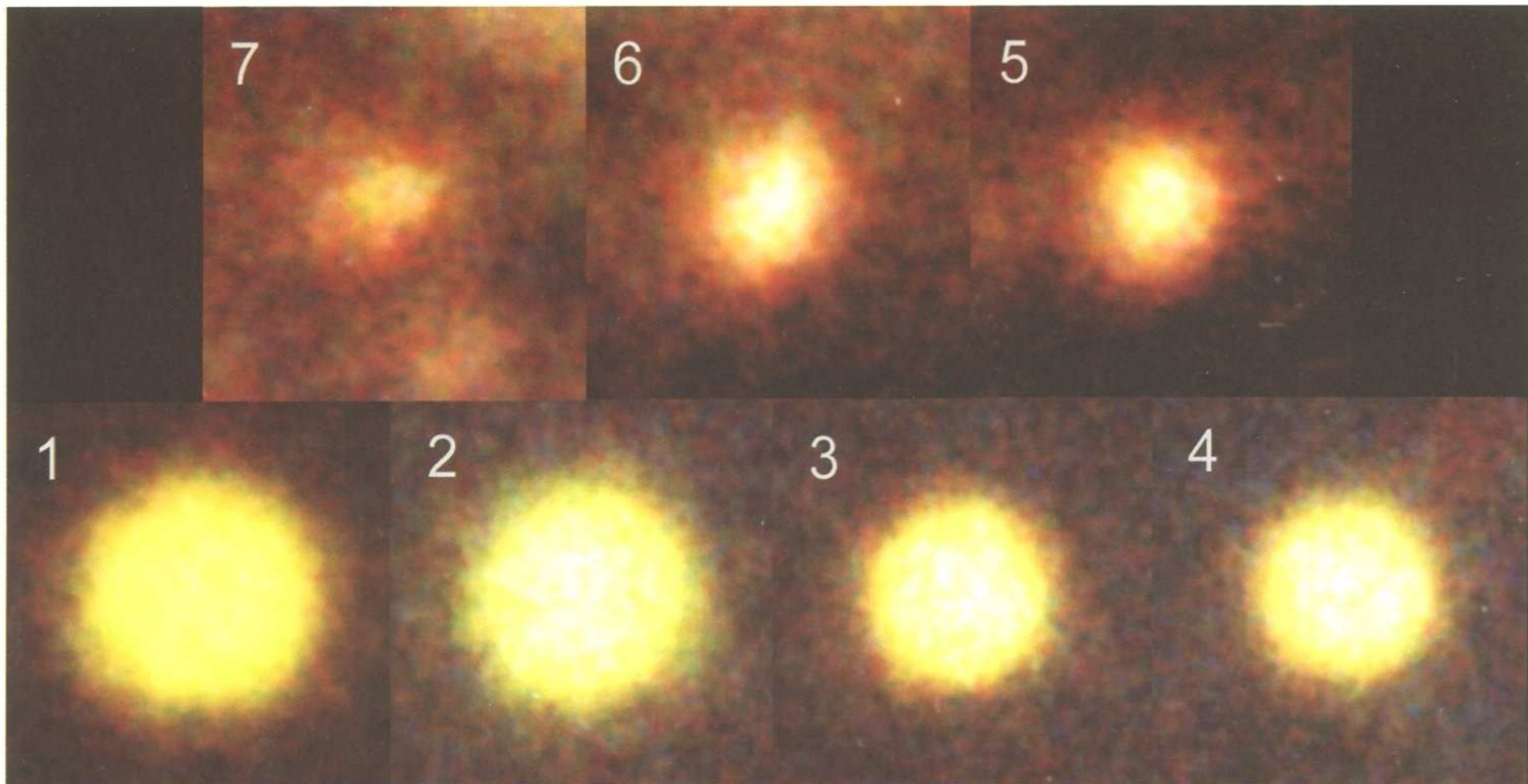
