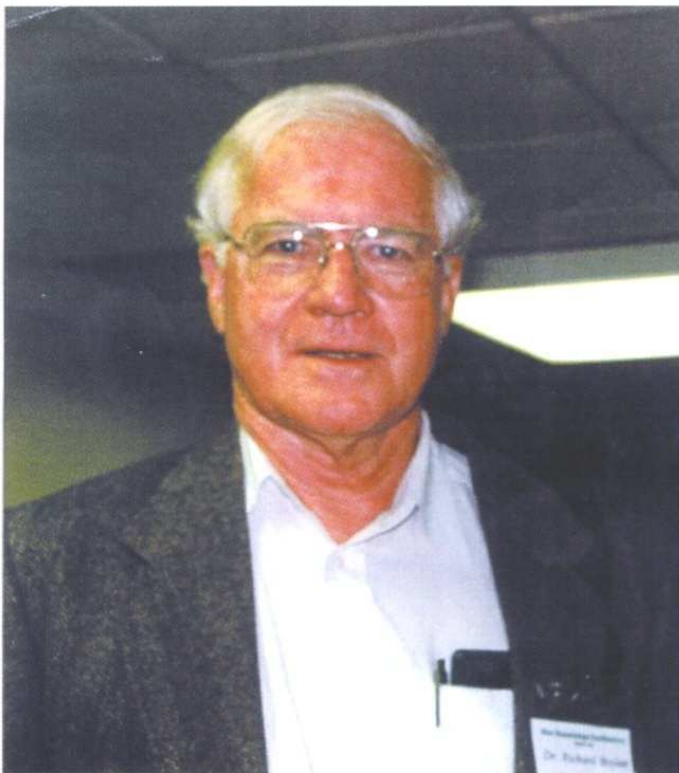


**NOT A FAKE!** Photo on front cover was taken in the first days of December of either 1957 or 1958 by ship's radio officer Tad Vogl aboard the British steamer S.S. Ramsay off the coast of southern California, and slightly to the south of San Pedro and Los Angeles. Time of day about 2.30 p.m. The story and photo were published in FSR 5/1 (Feb. 1959), and the photo became well known. But, owing to much publicity, ridicule, and general pressure, Mr Vogl later announced that he had faked it.

Today, 43 years later, now living in Canada, he has again contacted us and explained how he had been driven into "confessing". We plan to publish the whole story in a future issue of FSR.

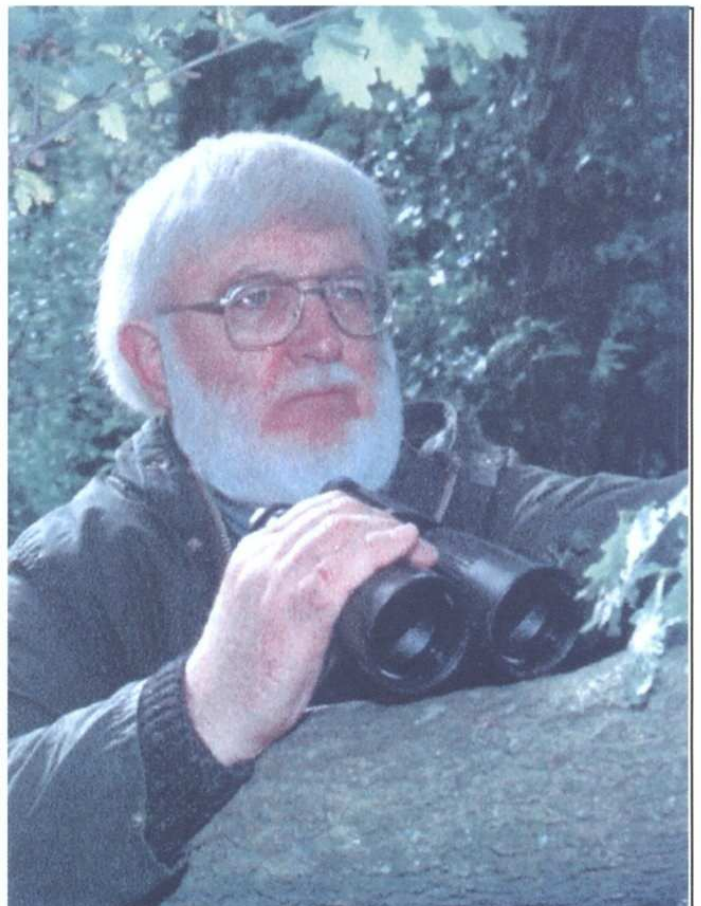

**O**n January 16th of this year the entire Monaghan area and other adjacent districts found their telephones and computers **DOWN!** People in the area were still able to phone *out*, but callers outside the area were unable to call *in* to it.

Well now, a series of remarkable phenomena had happened to me in the very early hours of that same day. I had been feeling chilled and 'fluish' at the time, and had been sitting in our kitchen by the cooker.

And suddenly, at 00400 hrs., (i.e. twenty minutes to one o'clock on that morning, January 16), I "*had a contact*" - that is to say, *I received a telepathic message.*

It said: "**GO OUTSIDE IN TEN MINUTES**".

Folk may jeer as much as they like, but it remains a fact that, all over the world, people are receiving such messages. Having already had other experiences of the sort, I did not hesitate. I stepped out, about ten seconds before the two minutes deadline, and looked up.

**And, exactly at 0042 hrs, the 'spectacular' started. What I can only describe as "A GIANT HAIRY SNOWBALL UFO" with a long trailing tail shot across the sky. It came from the SSE and arched towards the SW. It covered the distance from horizon to horizon in about 4 and a half to 5 seconds, and was**



gone. Its tail had several smaller UFO-like globes within it, and spread back for what appeared to be a mile or so.

DID ANYONE ELSE SEE WHAT I SAW? So far I have seen no reports. Cases of vast objects like this have been well documented and sometimes photographed, and

it instantly put me in mind of one that had been filmed in Mexico in 1996. I searched for it in my archives and found it so similar to what I myself saw that night that I attach a print of it herewith. (See inside front cover.)

## **SIX REPORTS FROM DR. RICHARD BOYLAN, PhD (CALIFORNIA).**

[For Dr Boylan's previous (and first) article in our journal, see his *Secret Saucer Sites* in FSR 38/4 (Winter 1993), describing his attempts to "take a look at" several secret military sites, including *Area 51*. -Editor]

I give below the full texts of six reports which Dr. Boylan has authorized me to republish in FSR. As will be seen, the first three of these highly important papers relate to extensive interviews which he had, in 1996 and 1997, with a high-ranking officer of the U.S. Air Force, Colonel Steve Wilson, of whom no doubt our readers have never heard before. (There is also yet a further very long article about Wilson's quite extraordinary life and Air Force career, which has already appeared in NEXUS MAGAZINE, and which I also have permission to publish in due course).

**Colonel Wilson is no longer with us in this world. He departed in November 1997, and the cause of his death was cancer. And the editors of NEXUS have not feared to voice the suspicion that his cancer may very likely have been deliberately planted in him. This is my opinion also, and I would draw the attention of readers to the many other deaths of UFO investigators in which cancer was the cause - Waveney Girvan (an early editor of FSR), Dr. J. Allen Hynek himself, Dr. Karla Turner, Cynthia Hind very recently, and certainly many others on whom I have no precise details.**

It seemed that for some very considerable time "somebody" may have suspected or known that Colonel

Wilson was planning to "spill the beans", and that consequently he was being plagued and driven from pillar to post. (As Dr Boylan too was about to be!)

*Liquidation* is, I feel sure, a threat that hangs over every one of us who "gets too much out of line" and attempts to investigate matters relating to the sinister Alien Powers that control our unfortunate species. OUR BEST PROTECTION IS *PUBLICITY*. (See Col. Wilson's specific mention of "MIB boys", the thugs of the WHACKENHUT AGENCY, in the second of Dr. Boylan's articles. These are the folk who uttered death threats to Tony Dodd and his wife when they were visiting the U.S.A.)

All that I have been able to learn points to the integrity and honesty of Dr. Richard Boylan, and to the probable accuracy of all that he is telling us about this immensely important individual, the late Colonel Steve Wilson, USAF (Ret'd.), some time Head of "OPERATION POUNCE." I suggest that it all be pondered very carefully. As Timothy Good reminded readers of his last two books, there is always a likelihood of deliberate *misinformation* from the U.S. Authorities, but ponder on it for yourselves, and decide how much truth *you* feel that is contained in what we are here transmitting to you. ### **I. COLONEL STEVE WILSON, USAF (Ret'd), REVEALS DETAILS OF "PROJECT POUNCE". © BY DR RICHARD BOYLAN, PhD.**

A further glimpse into the U.S. Military's secretive obsession with UFO technology was provided by Colonel Steve Wilson, U.S. Air Force (ret.), former head of *Project Pounce*, an elite Air Force/National Reconnaissance Organisation Special Forces Unit,

which retrieves downed UFOs (1). Colonel Wilson reports that "the first successful U.S. antigravity flight took place on July 18, 1971 at S-4, Dreamland [Area 51] (2), where light-bending capabilities were also demonstrated to obtain total invisibility. Present at this flight were notables such as Admiral [Bobbie Ray] Inman [former National Security Agency Director], who is now head of SAIC [Science Applications International, Incorporated] in San Diego, CA, which makes the antigravity drives."

Colonel Wilson also revealed that the recent announcement by Lockheed about an unmanned, electric-propulsion reconnaissance unit with short wings named "*Dark Star*", was actually a "cover"

project. The exotic technology being concealed is the real *Dark Star*, designated the X-22A, and manufactured by the Lockheed Skunk Works at Helendale, CA. This *Dark Star* is an operational, two-man, wingless antigravity craft.

He says: "I saw this UFO-copycat antigravity craft in test-flight at Area 51 in 1992. Its metallic airframe in flight is obscured by an intense bluish-white light, which pulsates off and on at about two-second intervals. During the phase where the intense light is off, the craft frame disappears from optical view, (and NOT just because its light is off), then reappears several hundred yards distant horizontally in the lit mode. Does that mean that this craft travels by small jumps through hyper-space? Gravity does bend space-time.

"The U.S. also flies discs which glow an intense golden-orange during flight, made by Northrop Aerospace at their secret facility northeast of Lancaster, CA, where I saw them test-flown in 1992."

Colonel Wilson says the military began publicly flying their enormous *Black Triangle* antigravity craft, back-engineered from extraterrestrial UFOs, on January 3, 1994. Several sources state that the McDonnell-Douglas, Lockheed-Martin and Northrop antigravity plants are connected underground by a superfast tunnel shuttle system with Area 51 and other sensitive underground installations.

Colonel Wilson says that the system, where magnetically-levitated trains zip through almost vacuum tubes, is called TAUSS, Trans-America Underground Subway System. The tunnels are excavated by nuclear Suterrenes, which can burn through rock and create six miles of tunnel per day.

The Colonel also furnishes the answer to the mystery "black helicopters" spotted around so-called "cattle mutilation" sites. These aren't your ordinary helicopters, but yet another U.S. antigravity craft, designated the XH-75D or "XH Shark", made by Teledyne Ryan Aeronautical Corporation of San Diego. He says that many of these XH-75Ds were assigned to the Delta/National Reconnaissance Organisation Division which retrieves downed UFOs.

[Figs 1a is an illustration of the *Shark* antigravity special-operations helicopter, furnished by Colonel Wilson. Fig. 1b unfortunately is not identified in text.]

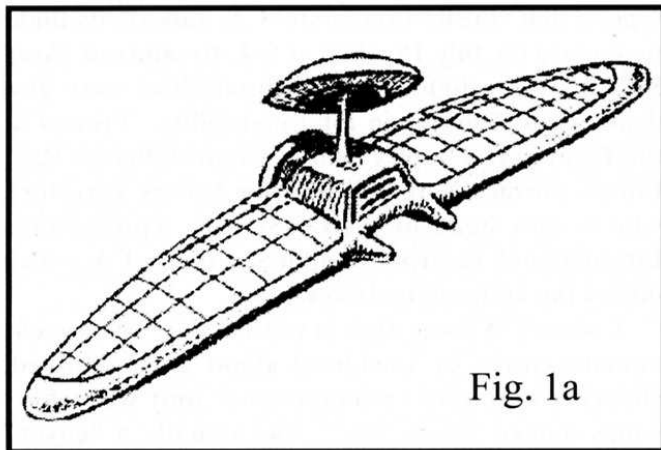

That Division is also implicated in mutilating cattle as psychological warfare on the American public, to try to get us to fear and hate (3) extraterrestrials through assuming that ETs cut up the cattle.

Finally, Colonel Wilson states that a supersecret mobile unit within Delta Force, the National Reconnaissance Organisation, is deployed with the *Equalizer*, an exotic-looking electromagnetic-pulse six-foot-long, one-foot-diameter cannon mounted on a pedestal on the back of a military truck which is used to shoot down UFOs using low-frequency pulsed microwave energy. The *Equalizer* is built by LTV, Lin-Temco-Vought, at Anaheim, CA.

"Antigravity technology is limitedly international. Russia is reported to have its own anti-gravity vehicles. And Paul Stonehill, a respected Russian UFO investigator (and FSR Consultant. G.C.), reports that the Russians in April, 1988 started using space-time-bending antigravity technology to do time-travel! In June, 1997, A Washington, DC-area intelligence "cut-out", who has been quite reliable, passed on information that China too now has acquired antigravity technology.

"A world-class UFO/ET research professional has additionally provided me with information that a renegade group in Japan also possesses antigravity technology. He reports that the possession of such extreme technology, [which besides ultrafast deployment, also involves radar and optical invisibility, and potentially time-travel capabilities,] by a sometimes-hostile Asian superpower such as China is seen by some Pentagon generals as destabilising the West's military edge.

#### NOTES BY EDITOR OF FSR.

1. For both sides of the argument over the presence or non-presence of back-engineered new types of craft and new technologies at *Area 51*", see Dr. Pierre Guérin's article. *The U.S. Air Force, Antigravity, and UFOs*, in FSR 43/3 (1998) and Dr. Jacques Vallée's reply, *Groom Lake and Anti-gravity*, in FSR 43/3 (1998). If what Col. Steve Wilson says is correct, then it would seem that Dr. Pierre Guérin was right and Dr. Jacques Vallée was wrong about what is happening at "*Area 51*"!

2. It may be recalled that in one of his earlier books (I have no time to check which book) Tim Good has discussed the role of Admiral Inman in connection with

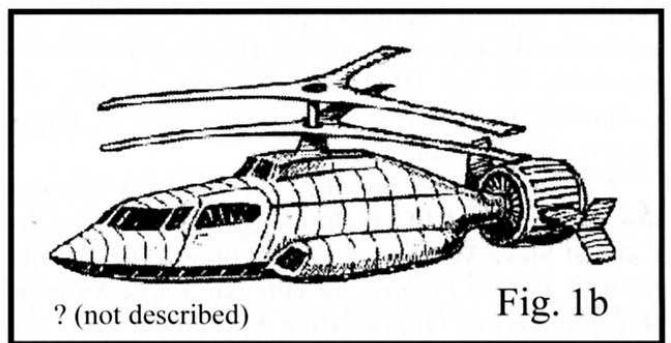

(from page 41 of EVIDENCIA OVNI No.11 (1997))

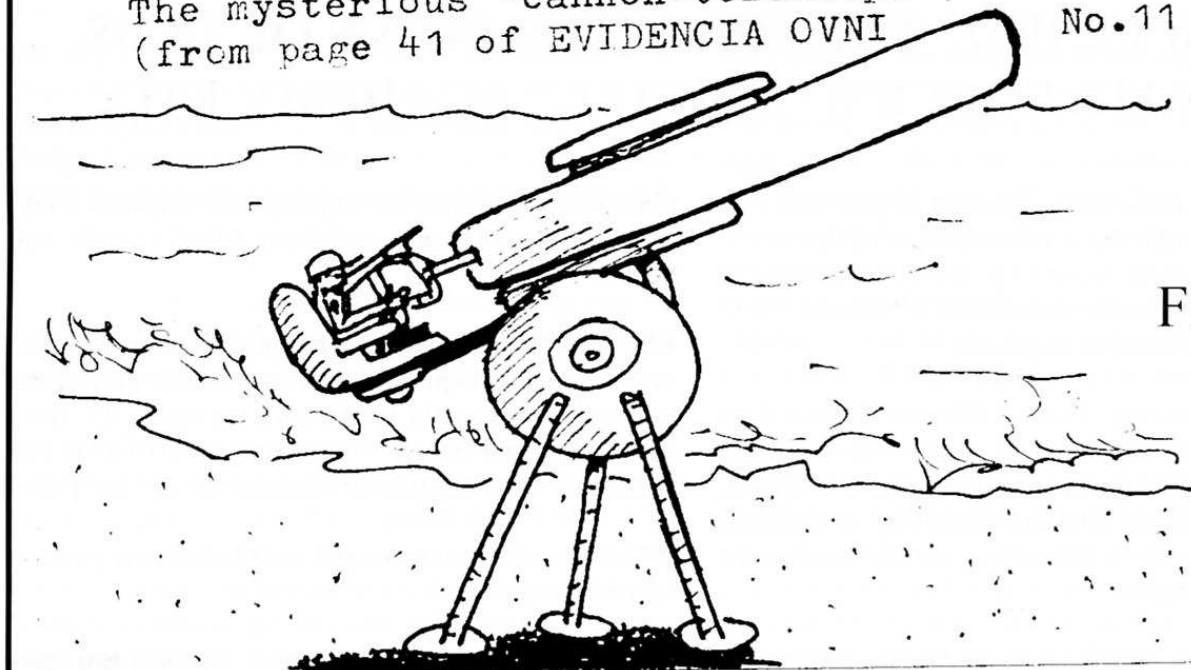

UFOs. Here again, if what Col. Wilson says is true, that role has been a big one, although so vehemently denied by Inman!

3. Personally I find it quite impossible to accept this "psychological warfare" story, which strikes me as totally ridiculous. Can anyone else confirm this theory?

4. From Jorge Martín's *EVIDENCIA OVNI* No. 11 (1996), I have already translated a tremendously important article, but have not yet been able to find a place for it in FSR. The title of it is "*Strange UFO Happenings in the Lajas Area (South West Puerto Rico)*", and here is a passage from it which must surely be describing the very same "UFO-busting gun" that Col. Wilson has just mentioned:

"At around 2.00 o'clock in the morning, I have seen, while UFOs were overhead, great convoys of American military trucks going by, together with American military people all in combat camouflage uniform, in jeeps, and another big military truck loaded with something big that is covered with canvas, and armed soldiers going along with it, and two police patrols escorting them.

"It is my opinion that they always come, at this same time.... Why so much mystery? Why do they go by at this hour of the night, as if so as not to let the people see them? What is it that they want to hide?....

And at times when I go down to the beach at Papayo, I meet these same people there, in camouflage, with the jeeps, and with the big truck. And .... do you know what that big thing carried by the truck is? Well, it's a big thing, that seems like a telescope - a weird thing that is a sort of a mixture between a telescope and a big gun. It has tripod legs, and something underneath like a base, and there is a seat on the cannon, and a soldier sitting on the set

controlling the strange apparatus - cannon or telescope - whatever it may be. (See Fig. 2).

They keep this "cannon-telescope" "aimed", at an inclined angle to the sky, pointing towards the stars. What are they looking for? I don't know, but something tells me that they are fighting the UFOs. The soldier who is sitting in the seat, at the base of that thing, is controlling it, and directing it towards different parts of the sky, as though seeking something.

That's why I say that the GOVERNMENT DO KNOW what is going on here, and is hiding it from us. And it is time that they told us the truth", (Statement by Señor Francisco Vargas, of El Papayo, Puerto Rico, to UFO investigator Jorge Martín, Editor of *EVIDENCIA OVNI*.)

Finally, on this question of "*Shooting down UFOs*", it must be emphasised that already, in Jorge Martín's extensive reporting from Puerto Rico, I have had some references to "one UFO chasing and shooting at another type of UFO", and not long ago, in a phoned interview with me for his weekly UFO Programme on the Puerto Rico Radio, Jorge Martín confirmed to me that this is apparently the prevailing situation on the Island.

In other words, maybe there is indeed "WAR IN HEAVEN" .... "COSMIC WAR" - a war in which willy-nilly and all unconscious of it, *Homo Sapiens* is serving as a junior partner (or maybe more likely a *slave*?) in some great struggle - A STRUGGLE IN WHICH WE DON'T EVEN KNOW WHO ARE TRULY IN CONTROL HERE - THE "GOODIES" OR THE "BADDIES".

[A DIALOGUE between Dr. Richard Boylan and Col. Steve Wilson, USAF (ret'd.) former head of PROJECT POUNCE - the most secret U.S. Air Force project to cordon off and secure the area around a "downed" UFO and seize the craft and its occupants.]

**R.B.** [Richard Boylan] 'Colonel Steve, in the Star Wars City (SDI/01) organizational chart which you posted, there is identified an "Air Force Special Academy" (AFSA), which takes its orders from Star Wars City in Colorado Springs, CO. I take it that this is *not* the regular Air Force Academy, right?'

**S.W.** Note: No it isn't the Regular Air Force Academy.

**RB:** Is it AFSA which trains the military astronauts who are quietly sent up from Vandenberg Air Force Base, Ca., while the press keeps the public's attention on the Space Shuttle operating from Cape Canaveral, FL?

**SW:** Note: Yes, Vandenburg and Beale AF Bases are both involved.

**RB:** Or does the AFSA have some other function?

**SW:** Note: Yes, it has other functions in Black Ops.

**RB:** And what range of duty assignments do these Star Warriors (military astronauts) have once they are positioned in Space?

**SW:** Note: To shoot down unfriendly UFOs. The USA is shooting down at least one a day. Other countries are doing this also. Russia is averaging two a day.

[Note by Richard Boylan:

I doubt seriously that the U.S. shoots "down" one UFO per day or any number near that. ONI and CIA informants have told Dr. Steven Greer that two UFOs were "shot down" in 1995. From my research I suspect that the total number may be closer to a half-dozen per year, certainly tragic regardless of the numbers. Dr. Michael Wolf of MJ-12/SSG states that a renegade group, "the Cabal" is conducting these unprovoked attacks in order to deliberately sabotage peaceful relations between ETs and Earth.]\*

**RB:** And in what vehicle do the military astronauts ascend into Space and operate therefrom? Is it the (classified, not-supposed-to-exist) *Aurora* aerospace vehicle, which flies above Mach 8, and operates at 100 miles up, where the atmosphere starts to approach vacuum?

**SW:** Note: No, these are our ultimate two-man back-engineered UFOs and classified Ultra Cosmic Top Secret.

**RB:** The (Ultra-classified) *Pumpkinseed* is reported much faster, and operates on a more exotic propulsion system, apparently including antigravity field propulsion, and fueled by antimatter reaction. Is this latter the vessel the military astronauts use in Space?

[**SW:** Note: Cannot comment on this, but sure you can figure it out]

**RB:** In the analysis of the Space Defense Initiative org chart posted on Skywatch, there is identified the 1010 Special Security Squadron, which bypasses the Air Force and reports directly to the National Reconnaissance (UFO Cover-up) Organization, and to MAJI [MJ-12, the UFO information policy group]. Is this specialized squadron composed of elite Delta Forces (black berets)?

**SW:** Note: No, this is the W[h]ackenhut agency and their Killers.\*\*

**RB:** Is this the unit in which *Project Pounce* was located?

**SW:** Note: *Project Pounce* does not exist as a unit per se. We all had other jobs and each came from our own areas of expertise. No one knew the other and only came together on a crash retrieval. Thus the Ultimate level of security was maintained.

**RB:** In the analysis of the Space Defence Initiative org chart posted on Skywatch, there is identified the "1010 Special Security Squadron" which bypasses the Air Force and reports directly to the National Reconnaissance [UFO Cover-up] Organization and to MAJI [MJ-12, UFO information policy group]. Is this specialized squadron composed of elite Delta Forces (Black Berets)?

**RB:** "Ultimate" as in classified Ultra Cosmic Top Secret, Q clearance, level 33?

**SW:** Note: Cosmic Q, level 33 is MAJI; level 32 is MJ-12; level 31 certain personnel in AC [aircraft] mfg; Level 30, the first 4 of W[h]ackenhut Officials, etc., DOD, NSC. I was only a level 27.... as far as I could go.

**RB:** Ah, Colonel Steve, as always, you are a fund of



interesting information. Permit me two more questions, if you would.

**RB's Q. 1:** I note on the Star Wars organization chart that the "Rockefeller Company" is one of the elite defence contractors at that trough of the Black Budget known as SDIO/BMDO [Star Wars projects]. What "contribution" does the Rockefeller Company make to the SDIO project?

**SW: Note:** Have no idea of specifics. Only general information. This is the reason that secrets can be kept. No one person knows it all except level 33.

**RB's Q. 2:** Also on the Strategic Defence Initiative org chart, there is a corporation known as Decision Science Applications, Incorporated (DSAI). This sounds an awful lot like Science Applications International Corporation (SAIC) of San Diego, headed by Black-ops veteran Admiral Bobbie Ray Inman, and which makes the engines for U.S. antigravity craft. Are DSAI and SAIC one and the same, or related companies/proprietaries?

**SW: Note:** This is a group made up of all heads of Military Hardware Manufacturing in the Black Area. By the way, I have heard that Inman chairs that group.

[Dr. Boylan NOTE: Thus, Decision Science Applications, Inc. (DSAI) consists of the directors of the Black Budget divisions (SU antigravity craft and space warfare weaponry) of: Rockwell, Martin-Boeing, IBM, Lockheed-McDonnell, Ford Aerospace, Aerojet Electro Systems, Teledyne Ryan Aeronautical, Inc., Kaman Industries Co., Rockefeller Company, and Fujika Company, etc. And retired NSA Admiral Bobbie Ray Inman heads both DSAI ("inside") and SAIC ("outside") the Black World. Although Dr. Michael Wolf of MJ-12/SSG says the DSAI and SAIC are one and the same!]

**RB:** Colonel, in the material posted on the Skywatch webpage [(formerly) [www.wic.net/colonel/ufopage.htm](http://www.wic.net/colonel/ufopage.htm)], the UFO information-secrecy management organization is laid out. Which leads to a question: What roles do Dr. Henry Kissinger and Dr. Edward Teller play in this ULTRA-classified organization? Dr. Teller cleared Department of Naval Intelligence physicist Bob Lazar to work at Area 51's S-4 on back-engineering captured UFOs. Dr. Kissinger's business office in New York City has gotten quite threatening with a person who made inquiries into Kissinger's connection to the UFO Cover-up. What light can you shed on these two men's involvement?

**S.W.: Note:** Both are MJ-12 members, which number 36 in all as of 1994. It might interest you to know that they go back as far as [Project] Paperclip, but even though they have histories before that, they do appear to have been at the University of Heidelberg during the same time period that they were supposed to have been in the U.S. Kissinger is a firm believer and key figure in MK-ULTRA, whereas Teller loves to play at it. (Nothing I can prove, just something I heard at a high level).

### III. REVELATIONS CONCERNING MJ-12, © BY DR RICHARD BOYLAN, PhD.

[Given by Colonel Steve Wilson, USAF (ret.) former Director of **Project Pounce**, to Dr. Richard Boylan PhD. on October 12 1996, and made available by Dr. Boylan.]

\* \* \* \*

**MJ-12** is an ULTRA TOP SECRET research and development Intelligence operation. **MJ-12** was established by President Truman on *September 24, 1947*. Later, **MJ-12** was set up as a "Committee" inside the National Security Council (NSC) by President Eisenhower

in 1954 by Secret Executive Order, "Order Number 54-12". The NSC called this group the "54-12 Committee", with the President having responsibility to approve all "Black" (covert) projects.

The **MJ-12 Group** since then, has been called the "Special Committee"; the "303 Committee" and currently the "40 Committee". It is described as the "Directorate" of the NSC. The "40 Committee" (PI-40) has access to advanced tehnology and teams to conduct "the cover-ups". In the past, this committee was headed by Dr. Henry Kissinger

(Code name: "The Overseer").

**OPERATION MAJORITY - CR-20M7/6.2 - FILE;  
MTR/K-25 MWC/JL - AFMWC/1972USN**

*Operation Majority* is the name of the operation responsible for every aspect, project and all consequences of Alien presence on earth.

**MAJESTY** was listed as the code name for the President of the United States for communications concerning this information

**GRUDGE** contains 16 volumes of documented information collected from the beginning of the United States investigation of the Unidentified Flying Objects (UFOs) and Identified Alien Crafts (IACs). The project was funded by the CIA, (confidential funds, non-appropriated) and money from the illicit drug trade. (it was rumoured in the higher echelons of the Air Force that participation in the illegal drug trade was justified in that it would identify and eliminate the weak elements of our society.)

The purpose of GRUDGE was to collect all scientific, technological, medical and intelligence information from UFO & IAC sightings as well as contacts with Alien Life Forms. This orderly file of collected information has been used to advance the United States Air Force Space Programme, (ULTRA TOP SECRET).

**JASON SOCIETY** (Jason Scholars). Former President Eisenhower commissioned a secret society known as the Jason Society (or Jason Scholars) under the leadership of the following: Director of Central Intelligence, Allen Welsh Dulles, Dr. Zbigniew Brzezinski, President of the Trilateral Commission from 1973 until 1976, and Dr. Henry Kissinger, leader of the scientific effort, to sift through all the facts, evidence, technology, lies and deceptions and find the truth of the Alien question. The society was made up of thirty two (32) of the most prominent men in the USA.

**MJ-12** is the name of the secret control group inside the Jason Society. The top 12 members of the 32 members of the Jason Society were designated as **MJ-12**. **MJ-12** has control of everything. They are designated by the code J-1, J-2, J-3, etc. all the way through the members of the Jason Society. The director of Central Intelligence was appointed J-1 and is the Director of the MJ-12 group. MJ-12 used to only be responsible to the President of the United States (not true any more). The actual cost of funding the Alien-connected projects is higher than anything you could imagine! Believe it or not, MJ-12 runs most of the world's illegal drug trade. This was done to hide funding and thus keep the secret from Congress and the people of the United States. It was justified in that it would identify and eliminate the weak and undesired elements of our society.

A secret meeting place was constructed for the MJ-12

group in Maryland and is only accessible by air. It contains full living, recreational, and other facilities for the MJ-12 group and the Jason Society. It is code-named "The Country Club". The land for the Country Club was donated by the Rockefeller family. Only those with ULTRA TOP SECRET - MAJI clearances are allowed to go there.

**MAJI** - *Majority Agency for Joint Intelligence*. All information, disinformation, and intelligence is gathered and evaluated by this agency. This agency is responsible for all disinformation and operates in conjunction with the CIA, NSA, DIA, and the Office of Naval Intelligence. This is a very powerful organization and all Alien projects are under its control. MAJI is responsible only to MJ-12. MAJIC is the security classification and clearance of all Alien-connected material, projects, and information.

**MAJIC** - means MAJI-CONTROLLED (MAJI plus Controlled = MAJIC)

**NOTE:** MJ-1 is the classification for the Director of MAJI, who is the Director of the CIA and reports only to the President. Other members of MAJI are designated MJ-2, MJ-3, etc. This is why there is some confusion about references of MJ-12, the group, or MJ-12 the person.

\*Designation for MJ-12 the group are MAJI or MAJIC

\* Designation in official documents about MJ-12 means the person only.

In 1947, *PROJECT SIGN* was created to acquire as much information as possible about UFOs, their performance characteristics and their purposes. In order to preserve security, liaison between Project Sign and MJ-12 was limited to two individuals within the intelligence division of the Air Material Command whose role was to pass along certain types of information through channels. Project Sign evolved into Project Grudge in December of 1948. Project Grudge had an overt civilian counterpart named PROJECT BLUE BOOK, with which we are all familiar. Only "Safe" reports were passed to Project Blue Book.

**MJ-12** was originally organized by General George C. Marshall in July 1947 to study the Roswell-Magdalena UFO crash recovery and debris. Admiral Hillenkoetter, director of the CIA from May 1, 1947 until September 1950, decided to activate the "Robertson Panel," which was designed to monitor civilian UFO study groups that were appearing all over the country. He also joined NICAP in 1956 and was chosen as a member of its board of directors. It was from this position that he was able to act as the MJ-12 "Mole" along with his team of other covert experts. They were able to steer NICAP in any direction they wanted it to go. With the "Flying Saucer Programme" under complete control of MJ-12 and with the physical evidence hidden away, General Marshall felt more at ease with this very bizarre situation. These men and their successors have most successfully kept most of the public fooled up to the present, including much of the



western world, by setting up false experts and throwing their influence behind them to make their plan work, with considerable success until now.

Within 6 months of the Roswell crash on July 2, 1947 and the finding of another crashed UFO at San Augustine Flats near Magdalena, New Mexico on July 3, 1947, a great deal of reorganization of agencies and shuffling of people took place. The main thrust behind the original "Security Lid", and the very reason for its construction, was the analysis and attempted duplication of the technologies of the discs. The activity was headed up by the following groups.

- \* The Research and Development Board (R & DB)
- \* Air Force Research and Development (AFRD)
- \* The Office of Naval Research (ONR)
- \* CIA Office of Scientific Intelligence (CIA-OSI)
- \* NSA Office of Scientific Intelligence (NSA-OSI)

No single one of these groups knew the whole story. Each group was to know only the parts that MJ-12 allowed them to know. MJ-12 also operates through the various civilian intelligence and investigative groups. The CIA and FBI are manipulated by MJ-12 to carry out their purposes. **The NSA was created in the first place to protect the secret of the recovered flying discs, and eventually got complete control over all communication intelligence. This control allows the NSA to monitor any individual through mail, telephone, telexes, telegrams, and now through on-line computers, monitoring private and personal communications as they may desire.**

### THE "MAGIC PROJECTS".

**SIGMA** is the project which first established communications with the Aliens and is responsible for communications.

**PLATO** is the project responsible for Diplomatic Relations with the Aliens. This project secured a formal treaty with the Aliens.

**AQUARIUS** is the project which compiled the history of the Alien presence and their interaction on Earth with the HOMO SAPIENS.

**GARNET** is the project responsible for control of all information and documents regarding the Alien subjects and accountability of their information and documents.

**PLUTO** is a project responsible for evaluating all UFO and IAC information pertaining to Space technology.

**POUNCE** project was formed to recover all downed and/

or crashed craft and Aliens. This project provided cover stories and operations to mask the true endeavour, whenever necessary. Covers which have been used were crashed experimental aircraft, construction, mining, etc. This project has been successful and is ongoing today.

**NRO** is the National Reconnaissance Organisation based at Fort Carson, Colorado. It is responsible for security on all Aliens or Alien Spacecraft connected to the projects.

**DELTA** is the designation for the specific arm of NRO which is specially trained and tasked with security of all MAJI projects. It's a security team and task force from NRO specially trained to provide Alien tasked projects and LUNA security (Also has the CODE NAME: "Men in Black" [MIB]). This project is ongoing.

**BLUE TEAM** is the first project responsible for reaction and/or recovery of downed and /or crashed Alien craft and/or Aliens. This was a U.S. Air Force Material Command project.

**SIGN** is the second project responsible for collection of intelligence and determining whether Alien presence constitutes a threat to the U.S. National Security. SIGN absorbed the BLUE TEAM project. This was a U.S. Air Force and CIA project.

**REDLIGHT** was the project to test-fly recovered Alien craft. This project was postponed after every attempt resulted in the destruction of the craft and death of the pilots. This project was carried out at AREA 51, Groom Lake, (Dreamland) in Nevada. Project REDLIGHT was resumed in 1972. This project has been partially successful. UFO sightings of craft accompanied by Black Helicopters are Project REDLIGHT assets. This project is now ongoing at AREA 51 in Nevada. **(Believed to have moved to Mexico at this time for testing).**

**SNOWBIRD** was established as a cover for Project Redlight. A "Flying Saucer" type aircraft was built using conventional technology. It was unveiled to the press and shown in public on several occasions. The purpose was to explain accidental sightings or disclosures of Redlight as having been Snowbird crafts. This was a very successful disinformation operation. This project is only activated when needed. This deception has not been used for many years. This project is currently in mothballs, until it is needed again.

**BLUE BOOK** was a U.S. Air Force, UFO, and Alien Intelligence collection and disinformation project. This project was terminated and its collected information and duties were absorbed by project Aquarius. **A classified report named "Grudge/Blue Book, Report Number 13" is the only significant information derived from the project and is unavailable to the public.**

# IV. THE VARIOUS KINDS OF EXTRATERRESTRIALS.

"Race" distinguishes various extraterrestrials of decidedly different appearances. More research into exobiology, (the science of extraterrestrial life's physical structure and processes), will help us understand better with how many races of intelligent species we are dealing.

So would the declassifying of the Government's already considerable covert research on extraterrestrial biology, (such as is going on at NASA's Ames Research Centre, Sunnyvale, CA, and at Los Alamos National Laboratories, NM). For convenience I shall use the term *race* to distinguish extraterrestrials of significantly different anatomical features.

## VARIOUS SPECIES OF "GREYS" ?

The most common extraterrestrial race encountered has a number of variants. These variations in size and details of appearance may represent origins on different planets. This race is popularly, and rather imprecisely, called the "Greys".

The "Greys" are stereotyped, by uninformed or careless writers, as: short, upright, two-legged beings, three-and-a-half feet tall, with greyish white skin, large, hairless, foetal-shaped heads, with huge, all-black, sloping, almond-shaped eyes without pupils or eyelids, whose eyes wrap around partially towards the temple-area sides of the head, a narrow jaw tapering to almost a V, small nostril holes but no nose, a small, thin, lip-less, horizontal slit for a mouth, thin torsos with no ribs and no genitals evident, long, spindly, but surprisingly strong arms reaching to the knees, similarly long, very thin legs, and hands with three, long, non-tapering, joint-less fingers, which end in claws instead of fingernails, but no thumb.

To be sure, there is such a race of beings; or at least a race of which this is one variant. However, there are also: five-foot tall "Greys", seven-foot tall "Greys", "Greys" with mushroom white skin, "Greys" with brown skin, "Greys", with black skin, "Greys" whose large eyes have a thin nictating membrane which can extend across the eye, "Greys" with midnight-blue eyes, "Greys" with wispy fine small amounts of hair on their heads, "Greys" with four fingers, and "Greys" with three or four fingers and another finger positioned where the human thumb would be, and "Greys" whose fingers end with suction-cup-like tips.

There have also been extraterrestrials reported who have a large process of folds along the back of their heads, a series of deep creases or crevices along the top of the head, sloping down forward towards the front, and with a strongly-pronounced brow-ridge above the eyes. Are these twelve different races; or variants based on evolving in different climatic zones on one planet?

Does this represent racial variation within inhabited planets in one star system? Or are these variations which occur within one cluster of star systems? Or does the "Grey" genotype tend to appear in many different star

systems, on some planets, along with other races, on other planets, within those same star systems?

The truth is, we do not know. Or at least that information has not been released to the public. Thus, we are still at the stage of gathering information on the various different types of intelligent lifeforms visiting our planet.

## CLOTHING.

Another source of variation even within what is apparently one race is clothing. Many experiencers report that their "Grey" visitors wore no clothes. Others have seen "Greys" wearing long robes and hoods over their heads. Others have seen crews where both versions of attire, as well as close-fitting jumpsuits, were in evidence. Yet Greys are not the only ones wearing robes.

## ANOTHER RACE.

Another race of extraterrestrials is the 4 - to - 5½-foot tall being, with a somewhat large head (by comparison with the human head) but not as proportionally large as the "Greys", and who has somewhat large (but smaller than the "Greys") dark oval eyes, spindly frame and limbs, and a hand with three long, cartilaginous, bone-less fingers, which end with neither claw nor suction-cup, but rather "ordinary" fingertip shape, except that their fingers do not taper.

## THE "PRAYING MANTIS".

A more distinctive kind of extraterrestrial is the "Praying Mantis type" race. These beings have long, narrow faces, with long, narrow, large eyes, sharply slanted upwards and outward in an almost narrow-V position, giving an almost insect-like appearance.

This comparison is heightened by the Praying-Mantis type's extremely thin, long torsos, long, extremely thin arms which are usually crooked into a sharp bend at the mid-joint, with the hand and fingers/mitten sloping almost vertically downward from the "wrist", and legs also bent at an almost right-angle at the mid-joint, creating a crouched pose.

The overall effect is the characteristic "Praying Mantis" look. It should be noted that experiencers feel that this type is no insect, but rather an intelligent, gentle-spirited, but somewhat "hyper" and jerky-moving, human-like lifeform, both males and females.

## "REPTILIANS" OR "REPTOIDS".

Another race is the so-called "Reptilians", or "Reptoids", although I note again that there is no implication in these descriptions other than of intelligent, communicative persons.

What distinguishes these "Reptilian" extraterrestrials is their skin, which has small, fine scales, rather than smooth; their face, which has larger-than-human



yellowish-green eyes with a “starburst”-shaped pupil; the eyes often oval, and an almost snout-like blunt process in the area of the nose and mouth, giving this type an almost dragon-like humanoid appearance.

### THE “JAWAS”.

Another group of extraterrestrials, for convenience, I call the “Jawas”, after their resemblance to the creatures in the film, *Star Wars*. This group is distinguished by their clothing. They wear hoods and robes, are generally short (three to four-and-a-half feet tall), and their faces are concealed by the shadows thrown by their hoods.

Sometimes there is a much taller hooded and robed one on board the UFO, who often stands to the experimenter’s left as he/she lies on the ET medical examining table. This Tall One appears to direct the procedures, and often is the one who telepathically communicates with the experimenter.

A few experiencers have noted glowing eyes under the “Jawas” hoods. Other experiencers have reported that when they got a glimpse of the being whose face was shadowed by the hood, it was a type of “Grey”. Still others saw neither glowing eyes nor “Greys” under the hoods, but rather never could distinguish the features in the shadows of the hoods.

There are often mixed-race crews on the UFOs. In such cases there could be “Jawas” or “Praying Mantis” types or “Reptoids” or “Greys” joining in a coordinated effort in carrying out scientific or medical tasks.

A few experiencers have noted robot-like figures, whose movements and “vibes” (or rather lack thereof) strongly suggest that these are *robots* sent remotely by the extraterrestrials to observe, reconnoitre, and possibly retrieve objects.

However, I have not encountered any reports of robots actually interfacing with humans to accomplish communication, or to remove the human to their craft for scientific examination. The robot-like figures appear to be relegated to the more impersonal tasks of information-gathering and stealthy surveillance, without the risk to the extraterrestrials that they would otherwise run, of possibly encountering hostile human responses.

### “HUMANOIDS”, “BLONDS”, “NORDICS”.

My research has come up with a goodly number of reports of “Humanoids”, “Blonds”, or “Nordics”, extraterrestrials almost indistinguishable from humans.

I have also encountered reports where the experimenter believed that the extraterrestrial with whom he/she was dealing appeared to be a human. However, in every case, this turned out to be an extraterrestrially-imposed mental visualization in the mind of the experimenter, the so-called “screen memory”.

Upon closer looking, the experimenter was able to see the actual nonhuman face of the extraterrestrial behind the mentally-imposed “human” mask.

My favourite variation of this mental cloaking experience occurred to one experimenter who believed that she was encountering a human “spaceman”. I invited her to look closely and carefully at the face of the “human spaceman”. When she did so, she suddenly was startled. “Oh, my”, she said, “It’s not a human after all. It’s one of those Greys”.

Other details made me suspect that we were still not done. I suggested that she study closely the face of her “Grey” visitor. Startled, she could see that it was a “Reptoid” who had previously cloaked himself mentally as a “Grey”.

### “DWARVES”.

Another extraterrestrial racial type described are the short, chubby “Dwarf” extraterrestrials, with round pudgy faces. They seem to be relegated to doing the menial chores during a contact.

Undoubtedly, many more races could be described. We as humans are challenged by intelligent life that looks so different from us, a challenge which can be disturbing. But it can also remind us that the Source of All is myriad in its expression of lifeforms, including intelligent lifeforms, across the vast Universe.

Only the anthropocentric would be offended by the Supreme Source’s creation of intelligence in other anatomical packages. And, indeed, ET messages tell us that we ourselves are that special variant mix of intelligent life; part-Earth primate, part-extraterrestrial intelligent lifeform.

Maybe “Yes”, but also maybe “No”! I still wonder. And I remember the South African case, which we published in FSR, years ago, about the alien entity that entered a car being levitated by them, and said to the driver: “We can make you see what we like. If it’s a duck, we’ll make you see a duck!” G.C.■

## V. TWENTY POSSIBLE SIGNS OF “E.T.” ENCOUNTERS. © BY RICHARD BOYLAN, PhD.

1. Unexplained persistent anxiety or restlessness after experiencing an event which has no ordinary explanation.
2. A strong fearful reaction when confronted with objects, pictures, stories, films, etc. which are associated with close extraterrestrial (ET) encounters.
3. Persistent insomnia after a highly unusual event, and/or nightmares with themes of UFOs, ETs, or close encounters.
4. Repeated daytime thinking about, or daydreaming about, or extremely vivid “dreams” about UFOs, ETs, or

close encounters.

5. Compulsive behaviour concerning UFOs or ETs, such as voluminous reading of any and everything available on UFOs.

6. Unexplained moodiness or irritability after an anomalous UFO-related incident.

7. Body symptoms or marks characteristic of a close extraterrestrial encounter.

8. Experiencing an unexplained substantial period of missing time following an anomalous incident.

9. Having sudden onset of feelings of social unordinariness.

10. Experiencing a new cosmic awareness and perspective, which frequently breaks into one's daily thinking.

11. Suddenly feeling an affinity for the personal ET-encounter experiencers one sees or reads about, or feeling an attraction to extraterrestrials as somehow familiar.

12. Having the sense of having received telepathic messages from the ETs, or repeatedly receiving gifted intuitions.

13. Having a sense of sharing the space in one's mind with an extraterrestrial.

14. Noticing the beginning of psychic ability, or, if already psychic, noticing a marked increase in psychic abilities.

15. Feeling attracted to a spirituality or religious practice which is based on the in-dwelling of the Supreme Source in all Nature, and as a result, the importance of reverencing all life-forms as related to you.

## **VI. A PERSONAL ANNOUNCEMENT FROM DR. RICHARD BOYLAN, PhD.**

Rather, it is in response to a series of threats to my family, especially focussed on one of my children, that I cannot and will not ignore. That benighted consortium of private sector and rogue governmental operations, which is responsible for the down-and-dirty side of the UFO cover-up, has escalated to death threats that I am obliged to face up to. Thus, the change in my public focus in matters ufological.**

You all know that I am not faint-hearted. I have placed my personal life, reputation, professional career and savings on the line, in pursuing my research and publicising my findings. In so doing I have suffered enormous personal harm. I can stand that. *But I will not place my family at risk in the face of these escalated grave threats.*

This decision is firm. I ask your understanding, and if so inclined, your prayers or other spiritual support.

At its most fundamental, this struggle between the fear-hate-attack side and the peaceful side of the UFO community mirrors a spiritual struggle in the Cosmos between the forces of Darkness and Light.

May we all advance in love and light.

#### NOTE BY EDITOR OF FLYING SAUCER REVIEW.

We had not seen until now very much of Dr. Boylan's writings on the UFO Problem, and what we had seen has at times inclined me to think that he was one of those very numerous people who (possibly merely gullible or possibly directly influenced) obstinately refuse to recognise that there is, in this "subject" of ours, at least also a very great element that is plainly evil and deeply hostile to our species. If however I am wrong on this point, as may well be the case, and if Dr. Boylan agrees with us on this point, then I feel sure I can say that I agree with all that he says in his article above.

On the question of harassment, threats, veiled or unveiled, and even murders, we all know enough now to be able to perceive that there *is*, as Dr. Boylan suggests, quite probably a secret human, governmental agency of the armed forces or of the security and secret services, in both the USA and in Britain, and elsewhere, which is active in watching, persecuting and harassing - and sometimes *murdering* investigators of the UFO problem. (The latter, by the way, are generally not notable for any interest in **politics** or in any matter that might be considered "politically subversive").

But what we apparently do not know for certain is this:- *Are they acting on the direct instructions of a Government, in an attempt to find out how much some of us have discovered about UFOs, or are they simply the tools of a Government that already **knows** everything about UFOs and is itself already controlled, as many of us suspect, by alien intelligences?*

*A third version, which one occasionally hears, is that maybe these are "rogue units" of the Military or the Intelligence Services, who are somehow or other able to operate on their own.*

That these agencies do harass and do maim and do kill, I have good personal reason to know for a certainty. An example of their activities here was the murder of the

Englishwoman Hilda Murrell who was killed by Military or Security/Intelligence operatives a few years ago.

We know too - because the former British Police Sergeant Tony Dodd has courageously published the facts in his book *ALIEN INVESTIGATOR* (1999) - that very recently he and his wife were taken out by unidentified American men to a lonely spot in the desert of the U.S. South-West and blatantly informed that, "*if they did not watch their step*" *their bones could end up out there and nobody would ever know what had become of them.* (See also the entire history of the Roswell Crash affair, in which numerous eyewitnesses have reported how they had been threatened with "serious trouble", or "Worse").

All these things are most emphatically occurring. But one must add that, so far it appears impossible to perceive with certainty what the actual roles of our own Governments can be in it all. **That they are the direct (even if unwilling) tools of malignant alien forces which have "taken over" here and are now "in the driving seat" here, cannot however be ruled out.**

It is extremely "interesting" news when we learn that, at precisely the same time as Dr. Boylan, his friend Dr. Roger K. Leir (another Californian resident) - is starting to experience similar "difficulties" in connection with his own research, which lies in the area of alien body implants.

Joël Mesnard, the editor of our French "opposite number", *LUMIERES DANS LA NUIT* (41st year, September 1999) has a lengthy article entitled "OBSTACLES OF HUMAN ORIGIN," which *inter-alia*, dwells on the British phenomenon of the "cornfield circles" and all the fantastic attempts of the British Government and its minions to provide effective "explanations" with the aid of the two famous old "daddy master-fakers", Doug and Dave and others.

For the moment I will discuss only that part of this French report that deals, both with crop-circles and with the "obstacles" suddenly confronting Dr. Roger Leir.

Clearly there is "someone" who dislikes Dr. Leir and his activities just as much as they "dislike" Dr. Boylan's activities. Here is Joël Mesnard's highly instructive little account, about which we must all do some very sharp thinking:-

#### LES ENNUIS DU DR. LEIR (DR. LEIR's "DIFFICULTIES") LDLN Nov. 1999 (page 4)

Translation from French: G.C.

Our last issue of LDLN, in which we had an article about the alleged "extraterrestrial implants", was just going to press when I learned from the French UFO researcher Gildas Bourdais that Dr. Roger Leir, the pioneer in the extraction of these little objects, was suddenly encountering serious difficulties. Here is a brief summary of it all:

In February 1999 Dr. Leir (already with 35 years of professional career behind him) learned that he was going to have to appear before a tribunal in May 1999 owing to a complaint lodged on March 17, 1994 (!) by a former patient on whom he had performed an operation in 1990 (!!). The reason for the charge - the first ever in his 35 years of professional service - had been a relatively banal

incident, namely *a post-operative infection*. (We all know how the bringing of charges against doctors has become a regular practice in the United States, and is beginning here. G.C.)

Dr. Leir had in fact been already notified and aware of this charge - *five years ago*, but as it had never led to any concrete action against him, he therefore felt convinced that the affair had long ago been settled by the U.S. Medical Board and closed.

Dr. Leir's lawyer, Gregory Avery, who specialises in this sort of affair, explains that in all cases of this kind - that is to say when suspicions are voiced regarding a doctor - the Medical Board's golden rule is always for *speedy action*: if a doctor (in this case a chiroprapist - in the USA termed a "*podiatrist*") - does not have, or no longer has, the expertise necessary for the proper exercise of his profession, he is, quite understandably, *immediately subjected to a general review and scrutiny of his competence*.

*Well now, in this case the Medical Board waited five years before embarking on any procedure of the examination and evaluation of the competence of Dr. Roger Leir! there is no "normal" explanation for this astounding delay of five years!*

*But it so happens that in 1999 Dr. Leir was now known for his work in researching and extracting mysterious implants from the human body. Most notably, he had been seen, on February 17, on the NBC Television channel, following the appearance of the book **The Aliens and the Scalpel** written by him and his colleague Derrel Sims. (Reviewed in FSR 44/4, G.C.)*

*The hearing against him opened on February 16, 2000, and during it, he was not permitted to speak or*

*even to communicate with the Court in writing! The judge delivered his verdict on April 23: Dr. Leir was to be "put on probation" for three years.*

*Dr. Leir is not a young man, the shock of this sudden impugment of his professional competence, added to the normal fatigue engendered by his heavy work-load, resulted, on May 24, 1999, in a heart attack, which put him in hospital. (He had already had some heart trouble in 1985.)*

*The consequence has been that, in a particularly critical period (with all the problems, notably family problems, and financial worries too) his research on implants has clearly had to be halted.*

*Contemplating the possible 'reasons' for this sudden and scarcely comprehensible "resurrection" of a matter that had been buried and forgotten long ago, AND JUST AT THE VERY MOMENT AS DR. LEIR WAS MAKING KNOWN HIS WORK ON THE IMPLANTS, the comment of Dr. Leir's lawyer is:*

*"I DON'T BELIEVE IN CHANCE. I BELIEVE IN CAUSE AND EFFECT".*

\*\*\*\*\*

So here, dear FSR reader, in the cases of Dr. Boylan and Dr. Leir, you have something on which to reflect deeply. The offence of Dr. Boylan is that he investigates UFOs. The offence of Dr. Leir is that he finds -and publicizes- body implants from UFOs.

Are these not just two more wondrous examples of the machinations and the devilry of that corrupt and evil Power which controls this entire world and all of us, and that has the whole of "anaesthetised", sleeping, unwitting, and witless mankind by the throat? G.C.■

## THE KHOURY CASE (AUSTRALIA), BY GORDON CREIGHTON.

Every UFO report has something weird about it, but this one seems one of the weirdest yet.

We learn that Bill Chalker, one of FSR's Correspondents in Australia, has recently investigated a highly unusual encounter case that involves a possible *alien hair sample*.

The sole participant in the case, Peter Khoury, born in the Lebanon in 1964, emigrated to Australia in 1974, and married there and has a family. He owns a business connected with cement production.

### FIRST ENCOUNTER.

Khoury says that during the night of July 12, 1988, he was lying in bed when he felt somebody grab him by the ankles and his entire body went numb, paralyzed. He could move nothing but his eyes. [We have heard of this feature in other cases. G.C.]

On the right side of his bed he could see three or four dark-robed figures, 3 - 4 ft tall, who informed him telepathically that no harm would come to him. Moving his eyes towards his left, he found two more beings there who were completely different - tall, thin, of a "golden" hue, with big black eyes and narrow chins. One of these

also contacted him telepathically, and told him not to worry and that it "would be like the last time" (sic). This being's eyes seemed to be friendly, almost "smiling", as they say.

They inserted a long needle-like flexible tube into the top left-side of Khoury's head, after which he seems to have blacked out.

Upon regaining consciousness, Khoury leapt from his bed and ran to find his relatives (father and brother) who were sleeping in another room. He awakened his brother and found him apparently "groggy". [Perhaps evidence that, as in so many cases, *the aliens had kept the father and brother fast asleep*. G.C.]

On checking the time, Khoury found *that two hours were unaccounted for*.

Next day his wife examined his head and found a puncture. Khoury asked his doctor to look at it, and when he told the doctor of his UFO experience the doctor just laughed at him and ridiculed it.

Months later, Khoury heard of Whitley Strieber's book *Communion*, and got a copy and read it. He saw that the "little Grey" shown on the cover was identical with the smaller type of the creatures that he had seen.



He joined a UFO study group briefly but found they could answer few of his questions.

## SECOND ENCOUNTER.

In the night of July 23, 1992, Khoury had his second experience.

He had been in bed and fast asleep, when suddenly he sat up and discovered two naked females sitting on his bed. (An extremely weird feature is that "*he could also see them through the back of his head*".)

The nearest of the two females was a big hefty blond, seemingly "in her mid-thirties". *She was a head and a half taller than he", and he is 6 feet.*

She had fair skin, high prominent cheek-bones, a big nose, normal-sized mouth and lips, a face longer and more pointed than we humans have, and eyes two or three times larger than is usual for humans. She seemed to have normal female breasts and he says she "*looked very humanoid, but not human.*"

Khoury says her hair, half way down her back, was somehow "exotic", and "wispy" and somehow "fragile". [May have been artificial].

The second female was small, shorter than Khoury, and had very straight, stiff black hair that he said "looked artificial". She herself "looked Asian - but too extreme - a bit as though she had been punched in the face by Mike Tyson!"

The next thing was that the big blond grabbed Khoury vigorously and pulled him towards her breast. Clearly, he says, she was extremely strong, "*but somehow she seemed to be without emotion*"

He resisted her, and she grabbed him again, and then again for the third time, and *this time he bit off the tip of one of her nipples and it got stuck in his throat! To his astonishment, he says it "felt like biting a plastic dummy. There was no blood!"*

She looked mildly surprised, as if to suggest, perhaps, that that wasn't quite the right sort of behaviour that she expected.

Khoury was gagging and coughing furiously and trying to bring up the piece of her nipple from his throat.

And, when his bout of coughing had ended, he looked around ....AND THE WOMEN WERE GONE!

## A GENITAL MYSTERY!

He went to the toilet for a drink of water and also to relieve his bladder for he badly needed to urinate. Then he found that his penis was very painful, because, wrapped tightly around it, beneath the foreskin, was some hair, which he found extremely painful to remove. The hair consisted of two intertwined pieces, the larger one some 10 - 12 cms. long, and "whitish rather than blond, and thin". It did not curl, and was "springy". Not surprisingly, he immediately associated it with the blond woman, though he had no idea how it could have got there.

He at once put the hair into a plastic bag and would let nobody look at it until he could turn it over for DNA testing, to the A.P.E.G. (Anomaly Physical Evidence Group) which he finally did in April of this year (2000)

A.P.E.G. are understood to be a group of professional scientists - all of them choosing to remain anonymous.

An extremely detailed report by them indicates that the blond hair - from whomever it might have come - was indeed pretty strange. Our report states that after surveying the available literature, the A.P.E.G. found it, seems, that only four persons could be identified as having had the same DNA matching, *and those four were all of the Chinese/Mongolian racial type which would of course mean individuals of Asian appearance and with black hair.*

The case remains highly mysterious for there is of course no way in which it can be *proved* that the fair hair came from the alien. Khoury of course had had no relations with any other woman, and the test of the sample of his own hair indicated his ordinary European background. (Apparently the analysis of his **wife's** hair was less easy, as it had been chemically treated by a hairdresser).

Altogether however *the testing had shown five differences from what is normal for humans, which means it seems, that while biologically close to normal human genetics, it is of an unusual racial type.*

For comparison, says the report, Neanderthals differ from modern humans at 27 locations in the same DNA, while chimpanzees differ from humans at 55 locations. This particular hair had differed at 5 locations.

## THE IMPLICATIONS.

Conclusions are difficult because, as emphasised, there is *no proof* that the blond hair came from the big fair alien whom Khoury claimed to have seen.

We have no evidence as to whether in fact Khoury actually had sexual relations with either woman. Certainly he has no recollection of it, or of having had sex with any other females. And, if the aliens had actually abducted him (probable, given the time loss) there is still no evidence as to whether he had sex with that particular female or with any other of them.

Whatever the details in this respect may be, it seems very evident that these two female creatures encountered by Khoury were *not hybrids, but were entirely artificial entities, - robots. If the nipple of a hybrid were bitten off, surely it would bleed!*

And we should not forget that Khoury himself had said that the "Asian" woman's hair had "looked artificial" and that her eyes (like glass eyes) had "shown no sign of life".

Khoury said that the object that had been lodged in his throat was suddenly gone after three days, and then his coughing stopped.

*Anyone who has had many years of experience in Parapsychology and in psychical research will not be surprised to hear that the mysterious piece of "nipple" should have vanished like this. To me nothing proves more effectively than this the fact that Khoury's visitors were not of this world, but in all probability from another dimensional level.*

However, in such cases of psychical materialisation from other planes, one would also expect everything else to vanish mysteriously.

*So what about the fair hair? That ought to have finally gone too!■*

# **A 1999 UFO WAVE IN MALAYSIA. © BY AHMAD JAMALUDIN, FSR Consultant (Malaysia and S.E.Asia).**

**U**FOs do not seem to pay much attention to Malaysia. On average only two sightings have been reported each year. While other nations have abounded with reports of UFO abductions, animal mutilations, and crop circles, not one case of such a nature has been reported here. Much of the excitement therefore seems to be missing in Malaysia.

But on the other hand, as regards UFO waves, this relatively insignificant piece of land cannot hide itself from whatever is coming from the direction of the sky, if that is where they are coming from. It has been observed that the region of Southeast Asia has received a certain amount of concentrated UFO manifestation once every 10 years (plus or minus a year).

There was a surge of reports in 1948 around Indochina and the Philippines. In 1959, New Guinea, at the southern tip of this region, was the choice of these anomalous visitations (1). Then in 1970 a wave of tiny UFO beings and their miniature craft was encountered across the Peninsula of Malaysia (2). In 1979 they made a comeback in a larger size in the Philippines (3). Therefore we expected them to show up again in the 1989 timeframe. However, there were none.

This disappearance from their regular 10 year cycle is suspected to be attributed to the wave area being out over the ocean. Hence there were no sighting reports. If this assumption is correct, then they should have been back in 1999. For whatever reason behind this 10 year cycle, the UFOs were indeed back. This time in Malaysia.

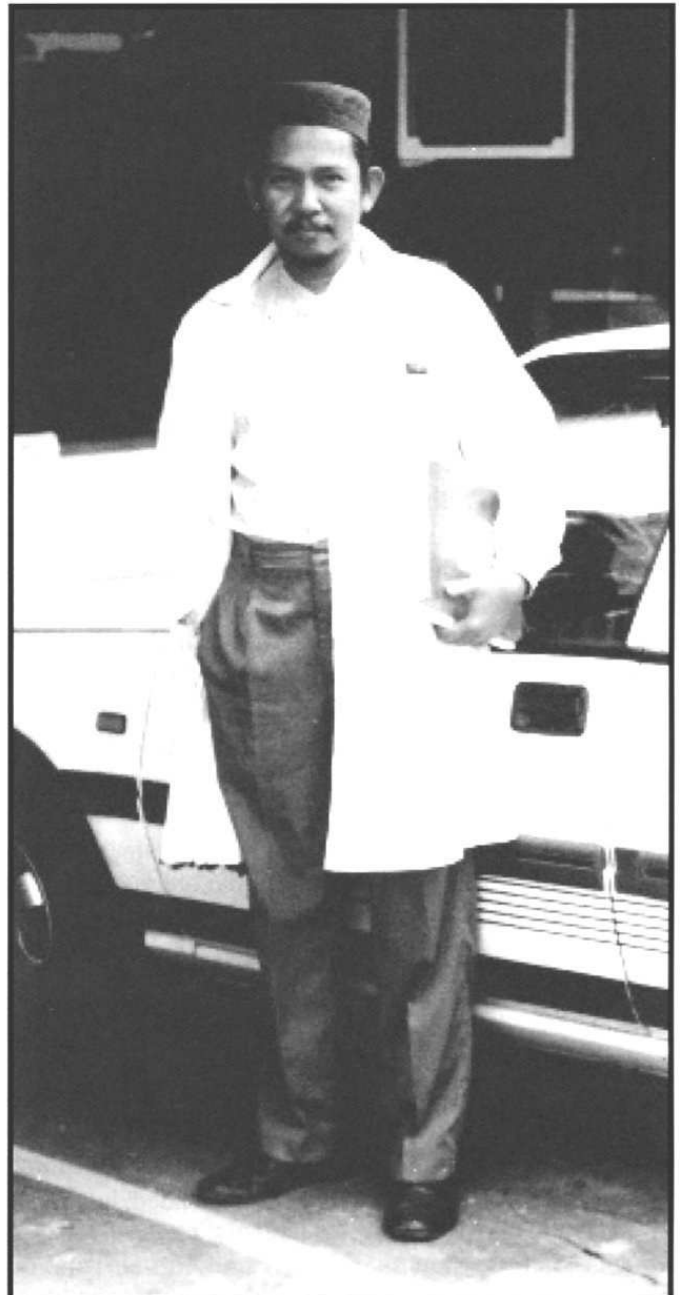
During early April, a lone UFO with bright lights appeared over the village of Tanjung Sepat, the scene of nightly aerial manifestations in 1995, which drew crowds of hundreds of people to the scene. In May, there were already indications that the wave had started. On 5 May, a witness in Kuala Lumpur, the Capital, saw a round object hovering in the sky overhead.

It had 8 dim blue lights on the base. Several witnesses near Baling, further to the north, reported that they had caught sight of a silent UFO with greenish lights loitering over their village early in the morning hours. A few hours before the UFO appeared, a loud explosion like thunder was heard over the area.

According to Mohamad Nor Abdul, 60, the explosion was very loud and strange. It had not sounded like any thunder we are familiar with. Then at 5.20 am, he caught sight of a strange flying object in the air. It was silent but giving out some light. The 1959 New Guinea UFO Wave was also accompanied by thunder-like sounds (4).

The witness described the thickness of the object as about 1 metre in height and its body was greenish-blue in colour. He lost sight of the object as it passed over the jungle.

The next day another UFO was sighted at Ipoh in the

evening. A female police clerk, Salmah Hashim, 44, claimed that on returning home from work at 7.00 pm, she and her 12 year old daughter spotted a silent object, red-yellow in colour, circling in the sky. At first she took it for a helicopter.

But on closer inspection, it appeared to be strange. At a different part of the town, another witness travelling in a car with his son spotted a bright object flying near the town's football stadium. The time was around 6 - 7 pm. It could have been the same object or a different one.

A week after the UFO had appeared near Baling, just 50 km further south, the village of Batu Lintang was in excitement when several local residents claimed that they had seen small greenish beings near the village road.



These beings were described as around 1 - 2 feet tall, big bald-heads, greenish skin and apparently not wearing any clothes. They were seen sometimes singly and at other times there were 3 of them. The location of the sightings was always in the same area. However no UFOs were seen.

One witness, Jamsari Mohamad, 24, claimed that early one morning, at 3 am, he and four other friends had spotted 3 strange beings, greenish in colour which appeared out of some bushes and crossed the road. The beings, under the street lamps, appeared human-like but very small. As they tried to approach the entities, these suddenly vanished.

A more significant UFO - humanoid association came at the height of the wave, when one strange lighted object landed at a secluded spot in Kampong Bemban Hilir on 22 May. The witness, Mohamad Fahmi, 16, claimed that he was awakened in the early morning hours when he heard the zinc roof of his house rattling. Thinking that there was a rainstorm, he peeked out through a chink in the wooden wall and beheld a bluish lighted object flying slowly over his house. He opened the back door and saw the object come closer to the ground near bushes about 20 feet away from his location.

He then saw a door open below the object. At the same time the UFO began to glow much more brightly. During this process he managed to catch a glimpse of a creature coming out of the object. Due to the bright light, the facial features of the being were not clearly discernable. But he did see its shape clearly, though only half of it. The being was described as about 1.5 feet tall, with drooping ears. The head was a bit pointed and the arms were long.

The sight of this strange being caused him to panic. Strangely he did not attempt to wake up his brother who was sleeping with him in the hall. Then he heard the sound of the door on the UFO closing again and it sounded metallic. In just a few seconds, the UFO took off silently into the sky. This case could very well be dismissed as a dream or a hoax if not for the fact that, in the morning, he told the story to his brother, and they went out to inspect the landing site. There they found several foot-prints, 0.5 cms deep, where he had seen the being walking (see photo). The prints had four toes with pointed ends or claws. [The accompanying photo was too poor to reproduce. -G.C.]

Earlier, on 18th May, several witnesses in Bintulu, Sarawak, observed a strange round object which was 4 times bigger than the size of the Moon. The object was first spotted low over the ocean. Then it started to expand and grew in size. This size change frightened the witness, and he did not wait to see the rest of the phenomenon. But on glimpsing back, he observed that the object had now begun to shrink back to its normal size. It was reddish-orange in colour.

There was a lull of reports in June, but the UFOs appeared again in July, the last month of their appearance in Malaysia for the year 1999. There were no more UFO reports till the end of the year.

### COMMENTS.

As usual, after the wave, the UFO situation in Malaysia is again quiet. To see UFOs again in a significant number, we will have to wait for another 10 years! One thing which requires in-depth study is the fact that UFOs are probably related to seismic events. I have observed time and again, for the events in Malaysia, that if there are UFO sightings then there is bound to have been a slight earth tremor in the 3 month period preceeding the UFO sighting. When this 1999 wave broke out, I knew very well that the tremor was coming. But when?

Timing from the last reported sighting, I predicted that the tremor should strike anytime between October to September. And finally, in September, I had the confirmation! It was a 5.5 magnitude earthquake striking the neighbouring island of Sumatra in Indonesia, and the tremor was felt as far away as the Klang Valley in Malaysia.

## A REPORTED CLOSE ENCOUNTER IN GERMANY. From *UFO-Nachrichten*, Germany, (Jan/Feb 2001).

(Translation from German. G.C.)

Herr Helmut Chodan, member of a Frankfurt UFO research group, claims that on November 30, 1989, he received the following story in a telephoned message from a man living in Albstadt (Hesse), but who refused to give his own name. (This man subsequently came to one of the local UFO study group's meetings, and met

Herr Helmut Chodan, but still refusing to reveal his name.)

The percipient told Herr Chodan that he is a keen amateur archeologist and user of a metal detector. He said that one day -date not given- while strolling with his metal detector in a forest near Judenwiese (Albstadt region) he came upon a landed UFO and, standing talking

near it, three of its crew members.

Their craft was about 12m long and 4m high, of tubular or airship shape, with no detectable windows, and with "rounded ends" and of a silvery colour.

The three occupants, in clothing also of silvery hue, were about 2m high. He gave no further details of their features etc.

He addressed them in English (presumably, no doubt because he thought them *Americans?*), and asked if they had problems. They at once replied in *German*, adding that they knew many of our languages.

**They confirmed that they were not from this world, but they have great underground and underwater bases here, and they explained that, in coming here (they did not say from where) they utilised the cosmic energy lines of the Universe, and travelled with them, as sailing ships would use the tides and winds. They also mentioned their ability to manipulate or transform matter.**

He talked with them for three hours, but they would not let him enter their craft. They then went back into it and took off vertically "and made off towards the Moon". (He does not seem to have said how he knew they were going to the Moon! -G.C.)

He mentioned one very interesting feature about their silvery clothing. He said it "*looked as though filled with liquid*".

#### **N.B. NOTE BY EDITOR OF FSR.**

I am greatly inclined to think that this is a genuine story, for almost all of its features seem to be identical with, or astonishingly similar to, the features of two cases reported by us in FSR years ago.

The first was the case of the American grain buyer Reinhold Schmidt, who encountered just such a craft and just such very friendly, human-like, tall people, near the Platt River in Nebraska, and when he reported the matter to officials in the nearest large town, he was promptly clapped into prison and given an unpleasant and extensive grilling for several days by Air Force Intelligence officers and/or CIA men.

The second case was that of a man named Bracciolo, who one day encountered precisely such a craft and such beings, very friendly, outside Florence in Italy.

These cases of Schmidt and Braccioli also both occurred in broad daylight but, so far as I can recall, in both these cases the percipient was permitted to enter and view their craft. G.C.■

## **MYSTERIOUS HUGE "ALIEN FROGMEN" IN CENTRAL ASIAN LAKES! © BY PAUL STONEHILL,** **Director and Founder of the Russian UFO Research Centre, California, and FSR** **Consultant. (P.O. Box 571951, TARZANA, CA 91357-1951)**

#### **NOTE ON PAUL STONEHILL.**

[In my article *UFOs in the Soviet Waters*, in FSR 44/1 (1999), I gave an account of the book *THE SOVIET FILES: PARANORMAL ENCOUNTERS BEHIND THE IRON CURTAIN* (ISBN 1-85833-858-1) by Paul Stonehill, the Ukrainian-born (Kiev) investigator who founded the Russian UFO Research Centre at Tarzana, California.

Born in 1966, and so today aged 34, Mr. Stonehill tells us that he first became filled with the desire to explore the UFO mystery when, just 8 years old (1972), he met a retired Soviet pilot who told the boy how, when flying over the Russian Arctic regions, he had once seen a disk-shaped craft that followed him and his crew so closely that finally they had opened fire on it. One year later (1973) Stonehill's parents left the USSR and took the boy to the U.S.A. and adopted their less "Russian-sounding" new surname.

In my article under reference (in FSR 44/1) I gave a summary of some of Stonehill's researches on the Soviet experience with UFOs under the seas.

#### **NOTES ON PAUL STONEHILL'S ARTICLE.**

[On page 15 of FSR 44/1 (1999), at the close of Paul Stonehill's article on the *UFOs in the Soviet Waters*, we gave the following brief item about *another* Russian mystery - *not in the oceans, but in the lakes of Russian-controlled Central Asia!*:-

"A man named D. Povaliyayev was hang-gliding one day in the early 1990s above the town of Kavgolov in the Leningrad area. The region has many lakes, and in one

of these lakes he observed what seemed to be "*three gigantic fish*". *He descended in order to get a closer view, and was able to observe "swimmers in silvery garb"*. He mentioned this episode in a book written by him - "*LETUCHI GOLLANDETS*" ("*THE FLYING DUTCHMAN*") - published in Russia in 1995.

In that particular area of Northern Russia there have been many UFO sightings."

#### **FURTHER AND FULLER REPORT.**

In continuation of this strange new phenomenon, "ALIEN LAKE FROGMEN", in Russian Ufology - certainly I myself had previously never heard of such a thing - I now give below a further and fuller report which Mr. Stonehill has just sent to us, and which describes weird great "alien frogmen" allegedly seen in, or reported from, several of the lakes in Soviet Central Asia, in the early 1980s, and only recently researched by him. G.C.]

#### **PAUL STONEHILL'S NEW ARTICLE.**

##### **RUSSIAN UNDERWATER ENCOUNTERS: WHAT LURKS BENEATH THE SURFACE OF THE LAKES?**

In the autumn of 1982, a Soviet Army officer, Mark Shteynberg, and a Lt. Col. Gennady Zverev, were conducting periodic training sessions of military reconnaissance divers ("frogmen") from the Turkestan and Central Asian Military Regions. The training exercises had been taking place in ISSYK KUL (Lat. 42°30N., Long. 77°30 E), a deep lake in the Transiliysk Ala Tau area, Kyrgyzia.

One day, totally unexpectedly, these officers received a visit by a very senior officer, Major-General V.

Demyanko, Commander of the military Diver Service of the Engineer Forces of the USSR Ministry of Defence.

He had come to inform them of an extraordinary event that had recently occurred during similar diving exercises by military frogmen in the huge Lake Baikal, (Lat. 51°00 N, Long. 108° E, some 1,500 miles to the north-east, in the far eastern Trans-Baikal area of Siberia, and also in other lakes (not named) in Western Siberia.

In those lakes, during their diving exercises, the men had encountered mysterious "underwater swimmers, very human-like, but huge in size (almost 3 m. in height!)"

These beings were clad in tight-fitting silvery suits, despite the icy cold temperatures of the lake waters. They encountered the "mystery swimmers" at a depth of 50m. The strangers had no scuba diving equipment ("aqualungs"), nor any other detectable equipment, apart from sphere-like helmets on their heads.

Alarmed at this situation, the local Military Commander at Lake Baikal decided to try to capture one of the entities, and sent an officer and a squad of seven divers with a net to do the job.

**When however, the seven Soviet frogmen attempted to net a "Visitor", the entire group of seven divers were flung up out of the lake by a powerful force. When returning from such a depth, it was essential for the men to be decompressed, and this is a slow process that has to be strictly followed.**

**The seven men were severely ill as a result, with aeroembolism - Caisson disease, and a compression chamber was at once essential for every one of them.**

**In the Baikal Area the authorities had several such chambers, but only one was in working order, and it could contain only two men at a time.**

**The local commanding officer tried to put four of them into the chamber at once, and the result was that 3 of the divers, including their leader, died, and the other 4 were left as permanent invalids, - the terrible consequences of characteristic Soviet inefficiency and bungling.**

The Major-General was now rushing to Issyk Kul to warn the local military, lest any similar rash acts should occur. (Issyk Kul is a great deal shallower than Lake Baikal, but nevertheless the authorities evidently felt that such beings might be there. Or maybe they even *knew* this as a fact. Did the Major-General already know something? ).

A short time later, the Headquarters of the Soviet Military Region of Turkmenistan received an Order from the Commander-in-Chief of the Soviet Armed Forces. It gave a detailed account and analysis of the Baikal episode, and was supplemented by an information bulletin issued by the Headquarters of the Engineering Forces of the Soviet Ministry of Defence.

This bulletin listed numerous other deep-water lakes where there had been "*anomalous phenomena*": sightings of underwater creatures similar to those seen in Lake Baikal; the descent or the surfacing of gigantic discs and spheres into or from the lakes; powerful luminescence emanating from the depths, etc., etc.

The purpose of these documents, in all cases *highly classified*, "for eyes only" of a very limited circle of senior military officers, was stated to be "*to obviate the occurrence of unnecessary encounters*"!■

## **A UFO CAUSED PANIC AT RIGA AIRPORT, LATVIA: CONFIRMATION OF THE EVENT (1961).**

*A few rumours about this incident had circulated in the USSR. I was aware of some, but until 1996 did not have the complete story. Here it is:-*

**I**n August of 1961, a test flight of the most modern Soviet fighter-interceptor jet was to take place. The top brass wanted to film everything, so as to demonstrate the might of the Soviet Air Force. A film crew, headed by Victor Dudinsh, was commissioned for that purpose.

They set up their equipment in the vicinity of the airplane, next to the take-off and landing strip, at Riga Airport, in Latvia. Over one hundred military officers had been waiting to see the air show. But nothing happened. The jet had worked perfectly the day before, but now the pilot could not start the engine. At the same time a sinister sound pierced through the air, and a strange object appeared in the sky.

It appeared from nowhere and everyone was able to see it at once. They started running in every direction. Fear gripped everyone, and panic ensued. Dudinsh, a real professional, fought this fear to film the occurrence. He aimed the camera at the object in the sky, pushed the start button, and ran to the shelter.

The object did not descend, but rather moved in a strange fashion. It would disappear, and then reappear, but slightly further from its original position. This went on for a few minutes, and then something else took place. An entity inside the UFO was seen moving about intensively. The object was illuminated by sun, blue sky in the background, i.e. the visibility was fine.

Its shape was that of a triangle, its colour violet. A few minutes later and the UFO suddenly dimmed. It remained in the sky, but became somewhat invisible. As its brightness disappeared, so did the fear. The military



crawled out from various holes and shelters, and discussed the event. Not one doubted the ET nature of the object.

Dudinsh ran back to his camera, and saw that it was working, but the film was already spent. He wanted to take it back to the studio, but the airfield commander confiscated it. The KGB arrived some time later, and took the film away.

Dudinsh, however, convinced the airfield commander to take witness statements from the hundreds of eyewitnesses. Most signed it with trepidation. The pilot was the first to sign; he also mentioned that it was probably the UFO that caused the strange behaviour of on-board equipment, and the dead engine of his jet.

Dudinsh and his colleagues did find out some time later that the UFO was filmed. Those who witnessed the object had been warned to forget everything and keep silent. Somehow the information about this UFO leaked to the West, and letters of inquiry followed. So did offers to buy the film.

To de-fuse the situation, the Soviet media published a report that the object sighted that night was a meteorological probe. For many long years no further information came from the KGB archives. I tried to get more details, but all my contacts could find out nothing.

S. Boyev pursued this case, too. He published his account in the *NLO* magazine (Issue 13, 1996). *Perestroika* was now in the air, and Boyev was able to get permission to see the film. He was preparing materials for his documentary about UFOs over the USSR.

The KGB, damaged by *glasnost* and changes sweeping the USSR, relented and released everything. A famous Soviet proponent of the UFO phenomenon, a scientist from the Academy of Sciences, V.S. Troitsky, assisted

Boyev. Still, even then the authorities did not recommend them to disseminate the information.

The first public showing of the film took place in somewhat strange circumstances. The giant hall of the Institute of High Temperatures was filled by hundreds of UFO debunkers. Exactly at midnight the light was turned off, and the crowd breathlessly watched a UFO over the airfield. The film lasted thirty seconds. For the next three minutes the audience sat silently, and then discussions literally exploded, and lasted until the morning.

Everyone had a UFO story of his own, and everyone there was tired and disgusted by the silence being maintained about the UFO phenomenon under the Soviet regime. Experts were questioned, and they confirmed that the UFO had nothing to do with weather balloons, probes, or space junk. The object was classified as a cosmic voyager, a phenomenon of extraterrestrial origin, unknown to science.

The psychosis -horrible fear- experienced by eyewitnesses was probably caused by powerful and directed infrasonic radiation. Other measurements based on the film and interviews indicated that the object had hovered at an altitude of 20 kilometres, and its "base" was more than 200 metres wide.

This affair of the 1961 Riga UFO left a mark in the history of Soviet UFO phenomena, a mark that the KGB could not hide. But not everyone agrees that the object actually was a UFO. The well-known Soviet debunker and scientist, Migulin, described it as "a weather balloon". This opinion is also shared by a respected Russian ufologist, Mikhail Gershtein. Hopefully, we will be able to examine the film closely, and find more eyewitnesses who were in Riga at the time, in 1961.■

## BIG CAT THOUGHTS, © by TREVOR BEER, FRES, FZS, MBOU, FSR Consultant.

**A** warm welcome to Trevor Beer, our new Consultant, who lives in Barnstaple, Devon, and, after a career as a writer in the educational field, is now well known as Britain's top expert on the various species of Big Cats which are found in our country and regarding which he writes regularly in the Devonshire newspaper *Western Morning News*.

A great lover of all kinds of wild life, he is a Scientific Fellow of the Zoological Society, a Fellow of the Royal Entomological Society, and a member of the British Ornithological Union and founder of the North Devon group of the RSPB (Royal Society for the Protection of Birds).

His highly popular *Nature Watch* column appears daily in the *Western Morning News* and he has just won the coveted David Bellamy Award issued every year by the British Naturalists' Association, the oldest conservation organisation in our country. FSR readers may have noticed that I have recently expressed some startling views about the possible origin of some (maybe most) of Britain's Big Cats, and I am delighted to find that Mr. Beer shares my belief that there "may be a UFO link" !

His letter in this issue shows the extraordinary range of Mr. Beer's knowledge and talents. -Editor

"Where do they come from?" The most asked question of all from believers and sceptics alike when the subject of British Mystery Cats loose in the wild in the UK and Ireland crops up. Interestingly no one asks where do they go, yet the creatures live on amongst us and we amongst them.

As a cryptozoologist and investigator into the alien big cats for many years, and into folklore and legend since the 1950s, it is the *black cat* phenomenon, of leopard size and sometimes larger, that intrigues me most of all.

Appearing and vanishing as they do with the ease of all felines, it is at times as if they disappear at will even

as one watches them. Many is the time I and others have watched such a cat crossing an open hillside when it has 'vanished' as if into thin air, presumably into a cave or some hidden goyal as we locals call the smaller coombes or unfarmed bits of countryside hereabouts.

Yet, as often as not, on going to what seems the exact spot, we find that the animal has disappeared, with the terrain showing no obvious hiding places. At such moments the air feels charged with electricity as one's own 'hackles' rise at the back of the neck and one feels as if one is in the presence of unseen, watching eyes, which is probably the case.

In recent years sightings of adults with cubs have been made which adds to the speculation surrounding these superb creatures. I have actually sat at a wood edge to suddenly feel watching eyes boring into me, have turned and there has been a black big cat just standing observing, as if it has sensed my presence and come to see what I'm up to. There has never been an obvious threat, yet the feeling is always one of awe at their power. At those moments, if it does not leave then *I do* - quite quickly.

Once two of us watched a black leopard coming towards us along a disused green lane, from a vantage point looking down along its length. The lane was bordered with trees and bushes with steepish fields on either side and leading to a waterway below.

Suddenly this cat came to a gorse patch but instead of appearing out the other side it, too, vanished. I say 'vanished' because though it might simply have lain down to rest up amongst the gorse, when we went down to look, it had gone, yet I feel sure that at no time as we walked down to the lane did I lose sight of the spot.

A friend who studies the phenomenon along with the Cadborosaurus situation in British Columbia, living in puma country, took 20 years before he saw one in the wild. So yes, such cats can appear and disappear virtually at will, their senses much more acute than ours.

My own view is that the black alien big cats (ABCs) are leopards, the melanistic form of the more usual spotted

leopard. I do not accept that a large number of black pumas are about, and in any case the ones we are observing are leopard-like in every way.

Intriguingly I have had a variety of stories from people as to their origin including the obvious releases and escapes from captive situations such as 'pets', menageries and so on, over many years, which makes some sense of sightings going back to Roman times for example, and of the strange beasts, black dogs, Wisht hounds and such which have always roamed the countryside of reality and legend.

I have received suggestions that a foreign power was dropping them off here to destroy our livestock and farming, and another that, bored with the mundanity of pheasant and other game-shooting, some people have released various animals including large cat species to better enjoy the thrill of hunting them in the wilds of 'Britain'!

**That the cats, some of them, are dropped from UFOs is not an uncommon theory. Interestingly, UFO activity, crop circles and ABCs often occur at the same time in many areas, and I've witnessed this myself many a time. I am not saying the three are part and parcel of one situation, but the links are there in terms of timing.**

**Of course, there are also links between all three and, say, local buses or the Royal Mail vans or whatever! One can easily make out a case for linked phenomena, but equally the links cannot be refuted and should therefore be examined both separately and in the context of possibly being related.**

Hauntings by 'ghost' cats also comes into the picture, and rightly so. As a dowser, who also studies leys, I have my views on this aspect of the big-cat presence, but that will have to be for another time.

What is certain is that alien or mystery cats of large size definitely exist in the wild in this country and abroad, countries where they are not naturally found in the wild. Have no doubt about that, dear readers. I have no doubt there are a number of reasons for their presence, and if space permits I will keep you informed.■

**HAVE YOU HEARD THE MYSTERY THROBBING?  
UNTRACEABLE SOUND BAFFLES BRITAIN.**

Have you heard the mystery noise? It's the British equivalent of America's flying saucers, and it's just as mysterious. Hundreds of people now claim to hear it - a whirring, throbbing, or roaring sound, a noise similar to the humming of the wind in roadside telephone wires or akin to the roar of 'planes flying high.

### **ARE FLYING SAUCERS INVOLVED?**

Ear-witness reports differ, as with eyewitness accounts of flying saucers, but the facts are on official file at the B.B.C. Some people complain of the noise only at infrequent intervals. Others insist that they can hear it day and night.... and they claim that it's getting louder.

One investigator, a retired London barrister, has asked sufferers to get in touch with him in order that scientific observations can be made, and reports have flooded in



from all over the country. There are even examples of *deaf people* who 'hear' the vibrations. Sometimes a man is worried by the noise, while his wife cannot hear it.

One by one, possible sources have been checked. Theories of distant jet engine tests or a 'radar hum' have all been disproved. One man turned up at Broadcasting House declaring that the noise was slowly killing him. Post Office and electrical engineers have been called out to people who assert that the continuous throbbing keeps them awake.

Most hearers agree that the noise is loudest at night and in the early morning. Some have kept log-books to show that the sound was intermittent until 1945, and has since been continuous. Doctors have even attached a name to the sound and call it '*radiophobia*'. It is used to describe the eccentrics who appear in the courts to claim injunctions against the Minister of Supply or the Postmaster-General that the noise shall cease.

Yet a parallel mystery recently cropped up in Australia,

where newspapers and radio authorities were bombarded with letters demanding that the "radio irritation" should cease. Sufferers were advised to switch off. Back came replies that they *had* - and could still hear it.

Are flying saucers sending these signals? Are they travelling on a humming, throbbing, sound-beam? Is it all imagination? People who hear the sound claim that those who cannot hear it simply cannot be listening!

\* (Note, incidentally, that whereas in the case recently published by us in FSR 45/2 it was said that 'only women tended ~~to~~ to hear the whine', this early report mentioned that, whereas a man was frequently worried by the sound, it was his 'wife' who could not hear it!) -G.C.

## II. MORE THROBBINGS, HUMS AND "GROINKLES".

In a letter dated August 24th, 2000 from long-term FSR reader D.J. Strudwick of Meopham, Kent, we learn that he and his wife Lesley have been similarly troubled for years past by what they term "*a groinkle*"! They live on the North Downs Ridge, four or five miles from the nearest motorway.

Late at night, on August 23, Dave Strudwick was working in his study on an electronic project, when he became aware once more of this "groinkle", which "sounds like a dish-washer running".

He checked everything, but everything, dish-washer, washing machine, heater, air filter fan, etc. was switched off. Going up to bed, where Lesley was already asleep, he could still hear it in the bathroom, and then, horror of horrors, it was even at its loudest in the bedroom!

When he awoke at 6.00 a.m. next day, it had stopped. But when his wife woke up shortly afterwards her first words were: "I heard that noise again last night."

Mr. Strudwick says no underground caves are known to exist beneath the area where he lives, but about ten miles away, further up on the North Downs Chalk Ridge, there are the famous chalk caves at Chislehurst. He says UFO sightings have always been very frequent in that area. But his wife "*wonders whether the noise may not be due to the 'Little Greys' doing their weekly wash in their caves on night-rate electricity?*"

[If so, what a pity that, while they are on the job, the "Little Greys" apparently can't make themselves a little "whiter than white". G.C.]■

## LATEST REPORTS FROM SPANISH AMERICA. BY GORDON CREIGHTON.

### I. MORE "CHUPACABRAS".

**I**n the last few years these creatures have been reported not only from Puerto Rico, but also from Mexico, Panama Republic and Panama Canal Zone, Nicaragua, and even from some of the southern states of the U.S.A!

The principal latest reports, gathered by Scott Corrales of the Hispanic UFO Research Centre, California, come from Chile.

Early on Sept. 13, 2000, 3 geese and 5 ducks were found dead in the usual condition in the La Flora district of Chile. This followed a whole series of similar reports from six or seven other localities of Chile, where the populace have spoken of a "**strange being that leaves no traces of any footprints, and is more like a ghost or a creature of the Devil himself**".

Geese are historically famous for their usefulness in sounding an alarm, but these geese gave none! And all

were found dead, bloodless, feet upwards, none of them showing any signs of violence except for the curious small punctures -all on the necks and throats.

The fowl house had also contained chickens and a dog. the dog was found alive, huddled in a corner, and the chickens had escaped by taking refuge up among the rafters. The owner said the killings "**appeared to be the work of a creature that passed through the wire without leaving a crack**". (Source: Newspaper *La Cuarta*, Sept. 14, 2000.)

Next, another local newspaper, *La Estrella del Loa*, (no date given), reported that, on or about Feb. 6, 2001, two chupacabras had been seen in the villages of La Banda and Independencia Norte, on the outskirts of Calama, in Chile.

A woman named Patricia Valdivia, of La Banda de Calama, had opened her front door and found a chupacabra



on the step!

She told the newspaper (*La Estrella del Loa*) that she had heard some strange noises at one o'clock in the morning. It is the hot season there now in the Atacama Desert. Going to the door, she saw **"three cats, more paralysed than a photograph, spaced at about a metre apart, and beside them, sitting right in front of the door, the chupacabra. When it saw me it immediately jumped over the outside wall and was gone in the darkness"**.

**She had noted that the strange creature measured about 60 - 70 cms and was in a seated position, with long legs hanging down from its body which was covered in leaden-coloured (i.e. grey) hair. She said it uttered "a strange growl that made the windowpanes rattle"! And this was repeated when it leapt over the garden wall.**

The ufologist Jaime Ferrer, who has been investigating the chupacabras for some months, took plaster casts of its footprints. [This is strangely at variance with the reports that it "leaves no traces of footprints". -G.C.]

In another case, at Independencia Norte, in the Calama district, three boys had an astonishing experience, being paralysed with fright on coming face-to-face with one of the critters.

The boys, Gabriel Herrera, Miguel Salvo, and Jorge Salvo, have told their stories separately, and with remarkable similarity. Their story is as follows:

"It was about 1 metre tall (3 ft 4 inches) and it was sitting there in the inner courtyard, but jumped effortlessly when Jorge opened the door. It scared us.

**"It had spines running down its back. It was hairy and grey. We thought it was a rabbit, and went to tell Momma. That's when it vanished. We all searched for it, but it was gone."**

Miguel Salvo specifically mentioned that **"it didn't have a nose, or elbows, but it had shining eyes, and legs that were thick at the top and skinny at the bottom. It jumped away and hid under a pick-up truck."** (Newspaper *La Estrella del Loa*, Jan. 30 and Feb 1, 2001; reports via Scott Corrales.)

[In a note issued through Rense.com, Scott Corrales mentions that the three boys may have made an important new discovery about the creature, and that a UFO researcher is investigating this, and for the time being all details are being kept under wraps.]

## II. THE NICARAGUA CASE.

*Report from Scott Corrales, President of the Hispanic UFO Research Centre, and FSR Consultant.*

Chupacabras have struck again in Nicaragua, killing seven goats on a farm in Limón.

On Monday, Sept. 11, 2000, Channel 7 TV in Managua aired video footage of the seven dead goats, which local residents said had been killed by "a strange animal which many consider to be the **chupacabra**."

The goats presented cuts measuring 2 cms on different parts of the body, through which the blood had been extracted. The attack took place on a farm approximately 164 kms from the Nicaraguan capital, Managua. (See *Radiogramas del Peru* for Sept. 1, 2000.)

## III. ABDUCTION REPORT FROM CHILE.

Joseph Trainor, *UFO Roundup*, Vol. 5, No. 44, carries a report that a UFO had allegedly abducted two people in Chile, and set them down again a short distance away.

The events appear to have started on Oct. 19, 2000, at 7.00 p.m. A teacher, Juan Rojas Moffett, and some colleagues, in a classroom on the second floor of the Escuela San Francisco at Chiu-Chiu, some 40 kms from Calama in the north of Chile, saw a "bright light in the sky".

Three hours later (10 p.m.) 35 adults, all members of the school's PTA (parent-teacher association) were having a meeting in the school, and some 20 children were playing outside. A weird sound was heard, and a UFO appeared.

Two eyewitnesses, René Calpa Carranza and Walter Anza Vilca said the UFO, mainly white in colour, with blue, red, and yellow flashing lights, hovered above the school playground. And a number of children recalled having smelt "a burning odour":

**Then a panel on the underside of the UFO opened, and a dazzling beam of light "stabbed downwards", bathing two people in its glow.**

**These were Sra. Fresia Vega, the school janitor, and a student, Valentina Rojas Espinoza, aged 8, and both of them instantly vanished.**

According to Sra. Monica Espinoza Fernández, mother of the girl, "The children were outside, and they were witnesses, and they called to the parents at the meeting to come out and see it. And we heard a tremendous blast, and everyone ran out to look".

They said the UFO was hovering above the playground at a height of no more than a four-storey building. They saw the dazzling beam switch off, and then the UFO sped away towards the south. **Fresia Vega and the child Valentina, were found, dazed and shivering, not far away.**

Interviewed by the newspaper *El Mercurio*, Srs Fresia Vega said: **"The thing was a very large ship, about the size of a soccer field, surrounded by lights of every imaginable colour. In the middle of it there was a door from which came a light that blinded me and left me paralysed. I felt myself being sucked through the door, and I felt a tingling sensation all over my body.**

"Voices became far, far away, and I froze. That's when I realised I must have passed out, because I remember nothing at all. I then felt the door was being shut with a sound like that of iron, and the ship looked as though it was surrounded by light."

The child Valentina gave a similar account, and said: "I felt cold, and my blood froze. I was very scared, and hid behind Fresia."

## IV. THE ANIMAL MUTILATIONS IN CHILE - "A TRULY FRIGHTENING SITUATION".

FSR's Vancouver Consultant/Correspondent Dr Max Edwards tells me that he has just received, on March 6th, the following report in a letter from Scott Corrales, who of course is so well known to us as another FSR Consultant/Correspondent. (To my surprise -for I had not heard this before- Scott Corrales is himself from Puerto Rico, and so he is a compatriot of our Jorge Martín! -G.C.)

### REPORT FROM SCOTT CORRALES.

"The situation in Chile regarding the animal

mutilations is truly frightening and ought to be taken seriously by anyone with half a mind. **Although the mutilations have toned down somewhat at the moment, sightings of the creatures causing them have increased ten-fold.**

"There was a case last week of a man who had one such entity jump onto the hood of his car and stare him down, issuing the telepathic command: 'DON'T SCREAM -I DON'T WANT YOU TO SCREAM'. 'Needless to say the man choked on his own utterance.

"Residents of some of the desert towns of Northern Chile where all this is taking place are hearing the sounds of creatures running across their rooftops at night as they leap from one house to another.

"Rationalists are hoping that the creatures -if ever captured- will be some kind of baboon entity set wild in the desert by some unknown agency for its own purposes, but the chances that we are dealing with something completely unknown are very high. **I wish you could see the messages that I am getting. People are truly scared, and there is evidence that the Government feels a certain amount of concern."**

Dr Max Edwards himself has first-hand knowledge of all these areas in the North Chilean Desert, and therefore his own comments are equally valuable. He writes:-

"It's about time Governments **did** 'feel a certain

amount of concern'. The towns in the Desert are few and far between, except for Arica, Iquique, and Antofagasta. The **waterless desert** ends just north of La Serena -I've been to all these places- **and if creatures can survive in that desert -without water-\* THEY MUST TRULY BE DEMONIC!** Fancy thinking it is a **baboon!**

"By this time one would think that people everywhere, after hearing all the chupacabras stories from Puerto Rico, would put two and two together, and realise the **sameness** between events in Puerto Rico and events in Chile! I believe too that, some time ago, Spain also had some 'chupacabra events'."

[Yes! See Magdalena del Amo-Freixedo's *Chupacabras Galore!* in FSR 42/2 (Summer 1997), and *More Animal Mutilations in Spain*, by Raquel Andión and Enrique Tomás, in FSR 44/2 (Summer 1999) -G.C.]

And Max Edwards concludes his comments:-

"To my mind this is all like the 'Jersey Devil', in New Jersey, USA, in the early years of the 19th century. Drawings of the 'Jersey Devil' and of the 'chupacabras' are strangely similar. I've seen the sketches of both."

# BOOK REVIEWS.

**I. RETURN OF THE GIANTS**, by **Barry Chamish**, FSR Consultant in Israel. Paperback, many illustrations, 200 pages. Pub. July 2000 by **Blue Star Productions**, Sun Lakes, Arizona. US\$ 10.95. **ISBN 1-881542-66-1**.

Since 1993 the terrifying ANAKIM, or REFA'IM, the "GIANTS" of the Bible, are back again in Israel, as we have already reported in FSR Nos. 39/4, 41/1, 42/3, 43/3, 44/4, and 45/1. As Barry says, "the evidence is totally watertight". Unpleasant beings, 7 ft. or more in height, and seemingly not merely three-dimensional. Barry sees the situation as decidedly ominous.

**II. UNEARTHLY DISCLOSURE**, by **Timothy Good**, FSR Consultant. Foreword by Admiral of the Fleet, The Lord Hill-Norton. Hardback, 277 pages, copiously illustrated, pub. by **Century**, London, price £16.99.

**ISBN 0-7162-8465**. Like Timothy Good's last book, *ALIEN BASE*, this volume makes very great use of material that is only available in FSR.

**III. YOU CAN'T TELL THE PEOPLE: THE DEFINITIVE ACCOUNT OF THE RENDLESHAM FOREST UFO MYSTERY**, by **Georgina Bruni**. Pub. Jan 2001 by Sidgwick and Jackson, London. Hardback, 450 pages, price £17.99. **ISBN 0-283-06358-01**.

### MRS CYNTHIA HIND (ZIMBABWE).

### DR PIERRE GUÉRIN (FRANCE).

This noted French physicist and astronomer - perhaps the most eminent in France of late- was long associated with the Institute de Physique in Paris, the Observatories of Paris and of Le Pic du Midi, and was Maître de Recherche in the CNRS (French National Council for Scientific Research). He left us on October 7, 2000, aged 74.

He had only just brought out, towards the end of 2000, an excellent book (his *first* on UFOs, so far as I am aware) -*OVNI: LES MÉCANISMES D'UNE DÉSINFORMATION* (pub. by Albin Michel, Paris, ISBN 9-78226120229). The English title would of

course read no doubt like "*UFOs: THE MECHANICS OF A SYSTEM OF DISINFORMATION*", which suffices to tell you that, after fifty years of UFO research and study, this top French astronomer had no doubt about the existence of "les OVNI" despite all the efforts at denial and cover-up -and these have been very powerful in France throughout, due no doubt in large measure to Monsieur Descartes himself.

So far as I gathered from our long contact with him, Dr Guérin was an astronomer who -unlike so many-seemed to have found no difficulty in accepting what we call "the E.T. theory".

Over the years we published in FSR 15 letters and articles from him, two of them under the nom-de-plume of "Jacques Lemaître". His last article for us, *THE U.S. AIR FORCE, GRAVITATION, AND UFOs*, in FSR 43/2 (Summer 1998), indicated that he was a believer in the presence of an alien technology at *Area 51*.

Our condolences and warmest sympathies go to Madame Anne-Marie Guérin and the large family of sons and daughters and grandchildren.

To Pierre himself go all our very best and warmest wishes as he proceeds on his journey out amongst the stars.

### DESMOND LESLIE.

Desmond Leslie, one of the "grand old men" of ufology, co-author with Adamski of *Flying Saucers Have Landed*, and one of the group who founded FSR, has just died at his home in the South of France at -as we believe- the age of 80. More in our next issue. G.C.■
