**ABSTRACT**

There is mounting evidence and human testimony that alien life forms are intruding on this planet now and have been for decades. This presentation focuses on eyewitness accounts of alien beings with animals, medical evidence that the excisions of animal tissues are done with high heat, an abduction in which uterus tissue and fluid were extracted from a Missouri woman, and information from another abductee about alien motives for the animal mutilations and human abductions.

**A STRANGE HARVEST**

Eight years ago on April 9, 1983, I was in Albuquerque, New Mexico sitting in the Air Force Office of Special Investigations headquarters listening to AFOSI Special Agent Richard Doty say to me:

"That documentary you did about the cattle mutilations upset some people in Washington. That's a subject we don't want connected in the public's mind to UFOs and extraterrestrials."

He was referring to my film "A Strange Harvest" in which I tried to find out why so many animals were being found like this:

- SLIDE #1 - Fritzier Ranch, Sterling, Colorado, 1975  
An ear missing; eyeball removed, along with a circular patch of hide around the eyeball.
- SLIDE #2 - Budin Ranch, Sterling, Colorado, 1976  
The jaw stripped of flesh and the tongue removed deep within the throat.
- SLIDE #3 - Karg Ranch, Sterling, Colorado
- SLIDE #4 - Weld County, 1988
- SLIDE #5 - Red Cloud, Nebraska, November 27, 1989  
Male genitals or female udder removed.



SLIDE #6 - Bear Lake County, Idaho, September 15, 1989  
And the rectum cored out.

**ALIEN LIFE FORM CONNECTION**

I had not set out to do a film about an alien life form connection to the phenomenon. But that's what I found in so many eyewitness accounts of orange glowing objects the size of football fields hovering above pasturelands where mutilated animals were later found. Or beams of light observed shining down from "silent helicopters" that lighted pastures "brighter than daylight" and the next day mutilated animals were found. And eyewitness reports of strange craft and/or non-human creatures involved with animals.

There was Judy Doraty who in 1973 watched a brown and white calf rise in a pale beam of yellow light. Inside the craft, she saw tissue cut from the eye, tongue and testicles by two small grey-skinned creatures. They had four fingers, instead of five, and those long, thin fingers tapered to dark nails. Their eyes had vertical pupils like a cat's or a crocodile's.

Judy's daughter, Cindy, also described in a 1990 hypnosis session seeing a calf rising in a beam of yellow light.

In 1980, Myrna Hansen and her young son saw two white-suited beings working on a cow near Cimarron, New Mexico. The cow was bellowing in pain and Myrna tried to interfere. The result was that both she and her son were abducted by large, brightly lighted discs which took them to an underground facility, she thought, in the Las Cruces region. There Myrna saw a humanoid figure floating in a vat of reddish liquid which she perceived to be a "treatment" of some kind for the immersed being. She also thought the liquid was related to fluids and tissues removed from animals.

Also in 1980, a Waco, Texas rancher watched in broad daylight as two, four-foot tall creatures with large, slanted black eyes carried a calf between them that was later found mutilated.

And on a sunny morning in July 1983, a Missouri couple had an experience which has haunted them ever since.

RON WATSON, Springfield, Missouri: "It was a day like today in 1983 when we seen this object. Well, it wasn't an object. It was a shiny thing and we didn't know what it was. And I couldn't really get a clear picture of it. I went into the house and got my binoculars and looked out across the field to make out what was out there and I couldn't really see very good because of the way the terrain is.



HOWE: BUT WITH YOUR NAKED EYE YOU COULD SEE SOMETHING?

Yeah, I did. Glittering.

PAULA WATSON: That's when he told me that there's something out there -- and I could keep seein' somethin' flickerin'. It was out of the ordinary. You just don't see somethin' shinin' and flickerin' across.

AND IT WAS RIGHT OUT HERE?

Right across there.

NOW, WHEN YOU GOT HERE YOU PUT THE BINOCULARS UP?

Yeah.

WHAT EXACTLY DID YOU SEE?

RON: Well, I put the binoculars up and looked in there and there was a green cone-shaped craft back there. It was green and looked solid and there was a door on it and a platform went out onto the side and the lizard-type creature -- he was standin' next to the ship. I told Paula, 'Look, Paula, there's somethin' back there! Look at this! Look at this!' And she took the binoculars...

PAULA: I took them and I looked and I didn't see the craft, but I could see the creature.

WHICH CREATURE?

It had big green eyes and it looked like leaves on it or like it was camouflaged. And I'm lookin' at it and then it looked at me with those big eyes and my heart stopped beatin' and I couldn't breathe and I said, "It's starin' right back at me!"

And so I handed them back to Ron. And I said, 'I saw the thing and it was lookin' right back at me. And then he started lookin' some more and I was really gettin' scared.

NOW, WHERE IS THIS, WHICH ONE SAW THE COW AND THE TWO LITTLE GREYS?

RON: That's when we looked again and I was back there tryin' to find out where that ship and everything was back and forth and I could see it -- I passed the binoculars back to Paula again because we're fightin' back and forth over the binoculars.

PAULA: I looked and I'm lookin' over there and I'm thinkin', all right, he's right there then what was shinin'?

And I saw this big, black cow lyin' down. I told Ron, 'My God, they got a cow! What are they doin' to it?' And it was just laying there. It had its eyes open and its tongue was like, hangin' out a little bit. But it just laid there and didn't move. And they just were runnin' their fingers over it like that and runnin' em down it and lookin' at their fingers.

NOW THESE ARE TWO LITTLE WHITE ... ?

Two little silver beings and their head -- it didn't look like there was no helmet on. I wonder if they can breathe our air -- like an astronaut helmet or something. I never seen nothin' like that before -- and they had their little packs on their back.

NOW SHOW ME AGAIN, LET'S SAY THE COW WAS ...

PAULA: The cow was layin' down.

AND IT'S COMPLETELY STILL?

PAULA: Yeah. And its head is right here where your foot would be and its mouth's open and there was one bein' on one side and one on the other -- and they just reached over to it and were like fingerin' through it. Like here's its neck and the head and they were just doin' like that...and then lookin' at their fingers. Then next they had their hands over it and there was a black ramp and they just went like this -- and the cow went up and it just floated right up the ramp into a hill. And once it got into the hill where the trees are ...

YOU MEAN LIKE A CONVEYOR BELT? OR JUST LIKE FLOAT? DID THE COW FLOAT?

The cow just floated right up -- I mean there was nobody hauled it. I mean it just floated right on to that ramp and just went right up and disappeared right into the hill. Where the trees are and everything. And it looked like there was actually a hill back there that it went up into.

RON: Which was the ship. Paula got me real nervous.

PAULA: I got scared.

RON: She got real scared because she said, 'Hey, if they're doin' that to animals, what can they, you know, what's next? Here we are a family and they can come over here and do as they well please if they're doin' that --

PAULA: Out in the boondocks. We told everyone, 'Man, you know, we saw these aliens out there with this cow!' They said, "Oh, sure you did!" Nobody could find nothin'.



RON: Like we were crazy.

PAULA: So later on, I said, 'Oh, how's everything goin' with your cows over there?' And he said, 'Yeah, yeah, we're missin' a cow.' I said, 'Oh, really, is it a black cow?' And he said, "Yeah."

Not only have there been eyewitnesses to alien life forms intruding on animal life, there is medical confirmation that the excisions in some mutilated animals have been done with high heat, probably above 350 degrees Fahrenheit.

SLIDE #8 - Normal Cow Tissue  
Here is what normal cow collagen tissue looks like under a moderate power in a microscope.

SLIDE #9 - Burned Cow Collagen Tissue  
And here is what a cow's collagen tissue looks like at the mutilator's cut line. Dr. John Altshuler, pathologist and hematologist in Denver, Colorado, found complete disintegration of cell material and a bluish color indicative of high heat.

SLIDE #10 - Cooked Cow Blood  
This is what happens to the blood: it turns an orange-yellow because the blood is cooked.

Dr. Altshuler has helped me examine mutilation excisions since 1989. In several animals, including a deer and two rabbits, he has found the same tissue and blood changes produced by high heat. The edges of the mutilator's cuts also are a dark brown and hard like plastic compared to normal tissue.

Further evidence of heat was described on February 22, 1991 by Veterinarian Madeline A. Rae who filed a formal "Report of Laboratory Examinations" in the Veterinary Diagnostic Laboratory College of Veterinary Medicine, Oregon State University, Corvallis, Oregon. See full copy of report on next page. She concluded that "The notched edge (of a 2-year-old steer found mutilated near Portland, Oregon February 12, 1991) does exhibit a band of coagulation necrosis consistent with a heat-induced incision, such as with an electrosurgical unit. ...It is not possible to tell whether this lesion was caused by a laser. It does appear consistent with a heat-induced injury."

Other animals Dr. Altshuler and I have investigated and discovered the presence of high heat at the excision lines have included:

SLIDE #11 - A rabbit found on April 29, 1990 at Sound Beach, Long Island, N.Y. The head had been cleanly severed as have several animals since 1990.

SLIDE #12 - A second rabbit was found that same day in South Beach with its eye and surrounding tissue removed, as we've seen in the cattle.


### PATHOLOGIST REPORT:

**HISTOPATHOLOGY:** Sections of skin from a steer are examined. All sections display moderately severe post-mortem autolysis. The notched edge does exhibit a band of coagulation necrosis consistent with a heat induced incision, such as with an electrosurgical unit. Numerous bacteria are present on the skin, except in the area of coagulation necrosis. This is consistent with a specimen collected via electrosurgical excision.

**DIAGNOSIS:** Coagulation necrosis of the skin.

**COMMENT:** It is not possible to tell whether this lesion was caused by a laser. It does appear consistent with a heat-induced injury.

SLIDE #13 - In both rabbits at the excision lines, the blood had been cooked and the basophilia cells showed the blue degeneration.

NEWSPAPER HEADLINE, Norfolk Daily News, "Mutilation suspected in calf's death." Then on September 23, 1990, a bull calf was found on the Dan Long farm near Madison, Nebraska.

SLIDE #14 - Wideshot of bull calf showing the caudal end of the scrotum cut off in a straight line, leaving the penis exposed. Rectum cored out.  
A researcher named Carol Werkmeister took these photographs and wrote to me: "The edge of the wounds made me think of a soft rubber or vinyl edging. Extremely smooth and black. I felt that some kind of heat had been used."

SLIDE #15 - Close shot of same.

SLIDE #16 - Closer shot of same.

The local veterinarian examined the animal and wrote in his report that "The caudal end of the scrotum was sharply removed with the testicles intact and remaining on the carcass." See full copy of report on next page. Dr. Altshuler examined this tissue under a microscope and again found the presence of high heat.

SLIDE #17 - Wideshot of deer in Pennsylvania with large excision in rectal area, belly and leg hide to knees.  
We found similar cell changes due to high heat in a deer found dead and oddly cut on December 9, 1990 north of Philadelphia

SLIDE #18 - Head of deer.  
The eye of the deer was discolored as many mutilation cases have been over the years. In conversation with medical doctors about what can cause the blue-white opaque glazing of eye tissue, I have been told that either heat or radiation can produce the change.

NEWSPAPER HEADLINE. Roanoke, Va. Times, January 14, 1991, "13 dogs mutilated, slain in Lynchburg"  
The next month in January 1991, 13 dogs were found mutilated in Lynchburg, Virginia. The heads and paws had been neatly cut off and the Lynchburg Police Commander Gary Renolds said: "It was kind of methodical the way they had been laid out. We've had no evidence of satanic sacrifices within the city of Lynchburg in my 16 years with the Police Department."

Newspaper headline: "Cow Becomes 2nd In Three Months"  
Then on February 4, 1991, in Green Forest, Arkansas, farmer James Thorne found his second cow mutilation in three months -- his fifth mutilation since 1978.

To Whom It May Concern:

On September 25, 1990 I necropsied a 500 lb. Charlois cross bull calf for Dan Long. The calf was found lying out in a pasture with no signs of struggling. The caudal end of the scrotum was sharply removed with the testicles intact and remaining on the carcass. A 10 inch circular area was cut out in the perineal region, extending about 6 inches deep, removing the skin at the base of the tail, anus and surrounding tissues down to the ischium of the pelvic bone. The accessory sex gland appeared to be removed also, but the penis remained intact.

Tissues for histopathologic examination were taken from the skin edges of the scrotum and perineal areas.

Total fees for this call was \$ 24.00.

# Farmer rules out all but aliens in cows' deaths

## Carroll County sheriff cites disease

BERRYVILLE — James Thorne doesn't come right out and say he thinks aliens from another planet are killing his cows.

He kind of backs into it.

It's not that he believes in UFOs or that he's read too many tabloids while standing in the grocery store checkout line, Thorne says. But the 74-year-old, plain-talking retiree can't come up with any other explanation for the mysterious deaths of five of his cows, two in the last three months.

The Carroll County sheriff can. He says the latest death — a cow found dead on Thorne's property Feb. 2 — had died of blackleg, a usually fatal toxemia linked to soil bacterium that can enter the tissue through minor wounds or abrasions.

But Thorne noted that each of the cows had her sex organs removed and blood had drained from each carcass. He said the animals bore cuts that looked to have been made with surgeon-like precision.

Sheriff Lonnie Nichols said the blood had not been drained, but rather had clotted in the veins and arteries. He said that's the reason the blood did not drip from the animal.

Thorne lost one cow in 1978, another in 1985 and another in 1986. In November, he found a fourth cow dead near his pond and then another on Feb. 2.

Thorne bases his aliens theory on the process of elimination.

He said an animal couldn't have done the dirty work because there were no signs of struggle near any of the dead cows. He also said he had watched as other animals avoided the dead cows — even vultures.

Thorne allowed a reporter to look at the carcass of the last cow found dead. The body appeared to be mostly intact, considering it had been exposed to the elements for almost two weeks.

Thorne ruled out human beings as suspects in the cow deaths, pointing to a steep mountainous terrain that was tough enough to handle during the day. A night hike would be impossible, he said, noting that each cow died during the night.

**James Thorne:** Said his animals bore cuts that looked to have been made with surgeon-like precision.

Thorne, who lives in Green Forest and owns the farm in Berryville, said that a person would have to travel about two miles with equipment and then leave without spilling about 2½ gallons of blood.

“I know no animal killed 'em and I know that no human killed 'em without anybody seeing it or alarming the dogs around here,” Thorne said.

“I know it sounds crazy.”

Nichols said he had a local veterinarian examine the cow found dead Feb. 2, and that the veterinarian had attributed the death to blackleg disease.

But two self-professed “UFO investigators” from Forsyth, Mo., also inspected the dead cow. Thorne said the team concluded after last week's visit that aliens had visited and used a laser to kill the cow and remove the organs.

“They were very professional,”

Thorne said of the UFO team.

“They went over that cow with a fine-tooth comb. I think it's possible it happened that way, but I don't know for sure. I do know it wasn't an animal or a human.”

Nichols recalled an experiment Washington County sheriff's deputies performed several years ago, using a carcass and time-lapse photography. During the 72 hours of photography, animals and insects cleaned the dead animal of its organs, he said.

Gene Wingate, Thorne's son-in-law who lives at the farm, said that didn't happen with the latest cow carcass.

“The tongue was sliced off from the back of the mouth,” Wingate said. “I found the cow with its mouth shut and jaw clenched. If it was a bird how did he get the tongue out and then close the cow's mouth without leaving any marks?”

When a dead cow, believed to be killed on Halloween, was discovered Nov. 1, Wingate said, the jaw and tongue were removed in a clean, straight line.

“If you saw when it was first discovered you'd understand,” Wingate said. “It's hard to imagine that the cow's organs could be taken off so clean without disturbing anything else and with no rips or tears. It just blows your mind.”
