Federal Weather Modification Board Suspect in "Unnatural" Midwest Floods

The federal Weather Modification Advisory Board was created in 1976 under Public Law 94-490 as a subdepartment in the Department of Commerce.

It is more than curious why NOAA (National Oceanic & Atmospheric Administration) has made no pronouncements on why this bizarre weather event should have occurred at all.

Perhaps this is a question you should ask your Congressperson: What does that National Weather Modification Advisory Board actually do, and why haven't we heard anything about this group in the mainstream media?

Was the Midwest flood, which caused so much heartache and ruined so many lives, a bizarre experiment gone awry, or was it a deliberate attempt to destroy America's entire food crop?
