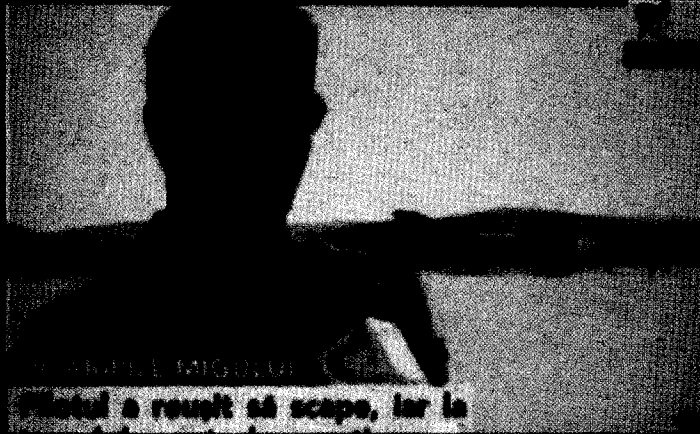

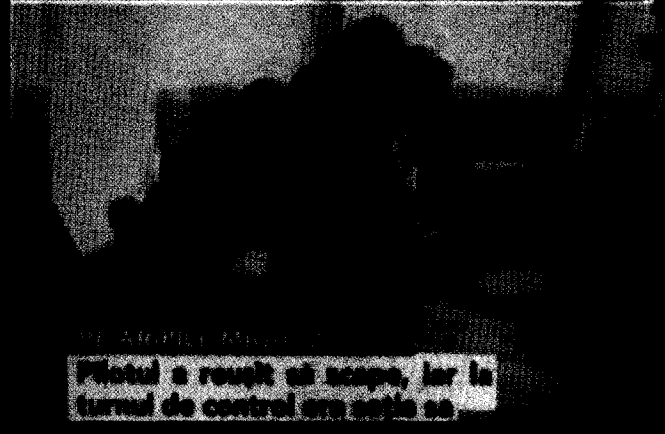

On the afternoon of 30th October 2007, six kilometres from the town Gherla, near Cluj-Napoca (Romania) a MIG 21 Lancer fighter, from Air Base 71 at Campia Turzii, performed a training flight. As Marin Mitrica, military pilot since 1991, recounted: Suddenly, from my right, I was hit by a tough object. The collision broke the plastic window covering the cockpit. The splinters punched a hole in the helmet and wounded my face. In the first moment I ducked as much as I could, over the console, as the air-stream was powerful and the temperature -30 Celsius. "I descended and reduced the speed from 850 km/h and from 6500 meters; to avoid hypoxia fortunately I had the oxygen mask. The biggest danger was the hypothermia".

The fighter landed without problems, directed by his wife from the control tower and was immediately investigated by a military commission. They had no conclusion. Each fighter has a video camera recording the flight, but the speed made the images unclear. General Ion Avram stated that the recording showed four triangles, the size of an A4 sheet, seen approaching from the right side. He added that the images were delivered to the "Serviciul Roman de Informatii" (Romanian Intelligence Service) to be analysed, "as they have laboratories and analytical equipment". The first hypothesis was that the objects were birds; but everybody agreed that no bird flies at this altitude in this season, because it is too cold. Nor was it the kinetic energy of a meteorite or space debris as this would destroy much more of the fighter. It was not something dropped from another plane as the last one passed that zone more than one hour before.

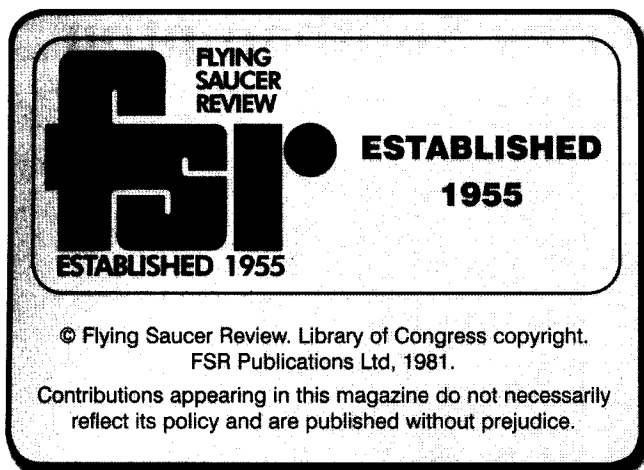
Lt. Commander Nicholas Grigorie investigating the case, (himself a MIG pilot and graduate of the French Institute for Aeronautical Security) stated in the newspaper Gândul that all conventional scientific explanations were ruled out. First they excluded natural causes: the device was not hit by a bird, they do not fly at the height of 6,500 meters, and traces of organic matter were not found on the body of the plane. It was not a piece of ice, because the sky was clear and did not create conditions for water to freeze. Nor was it hit by a meteorite, because astronomical data confirms entry of such bodies in the air that day.

Then they excluded causes due to human activities. There were no civilian flights at any hour at the location about 30 km from Gherla, and the MIG-21 Lancer unit was, no exercises with artillery cannon or missiles, no incidents reported to police involving missile launching or fireworks and no weapon had not been launched nor a weather balloon. Data collected by Lt.Com. Nicholas Grigorie has been supplemented by a survey of the National Institute of forensics, confirming that the object that struck the device was in motion, rotating around its own axis. It had an oblique trajectory towards the aircraft, but he rejected the assumption that his analysis had been talking about a projectile. "We cannot say with certainty what it was not, but not what it was - an object that struck the MIG, but we do not know what material was or origin", declared Lt.-Com. Grigorie to us, refusing to make any speculation about a possible "Extraterrestrial origin." We can confirm that during the few milliseconds when the UFO was caught in view by the camera two objects passed before the aircraft "just as something would pass in front of a car, without a hit."

Neither have European experts found an explanation. The incident above Cluj County has been discussed by the Air Forces Flight Safety Committee (Europe) (AFFSC E) However, none of the experts on military aircraft from other European countries have advanced any plausible alternative hypothesis to those discounted by the Romanian investigators. Finally, as a participant in this body for consulting experts in military aviation safety, Lt. commander Nicholas Grigorie is of the opinion that in Romania incidents involving unknowns are on par with those for other Air Forces not more not less. The conclusion of expert analysis performed by Catalin Grigoras is one of the two unidentified objects is ascending, the other having a descending trajectory. Radar from Camp Turzii did not record anything at that altitude so it is almost impossible for the object to be launched on Earth. In addition, the objects caught by video camera had irregular shapes.

A specialist opinion in the paranormal field, Professor Adrian Patru from "Babes-Bolyai University, president of the Romanian Society of Parapsychology, said the pilot who gave information about the incident will likely be reprimanded after things are calm. Such phenomena have been reported in the area of Cluj, during the years 1990-1992, but also in the Timis region. There were UFOs recorded on radar and seen with the naked eye. They were, however, never confirmed or denied."

The Milestones and gravestones of ufology

Donald Pilz's life has come to an abrupt end after his car ran off a county road and into a creek. A trooper said there were no skid marks or signs of braking after the Pilz vehicle left the road and went into a field before coming to rest in the creek, which was only about two feet deep. Pilz's body was not submerged when it was found. Having survived 'Football Island' in Vietnam 1969; Donald was no stranger to the arbitrary nature of sudden death, despite his grim experiences he remained an optimist, an honest patriot who loved his country. I'm sure if he were here, he would tell us how grateful he was.

Donald's personal UFO quest began after a close encounter that momentarily stopped time at Fishers near Carmel Indiana on August 2nd 1996, he was among the first to follow up on a UFO sighting using Doppler weather Radar. He found a detonation line of characteristic ring shaped clouds had appeared in the hours before his encounter which sparked his mind into working on the true nature of what he really saw happening that day.

He noticed that his Fishers craft exited via a very dark slit in the air and began to research reports that mentioned a dark soft spot appearing in the air around the UFO (he also realised that it was absolutely scandalous that there were so many neglected good observations sitting idle in data-bases). Donald wouldn't have minded me saying that he was a regular blue collar guy from Indiana; without a formal high level education, yet he knew how to organise his thoughts in order to ask the right questions about how the fields around UFOs really behave. He suspected that there might be legions of cases describing a variant of wormhole technology used by UFOs to gain entry and exit from our atmosphere. This was his masterful discovery, a common thread to link so many different types of UFO sighting. What Donald stumbled across might one day be recognised as vitally important to the cause of ufology. Donald's work will appear in a future book called "Frozen in Time," his death is not the end. We dedicate this issue to Donald Pilz.

We live in extraordinary times

An extraordinary film of a flying triangle has emerged, taken over Shirley, Southampton England at 14.30 on June 1st 2007. Filmed from a moving vehicle the triangle appears to slowly rotate and then ascend merging with the cloud base. The film was posted on the internet by a Polish friend of the original witness, who made the following additional comment: "In the last few months I've seen many of these and different objects over Southampton, but unluckily I don't have a proper camcorder. The number of sightings in my area increased 3 times since last summer." His words ring true, this year many people have seen a whole series of UFO incidents in the Southampton area as this is apparent by the many sightings and films volunteered by the locals following the initial publicity.

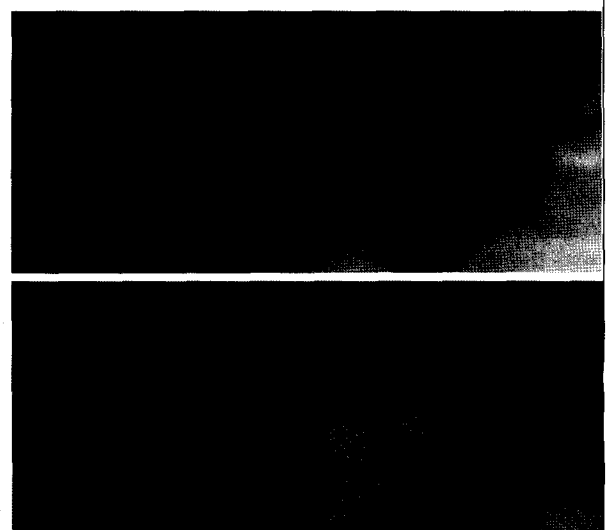
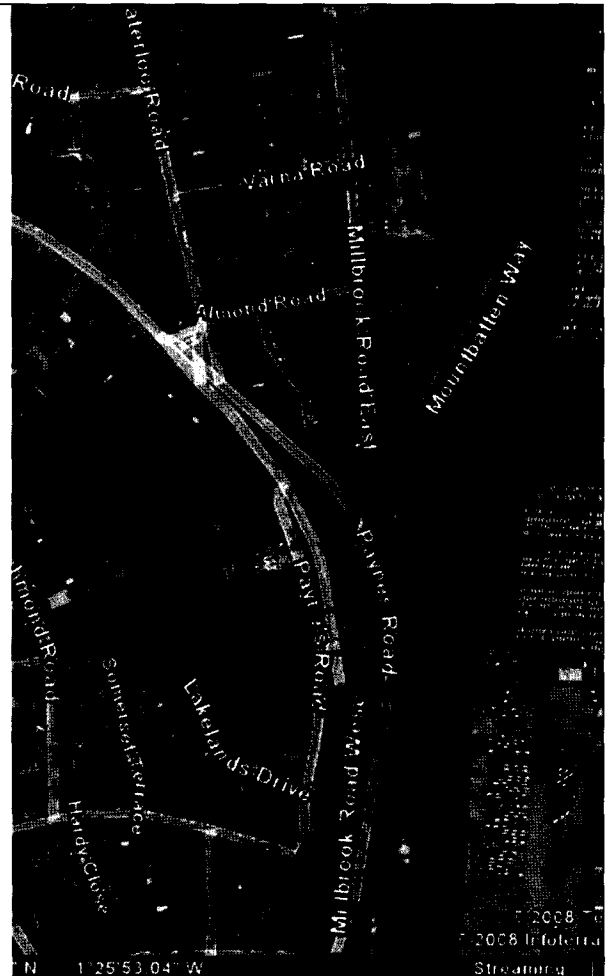
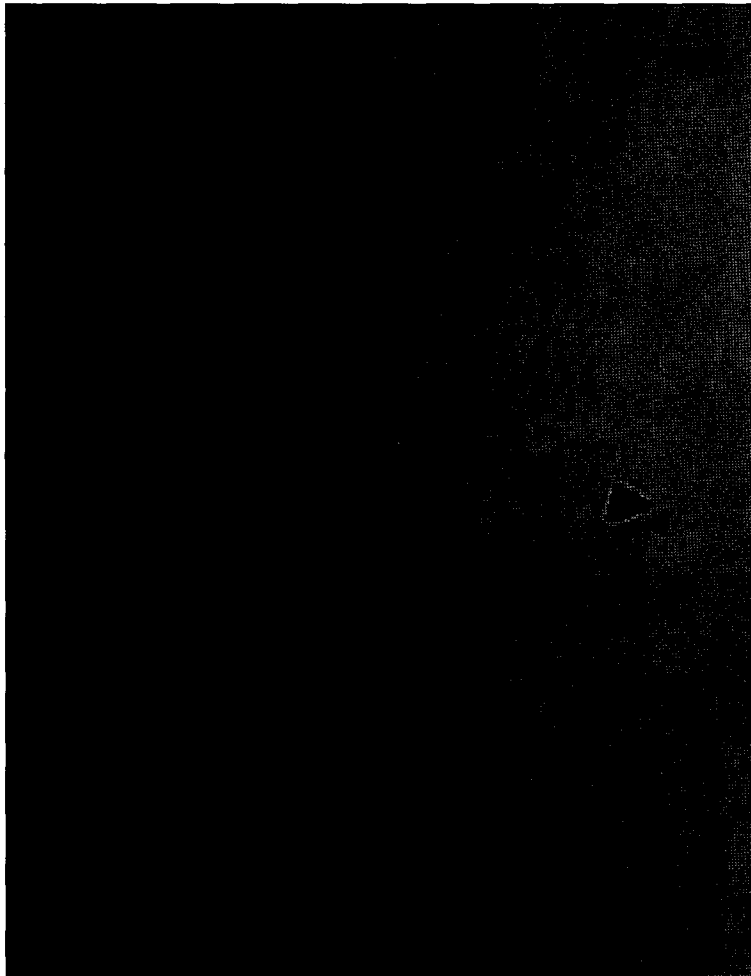
One more extraordinary observation that validates the June 1st sighting is the possible existence of a soft-spot (worm-hole) cloud phenomenon on the film. A reviewer of the film makes the following revealing statement: "Ok, just found a few odd things: Right at the beginning of the video, there is a ring in the clouds. Then about 0:16 to 0:17 you can see another ring, but this one seems to grow larger in a very small amount of time. It could just be the camera zoom that makes it look like it gets bigger, but its odd. At first I

the camera lenses, and this seems to be fixed in the sky. I looked around for other examples of "cloud rings" but could not find much information besides a type of cloud called cirrostratus clouds. These are known to be around 20,000ft in the air and make ice crystal halos." The triangular object was certainly not that high, rather moving below a low cloud base, therefore this statement shows how this type of cloud ring information used to so commonly go amiss, before Donald Pilz spotted it and we now know what we are looking at. Verification of authenticity, a UFO wormhole, no hoaxer has ever had the wit or reason to place such rings on a film.

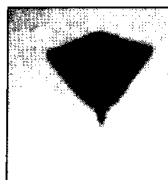

"We looked up into the sky and there it was - a black triangle," Mrs Bartlett said. "It did not seem to be moving left or right, it just drifted up into the clouds before disappearing." Mrs Bartlett said she had no idea what the mystery object was, but said it could not be a kite as there was absolutely no wind that day. Another reader, Leonard Cattley, spotted a similar UFO on the same day and said: "It was hovering for at least 15 minutes so we got a very good look at it, if it was a kite it would have been huge".

"It looked very much like a hovering stealth fighter but it made

Farnborough in my time, I am no stranger to aircraft but this object looked liked nothing I have seen before."

A strikingly similar UFO was photographed by reader Rob Baker from his backyard in Regent's Park three weeks ago. "We were out in the garden when my oldest son pointed it out. It was a long way away so I got my camera out to zoom in on it," he said. "From the zoomed image it looks like a powered hang glider. It was more of a square shape than a triangle and there was a dull humming sound, but I cannot be sure that wasn't coming from the road."

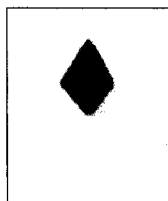


The X-Files-style mystery has left UFO enthusiasts baffled and an investigation was even launched by Southampton Airport after a worried member of the public alerted bosses. Possible explanations include Chinese lanterns, micro-lights, model aircraft,

kites or even a secret military project. Recruitment consultant Gavin Chapman also came forward with another mysterious photograph, which he took in the city last summer. "I was taking a photograph of a rainbow at the time, but I didn't notice there was also an object in the picture," he said. "Then, about three weeks ago, I was deleting pictures from my mobile phone when I spotted it. After reading about the other recent UFO sightings on the Echo website I decided to send it in because I hope somebody can tell me what it is." Mr Chapman added: "If you zoom in you can see that there are clearly three corners of a triangle. I honestly don't know what it is. I suppose it could be a helicopter or maybe just dirt on the lens. "I believe there is something out there. There has to be, but whether this is it, I don't know."

Mysterious object seen flying over Southampton

The Daily Echo needs help in solving Hampshire's latest UFO mystery. Just a day after it was revealed 42 UFOs have been spotted in the county in the past ten years, a new video has emerged of a strange object in our skies. The footage was captured by company director Will Campbell on Monday,

May 5, and shows a cube shaped object floating high above houses in Shirley.

"I was at home when my housemates Mina and Simon spotted the object out the window. We could barely see it with the naked eye, so I got my video camera out to zoom in to get a clearer picture of the object," the 28-year-old said. "It appeared to be a black, almost cube shaped. At first it was slowly rising, but then seemed to stabilise at an altitude and move away into the distance. We could see it for about 15 minutes, before it eventually got too far away." Mr Campbell was confident the object wasn't a kite as there was "absolutely" no wind that day. "Its large arc across the sky also means that it was not tethered to the ground in the way an advertising blimp would be. The shape of the object wasn't round like a weather balloon. "I rather hope that one of the readers of the Daily Echo might be able to shed some light on what the object was."

Mr Campbell said he believed extra-terrestrial life was out there, but that he was very sceptical of most UFO claims. "I don't believe that there is a great deal of UFO activity and I think that the vast majority of sightings can be explained. There are however a few sightings which are very difficult to explain."

As mentioned in FSR 52.4, there is currently no coherent way of monitoring UFO reports on a Europe-wide basis. In this issue we take a closer look at the Romanian UFO story, another Eastern European nation in the new Europe, that has overcome the legacy of systematic vicious repression of all forms of expression and intellectual freedom in the communist era. Today its people concern themselves with practicalities of modern life rather than burden themselves with elusive mysteries of the UFO question, however, they appear to be an open minded people, even in their academic institutions. They were among the newest entrants to the European Union in 2007, which may well lead to a return to common media censorship for example among their armed forces.

Public interest in UFOs in Romania began with the 1968 flap, when several interesting reports reached the mass media, among them one of the crew of the commercial airline TAROM in August 17, and several other encounters in the next time period, until the end of September. The first Romanian books about UFOs were written by the SF writer and critic Ion Hobana (Bucharest, 1971) and the engineer Florin Gheorghita (Iasi, 1973), both of them involved in the investigation of the 1968 cases. Ion Hobana, together with Julien Weverbergh, also published several UFO books abroad, among them the *Ufo's from behind the iron curtain* (1974), translated in several languages. In the early seventies, some UFO research groups were organised, the most important, established in 1971, at the Cultural House of the University Students in Bucharest, was lead by Ion Hobana himself.. Within this "UFO Scientific Circle," were many professionals from the university environment, interested in studying the phenomenon, conducting field research and archived reports and organised numerous meetings to inform the general public.

In 1977, one of the members of this group, Calin Turcu (1942-2006), living in the small town of Valenii de Munte (100 km north of Bucharest), organised an informal, nationwide team named "*Romanian UFO Researchers (RUFOR)*", that published a *samizdat* UFO bulletin (27 numbers, 1979-86). Turcu established, in time, in his house, the greatest archive of written records, photos and films about Romanian cases, as well as the greatest UFO book library in Romania. The same team published later the only printed UFO periodical in Romania, named "RUFOR" (1994-1996). It had 21 issues, the first 8 in a tabloid form, and the rest as an A4 magazine. The chief editor was Peter Leb from the Transylvanian city of Targu Mures. All important Romanian UFO researchers contributed to this magazine. Presently, there is no printed UFO periodical in Romania.

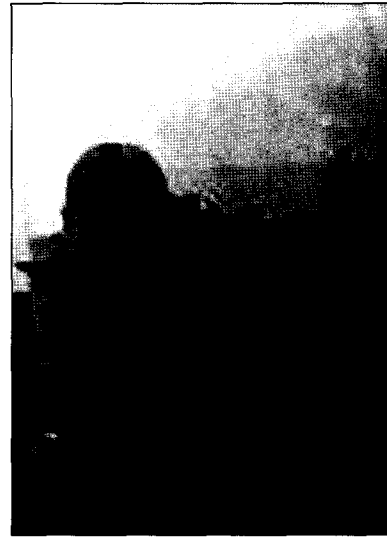
A dozen UFO books, translated or original, were published in

increased dramatically after 1990. Among the authors were Ion Hobana, Calin Turcu, Florin Gheorghita, Dan Farcas, Doru Davidovici (fighter pilot 1945-1989), Gyorgy Mandics (now living mainly in Hungary), Dan Apostol and Adrian Patrut (President of the Romanian Society of Parapsychology; he also wrote about some other strange phenomena in the Hoiu-Baciu forest near Cluj-Napoca). Unfortunately, an inadequate dissemination of books in the past 15 years, made many titles very restricted in their circulation. Also because of superficial editorial policies, books have emerged whose content does not meet minimum standards of the scientific process necessary to address the scope of the UFO. The Romanian UFO network (RUFON) has its headquarters in Coventry, Strada No Berzei, 16, headed by Paul Dorneanu and Florin Sirbu. In 1998 they established a database which increases day by day (www.rufon.org).

The Association for the Study of Unidentified Aerospace Phenomena (ASFAN) Romania was set up in 1998 by a group of people connected with the UFO phenomenon and was conceived as an organisation of well established specialists working in various directions relevant to UFO research. Currently ASFAN is the only organisation with legal status for studying unidentified aerial phenomena. ASFAN is a non-governmental and non-profit organisation recognised by the Bucharest City Court decision of 28 September 1998 and the approval of the Minister of Research and Technology and Mayor of Bucharest. ASFAN headquarters is at the Municipality



Astronomical Observatory "Admiral Vasile Ursianu", in Bucharest, bul. Lascar Catargiu 21. For three years (2000-2003) ASFAN held monthly public meetings at the Military Circle and for National Cultural Students. Among the guests, besides members of Bucharest were Gheorghe Mandics of Timisoara, Adrian Patrut in Cluj-Napoca, or John Adam ASFAN branch chief of Batam. ASFAN members were present in these years to

virtually all the TV channels and radio stations with national coverage, in debates on UFO issues

A flying man visits the Romanian village of Gemeni September 2007

When one looks at the honest faces of Romanian country folk recounting their sightings of a flying humanoid; we see shock still written in their expression. This community's shock is a direct result of an alien encounter; it is a very natural reaction to the unknown danger whose residue they sense so vividly and relive constantly. Many ordinary citizens of modern Western democracies often feel the need to mock or find unnecessary mirth at people's profound response to a contact. These Romanian villagers are simple people, now they know the illusion of normality in our world has literally broken in on them. Life will never be the same; it is the end of innocence.



Police in Romania's Mehedinti County investigated claims that Gemeni's villagers saw a Superman-type figure flying over the town. They took the accounts of almost 20 witnesses so seriously that an investigation was launched into the sightings. Folks from Gemeni, Mehedinti County said that they saw an unidentified flying man wearing a shiny blue suit just like the one Superman wears. Officers took written statements from all of the Superman attesters and told Ananova that witnesses described the airborne person in the same way. A local police officer, Ion Anuta, said that the Romanian cops talked to people of different ages and described witnesses as "reliable citizens." One of the onlookers, 41-year-old Constantin Ioader,

100 yards from the ground in a standing position. He didn't make any smoke or sound, just cruising around." Officer Anuta commented on the consistency of bystanders' stories, saying, "They all said they saw this strange creature that flew over their houses in his shiny blue costume. We'll just have to see what happens next."



Additional commentary by FSR: the account above appears to originate in September 2007. The following is taken from a posting by 'Cosmin' on a Romanian message board.

Discussion with 'someone who saw' by cosmin: Personally I do not believe in extraterrestrials, but listening to the story of the father of my friend who lives in the village of Gemeni I am less inclined to doubt. The figure was seen at 7 o'clock one morning near a field of cabbage, and then he moved on to a road in the village. He looked like a man made of plastic, more specifically a balloon in the form of a man. Strange, but no-one had interest in flying a balloon in the morning and there was no wind to help the movement. Then it flew over a house and rose up above. It wore a white suit with something phosphorescent in its chest. Its head had big blue eyes with something white and black striped in it's middle. The figure moved like a man and turned on the road to come back and then moved upwards. It returned to the sky and disappeared. Nobody had the courage to interact in any way with that thing.



An important note: The humanoid was described as a man made of plastic or more specifically a balloon in the form of a man. This is exactly the description of a helmeted flying humanoid that passed over a London suburb one evening in August 2007. His balloon-like appearance was

The mehedinbean Village of Gemeni is the place where an alien would have landed Monday morning for a few hours, after which he took flight and disappeared in the sky. At least so say the peasants. There was a

muscular man wearing a blue suit with white stripes, like the Superman movies. Other eyewitnesses said they saw him later; he flew in the upright position over houses. People did not approach him to ask him or reach him. They believed, initially, that he was a dummy put up by children.

Ana Crupan: Mr Bărbatu told me when he came from Cujmir, about the man in blue and then I said I saw him after. Standing upright, around eight. He was dressed in a dark blue costume with white stripes on the legs.

Ion Crupan (68 years) woke up around 6.30 and went out to do his chores, when he saw the extra-terrestrial that Monday. He had a blue suit, with white stripes. The head was round and had a mask. I thought is that a dummy made by children of the village. Many people in the village say that they saw a strange man. Others saw him fly when standing on top of houses. Then I was convinced that something was odd!

Aristică Găletușe in the morning, leading the cows, noticed a break in the fence there was a man in blue who had a mask on his face with white and black points. He was muscular like Superman. The man did

not harm anybody, left to him self! I was not scared I went to meet him to see what he was or talk to him.

Valerica Găletușe, is a woman of 71 years she was positive about what she saw. Opening the gate leading to geese, saw a man like a mannequin, in blue, standing in front of my house.

Constantin Toader (41 years) claims that, around 8 o'clock, he looked to the sky and what he saw shocked him. "I was not drinking, not anything and I know you see that it's not crazy. About 100 metres up in the sky was a man dressed in blue. There was no smoke or noise, the legs had some more colours.

Valerica Cristi Stoica was giving food to birds in the yard. "My husband said to me look what's on top. It was, actually, a man in blue, who flew off. Only God knows what he was.

Mayor of Dârvari, Ionel Mocanu, does not believe the story, but police took things seriously and have collected statements from all witnesses in the village: "I do not think so too, although the statements of people say that was about the same blue costume."

Police Officer John Anușă said that checks are being made with a view to explain the mystery. "I was on the spot and I took statements from seven to eight persons. It was not a tall story, because these are serious people, of different ages, men and women. All the witnesses say the same thing, namely that one strange man, who later flew over the village, was dressed in shiny blue suit. So far I do not know what he was!

Otopeni Airport, Romania, over-flown by a UFO in 2004

CCTV images of UFO were hidden until our newspaper 'Guard' insisted with the authorities that they are media. The magazine "Guard" came into possession of another recording, after the 'MIG hit' last year near Gherla. The new images, were taken from the control tower at "Henri Coanda Airport" (formerly Otopeni), in the summer of 2004. They can be found on the site www.gardianul.ro, they are regarded as genuine and are in the possession of the Ministry of Defence, SRI, the Airport "Henri Coanda" and other institutions.

They are inexplicable; they show a bright red and green object in the area at least 30 minutes. However, at certain times it moves. It is hard to believe that it is an aircraft about to land, because, according to video time codes it takes at least half an hour, during which time the plane should reach the runway.

"The images are authentic" said Sorin Stoicescu, director of the Directorate General of Civil Aviation of the Ministry of Transport in 2004. "We said that the pictures are authentic they were caught on video cameras of the Otopeni International Airport and were analysed by specialists of MAPN and SRI." According to Sorin Stoicescu, the object



UNUSUAL PHENOMENON OBSERVED WITH A RADAR DEVICE IN ROMANIA

Ion Lazeanu (ASFAN)

I was working, as senior meteorologist, at the RADAR laboratory (physics of the atmosphere) at the National Institute for Meteorology and Hydrology in Bucharest (Romania), since 1967. In the same year an English Plessey radar was installed in our Institute, the training of users being made by English and American specialists. In 1971 the Plessey device was replaced by a new installation: MRL-2, made in the former Soviet Union, the training being performed by an engineer from the manufacturer company. The radar had a range of 300 kilometres and a narrow angular opening, typical for meteorological radar devices.

The meteorological observations were performed each hour, 24 hours per day, working in shifts. During one of the routine observations, with this radar, on the night of August 1986, at 2.00 a.m., a sharp horizontal line, one cm long appeared on the screen. The position of the target remained stationary. By specific radar techniques, I determined that the distance to the object was 275-280 km southwest of our station, that is above the city of Sofia (Bulgaria), at an altitude of 30 000 meters. Through manual operations, for about 4-5 minutes, I stopped the radar beam on the "object", which remained motionless all this time. Afterwards, almost instantly, it disappeared. I found it immediately, on the same vertical, some 5000 metres lower down. I fixed the radar in this new position, continuing the observation, but after a short while it disappeared once again, this time rising into its initial position. I have good experience in observing flying objects and I have also two licenses as an airplane pilot, but this object and its movements resembled nothing I knew before.

In this period of time I was on duty by night, every four days. I had the opportunity to observe this strange "object" almost each time, during three-four weeks, in the same place. The length of the observations was varying between 3 and 20 minutes. I discovered the same object (or another, identical), above the city of Cluj-Napoca (Romania), located some 300 kilometres Northwest of Bucharest. Afterwards the object disappeared and it was impossible for me to find it, despite my efforts.

The object reappeared in February 1988, again in the area of Sofia, and again by night, between 2.00 and 4.00 a.m., my observations were made several times, the whether being good and the sky cloudless. Once again the "object" made its vertical movements. After one month, a change occurred; during one of my observations, the object disappeared suddenly, but this time horizontally; I found it more than 200 km eastward, in the area of the city of Varna (Bulgaria), after a search of one minute, but it seems that the distance was covered in a much shorter time. In the next observations I found it in this new location. When I fixed the radar beam on it, the object performed the same quick movements upward or downward. In one night, after repeating this operation several times, when I fixed once again the beam on it, the whole radar installation was disconnected spontaneously, with a muffled thud. I started it again only for the next hourly observation. After the usual operations, everything was functioning without any problem. But the "object" was visible no more. After this incident, I stopped studying the strange object. I saw it several times for a short glimpse, but I avoided stopping the device on it. I have to mention that the

After checking all the components, he told me that he did not found any explanation for the spontaneous stopping of the radar. As a matter of fact, the radar was working in the next period of time without any failure.

The dimensions of the object could be estimated by analogy. A big ship (e.g. 200 meters long), at a distance of 35-40 kilometres offshore, appears on the screen of a similar radar, installed on the coast of the Black Sea, as a horizontal one centimetre line. Taking into consideration the distance of 275-280 kilometres, the "object" could have a length of at least 1500 meters. It has to be remarked also its tremendous speed, both horizontally and vertically, as well as the property to reflect the radar beam.

NOTE - Following some comments which contest the possibility of stopping the radar device on the target, the author states that there are several types of radar and some differences between military and meteorological radars, as follows:

- The military radar transmits radio waves, with a great angular opening, to detect small targets. There are often two antennas moving horizontally and vertically. Only when they are moving they can "see" the target.
- The meteorological radars, as the MRL-2, have a small angular opening. Their purpose is to detect targets with large size and low speed (as the cloud systems). They act emitting two microsecond pulses of radio waves. When they "catch" a target, the echo of the pulses is received by the same antenna, in the same position. Unlike military radars, the meteorological ones can observe a target by being stopped on it.

Commentary by Harry Challenger: this important though historic Romanian article by Ion Lazeanu further validates the potential of weather radar to zero onto invisible UFOs. On each occasion the apparent UFO may have picked up that it was being monitored and reacted to avoid detection by moving thousands of metres in an instant. Alien craft may be routinely monitoring our cities.

In FSR 51.1 we raised the concept of using detection apparatus to filter the hypothetical compression layers in the air around cloaked UFOs, the compression causes drastic local changes in air condensation of water, something characteristic to a fingerprint for all exotic UFO including those that are cloaked silhouettes. These hypothetical findings conceivably can be picked up on visual spectral analysis, and will not be generated by conventional aircraft. The cloud ring generated by the June 1st Southampton triangle is a much more extensive rapid condensation phenomenon, but essentially the same process is potentially involved around all UFO energy fields. The future of ufology may require a dramatic period of evolutionary divergence into brand new forms of detection technology.

Phenomena in the Hoia-Baciu Wood near Cluj-Napoca.

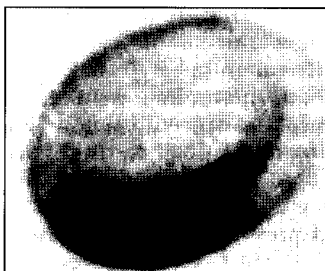
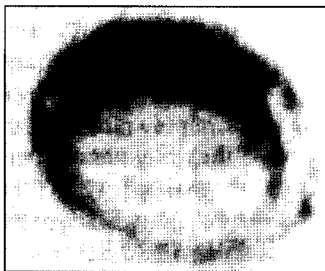
Cluj-Napoca (anomalies on photos, apparitions, strong sporadic radioactive emissions, magnetic deviations, biological effects etc).

The Hoia-Baciu wood (HBW), close to the city of Cluj-Napoca in Transylvania, Romania, is the site of some unconventional phenomena which have been recorded and researched for nearly 50 years. People of various ages and educational levels seem to create a modern variety of folklore on the basis of these unconventional occurrences. The HBW has a tendency to become the Romanian version of the Bermuda triangle.

The fame of the HBW has long reached beyond the borders of Romania. The international news agencies started with the



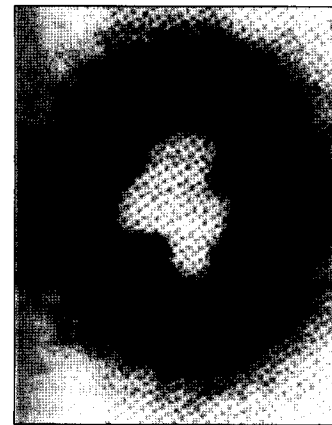
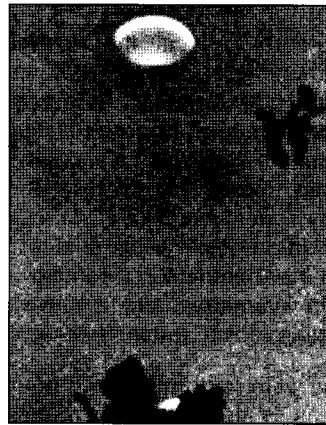
exceptionally-good photos and film of a disc-shaped UFO which flew over this wood on August 18, 1968, and continued, ever since, with many reports of the local phenomena. The evidence was studied by research institutes in Europe and the U.S.



The pioneer of the HBW research was the late biologist Alexandru Sift (1936 - 1993) who, while walking in the wood at the beginning of the 1950s, noticed, repeatedly, hazy shapes which could have passed, for untrained eyes, for natural events. Sift photographed the shapes and noticed that the film disclosed many more such shapes than apparent to the naked eye. The research continued with ever more visual and especially photographic recordings.



Sift's initial investigations were continued, beginning with 1970s, by several research teams and by independent researchers from Romania. The results were similar, rounding off Sift's findings. Most researchers were trusted scientists. Lately, research teams from France, Germany and Hungary visited the HBW and obtained remarkable results. Briefly, here are the occurrences: structures/shapes flying low over the ground, some visible, most invisible to the naked eye spots of light at night, coloured or white,



magnetic anomalies, electromagnetic fluctuations, microwave and infrasound emissions etc) unusual prints on the ground (on the grass or in the snow) - not unlike the circles and other geometric figures in crops. Associated biologic effects, especially on the plants (dehydration, burns, necrosis, etc), also on animals and even humans who reach the active zones (reddening of skin, burns, anxiety, head aches, thirst, sickness etc). The most characteristic manifestations are airborne, flying geometric shapes (pyramids, spheres, cylinders, cones, cubes etc) - either visible or, more often, invisible to the naked eye. These shapes have been photographed and filmed thousands of times; seen - in the hundreds. The most spectacular are probably of the UFO, pre-UFO or quasi-UFO types. The invisible UFOs, much more numerous than the visible ones, are unique in the world.

Also interesting are the so-called humanoid heads, usually invisible to the naked eye, along fully-bodied, visible and apparently animated (live) humanoids. Quite often, these structures resemble the face of a live or deceased person known to the beholder. Worth mentioning are also the transitory bursts of beta and/or gamma rays, sometimes of high intensity - along magnetic distortions, mainly associated with the white structures. The electromagnetic fields which empty the camera-batteries, or just arrest their power, are quite common. The "special active spot 3" identified in 1993, is reputed for distorted photographic images, partially or totally, fragmented or even split - which could only be obtained, otherwise, by multiple exposures. The research, so far, allows for a few more conclusions:

- The HBW phenomena are, most often than not, discreet, rather than obvious.
- The wood speaks more to the researcher than to seekers of spirits or extraterrestrial life.
- The phenomena are far more numerous than the sceptics would say, but far less frequent for the seekers of sensational occurrences.
- There seems to be a connection between certain more-mediumistic persons and these occurrences, but that is not a condition.
- The frequency of these phenomena is fluctuating - no regular pattern could be noticed.

The phenomena in the Hoia-Baciu wood are not singular. There are similar manifestations in the Mojave desert, in the Gulf Breeze (the U.S), in La Spezia Arenzano (Italy), the Hessdalen valley (Norway), Belu Horizonte (Brazil). It seems we have encountered a planetary oddity of a complexity we are not ready to decipher. By its relatively systematic occurrences, the Hoia-Baciu wood is the most important area of unconventional phenomena. in the

The work of the Romanian Florin Gheorghita on imaging invisible orbs and anomalies.

Florin Gheorghita was FSRs longstanding Romanian correspondent from the late 1960s onwards. He was an early supporter of Sift's photographic anomalies known as globular forms. He described Sift's first dramatic encounter as thus:

In 1953, when Sift was a 17 year old student he used to go for little outings in the Baci Forest near Cluj. One day in mid-summer he saw a luminous globe fall from the sky onto a large bush, and then suddenly vanish among its branches. Rushing to the spot, and still seeing nothing there, he pushed a stick among the foliage, hoping to find some traces of what had fallen. A most disturbing thing happened, he found he could no-longer see the stick, nor could he any longer see part of his hand. He felt a tingling sensation throughout his hand and great heat in the soles of his feet. Then immediately afterwards, this was followed by the sensation of something cold pressing down upon the surface of his body.

As an engineer Florin Gheorghita wrote extensively on the hypothetically laws of globular forms. A translated, unpublished manuscript from 1991 in the FSR archive supplied the following observations:

I wish to accomodate the reader with the interesting images belonging to a parallel invisible world. In the atmosphere, both in nature and inhabited zones and even in dwellings there exists invisible moving or standing agglomerations of extremely fine particles with special energetic behaviours. These agglomerations are spherical or ellipsoidal and relatively small in diameter, from some centimetres to some tens of centimetres. Their shape and dimensions are maintained during movement even at long distances.

The material particles agglomerated in such forms possess a higher energetic level, which induces a uniform emission of radiation responsible for producing images of plasmatic globes on film. They do not belong to the visible spectrum and as they are recorded on infra-red film they must be considered long wavelengths and thus to high frequency waves. In some situations the invisible form is recorded as a transparent presence, although continuing to emit unseen radiations, it is this aspect that makes them resemble plasmatic-type structures. It is never the less possible that the effect of transparency should not depend on a certain density of particles, but on a different energy level. These plasmoids maintain a constant volume even at long distance demonstrating that the inner cohesion force is much stronger than the dissipation tendency normally exercised by atmospheric agents. The constant maintenance of plasmoid volume suggest although radiant energetic processes occur within, the thermal component is negligible.

In a certain part of the Baci Forest frequent appearances of globes left some limited carbonisations, intense impressions on films at low exposure times as well as Geiger meter readings of discrete radioactivity. The radiation of the invisible globes is very penetrating that made me think they might contain gamma-type radiations. Searching a reduced zone of the Baci Forest, where the biologist Sift found strange burns on the trees branches in 1974, they were found to have occurred from the inner to the external part. No traces of fire were found on the ground which led us to the conclusion that the globes dissipate their energy within gamma type domain yet at quite low intensities. When Italian researchers asked me what they should do in a similar zone situated in the North-Western part of Italy, I advised them to take photographs in the invisible by employing Geiger Meters. The results obtained were remarkable, several presences and displacements of radiant globes were captured exactly where the counters indicated variations of local radioactivity!

One of the most interesting manifestations of these odd globes

unknown exchange of energy occurring during the displacement between the globes and the environment. The documentary photographs, always accidental, show a very interesting rhythmic emission of radiated energy from the globes. Such a phenomenon is wholly unknown with structures of normal matter in which all radiation processes are produced continuously until exhaustion of its energetic resource. Indeed it seems that the propulsion manner of invisible globes is based on a strange energetic manifestation, after covering a small portion of the route, the inner energetic potential seems consumed and the image of each moving spheroid is extinguished, seen no more on the negative. Yet, after covering an equally short distance the spheres image appears again emitting radiation of an equal intensity to that of the previous sequence.

In this way the whole agglomeration maintains the association of its particles, perhaps by absorbing a certain form of energy, cosmic or earthly from the environment and transforming it in a very short time of extinction following its emission. Both the intensity and the colours recorded on films specific to each sphere remain unchanged after each extinction and re-ignition regardless of distance covered. The unprecedented physical phenomenon of self-feeding with energy from the surroundings through a rhythmic energetic exchange proves even more the difference between invisible spheres and balled lightning or ionized plasma which is rapidly extinguished after loosing its electrical potential.

As a matter of fact the strange rhythmic radiant manifestations of invisible globes could be considered wholly similar with some vital processes of living organisms such as breathing or heart beating. Researching the unusual behaviour of pulsing spheres, several pictures record their trajectories as parallel to one another. In some situations rhythmic lines perform varied changes of direction appearing as if according to some rigorous program. Different recordings of parallel trajectories in various airy patterns taken around the World would involve either the influence of some external energetic factors whose strange and extremely high speed variations cause those incomprehensible games or the intervention of a certain intelligence that would conduct them according to the program. On trying to select a more logical and realistic hypothesis on the behaviour of spheres an unaccustomed idea, perhaps more close to reality, would be that each globe, large or small has its own intelligence.

As if adding to the oddness of this invisible world, the existence of which is undoubtedly felt by many people, some events suggest that the intelligent globular entities would not represent a parallel world to ours. The radiant globes would actually represent the ontological prototype of a fundamental category of intelligent matter, spread not only on Earth but all over the cosmos! Yet another interesting detail is present in the cases of extraterrestrial interference, various globes having probably come to Earth from other cosmic dwellings have been seen while specifically terrestrial globes, although frequently moving about us, might only be accidentally seen. Therefore the ever enigmatic UFOs have gradually convinced us they are messengers of some more advanced extraterrestrial civilisation carry bright globes with an intelligent behaviour too! If such radiant globes, generally unseen on Earth, become visible especially when coming from another part, does this mean they represent a proto-type of the beings in our galaxy and respectively, in the whole universe? If such a hypothesis would actually be a fundamental reality it means we should wholly accept the ancient spiritualistic philosophical concept that the human being would be made of a material body as well as an invisible entity, remaining after each life in the planetary space as a radiant globe that keeps its intelligent behaviour.

A CLOSE ENCOUNTER OF THE THIRD KIND IN ROMANIA.

During the night of July 8 to 9, 1996, in the centre of a village, in Eastern Romania, a police sergeant and a guardian had a close encounter of the third kind. They saw a UFO hovering above the road and three humanoids around it. Some other events seem to be connected with it. The case was widely exposed in the Romanian media but it was not thoroughly investigated by UFO specialists being almost unknown abroad. (This article and the article by Ion Lazeanu were originally published in the European Journal of UFO and Abduction Studies, a publication which is no longer in print).



The following case was observed in the village Certesti (pronounced *Tchertzeshti*), district Galati, in South of the Moldavian Region of Romania. Only newspaper and tabloid reporters investigated the CE III in the next days and not UFO "professionals", because of the lack of funds and of appropriate UFO research structures in Romania. The TV producer Mihai Badescu, with a small team, went to Certesti, on August 12, 1996, to make a short film about this event, for TVR1, the main Romanian Public TV channel. He invited Calin Turcu and me (both of us having books published in Romanian about the UFO phenomenon) for comments. During that day, we had detailed discussions with the witnesses of this encounter and with other people, including sceptics. The main findings are mentioned below.

The police sergeant *Marian Mancu* and *Marcel Rusu*, voluntary guardian, were patrolling on the main road passing the village Certesti, on July 8 to 9, 1996, at night, in front of the police office. In this place, on both sides, between the road and the sidewalks, there are deep ditches, with small bridges across them. The houses are behind the fences, in the middle of orchards and gardens, except a two-storied apartment house, opposite the police station. The police sergeant lived in one apartment of this building. Around 00.30 AM, Mancu told Rusu that he would go home for ten minutes, to eat something. The entrance is behind the building. The moment the sergeant passed the corner, he heard a whistling sound from the street and sensed a current of air. He turned immediately back, seeing on the road something which "splashed blue and red lights, making a sound like vroom-vroom".

At the first moment the sergeant had the impression that a police car from the district capital Galati had arrived on a routine patrol. Getting closer he realized that the object was hovering half meter above the pavement and a small and very strange person was moving around it. He cried "Guard!". As an answer, he observed the horrified guardian, coming half out from the ditch where he was hiding himself, below a bridge. He whispered "Mister Marian, Satan!" Rusu declared later that immediately after the sergeant disappeared behind the apartment house, "a fluttering from the above appeared." The neon lighting of the street seemed to change in intensity. The object descended smoothly, without noise, behind him. For a short instant he was also convinced that it was the police car, on routine patrol, but turning, he became frightened when realized that the object had no contact with the ground and that three small human like creatures moving around it. As he declared "when I saw how they were, their ugliness, I told

myself in the ditch because I have never seen such things my life."

As both witnesses agreed, the object had the form of a flat craft, 5-6 metres across and 2 - 2.5 meters high, and was hovering and balancing 0.5 meters above the ground. Around the edge it had a continuous girdle of light "as a rainbow". The colours: red and blue (or green in other declarations) change between each other and flared. At the bottom of the object was a bright white light. None of the witnesses saw door, portholes or other details. After about two minutes, as the estimated, the UFO rose vertically. At that moment its light became much brighter, but the neon streetlights went out. When the object reached around 30 meters, it change direction and turned toward East, with tremendous speed. The neon light went on after not more than thirty seconds.

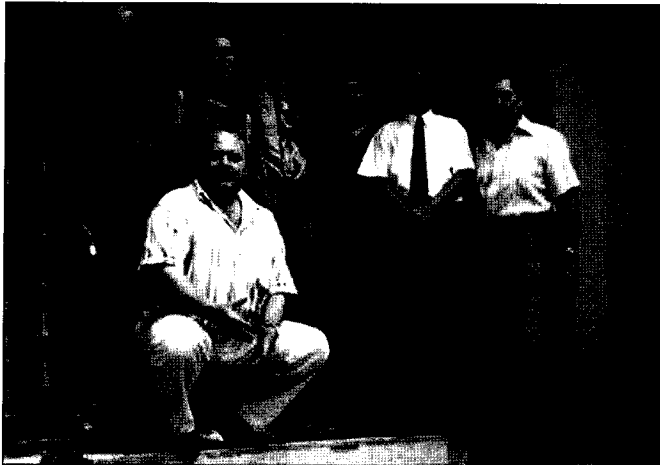
The guardian, Rusu, saw the humanoid creatures more clearly. Sergeant Mancu noticed only one and only from behind. The height was estimated to be around one meter, maybe less ("as

a child of six years"). Rusu said he heard some noise made by them, "like rain in a drain pipe". Both agreed the creatures gave the impression of "abortion" (in the sense of "unfulfilled development" as they mentioned later). The visitors had a big head, very elongated behind, and covered with bumps, no hair and big ears ("as a palm of a man"). Their face was white and they had big eyes. Gray scales with a metallic sheen, as fish scales, covered their bodies. The belly was relatively big and limp. The arms were "not thicker than two fingers". None of the witnesses remembered the nose, the mouth or if they wore shoes. The witnesses could not tell for sure if the creatures were walking or flying above the ground, but accepted the second possibility as more likely. Rusu said they moved, "as if they were drunk".

The physical traces were weak. A huge sweet cherry tree nearby had around 15% of its leaves affected, as if by extreme heat on the side where the object was seen. The damage was visible even after one month, when we visited. Some people from the village told us that next morning, after the encounter many leaves and broken limbs and were spread on the road in that place. Some others were convinced that this was the result of human activity. No other signs were recorded. Nobody measured the radioactivity or took samples. Sergeant Mancu declared that, after the object disappeared he had to help Rusu to come out of the ditch. The guardian told him that he was sick and he had to sit on the grass for a while before becoming capable of walking. He remained convinced he had seen Satan. After about a quarter of an hour a tractor came up the street, driven by *Nicu Chicos*. The two asked him if he had seen something. The tractor driver finally admitted that he and another countryman *Emil Bugeac*, of the nearby village *Carlomanesti*, had seen a bright light, with some coloured blinking, in the evening before at 10.30 or 11 P.M., three kilometres away from Certesti. But it could also have been

More interesting should be the testimony of the countryman *Gheorghe Ghenghea* from Certesti. He was watching that night, with his daughter, a song contest on TV. In a certain moment, the image deteriorated, extinguished, restored for a moment, extinguished once again, and after a short while came back without other problems. No other lights were on in the house; so, it could be a short blackout. The witness went out, to ask a neighbour about, but apparently, everybody was sleeping. The colour TV appliance was new and he had no problem with it until that moment, or after. The inhabitants told us that some other electrical appliances in the village were disturbed too. We had no time to verify these allegations.

Another interesting witness was *Stefan Dumitru Carje*, from the village *Cotoroia*, 4 km Northeast from Certesti. He woke up, the same night, because of the barking of dogs, at 1.12 AM (he remembered seeing his watch). The backyard was lit by a very powerful and extended yellow through red light coming from high up. Going outside, he was not capable of identifying the source. "The sky was red and the ground red, it was so bright you could read a newspaper". He said he was 62, he had three years with the air force but he had never seen such a light. The witness described the events, "all the animals were up, but not scared. The birds were not croaking or cackling. Only the dogs were barking". After a while he re entered the house. When as he was thinking of waking up his wife and two grandsons, to see the phenomenon, "the light became thinner and thinner, maybe it lasted three minutes until that powerful light disappeared and returned to the light of the night". He added later: "I saw something as a haze raising up to a certain height and afterwards disappearing slowly in the air".

We consider that the Certesti case could be classified as a CE III. But was it more than that? Maybe it was a CE IV; in other terms, was it abduction? A first argument is that, in the following days, sergeant Mancu felt sick and powerless; he supposed he was irradiated. The guardian, Rusu, had repeated nightmares. As he declares: "I was dreaming on the following days about how I was hiding myself in the ditch then I woke up frightened because they were so ugly". I questioned both of them about a possible "missing time" period. None of them had such an impression. But when I tried to establish more precisely the time marks, I found that none of them had a watch. The sergeant said "I did not have my watch with me because the strap was torn". Rusu had no watch at all.

Trying to establish the succession of the events, we found strange discontinuities. None of the witnesses remembered seeing the humanoids descend from the UFO or re-entering. More than that, the witnesses could not explain how the visitors did that, because no doors or entrances were visible. Maricel Rusu declared "I did not see which way they descended. They were already turning around".

The situation was the same when the UFO was flying up the creatures were simply no longer there, and nobody saw them going up in the object. The same witness declared: "they disappeared, but I didn't take notice what way they disappeared. I don't know where they entered and I did not see them entering, maybe behind." Sergeant Mancu also recognised that he could not explain how the little men disappeared. His impression was that he observed the small creature only for four-five seconds. In the literature there are many cases when the witnesses considered they had a CE III only for several seconds or minutes, but after some complementary procedures, for example hypnotic regression, they discover that it was a much longer story and a CE IV. Therefore, we agreed, it would be interesting to use this technique, or something similar, in this case too. Unfortunately, in Romania we face a lack of professionals practicing hypnotic regression or willing to apply it in such situations. Even the travelling expenses to arrange sessions constitute a problem.

Another curiosity discovered in our visit was that the villagers of Certesti told us about several other very interesting and quite typical UFO observations, even close encounters, in the last years. They have never been reported. They would have remained completely unknown if the main event had not happened. I wonder about how many similar situations are in the villages of Romania and of many other countries too. As a peculiar but not unique sequel, we can mention that, after two years, sergeant Mancu was fired from the police, most probably because he tried to be "hyper-correct" in several cases, even against his chiefs. One argument used was that Mancu is "that guy who sees UFOs."

Serpents of Wisdom or Snakes in the Grass?

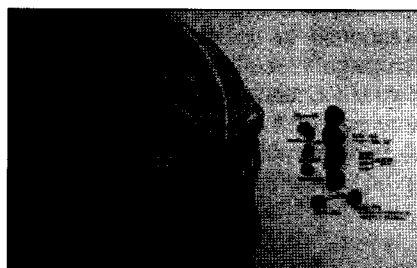


An extract of the work of **Beverley Trout**, the former Iowa MUFON State director. She addressed the reptilian alien question in a two part article in the MUFON UFO Journal of September October 2004.

In assessing our present reptilian-human relationship, I have felt a compelling urgency to probe, to take a closer look at our ancient past. A reptilian presence has been recorded in a highly visible way in ancient records.

For instance in 'Dead Sea Scrolls Uncovered' by **Robert Eisenman and Michael Wise**, among the Dead Sea Scrolls

discovered in 1947 is a document attributed to the father of Moses, which provides a physical description of 'watchers' over this planet. The narrative clearly points to some of the



'watchers' having a reptilian look. The author, Moses' father, in describing his encounters with the 'watchers' describes them as "**Terrifying in his appearance, like a viper.**" A book

Serpents and Dragons, The Story of Mankind's Reptilian Past authored by R.A. Boulay, (who incidentally was a cryptologist with the U.S. Government until his retirement in the late 1970's), cites historic and religious texts that refer to our reptilian connection. In a fragment from one of the Sumerian tablets dated 3500BC, there is a description of the coming of the 'gods' to this planet from the skies, long before the deluge, the reptilian nature of the 'gods' is explicit. **"The reptiles verily descend."**

For me it is interesting to note that a Sumerian term used to describe **"flying serpent with flaming breath"** was U-SHUM-GAL, which was a common epithet for the scientist god/alien, Enki, and other major gods that Zechariah Sitchin has written about in detailing research into Sumerian records. **U-SHUM-GAL is translated as simply one word "dragon."** There are also ancient Sanskrit sources which tell of a serpent race which descended from the skies and taught mankind; as well as South American cultures referring to their serpent gods. The book of Genesis points to the snake as a reptilian influence in mankind's development of knowledge.

I've run into several cases which could illustrate the variety of abduction experiences in which reptilians are involved, but in order to follow further exposition of my own reptilian perspective let me focus on just one incident. Jack is an abductee whom



I've known for several years, Jack and his partner were sleeping peacefully one night when he awoke to a sound from the adjoining bathroom. He saw a reptilian heading for his partner who was still sleeping peacefully beside him in bed.

Instantly, Jack sat up in bed, pointed a finger to the door and telepathically shouted, "Stop! You are not allowed into this space!" At this point, something gave this particular reptilian pause. He stopped, retreated about three feet and stood or hovered just inside the bathroom as if watching and waiting to see whether Jack was strong enough to prevent him from reaching his bed partner.

Then a thought stream permeated Jack's mind: "Call out to the Archangel Michael." Instantly, he did, silently, telepathically but succinctly and stating the exact need for intervention and the action desired. At this point, a beam of light energy entered the room, and from it came a shape holding a long rod of light. It was at least seven feet high and confronted the reptilian. Jack's perception was that the reptilian shrieked and then completely dissipated. Then the shape returned to the light beam and the beam retracted from the bedroom.

It should be noted that Jack is an abductee himself and he emphasised to me, "Bev, I've had interactions with reptilians for years, it hasn't been to scary, but I knew this particular individual meant no good. I pass on Jack's remark to show that he was not lumping all reptilians into one single deity or demonise category."

Then Jack and I got into a discussion of the "Archangel Michael" part of the episode, and the pillar of light which seemed to appear in response to Jack's extremely urgent request. Was it in fact an angel or could it have been some aspect of Jack himself which became activated, seemingly outside his physical self, yet perhaps stemming from his explicitly recognised need and his ability to state his desire for action. Long after this conversation, I chanced upon Dr. Richard Sanders book, Kundalini Tales, I was astounded to read the following:

some kind of archangel. Vastly and consciously powerful, able to engineer entire galaxies; but at the same time capable of interacting in an intensely personal way with individual human beings. Kundalini energy operates through our chakras (centres at various locations in the human body, it is also known as "Serpent energy."

Ingo Swann talked about what he considered to be the common denominator shared by humans and aliens in *Faith Magazine* more than a decade ago. Psychic communication and scanning by the aliens has been reported in many abductee accounts, he pointed out that aliens could not communicate with us unless we humans also possess psychic substructure through which such communication can take place. In other words if we are all wired for this, share communication, if we have a common psychic denominator with the aliens then exploring this potential more fully within our selves could effect a change in our relationship with them. How does it activate?

Perhaps focus and meditation on this powerful energy which is wired into our capabilities, will activate this powerful switch to turn it on. My own interpretation is to undertake a constant and ever-increasing questioning into our willingness to face reality whether in emergency situations such as Jack faced or in the routine events we encounter everyday. Facing reality, however involves facing our own fear, and I am not speaking of what we fear, I am speaking of facing fear itself without trying to use thought to escape it. I think we humans are apt to try to escape fear by setting up an escape thought pattern, which unfortunately serves to distract us from facing reality, from facing the specific now that Jack seems to have understood in his encounter with the reptilian. If Jack in the midst of feeling fear had attempted to think his way out of it instead of facing it, I do not like to think of what may have happened in the bedroom.

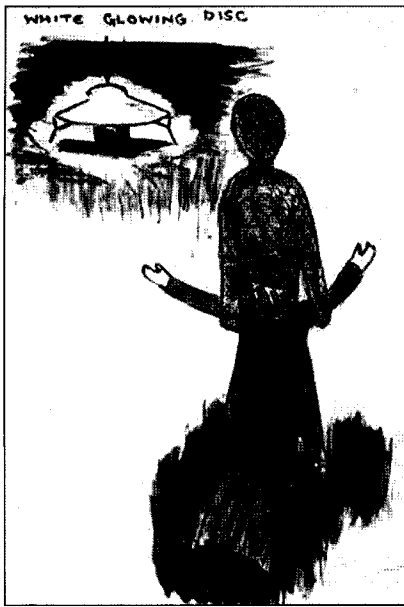
A similar case from January 1999 Vancouver, British Columbia, Canada

Eva Trent had fallen asleep when she awoke to a buzzing sound. Opening her eyes she was horrified to find two strange creatures standing on either side of her bed. The entity to her right was about 7-8-feet tall, weighed about 300 pounds, had apparently no clothing and seemed to have either crocodile or snake type skin. The creature to her left was identical in appearance but smaller in height and weight. They seemed to be communicating in a chirping manner. Each of the entities eyes glowed. Eva quickly discovered that she was unable to move. As she stared at the two creatures she found that either one or both were giving her instructions telepathically. The nature of this was seemingly for her to create mentally visual scenes of various kinds and then "they" proceeded to distort that particular pleasant scene in a perverse manner. Apparently the creatures were intent not only to observe her emotional reaction but also possibly to feed off the energy that was produced. After awhile Eva began to mentally resist the mind manipulation and began to pray earnestly. A short time later she fell back to sleep. The next morning the witness found 5 of her music tapes grossly distorted as if extreme heat had been applied. However no evidence of fire or odour was present.

My Reptilian Abduction: Year 1951: Location Farnborough, Hampshire.

As an opening, I would like to first just explain to the reader what led up to this abduction, as I feel certain key things took place before a victim is taken, which are worthy to note. When I was a very tiny child I remember having strange bedroom



visitors wearing long robes who suddenly appeared in my room. They would use the bedroom wall as a cinema screen and show me many strange things that I was far too young to understand. I have since come to learn that another important factor with young children having experiences such as this, is the amount of times they have 'imaginary' friends; so-called as imaginary but very real to the young child, yet

imagined to on-looking parents who see their youngster engaged in conversation, although no one else is visible or audible, often for hours at a time.

The next stage came despite my parents shoring up the garden, sealing every possible escape gap in the gate and fence; yet I would still go missing. This was from the age of only two years old onwards, when I was found anything up to half a mile away from my home. I could never quite understand why my mother wasn't keeping an eye on me in the garden that is, until very recently, when she opened up to me that she experienced some sort of unnaturally intense sleep state that she couldn't wake up from, often trying to scream herself awake, yet paralysed from doing so.

This frightening situation really upset her then and still does, and it took her a lot of courage to tell me this. She believed that it was during some of these strange sleeps states when I was taken from the garden, which happened many times. She revealed how she was always frantic about me going missing, as she knew she would have to find me when she came round, but nevertheless, she still became very annoyed with me for disappearing each time, even though it wasn't my fault.

On one occasion I was taken along with my bike, and found in Bask Crescent in Raiborough, a housing estate built for the pilots that were employed at Farnborough Airfield in Hampshire. In 1951 we had a big field next to my school which was only over the road from my home: There were several entrances to this land and on one occasion I was going through the Cody Road path to it when I saw a large illuminated disc sitting in a depression in the ground where an old WWII bomb had exploded years ago. The grass was very high in the field so I thought that if I got right down into it I wouldn't be seen. There I splayed my arms and legs out and shuffled forward to see what was happening, when suddenly standing before me was a five foot tall figure!

Looking up at the being, the only way I could explain how this odd creature looked was like a funny tortoise having never seen any other reptile other than a tortoise at that age. It had scaly-skin, brown/green in colour, two black eyes, two slits for a nose and a slit for a mouth, but I can't remember seeing it wearing any clothes. Suddenly I was grabbed tightly by my arms and dragged across the bumpy field and underneath this disc, then into a cylinder where the door closed behind us. We were then in complete darkness and I felt myself rising upwards till we were in a round room which was also dark; the only illumination was from glowing lights and switches on consoles. I found myself thrown on to some kind of bed, stripped of my clothes and invaded in places on my body with a sharp, pointed, probe that dug and hurt me from my toes to my head; at this point I don't remember any more.

A significant footnote to these remembrances:

On Channel 5 and elsewhere there have been several repeats of a programme about British UFO reports. I cannot remember the title of this documentary, but the part that interested me the most was where two air pilots were interviewed concerning something most unusual that they had witnessed over the Farnborough Airfield back in 1951. These trained observers spoke on how they had a couple of firm UFO sightings in this area; first they saw a silver disc flying at between 800mph to a 1000 mph over Farnborough, and on the second occasion they witnessed the same object flying at similar speeds and heading for Farnham. I wonder, could these incidents have been related to the disc that I witnessed on the ground?

President Eisenhower at Holloman AFB (Muroc)? Part 2.

As we have already seen in FSR 52.4, Art Campbell (right) produced a comprehensive account of the circumstances surrounding President Eisenhower's alien diplomacy on February 11th 1955. In the second part of his account we look at the peculiar group who accompanied Eisenhower on this mission.



Passenger Manifest, Godfrey, Murrow and the Secret Service.



Late in the Eisenhower/Holloman research, the author received a list of the crew and passengers on the trip to Moultrie/Spence AB and Thomasville, Georgia. The crew was a full complement of fourteen, including four guards who rotated shifts while the plane was on the ground. Going down the list, besides the President and First Lady and

might expect. There was Mamie's personal maid, Eisenhower's personal driver, Jim Hagerty (Ike's press secretary) Hagerty's secretary, and Ike's valet, etc. One name jumped off the list that of **Arthur Godfrey**.

I checked to see if this was the famous Godfrey of 1950s TV and radio fame, and sure enough, it was. He was not listed as a social guest as announced in Eisenhower's papers, nor was his name listed in any activities at Milestone Plantation. What was Arthur Godfrey doing on the president's plane? The Godfrey TV shows helped define at least the first decade of 1950s television and radio. Godfrey was associated with his weekly Talent Scout and Arthur Godfrey and his Friends, both variety shows on CBS TV. Both shows were watched by millions and finished in the top ten for most every year in the 1950s. However, Godfrey's star faded somewhat in the late 1950s as his human interest variety show, your name is station, and comedy show, beginning to be



made in Hollywood. But in February of 1955, his shows and his persona were very high on the TV producers' and viewers' lists.

Godfrey was a rather kindly, freckled-faced grandfatherly type with a folksy Will Rogers-type persona and delivery. He was very calming, as he introduced his clean-cut singers and guest stars. He was a skilled host and pitchman. He was credited with introducing such up-and-coming stars as Julius LaRosa, the McGuire Sisters, Pat Boone and a very popular group in those days, called the Toppers. He was TV's first super salesman. The Museum of Broadcast Communications said, "He only sold from the heart." His sales pitches sounded like "he was confiding in you alone. Godfrey's rich warm resonant descriptions of products he had personally tried caused many to go out and purchase what he endorsed." He also played the ukulele on occasion, and sang for his audience.

What was the one and only indomitable Arthur Godfrey doing on the president's plane? Was he there to do a monologue, play his uke and do a soft shoe in the aisle? He was not seated with Ike or his social guests in the main passenger compartment, but was in the forward crew compartment with about a dozen others, including the flight crew and some secret service agents. It is believed Godfrey had boarded the plane earlier before it had taxied to the main MATS terminal to pick up Ike and his guests. Ike's guests were probably not aware that he was on the plane. According to news sources including Time Magazine and other sources later confirmed, **Arthur Godfrey and Edward R. Murrow were part of a huge civil defence effort to assist the government in making pre-recorded taped messages to be sent on TV and radio airwaves in case of nuclear attack.**

Ted Gup wrote in a Time Magazine cover story (Aug. 10, 1992, p.32-38) that throughout **the Eisenhower administration, and for years after, a vault held tape-recorded addresses by both Eisenhower and celebrities Arthur Godfrey and Murrow.** The pre-recorded message was concise: **"The country has come under nuclear attack, but the government continues to function."** Gup said in his Time article that a number of newsmen had taken oaths of secrecy and had agreed to accompany the president to the relocation site of his choosing to lend their familiar names and voices to help calm the surviving audience. Recalling the separate press plane that accompanied Eisenhower to Spence AB and Thomasville, one wonders if any of these spokesmen were also along on this strange trip. What was going on here? Was this trip a true potential national emergency? Or another trial run of apparently many in those days? There were a number of facilities in the mid 50s, where government entities could relocate to in case of national emergency. One was an underground bunker named Mt. Weather near Godfrey's home in Beryville, Va. and another facility named Raven Rock near Gettysburg, Pa., where Eisenhower and his cabinet convened on a number of "practice occasions." There were also other sites prepared in case of emergency for almost all important branches of government. Another person or two on the passenger list, who may have been involved in what Time called The Doomsday Plan, was Joseph Giordano, a radio producer; and another man Robert Lennon whom we can find little about.

In retrospect, the Quemoy, Matsu international crisis did not seem, at the time, to be particularly serious. My (later to be) wife and I were experiencing a budding romance at a Junior College. A year before, I had been discharged from the US Navy and I was just getting my civilian college plans under way and preparing to enter Michigan State University the following fall. Apparently, there was some very serious rhetoric directed at the Red Chinese the Russians and East block countries by our government. The previous fall the Red Chinese had begun shelling some Nationalist Chinese strongholds in the Tachen Islands, including Quemoy and Matsu. Many thought an invasion of the islands was imminent that spring of 1955. To those readers

who were not around in those days the Red Chinese, (in 1949) under their dynamic leader Mao Tse-tung had pushed our wartime ally Chiang Kai-shek and his forces off mainland China. Chiang had retreated to some offshore islands with about 130,000 military men and over 900,000 civilians.

Alluded to earlier in this story was the Formosa Resolution passed overwhelmingly in both the Senate and the House (Senate 85 to 3, and House 409 to 3.) In essence, Congress had authorized "war in advance" at a time and place of President Eisenhower's choice. John Foster Dulles, Ike's Secretary of State talked about "new and powerful weapons of precision." Dulles said later that the US was prepared to use "tactical" atom weapons to defend Formosa. In a press conference a few days earlier, **Eisenhower inflamed the debate when he said about nuclear weapons, "These things can be used on strictly military purposes. I see no reason why they shouldn't be used just exactly as you would use a bullet."** This statement shocked many allies as it did Americans. As Ike and his hunting party left for Georgia on February 10th, the events of the last two weeks and our government's talk about nuclear weapons led to considerable tension in the world.

Admiral Radford, the chairman of the Joint Chiefs of Staff, said "War can break out any time." Ike's calendar, the first day after he returned from Georgia (February 14th), showed him with both Admiral Radford and John Foster Dulles in consultation. Realizing the Chinese shelling of Chiang's off shore islands in 1955 may seem today like a tempest in a teapot, but the international situation in early February of 1955 apparently warranted some contingency plans when the president travelled. A spokesman such as Arthur Godfrey may have been somewhat reassuring, at least to some. Congressional leader Lyndon Johnson helped push the Formosa Resolution through congress. Years later as president he used the Formosa Resolution as a model for his Gulf of Tonkin Resolution to escalate the fighting with North Vietnam.



According to Frank Stanton in a 2004 interview, a group called **The Eisenhower Ten**, was established during President Eisenhower's second term (1958-1961,) to serve in critical government roles, in the event of atomic attack or other disaster. Such an event had taken place Stanton (a Ph.D.) was to have served as administrator of what was known as the Emergency

Communications Agency. That Arthur Godfrey and Edward R. Murrow made the recordings. "It's true," Stanton said, "absolutely true." Searches in various archives, however, have failed to locate the recordings. Stanton who died in 2006 and was a revered figure in American television. He knew Arthur Godfrey well and was credited with bringing Jackie Gleason into television.

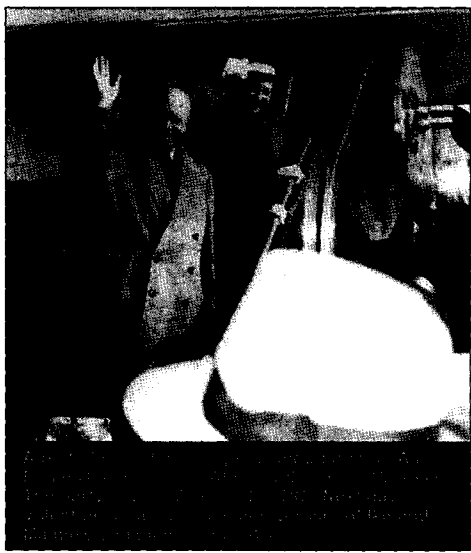
Of the eighteen passengers on the Columbine III that left Andrews AFB for Georgia on February 10th, 1955, well over half were secret service agents and supervisors. We also know that two or three secret service agents were on the press plane that preceded Ike's plane into Moultrie AB, twenty-five miles north of Thomasville. This would make a total of 12-13 agents for a simple hunting trip where only briefly (coming and going), would be in the public view. Correspondence from two former secret service agents indicates that this many agents would not be excessive for an overseas conference or a summit meeting where many experts well-versed in foreign language would be necessary. It was unheard of, however, for a short domestic "recreational" trip where the president would have little or limited public exposure.

The Humphrey plantation was off limits to reporters on this and subsequent trips while Ike was there and his exposure was limited to a few photo ops in and around Thomasville. Incidentally, one of the young secret service agents in the

He achieved quite a bit of publicity seven years later as the agent in charge of the secret service detail in Dallas TX, when President Kennedy was shot. Agent Kellerman was in the front seat of Kennedy's car.

In 2007 I interviewed one of the security guards on Eisenhower's Columbine III crew. I asked what the usual complement of secret agents was, and he replied, "Usually five or six", and if they were going to a new place where the president had not been, two agents would go ahead and make security arrangements, but five or six were usually in the plane. "They often sat with us in our section, and we knew most by their first names." Then he said "I do recall one trip down to south Georgia (he wasn't on this one) where there were a dozen or so going to this tiny little town."

He went on to say that plane crew did not ask any questions, but they learned why the following day. About 3:00 a.m. they had gotten word that the president would be leaving in an hour. "We were always ready for this kind of thing, and sure enough, the plane left one hour later." He said about a half hour before the plane left, two Air Force cars pulled up and six agents came on board. They had apparently been booked into a nearby motel somewhere for a day or so. The other agents in the little town bustled around in their darkened vehicles, indicating that the president was there. No one noticed when the president returned late at night a day or so later, and no one ever knew he had left.



Author's note:

This statement given in 2007 about an event 50 years earlier by a retired crew member/ guard is probably about as close as we will ever get to a verification of the Thomasville/Holloman AFB story of 1955. The gentleman did not have any additional details, but his recollections of a

dozen or so secret service agents on the plane matches the Air Force One leaving in the early a.m. for "somewhere in the west" story well. That many agents would be needed, especially if the president was appearing to be in one place but was actually "somewhere out west." The Feb 1955 supervisors and agents were: Jim Rowley, head of Eisenhower's Secret Service; Gerald Behn, head of White House Secret Service; John Campion, Head of Secret Service on specific trips; Agents John A. Walters, Secret Service linguist (spoke 6 languages); Agent Chavrans, Stewart and Stout. Also along were Agents Arnold Lau, William F. Shields, and Roy Kellerman. From press reports, we know of several other agents on the press plane.

Apparently, from Ike's known movements and activities according to reports of those who saw or heard him, he got his business over with the UFO by 9 a.m. or so. He spent the rest of the day with Base Commander Colonel Sharp looking at some facilities, having lunch, and speaking to several groups. It is felt by the author that both the president and Col. Sharp decided to allow some visibility as it would create more undesirable publicity to have him hidden, than in the public view where things would seem a little more normal. We knew Ike was on the base from about 9:00 a.m. until about 4:45 p.m., when Airman Kirtland and his friends saw the president's plane take off. A 45-minute meeting time with the UFO occupants would not lend itself to a

The review of an item or two and one or two questions from either party might be accomplished in this short time period. However the 6-7 hour time frame (by the ETs or us), could have been time enough



for some important information gathering or some additional consultation. "It was almost as if they were waiting for something and killing a lot of time," one civilian supervisor said. We know that in Feb of 1955 that the famous U-2 plane, was not operational yet. The major drawings were complete though, and the mock-up was being tested in the Lockheed wind tunnel. The maiden flight was not until Aug 4, 1955, later that summer. There, no doubt, were other intelligence sources available to the president and he might have been waiting on some of these. In any case, he left the Holloman base About 4: 45 p.m. Apparently, behind the pilot's compartment on Ike's plane there was a complete radar and radio room with state of the art communications gear including air to ground teletype and an air to ground telephone as well as scramblers and coding equipment.

Several curious facts emerge from the records of the Columbine III (AF 53-7885) that left Moultrie AB for Washington at 1:30 p.m. on Feb. 13th, 1955. Of the twenty-four in Ike's party that arrived in Moultrie (six in the social party and eighteen passengers), only 21 returned. Two were added; they were Mr. Jack Whitney and his wife Betsey who owned the Greenwood Plantation where Ike's party had lunched. Whitney later became the US Ambassador to Great Britain's Court of St. James. Two secret service agents did not return to Washington on Ike's plane, and conspicuously absent from the return list was Arthur Godfrey. If Ike had waited for some information at Holloman and it appeared that the smooth-talking, grandfatherly figures' services would not be needed, had he simply gone back to New York? We will probably never know. Regarding the nuclear threats that President Eisenhower and John Foster Dulles issued to the world's two most powerful Communist countries just before the Thomasville trip, a reaction was soon forthcoming Nikita Khrushchev, in a letter to the White House, complained that, "In the USA there are still people who do not want to part with the policy and threats of atomic blackmail." But President Eisenhower's warnings quelled the threat of a Chinese invasion. Over a half century later Taiwan (Formosa) prospers and still has not been invaded from the mainland.

Dwight Eisenhower, as he had done in the Korean War, gave the American people what they most wanted. He drew a line in the sand, stood up, and kept the peace. Partially, as a result of the lessening of world tensions of the spring and summer of 1955, a summit of the Big Four (Russia, UK, France and the US) was convened in Geneva that July. Also invited were other free world nations and those from the communist block, including the Peoples Republic of China. It was hoped by the US and other democratic nations that this summit might lead to disarmament. Although the conference did not lead to immediate world peace, it did start a dialogue which eventually led to the downsizing of nuclear arsenals and future conferences. It also led to the realization that Nikita Khrushchev was the rising power in Russia's leadership. At the conference, President Eisenhower gained recognition more firmly as a force for peace and disarmament. Journalists at the time called the open dialogue "the spirit of Geneva" and, for a brief time, the world seemed

In our series of articles to examine the state of play for UFOs in the new Europe, we continue with the smallest but perhaps most influential country, the Vatican City. It has existed as an independent state, since a treaty between Mussolini and Pope Pius XI in 1929.

In FSR 52.3 we revisited the story that there were organised formations of UFO that repeatedly flew over the Vatican on 6-7 November 1954. The Vatican observatory at Castel Gandolfo (a lakeside town in the hills outside Rome where the pope has summer residence) was also over-flown on 12th November 1954. In FSR 52.2 we revisited the well known tale of the 1963 Vatican meeting of George Adamski with Pope John XXIII, just before his death. Alongside there must be a steady stream of information arising from Central and South America with strong Vatican links. With so many global diplomatic missions it seems inconceivable that the Vatican is not being kept fully informed on the world UFO situation.

In popular ufology the influence of the vatican is often alluded to as a key player in the shrouded diplomacy that passes between the world powers over the UFO question. This rumour is re-enforced by the alleged confessions of a Jesuit working for the Holy See in Rome who alleged that there is a special vatican intelligence organisation that, S.I.V. "Servizio Informazioni del Vaticano" which in Italian means "Vatican Information Services."

"The Omega Secret" "Secretum Omega"

During the conference I spoke about underground bases in the USA and dedicated the last fifteen minutes of my speech to a very short summary of my work during last five years that had gone in a new direction and is the leading topic of my future lectures. In the year 2000, I was working in Rome as an editor in the "Stargate" magazine and I wrote many articles about the Fatima Apparitions that took place in Portugal in 1917 and their famous Third Secret, as well as, other Vatican State-related mysteries. After the initial publication of these articles, I started to receive many e-mails from a person who identified himself as a Vatican insider. The mysterious man attempted to contact me anonymously and intermittently because he was interested in me and my research into Fatima.



From those e-mails, a story emerged regarding an enigmatic Vatican Intelligence Agency named "S.I.V.", a code from "Servizio Informazioni del Vaticano". In those letters, there was interesting information and in one of these he advised me that I would receive a video tape about observations of a presumed "10th Planet" coming closer to our Solar System. The video was taken by a space craft, part of a deep space program, started in the early 1990s, called "Siloe."

Through these details, I understood that the writer knew much more information than he was relating to me. For about one year, there were informal contacts via email and postal letters during which he revealed to me that he was a Jesuit member of "S.I.V." and worked in Rome for a certain department of the Holy See, which I verified without his knowledge. Subsequently, I was able (with great difficulty) to arrange the first personal meeting in a public location in the capital (Rome) during which he continued to reveal more information to me.

I greatly desired the first personal meeting, which occurred in 2001, as a condition "sine qua non" because until then I was obviously sceptical (dubious) and untrusting of him even though the information and the video tape were interesting. It was during that meeting that all my doubts completely disappeared when he showed me his credentials, some of which corresponded with what I had previously checked out by myself. In addition, he revealed to me that he was authorized to supervise the so-called "Secretum Omega" ("The Omega Secret"), the highest secrecy category in the Roman Catholic Church, equivalent to (the military's) "Cosmic Top Secret" in NATO.

As prearranged, the dialogue between us was structured in a question and answer form with a stated agreement that I would pose precise questions. Although the format of the meeting was respected (despite my desire to ask various different questions) in the short time available, some of his answers reversed the original setup regarding some subjects. However,

the following conversation still represents the main part of the dialogue but not all of it because I decided not to reveal some of the details for the moment.

The Interview with "The Jesuit"

Barbato [B]: How did you become a member of S.I.V. (Servizio Informazioni del Vaticano)?

Gesuita [G]: The S.I.V. is composed of different elements, all of which are connected to the Church and mainly composed of at least the Directorate, of priests, the majority of whom are taken from the Jesuit Order, Benedictine Monks and Nuns; in total, a few more than 100 members.

There could be fewer members but if one considers all parts of the world where there is a priest or a nun, each is also a potential source of precise information. Some elements of S.I.V. were and are taken from lay areas and institutions internally connected to the Church, for example humanitarian associations, political groups close to the Holy See, "young Catholics" movements and others. My background was similar to these.

Briefly, the members were secretly overseen, directed and formed according to determined criteria in certain fields. Nowadays, all of us realize subsequently that we had a personal "guardian angel" or mentor.

[B]: Could you give us more details about S.I.V.? Why was it created and how long has it been active?

[G]: The structure is "Top Secret" but for the moment I can tell you that it is organised in a manner analogous to other intelligence organisations like CIA, MI-6, the KGB, etc. doesn't have an official seat but new a location for reunion is chosen from time to time, always under the oversight of the Vatican City. From a chronological point of view, the spark which ignited the start of said organisation, was caused by an event during the first half-decade of the 1950s in the

This event was the meeting that occurred in California at Muroc Airfield (which later became Edwards Air Force Base) of an alien delegation with the President, Dwight D. Eisenhower, attended by the Bishop of Los Angeles, James Francis McIntyre.

The meeting was filmed by the military with 3 16mm cameras, placed at different points, loaded with colour film and spring drive motors; that is because each camera operator had to change the film every 3 minutes and because in the presence of the aliens, electric motor did not work. In total they shot 20 minutes of film in 7 rolls, each of them 30 meters in length.

At the end of the meeting, each member of the Earth delegation swore never to reveal to anyone what he had seen and what he had heard about the aliens. Don't ask me where the film is because I think that you must know the answer. Anyway, some days later, McIntyre, probably disappointed to have sworn himself to secrecy, departed in a hurry with the goal of meeting with Pope Pius XII to inform him of the incredible event.

But in order to reach Italy, Bishop McIntyre had to fly first to New York and then proceed to Rome, always in private aircraft. About half an hour after take-off from Los Angeles, the airplane suddenly experienced technical difficulties and was forced to make an emergency landing at Sky Haven Airport, Las Vegas, NV during the night. During the time that the airplane was being repaired, a certain person boarded the airplane to confer with the Bishop. The man presented military credentials of the US Armed Forces, a colonel in the USAF, and was received by McIntyre. The conversation lasted 20 minutes during which time this man dissuaded the Bishop from revealing all the details of the meeting in which he had assisted because all the alien matters had already been studied for many years exclusively by the USAF. The military emphasised that the President had just requested a spiritual opinion and above all an understanding in a situation so anomalous and that his oath of secrecy also included the Holy Father. Not the least of which concerns was the internal infiltration of the Vatican by Soviet spies. The Bishop replied that it was precisely his intention to inform the Pope of the incredible event.

We now believe that the engine problem was previously and intentionally created in order to bring about that meeting, probably organised by certain military officers without President Eisenhower's knowledge. Before departing the military told the Bishop that notifying Rome would create great problems for him and for his safety, which could cost him much. Furthermore, they couldn't know yet if some divine message had predicted the meeting with the aliens.

Two days later, Pope Pius XII received Bishop McIntyre. After having meditated deeply on the possible implications of an exclusive military relationship with the aliens, the Pope decided to create a secret information department with a structure similar to the fascist military intelligence departments, to be called S.I.V. that would gather all possible information regarding the activities of the alien entity and information acquired by the Americans. It was very important to keep open channels of communication with President Eisenhower.

The S.I.V. was basically constituted to acquire and to manage all secret information above all regarding alien activities and matters, coordinating with other intelligence organisations in other countries. The main goal of the newly formed department was to manage all aspects of the moral, philosophical and religious points of view.

[B]: What made the Pope believe that the American military would have shared such sensitive information with the Vatican? What about the military man who appeared at the airport in Las Vegas?

[G]: Understand, that meeting convened in the middle of the night by the President of the United States, seeking aid and spiritual support in a situation, unique in the entire story of humanity, I believe was a sign of esteem and trust. In confirmation of this, I tell you that upon returning to the United States, McIntyre and Archbishop Edward Mooney of Detroit were later the principle coordinators of the operation passing the information to the Vatican. But these events took an unexpected turn because McIntyre and other S.I.V. members began to have direct contact, in essence without the knowledge of the military, with an alien race of the Nordic Type, apparently benevolent, coming from the Pleiades. These aliens advised to be careful with the other creatures encountered by the Americans in the California desert. These meetings with the members of S.I.V. happened many times in the United States and twice also inside the Vatican Gardens near the Pontifical Academy of Science, in the presence of Pope Pius XII.

[B]: Now, Padre Pio of Pietralcina spoke about the existence of other living creatures in other worlds that had attained a higher evolutionary state because they were without sin... Is that true?

[G]: Without a doubt, but these beings, which you refer to, live in a different dimensional plane, different from in not being the angels in the true sense of the word, while on the other hand the Nordic Aliens that I spoke about previously have flesh and bone, even though they are very evolved to a technological and spiritual point, they still have bodies. These creatures announced to have discovered in the Catholic Church, more precisely in the message of Christ, the pure presence of God and they offered to cooperate, themselves, for the good of humanity.

That firm affirmation on the part of these beings convinced Pius XII to collaborate with them and to consider them as authentic converts to the Christian faith. The Pontiff probably realized that the Universal Church should communicate its message even to beings coming from other worlds. Besides, these aliens through the years were determined to assist the Church of Rome in all its missions, particularly, in determining the character of social and political situations internationally.

(Author's Note: I suggest that you read what Alberto Perego wrote during his time as Vatican Consul in some of his books.)

Thereafter, even Pope John XXIII benefited from the support of these beings who had espoused the Christian cause but he always preferred to keep it secret speaking solely of "angelic intervention." Pope John XXIII had inherited, in a manner of speaking, an agreement for collaboration between the Holy See and these beneficent aliens of the Nordic Race as stipulated by his predecessor. This situation (the secret agreement) endured throughout the Pontificate of Angelus Giuseppe Roncalli, who many times expressed to the leaders of S.I.V. his fears regarding investing too much trust in these beings. That's why today we believe that one of the main reasons for convening The Second Vatican Ecumenical Council was the need to take a first concrete step toward the renewal of the Church, in view of the possibility of immanent contact.

[G]: I was just getting there. Adamski really met the Pope. He went to St. Peter's just once to meet the Pope who at that time had already decided that the Church ought not entertain any further direct contact with these aliens, even if they were positive. Furthermore, John XIII found it unacceptable to reveal this relationship to the Christian populace. The assignment that the aliens commissioned to Adamski was to try to attain a final agreement with the Pope, who was dying. Adamski was a messenger for those aliens who met with the Pope through him. These beings ordered Adamski to deliver a gift to the Pope. Moreover, this gesture on the part of the aliens convinced the dying Pope, with little lucidity and energy remaining, that the "Space Brothers" might surely conduct positive and benevolent activities toward humanity but that they should operate autonomously and distinctly from the Church and, in general, from human activities, with prayer, actions according to the Law of God and, in particular, under the direction of the Holy Spirit.

Adamski's attempted mission ended direct contact between these beings and that Pope and his successors, trusting in the insight of John XXIII who established that it was not allowed to have direct contacts. Later in a secret manuscript from Pope John XIII (Angelo Giuseppe Roncalli to his successor, which contained one special dossier about "Servizio Informazioni del Vaticano", the Pope mentioned a passage from the Gospel (of Mark) that clearly explained the position of the Church regarding these benevolent beings coming from other worlds.

The meaning, in essence, was that the presumed positive activities of these aliens, who accepted the Christic message, should be "blessed" and not opposed (or obstructed) but always kept distinct and parallel to that of the Church. These aliens should be considered as the stranger who rescues in the name of Christ and who should not be impeded from doing so.

In this course, we could interject the speech, which the new Pontiff gave, in succeeding the late Pius XII, as he proclaimed publicly on the 5th of April, 1961 in St. Peter Plaza before a general audience, saying:

"Some voices were previously unknown. But this concerns voices, descending from the sky to the Earth, voices which possess and reflect the omnipotence of the Heavenly Father."

[B]: Let's talk about your tasks on the S.I.V scene.

[J]: My tasks were purely technical, the most important of which were, for example, to take extremely secret information coming from a Vatican radio telescope located in Alaska and forward it to respective destinations.

[B]: Just a second, but to which radio telescope are you referring? I did not know that the Vatican owned such a structure in that area.

[J]: The Vatican owns and utilizes an extremely advanced radio telescope that is in the vanguard of systems and technology and is only used by Jesuits. [B]: When was that apparatus built and, above all, what end in sight did the Vatican have in owning so many other astronomical sites around the world?

[J]: What I can say is that it was built in the 1990s with the object of studying all anomalous celestial bodies approaching Earth, similar to what the CIA did with one of its "secret eyes," the twin to Hubble, called "Sky Hole 12" (a.k.a. [B]: I would like to ask you about a well-known religious legate to the Church. I am referring to Monsignor Balducci who publicly spoke about the extraterrestrial themes. Is it possible that Balducci is working in concert with S.I.V.? And that he has knowledge of its existence?

[J]: Surely Father Balducci made his studies and his research in a totally autonomous manner without following any pre-existing established program. During his research, he was never obstructed. On the contrary, in certain ways he was actually encouraged.

[B]: Just a moment please, it seems to me understanding your words that there exists a program for disclosure. And, maybe, for this reason could it be that you decided to meet me and reveal this information to me?

[J]: The probe called "SILOE" takes its name from an identically named program of space exploration begun in the early 1990s. Furthermore, regarding this, I can add that this program was part of another one, much wider in scope, named "Kerigma." (Author's note: Regarding the latter ("Kerigma"), nothing was revealed to me.) For now, I can just tell you that this probe was created in Area 51, has an electromagnetic impulse motor, and it was put in orbit by a space plane, like type "Aurora." The probe did not have any calculations or pre-indications of the trajectory or the precise location of "Nibiru," because its purpose was to approach that planet, correcting its direction to avoid impact and to return to this Solar System to a position close enough to transmit the data and images to the secret radio telescope located in Alaska. The probe was launched as soon as the radio telescope was and the probe was capable of transmitting images in 1995.

[B]: What I am hearing from you reminds me of some theories formulated by researcher, Zechariah Sitchin, regarding the future return of the mysterious 12th planet. Do you know this work?

"Sitchin's case originates in an Akkadian cylinder seal from the third millennium B.C. found in the Vorderasiatisches Museum in (then East) Berlin

A portion of it features a six-pointed star surrounded by eleven dots of varying size; Sitchin judged that the star symbolizes the Sun and the smaller elements are supposedly planets, including the lost 12th world."

Sitchin states, Nibiru was a planet ejected from some other planetary system in outer space that was captured into our Solar System as it passed near Neptune. It became involved in a collision with a pre-existing planet where the debris of the Asteroid Belt is now. As a result of that collision, some 4 billion years ago, the Earth and the Moon came to be where they are now.



Sitchin saw the Sumerian/Akkadian texts such as Enuma Elish (also called the Babylonian Epic of Creation as not merely a mythological tale but a record of an ancient claim that Earth had been visited by Extraterrestrials, the ANUNNAKI "Those Who from Heaven to Earth Came" of Sumerian lore. Many who advocated this theory imagined that Nibiru, Planet X, was to return in spring 2003 concluding it's 3600 year anti-clockwise round trip. Sitchin later wrote that he saw Nibiru more as a metaphorical trigger for awakening to a higher consciousness.

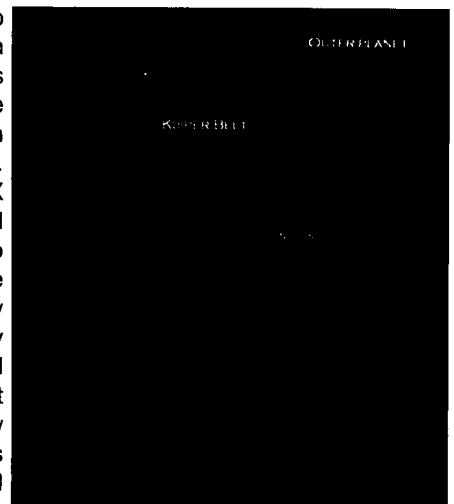
This once again raises the Astronomical community eye to the question of a planet x, another planet in our solar system beyond Pluto. Throughout modern astronomy we have references to a



cited as the cause to explain anomalies in the orbital patterns of the planets. Since the late 1980's with the research of Dr. Harrington, Planet X has been knocked back and forth as to whether or not the planet actually exists. Only recently in the year 2004 and beyond did we start to discover new "planetoid" bodies floating beyond Pluto. Some of these like Xena, or Qaorar are nothing more than large chunks or mainly ice. Not to be considered planets.

So what is so important about a planet x?

Pluto was only discovered in 1930, and even then orbital perturbations were detected which lead them to believe a yet undetected large object is still out there affecting the orbits of



advanced infrared telescopes and advanced computational mathematics are we able to finally image and pinpoint new planets in or beyond our solar system.

Interestingly enough, the first image taken of a planet around another sun (not ours) by the Hubble Telescope filmed a planet on a highly elliptical orbit around its sun. Until this footage, astronomers had never seen a planet on such a highly elliptical orbit. This led astronomers to ask how such a planet would extend so far into the depths of space and still continue its orbit back in our direction.

Could planet X have killed the Dinosaurs, what is the Nemesis theory?

When we pointed Hubble at newly discovered solar systems, an interesting pattern seemed to emerge. Almost 90% of external solar systems had "2 suns", a binary solar system. Immediately the idea of a "planet X" in our solar system started to seem more plausible with the idea that we too could have 2 suns (binary). However, our "other sun" is a failed star or Brown dwarf. Due to the immense dust clouds and debris in space, we have not been able to properly image this star. However the research presented by Dr. Muller at Berkley suggested Nemesis. He projected a large planet that orbited this failed sun dislodged comets in the Oort cloud sending that debris towards earth inevitably killing the dinosaurs.

How do astronomers go about looking for a planet x and who are these people?

One of the latest space telescopes deployed is called SIRTFF - space infrared telescope facility, recently renamed as Spitzer. This telescope is special in that it is kept below freezing temperatures and is able to tune its infrared capability in such a way as to match the temperature of these so called "dust clouds" deep in space allowing for a never seen clarity deep into space.

John Carr of the Naval Research Laboratory, Washington, and Joan Najita of the National Optical Astronomy Observatory, Tucson, Arizona have developed a new technique using Spitzer's infrared spectrograph to measure and analyze the chemical composition of the gases within proto-planetary disks. These are flattened disks of gas and dust that encircle young stars. Scientists believe they provide the building materials for planets and moons and eventually, over millions of years, evolve into orbiting planetary systems like our own.

What ancient knowledge is recorded about a planet X?

What most astronomers looking for planet x don't know, is that an ancient civilization over 6,000 years old also knew about another planet in our solar system. This ancient civilization produced over 100 of the 1st's for modern civilization and was found in where today's modern day Iraq is now located. The Sumerian Culture located in the land also known as Mesopotamia, Babylon, but originally called Sumer is today's Iraq. This amazing civilization had not only invented writing and mathematics, but had some of the most advanced astronomical data recorded that has been found to exist in the form of a written language and stone artefacts with pictograms.

What are the effects "Planet X" may have caused in the past?

The only culture using 2012 as a reference to pinpoint dates in the future were the Mayans on their LONG COUNT calendar. What most people are not aware of is that the Mayans had several calendars. The LONG COUNT calendar was one of which various PREDICTIONS were said to happen but not always accurate as time has shown us. Yes, they were master astronomers, but they were NOT able to see the future. They predicted in one of the Bactoons from the Long Count that their GOD KULKUKAN was going to return on a certain date. Instead, the Conquistadors showed up and aggressively destroyed their culture and almost all of the Mayan code.

Aside from the Mayan prediction for an end of time in 2012, there is no astronomical or Sumerian reference citing planet x is anywhere near us, nor will it be anytime soon.

The amateur astronomy community has always been very good at finding new objects in our vicinity even before professional telescopes. Just look at Hale-Bopp. If a planet 4-8 times the size of earth comes anywhere near us, trust me, we'll be able to find it.

From Jason Martell: I contacted Dr. Mukai to ask about the size of Planet X he was projecting. He referred to its diameter as expected to be 10,000-16,000km (roughly the same size as the earth).

FSR Commentary: a very interesting parallel arises in Jason Martel's account of a new technique using the Spitzer telescope's infrared spectrograph to measure and analyze the chemical composition of the gases within proto-planetary disks. These are flattened disks of gas and dust that encircle young stars. Scientists believe they provide the building materials for planets and moons and

eventually, over millions of years, evolve into orbiting planetary systems like our own. Martel suggests this is the technique of choice sweeping space with an infrared telescope facility, using a precise temperature match to the "dust clouds" deep in space allowing a never before seen clarity in the search for Planet X.

Does this infra-red telescope speciality closely match the profile of the new director of the Vatican Observatory

"Funes specializes in extra-galactic astronomy. His field of research includes the kinematics and dynamics of disk galaxies, the star formation in the local universe and the relationship between gravitational interaction and galactic activity. He studies the kinematics of stars and gas in the inner regions of disk galaxies."

On August 21st 2007 Pope Benedict XVI appointed a new director of the Vatican Observatory, **Rev. Jose Gabriel Funes** a native of Cordoba, Argentina. Funes, 43, holds a doctorate in astronomy from the University of Padua in Italy. He also studied theology at the **Jesuit-run** Gregorian University in Rome.

Vatican Observatory: "It is Possible To Believe in God and Aliens"

Believing that the universe may contain alien life does not contradict a faith in God, the Vatican's chief astronomer **Rev. Jose Gabriel Funes**, said in an interview by the Vatican newspaper L'Osservatore Romano. He was quoted as saying "the vastness of the universe means it is possible there could be other forms of life outside Earth, even intelligent ones." "How can we rule out that life may have developed elsewhere?" "Just as we consider earthly creatures as 'brother,' and 'sister,' why should we not talk about a 'extraterrestrial brother'? It would still be part of creation."

In the interview Funes said that such a notion "does not contradict our faith" because aliens would still be God's creatures. Ruling out the existence of aliens would be like "putting limits" on God's creative freedom, he said. The interview, headlined "The extraterrestrial is my brother" covered a variety of topics including the relationship between the Roman Catholic Church and science, and the theological implications of the existence of alien life.

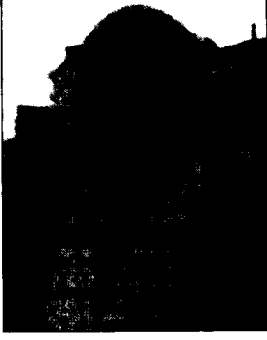
(A letter from Salvador Friexedo.)

A comment in FSR 51/3 made by Dominiguez Lopez was of particular interest "UFOs are especially present when we have altered the natural surroundings." He photographed the UFO "When the rocks were dynamited to construct the freeway." There have been occasions when UFOs and entities have appeared when there has been disturbance to the ground in the locality. In the Rowley Regis case (West Midlands) the witness left mince pies for her visitors at Christmas time, she lived next to a working quarry. In the New mill (Penzance) case of 1977 (FSR Vol 24/1) there was a working quarry within one mile as well as work on the building, an old post office.

One may speculate on the possibility of other dimensional forces being able via electromagnetism to penetrate into our physical environment more easily at such localities. Earthlights are seen in areas of geopathic stress, where rocks trigger E.M. disturbances. I have heard reports of lightening and storms when archaeologists excavate barrows. This sits alongside concept of magnetic temporal lobe effects in the brain inducing apparitions in electro sensitive people. Such experiments give a strong impression of an intelligence that can be a two-way interaction. The ubiquitous proliferation of E.M. pollution may trigger the human consciousness to respond via staged perceptions and interactions with spacecraft. One question is how far this experience is objective, in the environment and how much is subjective via the brains interpretation of the forces acting upon it?

Comment by Harry Challenger: Raymond Cox's welcome letter raises an important point, the interpretation of Susan Blakemore's work on EM effects on the temporal lobe. The magnetic fields used in her experiments were far far higher than any encountered in the natural. They were applied directly to the skull by a modified helmet emitter again in a way never to be experienced outside the lab. The Condign report also alluded to peculiar atmospheric plasmas causing similar hallucinogenic effects. Hogwash, they knew these EM effects could not possibly be acting on a human brain at the distances or intensities they used experimentally nor indeed due to the peculiar rarity of events like these in nature. Furthermore, so many UFOs have been observed by groups and filmed that they cannot possibly be put down to temporal lobe mediated hallucination in an individual brain. The intelligence we perceive in UFO and humanoid encounters is as real as our own.

The position advocated by this editorial is that we are dealing with (trans-dimensional) governing forces which intersect between worlds we do not yet know and our own. We may not have sufficient awareness of these unseen forces that penetrate into other realities but we can speculate that certain UFOs are routinely monitoring us for this very reason. The twelfth UFO Forum held in the Cultural Center "Agora" in Wroclaw Poland Sat. 17 May 2008.

The last Conference was organised as usual by Mr. Janusz Zagorski an animator by profession, who has integrated the whole Polish ufological scene. The co-organizers were "Agora" Cultural Center and the Forum Nowej Cywilizacji society. Also present was the "Czwarty Wymiar" monthly magazine, Radio Aplauz, TVK Wroclaw TV Center and the "Crystal" monthly magazine, which supports the UFO Forum.

The Conference program had a broad spectrum of topics on the Unknown: from Kirlian photography and PSI-phenomena to traces of a CEIV in Emilcin, which celebrated its 30th anniversary on May 10th this year. Personally I noted that there was a special accent put on the spiritual and esoteric aspects of the UFO-phenomenon and its cosmic origin. This is the line used by various New Age movements. I fear that it may push ufology towards the strange and new religious movements.

By the way I can say that we have no new ideas on ufology we remain in the description period of this phenomenon. Only two Polish organisations: **Center for the Unknown Phenomena Research in Cracow (CBZA) and Poznan UFO Research Group in Poznan (PGU)** share the concept, where the conclusions should be derived from the basic information of the UFO-sighting and Close Encounter with ALFs, EBEs, etc. Classic ufology circles the enchanted ring of the UFO-phenomenon description and is satisfied by the scholastic explanation saying that UFOs and Ufonauts came from space and they are the Aliens from Space only. The spiritualizing of this phenomenon is nothing more than avoiding an attempt at finding the rational core(s) in the existing relations, reports and so on about the UFO-sightings and Close Encounters with UFOs and Ufonauts, especially also the PSI-CE or CE5.

The fact is these meetings were attended by many contactees, people who stated that they are in telepathic contact with Aliens from Space. The great benefit of the UFO Forums was that those people could tell about their experiences without fear and shame. The Polish ufological community should be very grateful to Mr. Janusz Zagorski for that. It is not surprising that an initiative of that UFO Forum came from a town like Wroclaw, because this town is the most dynamic place in Poland, which comes from its European roots. I hope that Mr. Janusz Zagorski has not ditched his idea to integrate people with broader mental horizons the so called borderland sciences.

The event ended with a very curious discussion among UFO-researchers: Mr. Janusz Zagorski, Mr. Marcin McKey-Kaczmarek, Mr. Boleslaw Kula, Mr. Zygfryd Swierkowski, Mr. Rafal Nowicki and I: "What should ufologists do, when the

UFO-phenomenon will be publicly disclosed?" We were very sceptical about the UK Government's commencement of opening up the MOD and Police UFO archives. We were reminded that similar announcements from the government of Chile, Brazil, Belgium, and several different countries, ended in nothing. The ufologists always get handed some pieces of the 'sheep's cheese' but the 'honey and bacon' were still kept back. The discussion moved onto a very disturbing tone. We should fight for the Truth of UFOs, exactly like Poles fought with the communist regime for their freedom and national

unity. Now, in 21st century we must fight for this truth of the UFO-phenomenon. I think that those words were the most important ones expressed during that Conference. If it turned out that Contact with Extraterrestrials is something more than the day-dream and the devout wish of the ufologists, I am sure that only education and the free exchange of information can prevent the globalization process and one world government realizing Orwell's vision of a people held captive and manipulated by deception.

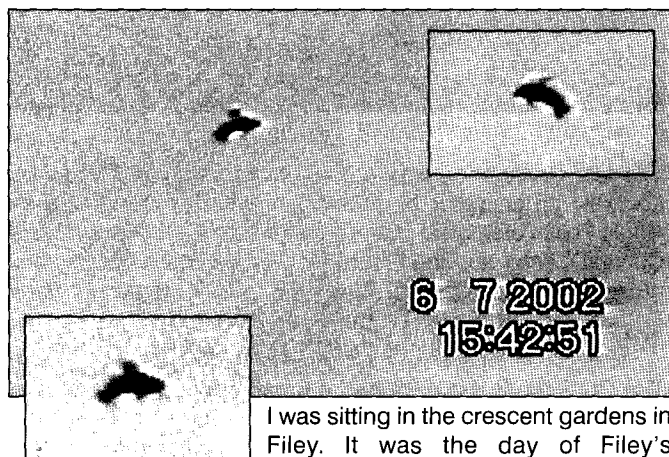
Aerial Dolphin over Filey?

I was sitting in the crescent gardens in Filey. It was the day of Filey's Edwardian festival 06/07/02. I had been sat waiting for about 20 minutes when a number of friends arrived. Like me they had seen a number of UFOs over the years. I was looking towards Filey Brig when I noticed an object elevated above the trees.

We all saw the object at the same time. I had my video camera with me so I started to film the object. The object seemed to be the size of a large car; the object then elevated even faster than before. Jodi asked me if I had it in view, and could I make out what it was. I zoomed in on the object and I could not believe my eyes. I told the group that the object looked like a dolphin. At first I thought it was a balloon but it was too big. As

it was the festival I thought it may be some kind of advertising. The sighting started at about 12.49pm and lasted for about four minutes.

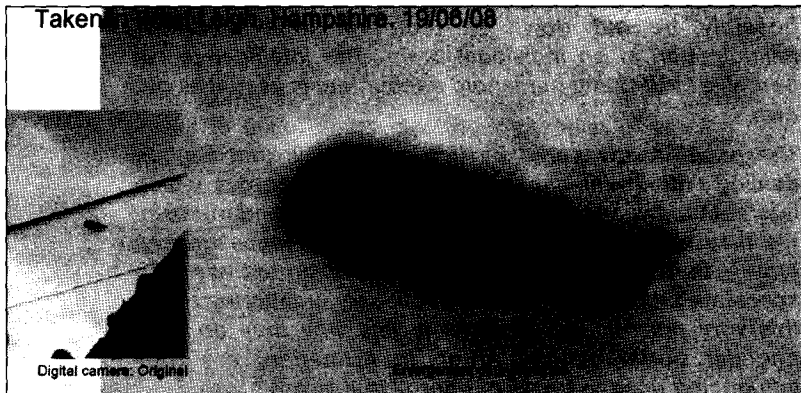
I was sat in the same spot all afternoon, my friends went in for a while and I stayed in the same place. On their return we talked about the dolphin object, Jodi told me that he had looked around town but he had not seen another dolphin balloon on any stalls. As we sat, we could not believe our eyes, the object was there in the same place as before. I looked at the time through the viewfinder it was now 15.45pm; this could not be a balloon, not in the same place for two and a half hours. There was a holiday campsite called the blue dolphin about 2 miles away, could it have been advertising for the coming season?

I rang the local news paper on the Monday to see if anyone had rang in about the sighting, I was told that no one had been it touch about the sighting. The paper put in a small piece asking if any one had seen the object. I had three people ring me to say that they had lost a dolphin balloon, but no one gave me the right time or the colour that we saw on the object. I then rang the campsite to see if they had been advertising their campsite using a balloon on the Saturday, their secretary told me no. I remember the weather had been slightly breezy on the day of the sighting, but even if it had been a balloon, to be in the same place high in the sky for two and a half hours is very unlikely. 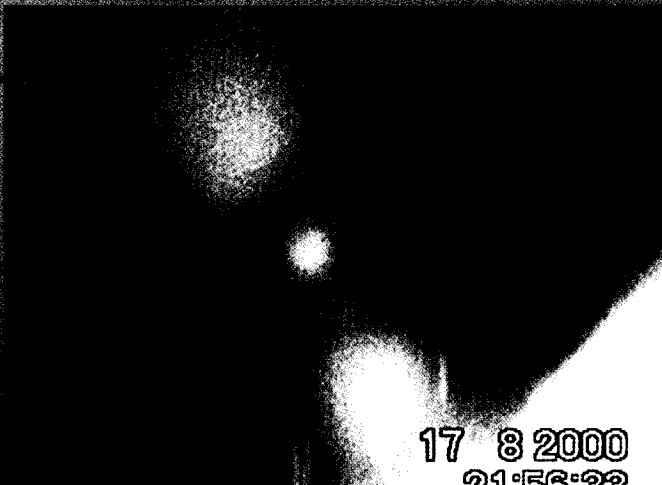
It all happened in an instant!

Sometimes a small ambiguous event may be spotted by a curious researcher and become a new area of enquiry. Just such an incident appeared on camera at 21:56:33 on August 17th 2000. I was filming a very bright ball of light moving North to South at the back of my house with a sky-watching colleague named Keith. After a couple of minutes I asked Keith if he would like to take over filming the object, he said yes so I pulled up the eye piece and could see the object with the naked eye. It was at this point I saw a flash and felt heat on my face. I told Keith I needed to carry on filming the object as something untoward had just occurred.



I eventually looked at the video in the afternoon. I observed the ball of light moving from North to South with buildings in the background. As I was pausing to speak to Keith the ball of light just goes out of sight for a second, you can see a house with a land rover parked out side and the light comes in to the top of the frame, its only when you play the video in slow motion that you realise there are four balls of light coming down in a matter of a second, this was during the flash when I felt the heat on my face and it felt cold like a chill. As you can see from

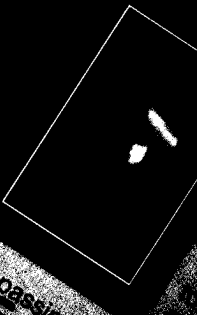


the pictures, the encounter with the balls of light lasted less than a second but that's all it takes to come under close inspection. I am familiar with visual artefacts and lens flare and can assure the reader that it is none of these things.

Commentary by FSR: The idea that extraordinary UFO events occur in fractions of a second was apparent in the David Tickle UFO footage taken in the early 1990s, dubbed Stonehenge. This film showed multiple aerial phenomena happening across Salisbury plain in fractions of a second. This millisecond timescale is also seen during the last 20 years of Canadian contactee Dorothy Izzet's time of sudden co-ordinated movements by aerial light sources also evident in the photos taken by Steve Lippard in the 1960s and 70s. This sudden phenomenon of movement and illumination also occurs in other well documented cases such as Koole Fooka's light ball phenomenon.

The question needs to be asked if the millisecond timescale is yet another major barrier to understanding the UFO infiltration and cover up plot.

It also becomes highly relevant to the research that individuals who have had UFO encounters in the same way they may work outside but they are not altogether. One thing is clear, encounters, yet the common factor researchers does not represent time and duration anomalies. Have we heard of any other photographs for surveillance that do not have the same completely random and unpredictable characteristics? What about the fact that the UFOs are seen in the same way as the other objects? The only thing that is common to all of these encounters is that they are all seen in the same way as the other objects.
