# ONE YEAR ON—A YEAR IN THE LIFE OF UFO MONTHLY.COM



## THE BEGINNING

Well where do I start? It is hard to believe that a year has passed since its launch at the end of April 2004.

Never in my wildest dreams did I ever think that I would one day be running a magazine, let alone a UFO related Ezine.

It is strange how my life has developed over the last few years.

I started writing seven years ago with a UFO screenplay and it was because of that, that I began to feel the lure of wanting to become an active researcher in this subject.

I have said my times that my involvement in UFOLOGY is due to my association with the much lamented Graham Birdsall, the founder and editor of what was UFO Magazine.

Only with his support and encouragement did I begin to

write articles on a regular basis for that particular magazine.

The sudden and tragic death of Graham and the ultimate demise of UFO Magazine threw my life sideways when faced with no monthly UFO fix.

To this day I find it hard to fathom how that magazine did not continue in a different form with new people at the helm. I can't help but feel that Graham would have



wanted the magazine, to which he had spent the greater portion of his life developing from a single sheet to a glossy publication that matched anything on the high street shelves, **to continue.**

For me that was Graham's real legacy. I respected Christine Birdsall's decision to walk away from the subject given her terrible loss **but not the ultimate disintegration of the thing he had poured his life into for so many years.**

## THE IDEA

Within days of the closure of UFO Magazine I felt compelled to do something to carry on the fine traditions that Graham Birdsall had set in motion.

My immediate thought was to provide a 30 page monthly UFO magazine that would be internet based.

I created the title, registered it as a domain on the web and approached Russ Callaghan, whom I knew through UFO Magazine to join me as partner in this new venture. Initially he wasn't able to go public in his support for the magazine but after about five weeks I was in a position to announce his involvement on the PRUFOS Police Database.

It was about five weeks after that initial approach before he was able to devote real time to the project.



A series of meetings followed and the basic outline of the new magazine emerged. It would be 30 pages of colour and available in PDF format.

A national launch date was set for April 27th 2004.

I remember it was a time of great expectation and both of us having to undergo crash courses in Microsoft Publisher editing software.

As the launch date approached the magazine began to take shape and bit by bit it went from being a mere concept to a fully realised goal—**UFO Monthly.com was born!**

Much credit has to go to Russel for his initial development of the UFO Monthly.com website and the many valuable tips he gave me from his vast experience of helping to run a national magazine not to mention his knowledge of photography.

I know the sudden disappearance of UFO MAGAZINE from high street shelves had caused many readers consternation, if not a little anger that 'their' magazine had disappeared

without a final issue and an opportunity for some kind of succession.

**I personally wish there had been one more issue dedicated to Graham's memory that would have given explanations for its demise and more importantly an opportunity for readers to have a degree of closure.**

It could have also been used to alert the many thousands of UFO Magazine readers about the launch of UFO Monthly.com.



the initial feedback from readers was nothing short of uniformly good.

Russ and I were pleasantly surprised and flattered to find that several readers had commented that the style and presentation of UFO Monthly.com compared favourably with that of UFO MAGAZINE.

As a result a steady stream of people began to subscribe to UFO Monthly.com on an initial six month basis (now available yearly).

I remember Russel and I celebrating the first issue with a meal in a lovely country pub just outside Wakefield.

It was a time of great optimism.

However that flush of success was tempered by the need to prepare issue two so Russ and I began piece to gather the content for the next magazine.

It was then that I began to realise what it takes to produce such a magazine on a monthly basis. No sooner do you complete one then you have to be preparing the next.

Alas it was not to be and an opportunity to reach thousands in an instant was gone.

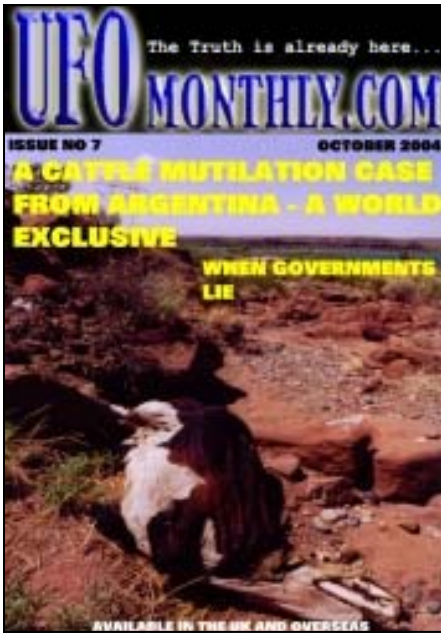
### THE LAUNCH

Without a national outlet the launch of the magazine was restricted to the internet and supportive articles in the Yorkshire Evening Post and Fortean Times.

We decided that the **first issue** would be free and available to anyone that wanted to download it.

Following the public launch





**Issue two** went out toward the end of May 2004 shortly before myself, Russel and Tony Barker embarked on a four day trip to Galway, Ireland for the first ever Irish UFO Conference at the invitation of Betty Meyler, the founder of the organisation.

I mention the conference in relation to the development of UFO Monthly.com for three specific reasons.

Firstly it was an opportunity to publicize the magazine in Ireland and a great opportunity to meet up with the other speakers that included the likes of Stanton Friedman, Roger Leir and Michael Hesemann.

Secondly it was only **days** after the conference that Russel told me of his decision to pull out of the magazine. He told me that he wanted to spend more time with his family.

That was something of a shock but given what happened to Graham and being married to his daughter and with a young daughter I was not overly surprised.

However, I had never contemplated running the magazine alone, yet when faced with Russel's decision I was determined not to let it put an end to the then fledgling magazine.

The third and final reason I mention the Irish conference was a bizarre twist of fate. Having recently come out of one long lasting relationship I was quite unprepared for what happened next.

Whilst in Galway I had met one of Betty Meyler's helpers and within a couple of month's I had invited Valerie to join me



here in England!

At a critical time in the evolution of the UFO Monthly.com Valerie stepped into the fray and her help has proved to be priceless as a supportive partner to the needs of the magazine. Her administration skills have allowed me to concentrate on writing and compiling the magazine and I am indebted to her for that.

### THE MONTHS ROLL BY

**Issue 3** highlighted the excellent work done by Andrew

Buckley with the Crop Circle phenomena in Wiltshire. He sent me a VHS compilation tape of mysterious objects seen in the vicinity of crop formations.

In particular two sequences appeared to show incredible bursts of acceleration by apparent UFOs!

Respected author, Alan Alford contributed with an article about his continuing work with the mysteries of the Great Pyramid of Giza having just completed work on his latest book about the subject entitled 'Pyramid of Secrets'.

**Issue 4** saw the exclusive PRUFOS Database sighting by PC Trevor Blower in a 1967/68 case relating a formation of nine UFOs over the Cheshire countryside. This was a case where he was later advised by senior officers to 'keep quiet' about the incident!

Onto **Issue 5** that led with an amazingly rare documentary that was made in conjunction with the US military and NASA where they actually admitted that some UFOs were of extraterrestrial origin! I kid you not, made



with on screen contributions by the likes of Colonel Hector Quintanella, Colonel Al Chop, Colonel Robert Friend and Colonel Bill Coleman!

The main highlight of Issue five saw the welcome addition of the much respected animal mutilation expert, David Cayton, to the list of famous contributors to the magazine. In his first article he outlined the reasons why he became involved in the UFO enigma. Since then David has gone on to become a regular feature writer for the magazine.

Before I knew it **Issue 6** was completed and we sadly marked our first half year anniversary with the tragic news of the death of Dr John Mack, killed by a drunken driver on September 27th 2004 whilst on a lecture tour of England.

I also took the opportunity to show some of the stills from the amazing Anthony Woods daylight UFO sequences filmed over Portsmouth. I had been fortunate to work on the raw footage as part of the Quest team that put together its final documentary—'The Journey'.

**Issue 7** led with David Cayton revealing a world exclusive



animal mutilation case from 2004 in Argentina.

I also looked at how governments can 'lie' to their people in the name of science.

Another world exclusive followed in **Issue 8** with the publication of the third annual PRUFOS Police Database report of 2004 (part one). 101 'On Duty' cases involving 278 British police officers.

Also the respected Crop Circle researcher Robert Hulse, recounted his experiences



and fascination with the subject of UFOs. That issue also marked the passing of one of the subject's greatest proponents, former Gemini Astronaut, Gordon Cooper.

**Issue 9** followed and I released details of the 'Off Duty' police cases that completed the second part of my annual report. 21 cases involving 24 officers giving a combined total of 122 cases involving 302 British police officers. The issue also took a look at how the new British Freedom of Information Act would work.

David Cayton revealed fascinating details of a 1994



case linking UFOs and electricity whilst A J Geveard of the Brazilian UFO Magazine gave amazing testimony of the Doctor who tended to Marco Eli Chereze shortly before he died after he had allegedly touched one of the captured alien creatures from Varginha.

**Issue 10** saw me review the historical importance of the 'Foo Fighter' enigma during the latter years of WW2 whilst one of my readers revealed exclusive details of a series of UFO sightings in the Barr Beacon area of Birmingham in 1970.

The highlights of **Issue 11** saw a new look cover, a look at the truth about Astronaut and Cosmonaut sightings whilst David Cayton revealed a startling 1993 case from his Cold Case files.

That brings me to this issue—**UFO Monthly.com is one year old today!**

I want to thank everyone for their support and contributions to the magazine over the past year. The magazine relies on a constant flow of goodwill from like minded people. Thank you.

All I provide is a conduit for the truth to prevail. **GH**

# THE 14TH WORLD UFO CONFERENCE IN LAUGHLIN, USA: MARCH 2005 A REPORT BY SPECIAL CORRESPONDENT BETTY MEYLER



He spoke of the Sacred Geometry energy connections between Crop Circles, Cathedrals and Sacred Space, a fact that our ancestors were well aware of and his research has shown that Crop Circles contain measurable energetic properties which influence the rhythms of the human body, its

microlensing, the nature of dark matter, and the nature of quasars themselves.

Jim **Marrs (U.S.)**, a professional investigator, gave a very startling and indeed disturbing account of the 9/11 event. Evidence uncovered by hundreds of independent researchers have revealed that powerful U.S. officials must have had foreknowledge of the planned attacks and then acted from the inside to thwart efforts to prevent the disaster, by removing and/or covering-up criminal evidence and then hampering inquiries into what happened as when vital physical evidence was removed and has never been released to investigators.

**Sean David Morton (U.S.)** is a scientist who talked of the future prospects of the world according to the Bible Code. If we do not change the way we deal with each other, it will probable be the latter.

**William Henry (U.S.)** took us on a fantastic journey into his latest research with the most cryptic symbols in Sumerian, Egyptian and Mayan artwork and symbolism to reveal their shared ideal – the phenomenal “Stargate of the Gods, the angelic Stairway to Heaven. He compared these images to those of leading edge modern physics to present the highlights of the scientific and spiritual revolution that is transforming our world.

**Michael Salla** is a pioneer in the development of exopolitics, the study of the main actors,

**Dr. Thomas van Flandern (U.S.)** is an astronomer specialising in celestial mechanics. He discussed the possibility of finding intelligent activity predating modern humans on Mars. He showed some very interesting pictures of what would appear to be canals and other constructions which would seem to be artificially constructed and could be taken to be evidence of a form of life on Mars. He also believes that ‘faster-than-light’ communication and travel is indeed possible.

**Donald Ware (U.S.)** is a scientist and has participated in many conferences around the world. For the past 11 years he has focussed his attention on the influence of higher intelligence on our World Leaders and as a Director of the International UFO Congress, he participated in the 6<sup>th</sup> (and last) State of the World Forum held in conjunction with the UN Millennium Summit.

**Freddy Silva (U.K.)** has spent a decade researching Crop circles.

brainwave patterns, even consciousness itself.

**Bruce Moen (U.S.)** is an engineer, with a deep curiosity about where we go after we die. He described his experiences exploring physical reality within the place we call ‘The Afterlife’ where he has made contact and communicated with Beings from other planets within our universe and areas beyond I, which has let to an understanding of what we humans call the Earth Changes.

**Tom Valone (U.S.)** is a physicist and engineer who believes that a world revolution awaits when magnetism, which is the only force in nature not directly harnessed for energy usage, is used for the performance of useful work for mankind, such a navigation. While some UFO stories include permanent magnet-powered craft, building the practical replication has proved to be somewhat elusive.

**Rudy Schild (U.S.)** is a research astronomer who has made several important discoveries related to gravitational lensing of distant quasars by galaxies. The discoveries consist of time delay,



institutions and processes associated with an extraterrestrial presence. He spoke of the legacy of Nazi Germany in terms of ET technologies and agreements, trauma based mind control and post-war Nazi operations including their alleged exodus to South America and the impact on the global management system for extraterrestrial affairs.

**Dolores Cannon** is a regressionist and psychic researcher who specialises in the recovery and cataloguing of "lost" knowledge. She says she has been able to establish communication with the prophet Nostradamus. She discussed material from her new book "Convoluting Universe Book II" including, amongst others, such subjects as hidden underground cities, energy, time portals for travelling between dimensions, and healings from ETs.

**Dr. Len Horowitz (U.S.)** gave a very scientific presentation on 'DNA and the Alien threat to Humanity'. He advanced evidence of nefarious tinkering with human genetics befitting a massive 'alien' conspiracy and maintains that 'your physical body is a crystallization of love vibrations. The electromagnetic and bio-acoustic frequencies of creative energy move physical matter along paths of least resistance to flow into sacred geometric forms which we perceive as physical reality'.

**Ann & Jason Andrews (U.K.)** are a mother and son team. Ann gave a riveting talk of how a very ordinary family living on a farm in Kent, England, became involved in a series of bizarre and sometimes distressing events over many years, including animal mutations and deaths and seeing strange lights in the sky. Ann described how Jason from a very young age had endured abduction experiences which at the time were very painful. He has now come to terms with understanding that he is of alien origin and wishes to spend the rest of his life helping other people with similar experiences, - a really remarkable young man.

**Steven Jones (U.S.)** is an ordinary man with over 40 years of 'contact experiences' - occasionally terrifying, sometimes astounding, but always pushing the boundaries of the human belief system. He described his movement through solid objects, his interaction with transgenic children, translocating from one house to another and his profound relationship with one of his abductors.

**Joe Lewells, Ph.D. & Barbara Lamb (U.S.)** have both worked closely with the late Dr. John E. Mack on the importance and significance of the discovery of the presence of sentient, reptilian entities in UFO contact cases as well as in shamanic experiences and in ancient writings of cultures around the world. Barbara gave case studies of several people who have encountered one of the most fascinating and feared species who interact with some experiencers - Reptilian Beings.

**Wendelle Stevens (U.S.)** presented the case of Bob Renaud, who had made contact with Beings from the planet Korendor as far back as 1961 when he was a young Ham Radio operator. He was trying to pick up BBC Radio when he picked up a strange beep high in the 25-meter band that overshadowed BBC. When he tuned in on the beep it stopped and a voice greeted him from a spaceship from Planet Korendor. The contacts have now developed into face-to-face meetings and trips in their craft.

**Dr. Simeon Hein & Ron Russell (U.S.)** have been developing Resonant Viewing or Remote Viewing, as it is sometimes called, into a systematic set of procedures that allow you to transcend your conscious mind and gain access to your intuitions, subtle sense and perceptions. They carried out an experiment whereby the audience were given paper and pencil and asked to focus on a picture that Ron held in his hand and then draw what they felt it to be. It was amazing and indeed surprising, to see how close most of us got.

**A.J. Gevaerd (Brazil) & Dr. Roger Leir (U.S.)** gave a joint presentation on the Varginha incident (reported in our November 2002 Newsletter). A.J. is the founder and director of the Brazilian Centre for Flying Saucer Research and Dr. Roger is a podiatric Surgeon who has removed alien implants from abductees - you might recall that he was one of the Speakers at our last Conference. In the Varginha incident, on 20<sup>th</sup> January 1996 two non-human creatures were found after the crash of a UFO and were captured and removed by the Brazilian Army and local Fire Department, but both of whom died shortly after. The case has been well documented.

**Paola Harris (Italy)** is an Italo-American photojournalist and investigative reporter in the field of extraterrestrial related phenomena research and presented disclosure

interviews from top level people who are mostly military, intelligence and ex-NASA personnel and who discuss their personal involvement in the UFO Phenomena. She was a close friend of Col. Philip Corso.

**Charles Hall (U.S.)** was a weather observer in the U.S. Air Force stationed at Nellis Air Force Base just outside Las Vegas, and very often came into contact with extraterrestrials known as the 'The Tall Whites'. Apparently as they were not too different-looking from us humans, they were able to mix quite freely with the inhabitants of the local area.

**Jaime Maussan (Mexico)** is internationally known for his investigations in the UFO field. He showed some extraordinary videos of UFOs including the recent famous Mexican Air Force one. One particular video showed as many as 500 UFOs in one shot - truly a spectacular sight! He also showed some fascinating infra-red videos which showed little "Beings" quite clearly. They were just a few feet tall with the classic big eyes and spindly limbs that we have come to associate with extraterrestrials. Apparently they were not visible at the time of taking the photographs.

**Dr. Richard Boylan (U.S.)** is a Ph.D. behavioural scientist, anthropologist and hypnotherapist, and provides hypnotherapy for recalling full details of partially-remembered close encounters with the Star Visitors. He talked about the Project Pounce and work done by Col. Steve Wilson at Nellis Air Force Range, Nevada and described secret Air Force bases tunnelled into the surrounding mountains. He also talked about dics test flights he had observed at the Nevada Test range.

**Dr. Nick Begich (U.S.)** lives in Alaska and has been pursuing independent research in the sciences and politics and has appeared on many TV programs throughout the world reporting on his research work on new technologies. He presented the most startling, and indeed frightening, advances in the area of technology where the mind, emotion and physical health of people can be manipulated, as is evidenced by the subliminal messages we are receiving constantly through the medium of TV, radio and other media, for both military and private sector uses.

# A DISTURBING CASE: DOMESTIC CAT MUTILATIONS IN BRITAIN

I do not profess to be an expert in the field of animal mutilations but I do know enough to believe that as disturbing as it is, that it is a very phenomena and in every sense an integral part of the UFO enigma.

Set against that backdrop I was somewhat taken aback by a phone call from someone who I am now confident is what he says he is—a theoretical physicist based at a university in the 'Midlands' area—that related to a friends cat that had gone missing four days earlier.

The point of the call was to say that the cat had been found mutilated in such a way that it fell within the domain of alien animal mutilations!

It soon became clear that the caller had held a long interest in the UFO animal mutilation field and totally accepted the premise of extraterrestrial involvement.

The first thing that struck me is – cats? I wasn't aware that there had been such cases involving cats but a quick call to my resident expert, David Cayton, soon put me right on that subject.

Whilst not as prolific as cattle and sheep mutilations, cats had been recorded in various countries around the world!

In fact he was able to produce

fairly gruesome photographs graphically illustrating the point!

Whilst I do not want to offend anyone I believe that if we are to look at this subject seriously we have to be prepared to examine that evidence—hence



why I have used two cat photographs in this article that illustrate the precise nature of this phenomena.

I would not use these disturbing images if believed they were caused by man or an earthly animal predator.

Please note that the picture above does not relate to the following case as cited by the university scientist.

I have asked David to prepare a detailed article on cat mutilations that will appear in a future issue. **GH**

## THE CASE

**Date of Discovery: 7th April 2005, approx 1630 hours.**

**Subject: Domestic Short Haired Cat (male) Age: 6 years (approx).**

**The cat in question belonged to a family who live next door. They have had the cat for approximately 6 years.**

**Four days ago the cat went missing. There had been no sounds of cats fighting in the immediate area for the past month.**

**At approximately 16.30 hours I discovered him in the front garden.**

**The cat had suffered massive injuries which included the following:**  
**1. Broken spinal cord, (possibly the result of being dropped from a great height).**

**2. Complete removal of the abdomen up to the spinal cord, leaving the back legs and tail attached to the spine.**

**3. The removal of the abdomen was done (in my opinion) with surgical skill and a good knowledge of feline anatomy - all openings were complete clean cuts.**

**4. Removal of internal organs these include:**

- (i) The stomach.**
- (ii). The heart.**
- (iii) The kidneys.**

**5. Complete removal of anus, penis and testicles and rectum.**

### **OTHER OBSERVATIONS**

**1. Although there was some blood pooled around some of the organs, there was no trace of blood on the ground. The corpse had been deposited on grass, yet there was not a trace of blood on the grass.**



**2. If the injuries were the result of collision with a car or other fast moving vehicle, the cat would have been killed immediately especially with the amount of damage done. It would be impossible for the cat to crawl over the road, jump over the fence and into the front garden without leaving any trail of blood!**

**3. The cats tongue was still inside the cat and in good health-ie the tongue was not swollen and protruding**

**from the mouth with foam. This would imply the cat was not conscious when this was performed.**

**4. There was no smell, the corpse was completely odour free.**

**5. There was absolutely no tearing of the skin. If these injuries had been the result of a predator one would have observed tearing of the flesh. Every cut was perfect,**

**6. Rigor mortis appeared not to have set in, implying this was done recently.**

**7. The organs which were**

**removed were also cleanly cut no tearing visible inside the corpse.**

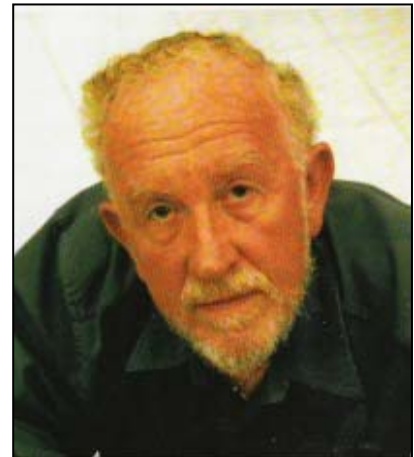
**8. The remains of the large intestine were wrapped once around the cat, possibly the result of the fall?**

**Due to the highly distressing and bizarre nature of the corpse and arrival of family members, it was impossible to obtain any pictures of the corpse or for an autopsy to be performed by a qualified**

**veterinary surgeon.**

That was the verbatim report given to me by the scientist!

David Cayton now casts his eyes over the case for his opinion.



### **COMMENT BY DAVID CAYTON**

This month we received a report from a Theoretical Physicist working at a 'Midlands' University.

Not initially knowing who to inform about this, he was advised to telephone Gary Heseltine, who then passed over his contact details to me.

I made contact with him a few days later. He has given us permission to report the case details but requests anonymity. Sadly we have no photographs of this cat which is often the case with domestic pet mutilations. The grieving pet owners usually only wish to bury their animal as quickly as possible!

The cat mutilation pictures here are from my files, courtesy of Linda Moulton-Howe. There have been a number of half-cat mutilation in the United States.

A few years ago there was a spate of cat deaths with typical mutilation injuries around the Greater London area. Over a hundred cases were reported as far as Essex and Surrey.

Animal owners eventually brought pressure upon their Members of Parliament to insist on action from the police to join forces with the RSPCA in their investigations.

The 'Operation' lasted several weeks (I have forgotten the official Operation code name) and was eventually terminated without any arrests or clear conclusions as to who or what was to blame!

By the autumn of 1998, the Greater Manchester area was also plagued by unusual cat and pet rabbit deaths and mutilations.

Appeals for information were being made by senior RSPCA officers in the local press and via Manchester radio station broadcasts.

Rabbits were being discovered dead on the owners' doorsteps with the hutches still secure and undamaged!

Cats were found on the owners' premises, neatly 'laid out' on driveways, lawns and doorsteps!

I wrote to the RSPCA, Regional Superintendent, Mr. Cottingham, near Oldham, offering to present free briefing sessions to his Field Officers with the intention of enlightening them regarding the types of injuries to be on the look out for.

This offer of assistance was declined and my letter was forwarded on to their 'specialist mutilation officer' at the RSPCA H.Q. in Horsham,

Sussex!

I hasten to add that the man concerned (who I have since met twice) was responsible for working undercover with the police with the objective of bringing 'human' animal mutilators to justice!

Sadly some people do indeed slash horses and sexually abuse animals, however this officer was aware and interested privately in the non-human mutilation scene world-wide!

It had been made clear to him by senior officials in RSPCA that his 'private interest' must not tarnish the good name of the Organisation!

Another case of 'head in sand' attitude shown by the authorities in dealing with the reality of this problem!

To return to the cat death mentioned earlier the Physicist found his neighbours tom cat on his garden lawn on April 7<sup>th</sup>2005.

The cat actually had been missing for a period of four days of very wet weather but curiously it was found that the fur was very clean and dry!

There was absence of odour, flies or signs of decomposition and bacterial attack.

The cat, a male, had the genitals removed in such a clean and surgical manner, that it appeared as if the genital organs had never existed!

There was no blood or staining of the fur around the wounds which would indicate that the cat was dead prior to mutilation.

The abdomen had been

opened up rearwards half way down the sternum and the heart and liver were missing.

There was a neat circular hole cut into the rectum but the depth of 'coring' is unknown.

The back was also broken suggesting a fall from some height. The head area seemed untouched.

The cat owners had contacted the police who had no explanation but issued a crime number and were apparently not aware of any other local incidents.

Domestic animal mutilations, I suspect, go largely unreported, especially when there are youngsters in the family. Priority is the garden burial ritual followed by a quick visit to the pet shop or animal rescue centre for a replacement!

As an experienced and respected UFO researcher and author in his own right he made the point that unlike UFOs, ghosts were generally more predictable and therefore easier to study.

It seems that descriptions of ghosts have on the whole remained unchanged through the years, whereas descriptions of UFOs seem to change according to era of

the sighting.

**JOHN SLATER -**

**Paraquest paranormal group.**

John's presentation was cut short due to a delayed start to the event. He outlined to the audience that Paraquest has a membership of 40 with a hardcore of 15 making up the active group. They pride themselves on a scientific approach. Based in Manchester, they also operate in the immediate area if asked to do so.

Paraquest have a healthy but sceptical attitude to all aspects of the paranormal that includes the UFOs enigma.

Paraquest have also taken the unusual step of training themselves in specific technical areas to GCSE level.

The group investigate UFOs, ghosts, dowsing, crop circles and Tarot cards to name but a few subjects.

**GARY HESELTINE -**

**Police reporting UFO sightings (PRUFOS).**

**This review is supplied by Joe McGonagle of UFOLOGYINUK who was in the audience.**

Gary's presentation was very professional, making use of a computer slide show. He described how he first became interested in UFOs as a child, having witnessed one in his home town of Ashby in the summer of 1975. This object interrupted the electricity supply of the area in it's wake.

He went on to discuss the evidence which is available to support the existence of UFOs, stating that sufficient physical, radar, and video evidence to support the case. He quoted sightings by 2,500 civil pilots, 2,000 military pilots, radar operators, senior military officers, scientists, and other key professional people. He

craft throughout his presentation).

Following his own sighting, Gary started reading about UFOs and also joined BUFORA for a time. As he matured other interests and obligations overtook his interest in UFOs, and it wasn't until 1995 when his interest was rekindled when he saw a copy of UFO magazine. He started to read the current UFO literature and was impressed by Tim Good (who he regards as being in the top 5 researchers in the world) and Nick Redfern. He started to consider what he could do to further the cause of ufology, and wrote a screenplay which he then

the following January.

Gary then presented his view that the MoD policy that UFOs are of "no defence significance" is flawed. He has so far catalogued 122 cases involving policemen since 1950, involving 302 individual officers. He then provided brief details of UK cases involving the police at a naval base, a power station, and an oil terminal. Clearly, these installations should be considered as of "Defence significance".

The presentation then focussed on cases involving government secrecy. His first example was from 1969, in the area of Leek. A message was broadcast over the police radio network to be on the lookout for UFOs. PC Trevor Blower heard this and also heard colleagues calling in reports, and witnessed 7 UFOs at the time. He was later summoned to Leek police station together with other officers involved in the event where they were interviewed by staff from the Air Ministry and instructed not to discuss the matter.

The focus then shifted to radar cases. Gary described a case in December 1989 at Kidsgrove, Staffordshire. A call was received at the station, asking for observations of objects detected on radar. Two officers were deployed to a local high point (Mow Cop) and from there they observed an object ejecting flare-like material. The observation lasted two hours.

Following this, Gary moved on to discuss cases involving close-quarter sightings. He mentioned the famous Alan Godfrey case (which Gary has written a screenplay for), a case in Wilmslow in 1966 (PC

went on to claim that the scale of evidence is actively suppressed by the media and the authorities. As a professional policeman, a detective for 11 years, he regards himself as knowledgeable as to the quality of evidence, and in his opinion, UFOs are an undeniable fact. (I got the impression that Gary meant UFOs in the sense of alien

showed to Graham Birdsall (UFO Magazine editor). Graham was impressed with the play, and encouraged Gary to take a more active role in ufology. Gary decided that he was ideally placed to create a catalogue of police reports and consequently set up "Police Reporting UFO Sightings" (PRUFOS) in November 2001 though it wasn't launched publicly until

## **LARRY WARREN -**

### **Rendlesham Forest— An update**

The final presentation of the day was by Larry Warren. Larry was involved in the Rendlesham Forest event in 1980 and co-authored "Left at East Gate" with Peter Robins. confirmed they will be made generally available.

Before commencing his presentation, Larry expressed his thanks to the organisers and the audience. Larry's lecture was based on a paper that had been presented to the Crash Retrieval Conference held in the USA on 13th November 2004.

After initially giving a brief review of the Rendlesham Forest case his lecture focussed on what had happened to him after the incident.

Larry was given a de-brief by the Office of Naval Intelligence (ONI) and the National Security Agency (NSA). Note it was not done by officers from the Office of Special Investigations (OSI) as is widely reported.

Over the years since 1980 he has been the subject of considerable criticism in some quarters about his story because his account has been seen to change.

Colonel Halt (famous for the 'Halt Memorandum') had stated that Larry was not involved in the incident at all.

Halt has now acknowledged that he was wrong and fully accepts that Larry was involved on the third night of the sightings at the bases.

Larry explained why this was.

Perhaps understandably he said that he had been

reluctant to disclose the true extent of his sightings because of their fantastic nature.

He then went on to quote from several letters he'd received from former servicemen who confirmed much of what he had been saying for years about the incident.

Larry stated that he was forced to undergo medical treatments against his wishes that were at the hands of the military, some of whom had British accents!

He went on to discuss his belief that vast underground installations existed beneath the Bentwaters and Woodbridge bases.

He cited one visit to the bases with Peter Robins, Matthew Williams when they intended to explore them, however their hopes were dashed when they found that metal covers had been welded shut thus preventing access into them.

Larry had originally intended to show the full version (2 hour) of a programme made by the SCI-FI channel entitled "UFO Invasion at Rendlesham".

When it was later shown on Sky only 45 minutes of it was broadcast.

Sadly we were only able to see a few short extracts of the extra material as a result of some equipment failures.

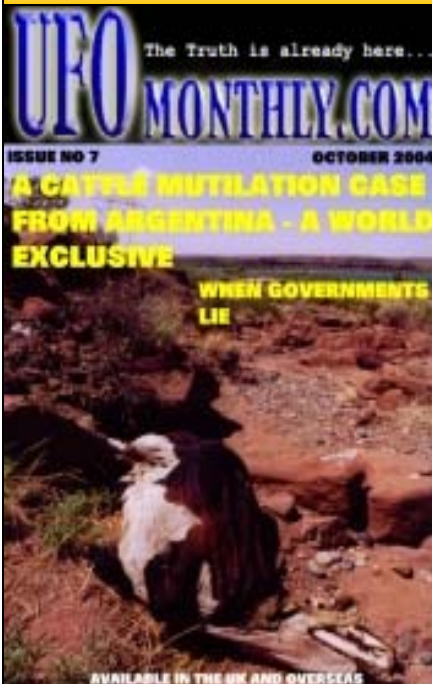

## Look out for giant triangles in space

THE search for extraterrestrial intelligence (SETI) could be taking the wrong approach. Instead of listening for alien radio broadcasts, a better strategy may be to look for giant structures placed in orbit around nearby stars by alien civilisations.

"Artificial structures may be the best way for an advanced extraterrestrial civilisation to signal its presence to an emerging technology like ours," says Luc Arnold of the Observatory of Haute-Provence in France. And he believes that the generation of space-based telescopes now being designed will be able to spot them.

Arnold has studied the capabilities of space-based telescopes such as the European Space Agency's forthcoming Corot telescope and NASA's Kepler. These instruments will look for the telltale dimming of a star's light when a planet passes in front of it. They could also identify an artificial object the size of a planet, such as a lightweight solar sail, says Arnold. His work will be published in *The Astrophysical Journal* ([www.arxiv.org/astro-ph/0503580](http://www.arxiv.org/astro-ph/0503580)).

Arnold has determined the characteristic transit signal that differently shaped objects would produce, including a Jupiter-sized equilateral

triangle and a louvre - parallel slats with gaps between them. Corot and Kepler will be capable of distinguishing these objects from most planets, though they could still be confused with a ringed planet like Saturn, he says.

To ensure the signal is unambiguous, an alien civilisation would have to launch a number of objects into orbit around a star. As an example, Arnold imagines 11 objects orbiting a star in groups of one, two, three and five - the first prime numbers. The time interval between each group could also encode prime numbers if the objects were powered rather than orbiting freely. He thinks any civilisation that can engineer giant structures in space would probably not find this a problem.

Arnold believes that this type of signalling is at least as effective as broadcasting a message using a high-powered laser pulse or a radio signal, which SETI is searching for.

The best place to begin looking for artificial structures could be around dwarf stars. Their small size means they can be dimmed by the transit of a relatively small object, making them the best bet for an advanced civilisation wishing to announce itself.

But SETI researchers aren't changing tack just yet. "Arnold's proposal falls within the category of SETT - the

search for extraterrestrial technology," says Paul Schuch, executive director of The SETI League in New Jersey. "SETT is entirely complementary to SETI, which is narrowly defined as the search for electromagnetic emissions from other technological societies. The SETI League actively encourages and enthusiastically endorses such research," he adds.

## PENTAGON'S FLYING SAUCER

Before the Pentagon decided that it wanted to stock soldiers' backpacks with [miniature unmanned aerial vehicles](#), or UAVs, Defense Department researchers had a slightly different idea: give G.I.s their own flying saucers instead.

The [Multipurpose Security and Surveillance Mission Platform](#) (MSSMP), flown from 1992 to 1998, used a ducted fan and a 50 hp engine to "cruise at speeds of up to 80 knots, for up to three hours, with a ceiling of 8,000 feet," according to [Helicopters.com](#). Weighing at 250 pounds with a diameter of six feet, the MSSMP was meant to "provide a rapidly deployable, extended-range surveillance capability for a variety of operations and missions, including: fire control, force protection, tactical security, support to counterdrug and border patrol operations,

signal/communications relays, detection and assessment of barriers (i.e., mine fields, tank traps), remote assessment of suspected contaminated areas (i.e., chemical, biological, and nuclear), and even resupply of small quantities of critical items," its makers at the Space and Naval Warfare Systems Center say. (These are the same wizards of robotics that put together the ultra-intimidating [Robart III guard drone](#).)

In the mid-90's, the MSSMP apparently had a couple of successful demonstrations at Army posts. For example, in January 1997, the MSSMP system's flew over Ft. Benning's urban operations training facility, providing "reconnaissance support with the vehicle flying down city streets, looking through upper- and lower-story windows, providing lookout support ahead of advancing troops, and performing observations after landing on the roof of a two story building. The vehicle also dropped a simulated radio relay on the top of a building, a miniature intrusion detector in an open field, and carried a standard Army laser rangefinder/designator as a payload."

The Army has a similar set of tasks in mind for its family of "[Organic Air Vehicles](#)," slated for soldiers hands if and when the [Future Combat Systems](#) project ever comes to pass. The "Organics" rely the same, ducted-fan propulsion as the MSSMP.

This isn't the only saucer-esque craft the Pentagon has toyed with. In 2003, the Navy worked briefly with Russian scientists on a vacuum-powered, [pita-shaped UAV](#). And back in the 40's, the Navy developed the [Flying Flapjack](#) - a propeller-powered, Frisbee-looking fighter plane that could take off and land like a helicopter. Despite years of testing, it never got more than a few feet off of the ground.

## **Peter Jennings Defrauding: Inside The ABC News UFO Documentary Hoax**

Of course, the title of the show was 'Peter Jennings Reporting...' [see <http://abcnews.go.com/Technology/Primetime/>] - if only that were so. This is the story of how, once again, the corrupt Big Media has defrauded the American people, from one who had a front row seat to the spectacle.

In the summer of 2004, as founder and director of The Disclosure Project ([www.DisclosureProject.org](http://www.DisclosureProject.org)) I was approached by Jennings Productions producer Jordan Kronick. He explained how ABC News was going to make

history by doing a serious expose of the UFO matter - for the first time on network news.

Initially skeptical - we have seen and heard this song and dance before - I agreed to meet with Kronick at our offices in Washington DC. Over the course of several hours, we discussed the subject and how The Disclosure Project had identified several hundred top secret military and government witnesses to UFO events and projects.

Kronick expressed great interest and repeatedly stated that this is exactly what Jennings, chief producer Mark Obenhaus and he were looking for. I offered to provide, pro bono, ALL Disclosure Project digital videotape interviews and full access to ALL Disclosure Project witnesses willing to cooperate with ABC News - including those witnesses not yet taped by us.

The reader at this point needs to know that these are not fuzzy, blacked-out deep throats anonymously telling stories of the night. These are hundreds of military, government and corporate insiders who have been identified by us over the past 14 years. They range from Generals, to Astronauts, to senior FAA officials who were privy to events, projects and cover-ups involving UFOs. Additionally, we have thousands of pages of uncontested official government smoking gun documents and physical evidence, photos, videos, landing trace events and other unambiguous proof.

The ABC News production

team claimed to want exactly this type of evidence – and especially the high-level government and military insider whistle-blowers who could credibly blow the lid off of decades of secrecy.

As a two-hour news special, ABC claimed that they could, at long last, give the subject the focus and rigor needed to achieve this objective.

But as discussions continued, it became more and more clear that Obenhaus and Jennings really wanted to do a human interest story – including anecdotal civilian witnesses, man-in-the-street interviews and the general silly season and carnival atmosphere surrounding most things ufological.

We agreed to cooperate with the filming of a CSETI (Center for the Study of Extraterrestrial Intelligence) research expedition to Mt. Shasta in August of 2004, at which time we were able to have discussions with Obenhaus, the senior producer in charge of the project.

We were incredulous as Obenhaus revealed to us that he was sure the matter was not really being kept secret but had just 'fallen through the cracks' due to lack of follow through, laziness and so forth on the part of the government! It was clear he had not studied the data or evidence given to him, and had his mind made up to do a 'light', human interest piece and not a real expose or research project.

This was later confirmed when,

as summer turned to fall, the long promised serious research and interviews they claimed they wanted to do with these top-secret government witnesses were never followed up. I spoke a few more times to Kronick, who promised a sit down interview and follow-up with these high-ranking and conclusive witnesses. They never did.

Instead, the final ABC News show was weaker in evidence than most tabloid cable channel pieces on the UFO subject – with the bulk of the 'documentary' being interviews with UFO personalities, debunkers and the carnival atmosphere of UFO hotspots like Roswell.

They fraudulently appeared to be 'balanced' by having both skeptics and 'believers' – with the clear implication that the skeptics were 'real scientists' and the 'believers' were misguided flakes. Using the ruse of media 'objectivity', ABC News would asymmetrically show, say, a Harvard scientist skeptic juxtaposed against a civilian who thought he had been sexually assaulted by aliens!

The few, very brief interviews with pilots and military people were overwhelmed by the spurious, carnival-like pseudo-ethnography of the UFO subculture mixed in with long segments of scientists pooh-poohing the entire matter.

While appearing objective and 'balanced' to the general viewer, the project was, rather, a disinformation piece, carefully crafted to give the

mere appearance of objectivity.

Otherwise, why spend so much air time interviewing UFO personalities, media figures and the like – while completely leaving out ALL high-ranking military, government and scientific witnesses and evidence given directly by us to them?

In light of the range and scope of material that we personally gave them, it is incomprehensible why ALL of it would be omitted – unless it was their intent from the beginning to do a disinformation and cover-up piece.

Why else would Peter Jennings state that the US Government has been out of the UFO matter since 1969, when Project Blue Book was closed, even though he and his team were directly given by us official US government documents, senior government whistle-blower testimony and physical evidence – including radar tapes – to the contrary? Why would Jennings feature uninformed scientists rhetorically asking 'where's the physical evidence' when abundant physical evidence is available and was offered to him?

Why indeed. We have received a CIA document from 1991 that clearly states that the CIA has contacts in the Big Media to change, kill or spin stories. From this document, dated 20 December 1991, and released 1 April 1992, to the Director of Central Intelligence from the Task Force on Greater CIA Openness, on page 6:

“PAO [the Public Affairs Office] now has relationships with reporters from every major wire service, newspaper, news weekly, and television network in the nation. This has helped us turn some intelligence failure stories into intelligence success stories...In many instances, we have persuaded reporters to postpone, change, hold or even scrap stories...”

And from a CIA document regarding the psychological warfare implications of UFOs, we find a reference to Disney Studios, now the parent company of ABC, being used as a source for doing cartoon-like portrayals of the subject for psychological warfare purposes. Can we be surprised ABC News has, again, defrauded the American people – only pretending to do news and real investigative reporting when in reality they are purveying disinformation to an accepting public?

Obenhaus, without any research or foundation in fact, went so far as to personally assert to me that the hybrid government – corporate complex is not keeping new energy, propulsion and related technologies hidden from the public! His prejudice on the matter was profound and unwavering: forget the facts, my mind is made up.

It is hard to reconcile ABC News' claims to doing a serious expose and investigative report when the senior producer of the project, without any investigation or research, espouses such closed-minded conclusions at the outset.

Those who know me know

that I like to stay positive, present the affirmative facts and present the promise of an advanced, sustainable civilization on Earth benefiting from the knowledge of these new technologies. But it is time for the American people to wake up to the fact that the Big Media and their corporate masters are the central problem blocking the truth from coming out. As a former board member of Time Warner told me, the Big Media has become scribes taking dictation from the right hand of the king – and the fourth estate is essentially dead.

## **A CALL TO ACTION**

The American people must demand that ABC News correct its fraudulent assertions – and do a real investigative report on the serious evidence, government documents and courageous military whistle-blower testimony that The Disclosure Project and others have identified.

After studying all of the facts available, it was determined that nothing would be gained by further investigation, since there was an absence of tangible evidence.

In October 1992, NASA was directed by Congress to begin a detailed search for artificial radio signals from other civilizations under the NASA Towards Other Planetary Systems (TOPS)/High Resolution Microwave Survey (HRMS) program (also known as the Search for Extraterrestrial Intelligence project).

Congress directed NASA to end this project in October 1993, citing pressures on the US Federal budget.

The HRMS did not detect any confirmed signal before it was stopped. However, similar work continued through efforts of private groups and through academic institutions. The Search for Extraterrestrial Intelligence Institute (SETI Institute) in Mountain View, CA, effectively replaced the Government project, borrowing the signal processing system from NASA. The SETI Institute is a nonprofit corporation conducting research in a number of fields including all science and technology aspects of astronomy and planetary sciences, chemical evolution, the origin of life, biological evolution, and cultural evolution.

During several space missions, NASA astronauts have reported phenomena not immediately explainable; however, in every instance NASA determined that the observations could not be termed "abnormal" in the space environment. The 1947 to 1969 USAF investigations studied UFO's under Project Blue Book. The project, headquartered at Wright-Patterson Air Force Base, Ohio, was terminated December 17, 1969. Of the total of 12,618 sightings reported to Project Blue Book, 701 remain "unidentified."

The decision to discontinue UFO investigations was based on an evaluation of a report prepared by the University of

Colorado entitled, "Scientific Study of Unidentified Flying Objects;" a review of the University of Colorado's report by the National Academy of Sciences; previous UFO studies; and Air Force experience investigating UFO reports during the 1940's, '50's and '60's. As a result of experience, investigations, and studies since 1948, the conclusions of Project Blue Book were: (1) no UFO reported, investigated, and evaluated by the Air Force was ever a threat to our national security; (2) there was no evidence submitted to, or discovered by, the Air Force that sightings categorized as "unidentified" represented

**1. Purpose and Scope.** This Regulation establishes procedures for reporting information and evidence pertaining to unidentified flying objects and sets forth the responsibility of Air Force activities in this regard. It applies to all Air Force activities.

#### 2. Definitions:

a. *Unidentified Flying Objects (UFOB)*—Relates to any airborne object which by performance, aerodynamic characteristics, or unusual features does not conform to any presently known aircraft or missile type, or which cannot be positively identified as a familiar object.

b. *Familiar Objects*—Include balloons, astronomical bodies, birds, and so forth.

**3. Objectives.** Air Force interest in unidentified flying objects is twofold: First as a possible threat to the security of the United States and its forces, and secondly, to determine technical aspects involved.

a. *Air Defense.* To date, the flying objects reported have imposed no threat to the security of the United States and its Possessions. However, the possibility that new air vehicles, hostile aircraft or missiles may first be regarded as flying objects by the initial observer is real. This requires that sightings be reported rapidly and as completely as information permits.

b. *Technical.* Analysis thus far has failed to provide a satisfactory explanation for a number of sightings reported. The Air Force will continue to collect and analyze reports until all sightings can be satisfactorily explained, bearing in mind that:

- (1) To measure scientific advances, the Air Force must be informed on experimentation and development of new air vehicles.

- (2) The possibility exists that an air vehicle of revolutionary configuration may be developed.
- (3) The reporting of all pertinent factors will have a direct bearing on the success of the technical analysis.

#### 4. Responsibility:

a. *Reporting.* Commanders of Air Force activities will report all information and evidence that may come to their attention, including that received from adjacent commands of the other services and from civilians.

b. *Investigation.* Air Defense Command will conduct all field investigations within the ZI, to determine the identity of any UFOB.

c. *Analysis.* The Air Technical Intelligence Center (ATIC), Wright-Patterson Air Force Base, Ohio, will analyze and evaluate: All information and evidence reported within the ZI after the Air Defense Command has exhausted all efforts to identify the UFOB; and all information and evidence collected in oversea areas.

d. *Cooperation.* All activities will cooperate with Air Defense Command representatives to insure the economical and prompt success of an investigation, including the furnishing of air and ground transportation, when feasible.

**5. Guidance.** The thoroughness and quality of a report or investigation into incidents of unidentified flying objects are limited only by the resourcefulness and imagination of the person responsible for preparing the report. Guidance set forth below is based on experience and has been found helpful in evaluating incidents:

- a. Theodolite measurements of changes of azimuth and elevation and angular size.
- b. Interception, identification, or air search

action. These actions may be taken if appropriate and within the scope of existing air defense regulations.

c. Contact with local aircraft control and warning (AC&W) units, ground observation corps (GOC) posts and filter centers, pilots and crews of aircraft aloft at the time and place of sighting whenever feasible, and any other persons or organizations which may have factual data bearing on the UFOB or may be able to offer corroborating evidence, electronic or otherwise.

d. Consultation with military or civilian weather forecasters to obtain data on: Tracks of weather balloons released in the area, since these often are responsible for sightings; and any unusual meteorological activity which may have a bearing on the UFOB.

e. Consultation with astronomers in the area to determine whether any astronomical body or phenomenon would account for or have a bearing on the observation.

f. Contact with military and civilian tower operators, air operations offices, and so forth, to determine whether the sighting could be the result of misidentification of known aircraft.

g. Contact with persons who might have knowledge of experimental aircraft of unusual configuration, rocket and guided missile firings, and so forth, in the area.

**6. ZI Collection.** The Air Defense Command has a direct interest in the facts pertaining to UFOB's reported within the ZI and has, in the 4602d Air Intelligence Service Squadron (AISS), the capability to investigate these reports. The 4602d AISS is composed of specialists trained for field collection and investigation of matters of air intelligence interest which occur within the ZI. This squadron is highly mobile and deployed throughout the ZI as follows: Flights are attached to air defense divisions, detachments are attached to each of the defense forces, and the squadron headquarters is located at Peterson Field, Colorado, adjacent to Headquarters, Air Defense Command. Air Force activities, therefore, should establish and maintain liaison with the nearest element of this squadron. This can be accomplished by contacting the appropriate echelon of the Air Defense Command as outlined above.

a. All Air Force activities are authorized to conduct such preliminary investigation as may be required for reporting purposes; however, investigations should not be carried beyond this point, unless such action is requested by the 4602d AISS.

b. On occasions—after initial reports are

submitted—additional data is required which can be developed more economically by the nearest Air Force activity, such as: narrative statements, sketches, marked maps, charts, and so forth. Under such circumstances, appropriate commanders will be contacted by the 4602d AISS.

c. Direct communication between echelons of the 4602d AISS and Air Force activities is authorized.

**7. Reporting.** All information relating to UFOB's will be reported promptly. The method (electrical or written) and priority of dispatch will be selected in accordance with the apparent intelligence value of the information. In most instances, reports will be made by electrical means: Information over 24 hours old will be given a "deferred" precedence. Reports over 3 days old will be made by written report prepared on AF Form 112, Air Intelligence Information Report, and AF Form 112a, Supplement to AF Form 112.

a. *Addressees:*

- (1) *Electrical Reports.* All electrical reports will be multiple addressed to:
  - (a) Commander, Air Defense Command, Ent Air Force Base, Colorado Springs, Colorado.
  - (b) Nearest Air Division (Defense). (For ZI only.)
  - (c) Commander, Air Technical Intelligence Center, Wright-Patterson Air Force Base, Ohio.
  - (d) Director of Intelligence, Headquarters USAF, Washington 25, D. C.

(2) *Written Reports:*

- (a) Within the ZI, reports will be submitted direct to the Air Defense Command. Air Defense Command will reproduce the report and distribute it to interested ZI intelligence agencies. The original report together with notation of the distribution effected then will be forwarded to the Director of Intelligence, Headquarters USAF, Washington 25, D. C.
- (b) Outside the ZI, reports will be submitted direct to Director of Intelligence, Headquarters USAF, Washington 25, D. C. as prescribed in "Intelligence Collection Instructions" (ICI), June 1954.

b. *Short Title.* "UFOB" will appear at the beginning of the text of electrical messages and in the subject of written reports.

c. *Negative Data.* The word "negative"

in reply to any numbered item of the report format will indicate that all logical leads were developed without success. The phrase "not applicable" (N/A) will indicate that the question does not apply to the sighting being investigated.

d. *Report Format.* Reports will include the following numbered items:

(1) Description of the object(s):

- (a) Shape.
- (b) Size compared to a known object (use one of the following terms: Head of a pin, pea, dime, nickel, quarter, half dollar, silver dollar, baseball, grapefruit, or basketball) held in the hand at about arms length.
- (c) Color.
- (d) Number.
- (e) Formation, if more than one.
- (f) Any discernible features or details.
- (g) Tail, trail, or exhaust, including size of same compared to size of object(s).
- (h) Sound. If heard, describe sound.
- (i) Other pertinent or unusual features.

(2) Description of course of object(s):

- (a) What first called the attention of observer(s) to the object(s)?
- (b) Angle of elevation and azimuth of the object(s) when first observed.
- (c) Angle of elevation and azimuth of object(s) upon disappearance.
- (d) Description of flight path and maneuvers of object(s).
- (e) Manner of disappearance of object(s).
- (f) Length of time in sight.

(3) Manner of observation:

- (a) Use one or any combination of the following items: Ground-visual, ground-electronic, air-electronic. (If electronic, specify type of radar.)
- (b) Statement as to optical aids (telescopes, binoculars, and so forth) used and description thereof.
- (c) If the sighting is made while airborne, give type aircraft, identification number, altitude, heading, speed, and home station.

(4) Time and date of sighting:

- (a) Zulu time-date group of sighting.
- (b) Light conditions (use one of the following terms): Night, day, dawn, dusk.

- (5) Locations of observer(s). Exact latitude and longitude of each observer, or Georef position, or position with reference to a known landmark.
- (6) Identifying information of all observer(s):
  - (a) Civilian—Name, age, mailing address, occupation.
  - (b) Military—Name, grade, organization, duty, and estimate of reliability.
- (7) Weather and winds-aloft conditions at time and place of sightings:
  - (a) Observer(s) account of weather conditions.
  - (b) Report from nearest AWS or U. S. Weather Bureau Office of wind direction and velocity in degrees and knots at surface, 6,000', 10,000', 16,000', 20,000', 30,000', 50,000', and 80,000', if available.
  - (c) Ceiling.
  - (d) Visibility.
  - (e) Amount of cloud cover.
  - (f) Thunderstorms in area and quadrant in which located.
- (8) Any other unusual activity or condition, meteorological, astronomical, or otherwise, which might account for the sighting.
- (9) Interception or identification action taken (such action may be taken whenever feasible, complying with existing air defense directives).
- (10) Location of any air traffic in the area at time of sighting.
- (11) Position title and comments of the preparing officer, including his preliminary analysis of the possible cause of the sighting(s).
- (12) Existence of physical evidence, such as materials and photographs.

e. *Security.* Reports should be unclassified unless inclusion of data required by d above necessitates a higher classification.

**8. Evidence.** The existence of physical evidence (photographs or materiel) will be promptly reported.

a. *Photographic:*

- (1) *Visual.* The negative and two prints will be forwarded, all original film, including wherever possible both prints and negatives, will be titled or otherwise properly identified as to place, time, and date of the incident

(see "Intelligence Collection Instructions" (ICI), June 1954).

- (2) *Radar*. Two copies of each print will be forwarded. Prints of radarscope photography will be titled in accordance with AFR 95-7 and forwarded in compliance with AFR 95-6.

b. *Materiel*. Suspected or actual items of materiel which come into possession of any Air Force echelon will be safeguarded in such manner as to prevent any defacing or alteration which might reduce its value for intelligence examination and analysis.

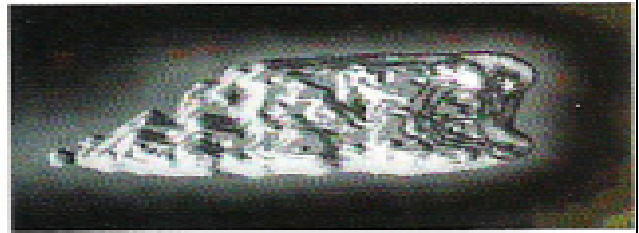
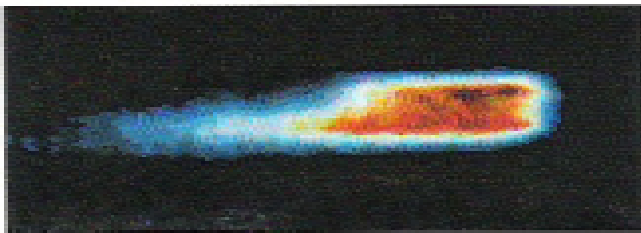

9. **Release of Facts.** Headquarters USAF will release summaries of evaluated data which will inform the public on this subject. In response to local inquiries, it is permissible to inform news media representatives on UFOB's when the object is positively identified as a familiar object (see paragraph 2b), except that the following type of data warrants protection and should not be revealed: Names of principles, intercept and investigation procedures, and classified radar data. For those objects which are not explainable, only the fact that ATIC will analyze the data is worthy of release, due to the many unknowns involved.

technological developments or principles beyond the range of modern scientific knowledge; and (3) there was no evidence indicating that sightings categorized as "unidentified" were extraterrestrial vehicles.

With the termination of Project Blue Book, the USAF regulation establishing and controlling the program for investigating and analyzing UFO's was rescinded. Documentation regarding the former Project Blue Book investigation was permanently transferred to the Modern Military Branch, National Archives and Records Service, in Washington, DC 20408, and is available for public review and analysis.

Since the termination of Project Blue Book, nothing has occurred that would support a resumption of UFO investigations by the U.S. government.

Since neither NASA nor the Air Force is engaged in day-to-day UFO research, neither one reviews UFO-related articles intended for publication, evaluates UFO-type spacecraft drawings, or accepts accounts of UFO sightings or applications for employment in the field of aerial phenomena investigation.


